

Robert Hockin, Grand Master, then rose and presented his Annual Report as follows:—

REPORT OF THE M. W. GRAND MASTER.

To the R. W. Grand Lodge, 1. O. O. F., Lower Provinces, B. N. A. :

REPRESENTATIVES,—By the good providence of God we are assembled in this the Twenty-second Annual Communication of this Grand Lodge,—assembled upon the spot where in the forest primeval was first heard the clangor of warfare, and where, in the early history of our Province, were witnessed scenes, never to be forgotten, which told of man's inhumanity to man.

To-day we are assembled to promulgate the lessons of Friendship, Love and Truth. We meet for inutual counsel, the relief of distress, and the elevation of human character. And while we are reminded what the heart of man can devise when carried away by sensuality and passion, let us, in our intercourse, do what lays in our power to soothe the asperities of life, and lay broad and deep the foundation of Brotherly Love.

In accordance with custom, I present a resume of such matters as have come under my own immediate attention since I last addressed you, and which is now fraternally submitted for your approval and confirmation.

Warrants have been issued constituting three new Lodges, viz.: Caledonia, No. 28, situate at Hopewell, Pictou County, N. S.; Siloam. No. 29, at St. John, N. B.; and Union, No. 30, at Springville, Pictou Co., N. S.

With the assistance of Past Grand Master Mitchell, as also the Grand Conductor, together with members of Fuller and Norton Lodges, I instituted Caledonia Lodge at Hopewell.

Since their institution they have given the best evidence of their intentions in the rapidity with which they have increased in membership, and the efficiency with which their work is done.

Siloam Lodge, St. John, was instituted by D. D. G. M. Murdoch, who

makes special mention of this in his report.

Past Grand Master Mitchell instituted Union Lodge, and I doubt not will report.

DECISIONS.

The following decisions have been given, some of which may only be a statement of existing law—still, as they are cases where perhaps there may be some difference of opinion as to what existing law is, I have thought it better to report them.

- 1. A Dispensation issued by a Grand Master, constituting a subordinate Lodge, being only a provisional instrument, is of no force or effect after a charter has been issued, nor could it be recognized as valid after the first session of the Grand Lodge subsequent to its issue.
- 2. A mere clerical error, such as the substitution of a wrong name in the body of a charter, regularly issued by a Grand Lodge, is not sufficient to vitiate that instrument.
- 3. During the absence of the N. G. the V. G. takes his position, but if a vacancy occur by resignation or otherwise, the office ought to be filled by election.
- 4. In the event of a vacancy, a sitting V. G. who is not a Past V. G. is not eligible for election to the office of N. G., unless all others qualified refuse to act.
- 5. When neither expulsion nor suspension have been determined upon as a penalty, under Sec. 6, Art. VIII., Constitution of Subordinates, then it remains for a Lodge to decide whether the penalty shall be "reprimand or fine," and it has no option but to inflict one of these penalties.
- 6. If a brother's illness is such as does not prevent him from earning a livelihood, he is not entitled to henefits.
- 7. It is illegal and improper for a Lodge to appoint a committee to investigate street rumours respecting a brother. Members of the Order ought not to be harassed with indirect charges; and it is in the spirit of the Constitution that there should be a person responsible for a libel against a brother.
- 3. A charge was brought against a member of a Lodge, which was decided by the Lodge in his favor; but an appeal was taken to this Grand Lodge. Subsequently the member was elected N. G. of his Lodge. Objection was taken to his installation because he was under charges.

I decided that there was nothing in the foregoing case to prevent the member from being duly installed as N. G.

VISITATIONS.

Believing that it was the intention of this Grand Lodge that the policy of this office should for the present be a conserving of the funds, and further, as most Lodges in the jurisdiction had lately been visited by the incumbent of this chair, I have not thought it necessary to make any extensive visitation.

It was my good fortune to be in St. John city during the past winter. I took advantage of the opportunity to visit some of the Lodges, among them Peerless Lodge,—to which more than a passing tribute ought to be paid; the completeness of their outfit—the elegance of their Lodge room—the character of the meeting at which I was present, are evidences to me that Peerless takes rank among the first Lodges in the jurisdiction.

Of Beacon Lodge—its character is already too well known to require a word from me. Even had not later circumstances created a new era in its history, which makes it nunecessary to speak of its past.

These, with Eastern Star Lodge, which, by-the-by, continues to be one of the star Lodges of the Order, are the only Lodges which I have had the good fortune to visit; but as each district is under the supervision of an able and efficient D. D. Grand Master, the want of these visitations will, I trust, not be felt.

DISPENSATIONS -- GENERAL

Most of the cases for which a Dispensation is required come within the control of D. D. G. Masters, consequently I have not been requested to issue more than one Dispensation, viz., to Eastern Star Lodge, to confer Degrees upon Jas. Gerdon and J. Gould in less time than required by law.

I refused to grant to another Lodge a Dispensation to elect as Secretary

a Brother who had not attained the scarlet Degree.

We have experienced during the past year, what, happily, is in this jurisdiction, a new sensation, viz.: the surrender of their charters by two of our Subordinate Lodges. The first to succumb—Excelsior, of Dartmouth -I cannot help believing, received its death blow at the hands of this Grand Lodge, when it decided that residents of Dartmouth could be initiated in Halifax—the greater strength and consequently better position of the city Lodges presenting a stronger attraction than the weaker town Lodge. other-Widows' Hope-has been known to be in a declining state, and the executive were authorized at last Session to consider the propriety of its surrendering the Charter.

Excelsior Lodge resigned its Charter to Bro. Thos. Robertson, D. D. G. M., who reports thereon. I took charge of the property of Widows' Hope, and issued a Commission to James E. Geldert, P. G., authorizing him to collect certain amounts due to the Lodge, and to pay a claim for rent of Hall, to take charge of the personal property and take

such steps as might be necessary to secure and protect the same.

The question of incorporating this Grand Lodge is yearly becoming one of more importance. In other jurisdictions Grand Lodges are incorporated in such a way as admits Subordinate Lodges to all privileges of incorporation by simply registering their names with the Grand Secretary. If, under the Dominion, such a system could be procured, it would serve as an economical and convenient method for our Subordinate Lodges.

I would suggest a Committee to bring this matter before such Subordinate Lodges as would wish to be incorporated, and who might contribute

towards the cost of the same.

At the last Session it was decided to procure a new form of Returns. The Executive have adopted and issued for the past year one which is hoped

will meet the requirements of the Grand Lodge.

Forms of Dispensations for the use of D. D. Grand Masters, with a convenient method of recording purpose of issue have also been procured, at a little expense, it is true; but it is expected that this system will lead to a greater revenue from Dispensations than heretofore.

The Grand Lodge of the United States, although claiming the right to issue all eards required for the Order, has left it with Grand Lodge jurisdictions to adopt such form of card for members of defunct Lodges as they see fit. It became necessary to supply this want, and a form was accordingly adopted, and the price charged for these the same as regular withdrawal

By some inadvertence or misunderstanding of the usage of the Order a late Grand Secretary issued ode cards printed for the Grand Lodge in Halifax.

I received a circular from the Grand Sire, in which attention is called to the practice by many Grand Jurisdictions of issuing ode cards, and calling upon such to comply with the requirements of the G. L. U. S. Accordingly a number of odes were procured and substituted for those issued, and a circular addressed to the several D. D. G. M's and Secretaries of Lodges requiring them to comply with the law.

Last Session a resolution was passed requiring the Grand Secretary, and Grand Treasurer to give bonds in the Canada Guarantee Company. Application was made to the Company, but they refused to accept, giving as reason that they object to giving guarantees where the office is an honorary one.

At the Session previous to the last a Committee was appointed to get up the necessary Constitution, &c., for Degree Lodges. They have failed to report, and as applications have been made with a view to establishing Degree Lodges I would suggest the appointment of a new Committee to carry out that object.

I received in June last the resignation of Bro. Thos. Robertson, as D. D. G. M. of Halifax, in consequence of his removal from that city. As it was near the end of the year I did not think it necessary to appoint a D. D. G. M. for so short a period. The officers of the Halifax Lodges were

duly installed by Past Grand Master H. A. Taylor.

In reviewing the progress of the Order during the past year, it is a matter of congratulation that although it has not been a year of uninterrupted progress, still material prosperity has been ours. We have to regret a large increase in the number dropped for non-payment of dues, consequent upon the depression in the commercial world. And while upon this subject, I desire to mention a probable cause for this increase, and trust a remedy may be found. Under our present system, if a member allows his dues to accumulate, it seldom happens that any effort is made upon the part of Secretaries to collect the same—the amount is allowed to grow until it becomes irksome, and the member concludes to let it remain, while if a little effort was made from time to time when the amounts were small, his good standing would be maintained, and thus prevent a large falling off of membership, mainly because of carelessness upon the part of members themselves.

But while we have to regret this loss, it is insignificant as compared with the disaster which has befallen the Jurisdiction through the late St. John fire. It will be admitted, I think, that the flickering light of Odd-fellowship which existed previous to the organization of Pioneer and Beacon Lodges, was mainly through and because of these Lodges—fanned into a flame; and we are here to-day, representatives from the East and West, North and South, as a result largely flowing from the labors, and from the position which the Order assumed by being endorsed by the city of St. John, now in ashes. It is true that to the Order in the Jurisdiction the disaster is not an unmixed evil. It has shown that it is not in the sunshine of prosperity that the excellent qualities of the Order are discovered, but in the midnight of adversity when all is gloom that there arises above the horizon of our despondency a ministering light.

The immediate and voluntary effort upon the part of our Lodges, and the generous assistance from other Grand Jurisdictions speak, in unmistakable tones, that it is not as a pleasant tale to please the imagination that its members receive the teachings of Odd fellowship.

And now, Representatives, permit me in conclusion to remind you that you are charged with the authority to legislate for ar organization which is fast numbering its thousands,—that it devolves upon you to adjudicate upon controversies and alleged grievances which are inseparable from a large membership,—that it is your prerogative to elect for the ensuing year the chief excellencies in the Jurisdiction. It is obvious, therefore, and perfectly natural, that your proceedings should be looked upon with interest, and that your deliberations should challenge the closest scrutiny and attention.

Let us, therefore, approach these duties with a proper estimate of the gravity and impressiveness of our responsibility, (and with pure hearts and clean hands must we come to such offices,) so that from this perennial fountain may flow a wise and faithful administration, which may result in perpetuating that profound and abiding love and veneration which we cherish for our Order, and which may baile up, year by year, that confidence in its impartiality and respect for its judgment, so inseparable from an agreeable and efficient administering of the affairs of the Jurisdiction.

I have to thank you for the renewed expression of confidence in electing me a second time to this position. I beg to return my sincere thanks to the Grand Lodge for the marked courtesy and kindness which has generally been extended to me by its members since my occupancy of this chair. And while I regret that the policy I have alluded to has not permitted actual zeal, while I am aware that there are many things which I could have wished it was within my power to attend to more promptly than has been done, I yet have the self-assurance that where such has been the case, or wherein I have erred in judgment, it has not been from want of earnest love for the Order.

May God speed the great work we have in hand, and may our efforts at this and every succeeding Grand Lodge redound to His glory and the happiness of mankind.

REPORT OF THE D. D. GRAND MASTER FOR THE DISTRICT OF EGERTON.

STELLARTON, August 7th, 1877.

To the Most Worthy Grand Master of the R. W. G. Lodge, I. O. O. F., of the Lower Provinces of B. N. A.:

Most Worthy Sir and Brother,—Having been honored by you with the appointment of District Deputy Grand Master for the District of Egerton, I herewith, in accordance with the requirements of the R. W. Grand Lodge, submit a report of my official duties during that term, which I trust will meet with your approval. My official acts during the year have been as follows:

INSTALLATIONS.

Fuller Lodge, No. 5, Stellarton.—Jan. 5, I visited the Lodge and installed the officers. July 6, I visited the Lodge and installed the officers. This Lodge still stands high in point of numbers, although it numbers less than last year, as the return will show a number of members dropped for non-payment of dues. The attendance is good, and the officers and members take an interest in the work.

In October last, having received a Dispensation to epen a new Lodge in Springville in this District, and previous arrangements having been made therefor, in compliance with, and by the authority delegated to me by your Dispensation, I proceeded to Springville on the 17th October, accompanied by qualified P. Grands from Fuller and Moore Lodges. I opened and constituted a Lodge under the name and title of Union Lodge, No. 30, and regularly installed the following officers, viz.: Robert McLean, N. G.; William McGilvray, V. G.; Robert A. McIntosh, Secretary; Joseph Grant, Treasurer; David McLean, Warden. And it having been previously arranged by the Charter members to secure and initiate some candidates, and as it is usual on such occasions to grant Dispensations for the purpose. I granted their request, and received and initiated eight candidates. There were also two Brothers admitted by card. You will see that Union Lodge starts with sinkeen members, and with fair prospects of adding to the number, and I have good hope that the Lodge is in good hands, and has every prospect of success.

DISPENSATIONS.

October 22, 1876, granted a Dispensation to Scotia Lodge, No. 11, to confer Degrees on Bro. Norman Beaton.

February 19, 1877, granted a Dispensation to Norton Lodge, New Glasgow to have an entertainment for some Pictou Brothers on a fraternal visit.

March 19, 1877, granted a Dispensation to Union Eodge, No. 30, to confer Degrees on Brothers Daniel McDonald and Alexander Duff.

April 24, 1877, Granted a Dispensation to Scotia Lodge, No. 11, to walk in Regalia on the 26th inst.

April 24, 1877, granted a Dispensation to Fuller Lodge for same purpose.

June 11, 1877, granted Dispensation to Moore Lodge to confer the five Degrees on John D. McDonald.

June 27, 1877, granted Dispensation to Moore Lodge to hold a picnic.

June 23, granted a Dispensation to Fuller Lodge, No. 5, to receive the application of Bro. James Burrows, who held a withdrawal card from Widows' Hope Lodge, and ballot and admit him the same evening, as he was to leave the Province before next meeting,—the granting of this Dispensation being in my opinion for the advancement and welfare of the Order.

In conformity to the circular received from yc. 1 to visit the Lodges in this District, and bring to their notice the illegality of using ode cards, &c., that had not the imprint of the G. Lodge of the United States on them, I attended to this duty on my visit of Installation, and found that Fuller was the only Lodge that had cards with the imprint of the G. Lodge of the United States; Scotia Lodge had a few legal and a number of illegal cards. I collected them all and sent an account of them to the G. Secretary-The cards I have in my possession, and will deliver them to the G. Secretary when I go to the G. Lodge.

During the past year Odd Fellowship has not increased in this District as in previous years, as will be seen by the Grand Secretary's report, although two new Lodges have been formed. The number of members has rather decreased. The principal reason for this is the dull times caused by the great depression of trade, and principally the coal trade (which is the main business of the District) causing a great number of members to be dropped for non-payment of dues, as will be seen by the reports.

Any appeals I have received were handed over to you for your decision. In conclusion I have to thank you for your uniform kindness inpromptly answering all inquiries on all occasions; also the R. W. G. Secretary in answering all communications that I had to write; also to the officers and members of the different Lodges in this District, for the courtesy shewn me on all occasions, and the past officers of the different Lodges for their kindness and willingness at all times to assist me at installations. REPORT OF THE O. D. GRAND MASTER FOR THE DISTRICT OF FREDERICTON.

FREDERICTON, N. B., July 16th, 1877.

To Robert Hockin, Esq., M. W. Grand Master of the Grand Lodge 1.0.0.F. of the Lower Provinces of B. N. A.:

MOST WORTHY SIR AND BROTHER,-I am deeply sensible of the honor conferred upon me by appointing me your Deputy for the District of Fredericton and although my District embraces but one Lodge, still it affords me great satisfaction to submit a report of my official acts during the past year.

DISPENSATIONS GRANTED.

During the year four Dispensations have been granted viz.: August 3, 1876. Dispensation to Victoria Lodge, No. 13, to adjourn regular meeting of 9th August for the purpose of holding a moonlight excursion on the River St. John, in honor of the Grand Lodge.

December 12. Dispensation to Victoria Lodge, No. 13, to hold a literary and musical entertainment.

January 26, 1877. Dispensation to Victoria Lodge, No. 13, to hold a

second literary and musical entertainment.

March 17. Dispensation to Victoria Lodge, No. 13 for a public lecture by a distinguished Brother in the City Hall. In the latter case permission was asked for members of the Order to be allowed to appear in Regalia. I declined to give this permission, believing, as I did, that it would not be for the "good and weltare of the Order." I beg to ask your confirmation of these Dispensation.

INSTALLATION OF OFFICERS.

On the 3rd January I installed the officers of Victoria Lodge, being ably assisted by a number of the Brethren, and on the 4th July instant, I again visited the Lodge for the purpose of installing the officers for the current term, but owing to the returns, &c., being in an unsatisfactory condition, I declined doing so. On the following Wednesday evening (July 11tb), I again visited the Lodge, and the books, papers and returns being in a satisfactory state, I installed the officers in regular form, having the assistance of Past Grands Estey, Fowler and others.

During the past year the Order in Fredericton has taken rapid strides and has further developed the popularity and efficiency of our Institution. Members have been relieved without feeling that they were accepting a charity, and one Brother connected with Victoria Lodge has felt the benign influence in the far off clime of California, a stranger in a strange land, he was prostrated by sickness, without means, and, as he thought, without a friend within thousands of miles. He at last bethought him of the card he had taken the precaution to procure before leaving home; this he forwarded to the Relief Committee of San Francisco, and it met with a prompt and cheerful response, his wants were immediately relieved, and every care and attention bestowed upon him, until he was again restored to health. The amount advanced was immediately refunded by Victoria Lodge. I mention this circumstance to show our Brethren the practical and beneficial results of a membership in our beloved Order. It is thus that we see fully demonstrated that this Order knows no nationality but our common brotherhood, five hundred thousand strong, reaching from the Atlantic to the Pacific, from frozen North to sunny South, and to all nations, tribes and kindreds.

I have made several official visits to the Lodge in my jurisdiction during the past year. The attendance has been above the average. The office of N. G. of Victoria Lodge has been most acceptably filled during the past two years, by Brothers who took pride in having the work correctly done, and well done, and indeed I may say as much for all the officers. I have on more than one occasion witnessed with much satisfaction the correct manner in which the work has been performed. The Sitting N. G. will, I feel confident, conduct the affairs of the Lodge with satisfaction to his Brethren and honor to the Order.

An effort was being put forth to establish branches of our Order in the towns of St. Stephen and Woodstock; but the recent fires in both these places will preclude the possibility of extending our Order in that direction for some short time at least.

The late visitation of God's Providence whereby two-thirds of the City of St. John was reduced to ashes, stirred the hearts of the Brethren of this District and a spontaneous burst of sympathy went forth to our distressed

The Grand Secretary presented his Annual Report as follows:—

REPORT OF R. W. GRAND SECRETARY.

M. W. Grand Master, Officers and Representatives:

It has become my duty to lay before you my first Report of the transactions of the office of Grand Secretary, and a summary of the information sent to that office during the past year. The Grand Lodge having decided, in accordance with the recommendation of the Finance Committee last year, to make the financial year close on July 31st, this report covers the period

from August 9th, 1876 to July 31st, 1877.

In accordance with a vote of the Grand Lodge at last meeting recorded on page 27 of the report, I returned the reports of the following Lodges for correction, viz.: Eastern Star, No. 2, Widows' Hope, No. 7, St. Lawrence, No. 8, Scotia, No. 11, Beacon, No. 12, Excelsior, No. 14, Western Star, No. 16, and Crystal Wave, No. 25. Of these Eastern Star, Scotia, Excelsior, and Crystal Wave responded to my request and sent back their reports corrected, or partly so. The others, viz.: Norton, Widows' Hope, St. Lawrence, Beacon, and Western Star, never answered my letters, and have not yet sent back the reports, although repeatedly requested to do so.

The Grand Lodge having adopted the Report of the Committee on the State of the Order, in which it was recommended that Brother H. A. Taylor, P. G. M., should be presented with a collar, I esteemed it my duty to purchase and present to the said worthy Brother a P. G. M's. collar. The presentation took place on the 5th of March at his own house, in the presence of several members of the Order in Halifax, who appeared to enjoy the

oceasion very much.

I found in the office no proper Roll of the membership of the Subordinate Lodges, which, it appeared to me, ought to be kept, and amended from year to year as the reports from the various Lodges come in. I have accordingly had prepared a book for the purpose, and have now a complete roll of the membership of all the Lodges that complied with the law by sending in a roll of their members on December 31st. The following Lodges neglected to do so, viz.: St. Lawrence, Pioneer, Orient, and Beacon.

During the year two Lodges have surrendered their Charters,—Widows' Hope, No. 7, of Truro, and Excelsior, No. 14, of Dartmouth. The effects

The total assets of the Lodges reach the respectable sum of..\$18,424 10 or an average of \$737 to each Lodge.

Seven Lodges do not report any W. & O's fund. The figures reported by the other Lodges amount to \$3371.01, of which sum Pioneer Lodge reports \$1470.87.

It would be interesting to know what is the amount of this fund, and it would be much more satisfactory, I should think, to all friends of the order to know that the fund is being properly reserved for the purpose for which it

was constituted. I should judge from the reports that in many of the Lodges the accounts of the fund are not properly kept, or not kept at all. I have not had time to look into the matter thoroughly; but I examined the reports of one Lodge, whose W. & O's fund ought to amount to at least \$250 after deducting all payments reported, but which returns by last report less than \$100.

This is an important matter, it appears to me, and a subject on which the Grand Lodge has a right to require accurate information. The fund is, if I understand it aright, a trust fund, and Lodges have no right to use it for any other purpose than that for which it is ordered to be reserved. Or, at least, if they should use a part of it for other purposes in cases of necessity, they have no right to alienate it from the fund, but should by all means acknowledge the liability in their accounts and reports, and make provision for its re-payment, as if they had borrowed the money from any other source.

The receipts and expenditures of my office may be summarized as follows—the cash book showing particulars will be submitted to the Finance Committee:—

RECEIPTS.

A balance sheet showing the standing of the accounts, and closing of the dedger is herewith submitted.

Before the end of the term in which I was elected to this office, by the advice and with the assistance of the M. W. Grand Master, and other members of the Executive Committee, I had a new form of semi-annual reports printed, and the reports for the last two terms have been made on that form. If I had waited till I had gained a little more experience in the office, I think I could have improved on that form in some particulars, but our old ones were about exhausted and so new ones had to be procured.

During this year I have kept a careful record of the letters I have written and a file of those received, all of which are herewith submitted for the examination of the proper Committee.

Before closing this report, I would respectfully suggest the necessity of so amending the Constitution as to define more clearly the respective duties of the G. Secretary and G. Treasurer. These offices having been till last year held by the same individual, the Constitution defines the duties of the one officer in the double capacity, which does not apply to the present position.

Brethren, I came to this office with very little experience of its requirements, or of the working of Odd Fellowship; and I have found the duties such as require a good deal of knowledge, experience, wisdom and care. I have endeavored to perform them punctually and well. If I have not succeeded entirely, you will, I know, look leniently on errors which were not intended. I have not sufficient experience to entitle me to give advice, and shall not attempt to do so. Nor shall I indulge in any high-sounding words in regard to the principles and merits of our Order. I simply lay the facts collected in my office before you as I find them, and trust you may all be endued with wisdom to draw from them the lessons they teach, and put in practice the duties they enjoin.

The Historiographer presented his Report as follows:—

REPORT OF HISTORIOGRAPHER.

BARRINGTON, SHELBURNE Co., August, 1876.

To M. W. Grand Master, G Lodge, L. P. B. N. A.:

During the past year but little has been done by myself towards collecting and arranging the history of Odd-fellowship in this Jurisdiction. My removal from Halifax and change of business has been largely the cause of this, and an almost general apathy on the part of Subordinate Lodges has rendered it impossible to make any advance. The local histories already forwarded me are in my custody, and these, with additions that may be made to them in the future, will form interesting pages in connection with the Order in those localities to which they especially refer.

I again desire to press upon the attention of Representatives from those Lodges which have not yet complied with the request of the Grand Lodge, the importance of collecting and arranging their local history, by some competent member, assisting by this means my work, as such duty has been assigned to me by the Grand Lodge, and at the same time depositing among the Records of this Body that which may some day be required for historical purposes.

MORNING SESSION.

Wednesday, August 15th, 1877.

Grand Lodge re-assembled pursuant to adjournment at 9 o'clock, A. M.

Minutes of last Session were read and confirmed.

Thos. Robertson, G. Representative from the Committee on Appeals, reported in the case of Foster v. Guiding Star Lodge, asking for power to summon witnesses.

Moved by Representative Jas. R. Macdonald of No. 18, seconded by Representative Fred'k L. Hea of No. 9, that the request be granted. Motion passed.

Western Star Lodge, No. 16, having accredited six representatives, and being entitled to only three, the Grand Secretary brought the matter to the notice of the Grand Lodge, when it was agreed that Representatives Tedford, Edwards and Crowe were the proper representatives, Past Grands Anderson and Wilson, and Grand Warden VanBlarcom withdrawing their credentials.

Representatives Theo. L. Chappelle, G. H., seconded by Representative W. C. DesBrisay, moved the following resolution:—

Resolved, That a committee of five be appointed to publish a periodical (the number of issues per year being left to their decision) which will be recognized as the official organ of the Grand Lodge of L. P. B. N. A., and which will diffuse the principles and progress of the Order in this jurisdsetion.

Moved by Thos. Robertson, G. Representative, seconded by Representative N. A. Cliff of No. 13, that the resolution be received and referred to a special committee to be composed of the Committee on the State of the Order and the Committee on Finance. Motion passed.

Representative W. C. DesBrisay of No. 8, seconded by Representative Theo. L. Chappelle, G. H., moved the following resolution, which was referred to the Committee on Legislation:—

Resolved, That Section 8 of the Constitution of Subordinate Lodges be struck out and the following substituted:—Any member neglecting to make payment of his dues or demands against him, to the Lodge according to its constitution or bye-laws, for the space of seven months shall cease to be a member of said Lodge, provided that the fact of his so being in arrears for seven months shall first be announced in open Lodge, at two regular meetings.

Representative Frank Graham of No. 10, moved, seconded by Representative Fred'k L. Hea of No. 9, that the election of officers for the ensuing year take place at 4 o'clock this afternoon. Motion passed.

Representative A. A. McLennan of No. 22, seconded by Representative W. A. Moore, G. Chaplain, moved the following resolution, which was concurred in:—

Whereas, A charter was in August, 1875, issued to Prince Edward Lodge, No. 22, which said charter contained errors and omissions in the names of charter members and was immediately returned by said Lodge to the late G. Secratary, and has not since been in the possession of said Lodge.

Therefore resolved, That the Grand Master be authorised to issue a duplicate charter (without charge) to Prince Edward Lodge, inserting therein as charter members the names of brothers to be furnished the Grand

Secretary by the Secretary of Prince Edward Lodge.

Representative Frank Graham of No. 10, from the Committee on Finance presented the following report, which, on motion of Representative W. A. Moore, G. Chaplain, seconded by Representative W. M. McLean of No. 29, was laid on the table till the afternoon Session.

FINANCE COMMITTEE'S REPORT.

To the Right Worthy Grand Lodge, I. O. O. F., L. P. B. N. A.:

Your Finance Committee beg leave to report to the Grand Lodge now in session, that they have had submitted to them the books, accounts and reports of the Grand Secretary and Grand Treasurer, and have carefully examined the same.

The books of the Grand Secretary have been kept in a straight-forward and legible manner, and therefore materially lessened our labors in auditing

REPORT OF THE COMMITTEE ON RETURNS.

To the Right Worthy Grand Lodge, I. O. O. F., of the L. P. B. N. A.:

The Committee on Returns beg to report that they have examined the several returns submitted to them for the terms ending Dec. 31st, 1876, and June 30th, 1877, and find them all correct except the Returns of Eastern Star. No. 2, Fuller, No. 5, Moore, No. 17, Peerless, No. 19, Guiding Star, No. 21, and Caledonia, No. 28, which do not show the amounts to credit of

Widows' and Orphans' Fund. The Returns of Eastern Star, No. 2, Norton, No. 6, and Moore, No. 17, appear incomplete in number of members, and the Returns of Western Star Lodge, No. 16, are defective in not giving the financial statement. There is a marked discrepancy between the Returns of St. Lawrence Lodge for terms ending Dec. 31st, 1876, and June 30th, 1877, but the committee are satisfied that the last is correct.

Feeling the importance of having correct Returns from every Lodge in the Jurisdiction, your committee would urge on secretaries the necessity of taking more care in their preparation.

Your committee cannot close their report without expressing their regret that the Lodges have not remitted to the Grand Lodge the returns sent to them for correction by order of this Grand Body at its last Annual Session, and hope that this will be attended to immediately.

CHISHOLM &S. NORTON LODGE,

presented the following report:-

In this case P. McG. Chisholm, Past Grand, charges Bro. John K. Fraser of violation of obligation taken in this Order, and for using indecorous and disrespectful language in Lodge Room, and for conduct unbecoming an Odd Fellow. The action of Norton Lodge, No. 6, relieves Brother Fraser from these charges, from which decision Past Grand Chisholm appeals upon the following grounds:

That committee refused to hear witnesses offered by him, and other charges of a serious nature against members of committee and of Norton Lodge.

From the documents in our possession we have no evidence to establish the truthfulness of these statements nor any reply of the committee or Jodge thereto.

From among the papers submitted in this case we make the following extract from the report of committee of Norton Lodge, No. 6, the adoption of which, and subsequent action of lodge thereon formed the ground of Past Grand P. McG. Chisholm's appeal:

"From the high state of excitement which prevailed on the night of the 5th March, and the quantity of ill-tempered language used by members on that night, the members of this committee who were present on that occasion cannot weigh properly the personal testimony of either party to this case,

which is directly opposed one to the other.

"As Odd Fellows bound together by the most solemn obligations to rule our conduct towards each other by the standard of Friendship, Love and Truth, we would solemnly protest against such disgraceful scenes as occurred in our lodge room on the night of the 5th March, and we therefore recommend that the Lodge take such action in reference to the portions of the charge which have been sustained as will help members to keep in wholesome remembrance the fact that however great the provocation, the members of this Lodge will always hold worthy of censure any member who takes upon himself to obtain, independent of the Lodge, satisfaction for attacks upon his character, or breaches of the principles of our Order, made by members of the Order in or out of lodge-room."

Your committee recommend that the appeal of Past Grand Chisholm, be referred to Norton Lodge, No. 6, for their answer thereto, and are of the opinion that such personal wrangling and disputes are calculated to inflict disaster and disrespect upon the Order when brought to this Grand Body, and had the appellant in this case been guided by the brotherly suggestions of the committee, as from his position as a member of this Grand Body he was bound to do, the strife and discord which in this case created heart burnings and divisions among brethren would have been banished from the lodge room, and the names of brothers who indulged in the unseemly personalities would

have been unknown to the Representatives here assembled.

JAMES H. ELLIS, FRED'K L. HEA, CALEB SCHURMAN, T. A. COSSMANN, THOMAS ROBERTSON, Representative W. A. Moore, G. Chap., moved, seconded by J. C. P. Frazee, G. Sec., that the report be adopted. Motion withdrawn, and the report laid on the table.

Moved by Representative Frank Graham of No. 10, seconded by Representative W. M. McLean of No. 29, that the report be referred back to the committee to bring an outline of the case.

Moved and seconded as an amendment that the papers be now read. Amendment lost. Motion passed.

The members of the Committee on Laws of Subordinates being absent, the Grand Master appointed Representative Frank Graham of No. 10, Representative W. M. McLean of No. 29, and Representative E. A. Bent of No. 25, to serve on that committee.

Representative D. B. Stewart of No. 23, from the Committee on the State of the Order, presented the following report, which was received and adopted:

REPORT OF COMMITTEE ON THE STATE OF THE ORDER.

To the R. W. Grand Lodge, I. O. O. F., of the Lower Provinces, B. N. A.:

Your Committee on the State of the Order, beg leave to submit the following report:

1st. That they consider that this Grand Body is to be congratulated on the very satisfactory progress since our last Annual Session, as shown by the reports submitted by our M. W. G. Master, G. Secretary and G. Treasurer; and also that the large representation now present denotes a more general interest in our Order throughout the jurisdiction than ever before evinced.

2nd. Your committee would heartily commend the action of the G Master in carrying out the suggestions of the previous Committee on the State of the Order; we believe the caution exercised by him in granting dispensations has already wrought a marked change in the harmony and general welfare of the Order.

3rd. They would also congratulate this Grand Body on having the services of such an efficient Secretary as the present incumbent has proved himself to be by the able and thoroughly practical report which he has submitted; they would also remark the decided advantage of having the offices of G. Sec. and G. Treas. distinct, and would compliment the G. Treasurer on the highly satisfactory exhibit which he has submitted.

4th. Your committee would consider the explanation of Bro. Robertson as Historiographer as perfectly satisfactory, and would recommend that he be retained in that office. They would suggest that Representatives bring the matter to the immediate notice of their respective Lodges, and urge the necessity of complying with the Grand Secretary's circular of Dec. 4, 1875, in every case where it has not been done.

5th. They would notice that there is a growing tendency of inquiry regarding our principles in localities where Lodges have not yet been instituted, and although our Order is not aggressive in principle, yet they would urge upon District Deputies the advisability of fostering our principles wherever they may have taken root; they would call the special attention of Deputies to the following places which have been brought to the immediate notice of the committee, viz., Berwick, Wolfville and Amherst in Nova Scotia, Chatham and Carleton, N. B., and Alberton and Souris, P. E. I.

6th. There being an evident lack of uniformity in the business management and working of Subordinate Lodges, it is highly necessary that a Grand Instructor be appointed to visit all the Lodges in this juristiction as often as deemed necessary, for the purpose of giving instruction in the workings of the Order, and the thorough inspection of the books and documents of each Lodge, thereby preventing the evils and irregularities evinced by incomplete returns, as noticed in the report of the Grand Secretary.

7th. If this Grand Body would entertain a change in the representation from Subordinate Lodges, viz.,—that they be entitled to one charter representative instead of two as at present, the amount thus saved would provide remuneration for a Grand Instructor.

Past Grand Master H. A. Taylor, G. Treas., from the Committee on Legislation, presented the following report which was adopted:—

REPORT OF THE COMMITTEE ON LEGISLATION.

To the R. W. Grand Lodge, I. O. O. F., of the Lower Provinces, B. N. A.:

Your Committee on Legislation, to whom was referred the Decisions of the M. W. Grand Master, beg to report:

1st. "A dispensation issued by a Grand Master, constituting a Subordinate Lodge, being only a provisional instrument is of no force or effect after a charter has been issued, nor could it be recognized as valid after the first session of the Grand Lodge subsequent to its issue."

This decision is approved being in accordance with Section 535 of the Digest.

2nd. "A mere clerical error, such as the substitution of a wrong name in the body of a charter, regularly issued by a Grand Lodge, is not sufficient to vitiate that instrument."

To this decision which is approved, we would add that should the Grand Secretary fail to rectify such an error when requested, the Lodge desiring such correction may petition the Grand Lodge to direct the same to be done.

3rd. "During the absence of the N. G. the V. G. takes his position; but if a vacancy occur by resignation or otherwise, the office ought to be filled by election."

This decision is approved, being in accordance with the usages of the Order. See Digest, Sec. 1333.

4th. "In the event of a vacancy, a sitting V. G., who is not a Past V. G., is not eligible for election to the office of N. G., unless all others qualified refuse to act."

This decision is approved, being in accordance with Section 1333 of the Digest.

5th. "When neither expulsion nor suspension has been determined upon as a penalty under Sec. 6, Art. VIII. of the Constitution of Subordinates, then it remains for the Lodge to decide whether the penalty shall be 'reprimand or fine,' and it has no option but to inflict one of these penalties."

The principle involved in this decision is fully borne out by the Section of the Constitution of Subordinates referred to, and is therefore approved.

6th. "If a Brother's illness is such as does not prevent him from earning a livelihood, he is not entitled to benefits."

Approved, being in accordance with Sections 172 and 173 of the Digest. 7th. "It is illegal and improper for a Lodge to appoint a committee to investigate street rumors concerning a Brother.

"Members of the Order ought not to be harassed with indirect charges, and it is in the spirit of the Constitution that there should be a person responsible for a libel against a Brother."

Fully sustained by Sec. 3, Art. VIII. of the Constitution of Subordinates,

and is therefore approved.

8th. "A charge was brought against a member of a Lodge, which was decided in his favor, but an appeal was taken to this Grand Lodge. Subsequently the member was elected N. G. of his Lodge. Objection was taken to his installation because he was under charges.

I decided that there was nothing in the foregoing case to prevent the

member from being installed as N. G."

Approved, as in accordance with the spirit of Section 325 a of the Digest.

Past Grand Master Taylor, G. Treas., from the same Committee, also presented the following Report, which was adopted:—

REPORT OF THE COMMITTEE ON LEGISLATION.

Your Committee on Legislation, to whom was referred that part of the Grand Secretary's report relating to the respective duties of the Grand Secretary and Grand Treasurer, beg leave to recommend that Sec. 4, Art. IV. of the Constitution be amended to read as follows:

Section 4.—The Right Worthy Grand Secretary shall make a just and true record of the proceedings of the Grand Lodge at every session, and transmit, as soon as practicable after the close of the annual session, to the Subordinate Lodges each two printed copies thereof. He shall keep the accounts between the Grand Lodge and its subordinates, receive all moneys and pay the same immediately to the Grand Treasurer, taking his receipt for the same. He shall issue all necessary notices and circulars to subordinates, representatives and officers; transmit to the Grand Lodge of the United States a regular report of the Order, made up to the 31st of December in each year. He shall provide all stationery for the use of the Grand Lodge, and superintend such printing as the Grand Lodge shall direct. He shall keep his accounts in such a manner as will exhibit the source and amount of receipts, and by whom paid; and the purpose and amount of the disbursements; have his accounts closed up to the 31st day of July in each year, and submit them to the Finance Committee at the annual session of the Grand Lodge. He shall attend all regular sessions of the Grand Lodge. He shall, previous to his installation, give bonds to the Trustees of the Grand Lodge of the Independent Order of Odd Fellows of the Lower Provinces of British North America, conditioned in such an amount as the Standing Committee of the Grand Lodge may from time to time require: provided, the amount of such bond shall in no case be less than one thousand dollars, for the faithful performance of his duties; and he shall receive such salary as the Grand Lodge at each annual session may determine.

The Right Worthy Grand Treasurer shall receive and hold all moneys handed to him by the Grand Secretary, giving his receipt for the same. He shall pay all orders drawn on him by the Grand Master, and counter-signed by the Grand Secretary. He shall deposit all sums over thirty dollars in his possession in a savings' bank, and be prepared at all times to give such financial information as the Grand Master or Trustees may require. He shall, previous to his installation give to the Trustees such a bond as shall be satisfactory to the Standing Committee of the Grand Lodge, in the sum of one thousand dollars, for the faithful performance of his duties.

Wednesday, August 15th, 1877.

Grand Lodge re-assembled pursuant to adjournment at 2 o'clock, P. M., W. W. Stumbles, jr., D. G. M., in the chair. Minutes of last Session read, and on motion approved.

Representative Frank Graham, of No. 10, from the Committee on Laws of Subordinates, presented the following Report:—

REPORT OF COMMITTEE ON LAWS OF SUBORDINATES.

To the R. W. Grand Lodge, I. O. O. F., Lower Provinces, B. N. A.:

Your Committee on Laws of Subordinates, respectfully beg to report that the only matter before them for this Session is, that of the advisability of establishing Degree Lodges in this jurisdiction. They have therefore to present the following, relative to Degree and Rebekah Lodges, as an amendment to the Constitution:

CONSTITUTION AND GENERAL REGULATIONS FOR THE FORMATION AND GOVERNMENT OF DEGREE LODGES.

1.—Whenever it may appear to the brethren of any Lodge or Lodges in any city or town under the jurisdiction of the Grand Lodge of the L. P. B. N. A., that it would be consistent with the interests of the Order to establish a Degree Lodge in such place, it shall be proper for them to authorize ten brothers of the Scarlet Degree to make a written application to this Grand Lodge to that effect.

Such application shall be signed by the full number of the brethren so authorized; and shall be accompanied by the Charter Fee, \$5; by a certificate from the D. D. G. M., that the petitioners are properly qualified, and by a certificate over the Seal of the Lodge or Lodges with which they are connected, that they are members in good standing, and that they have been duly authorized by their Lodge or Lodges to apply for such Charter.

3.—On receipt of a formal application for a Charter as above required, the Grand Master may issue a Warrant for the immediate establishment of a Degree Lodge.

4.—As soon as the necessary authority shall have been obtained from the Grand Moter, the D. D. G. M. shall summon all Scarlet Degree members in good standing in their Lodge or Lodges, and proceed with the institution of the Lodge and the election and installation of the officers, after the manner and form prescribed for the same.

5.—A Degree Lodge shall be composed of members in good standing in the Order of the Scarlet Degree, resident within the jurisdiction of the Degree Lodge, and all business (except that of conferring the 1st, 2nd, 3rd, and 4th Degrees of this Order), shall be transacted when open in the Scarlet Degree, and five members shall constitute a quorum.

6.—The Elective Officers of a Degree Lodge shall be a Degree Master, Deputy Degree Master, 1st Assistant Deputy Degree Master, 2nd Assistant Deputy Degree Master, Secretary and Treasurer, who shall be elected annu-

ally by a majority of the votes polled for that purpose.

7.—Nominations for Elective Officers shall be made upon the last two meetings in the term, and the election shall be held upon the last regular meeting in the term, and the installation of Officers shall take place on the first regular meeting of the succeeding term.

8.—The Appointed Officers shall be a Warden, Conductor, and Outside and Inside Guardians, to be appointed by the Degree Master on the night

of his installation.

9.—No brother shall be eligible for the office of Degree Master or Deputy Degree Master, who is not a P. G. in good standing in some Subordinate

Lodge of this Order in the L. P. B. N. A.

10.—Loss of good standing, suspension or expulsion from membership in a Subordinate Lodge, shall at once similarly affect the member's standing in the Degree Lodge, and re-instatement in the Subordinate shall work re-instatement in the Degree Lodge.

11.—The Degree Master shall preside, and shall have power to convene special meetings, and shall perform such other duties as are prescribed by the

official ligations and the usages of the Order.

12. —The Deputy Degree Master shall occupy the usual position of the V. G., assist the Degree Master in the discharge of his duties, and in his absence shall preside.

13.—The 1st A. D. D. Master, 2nd A. D. D. Master, Treasurer, Warden, Conductor, Inside Guardian and Outside Guardian, shall perform the duties

assigned to them at their installation, and by the usages of the Order.

14.—The Secretary shall keep accurate minutes of the transactions of the Degree Lodge, he shall conduct all correspondence and report promptly to their respective Lodges, the names of brothers upon whom Degrees are conferred, and also the date and name or names, or numbers of the Degrees conferred. He shall make out for the Grand Lodge, at the first regular meeting in each term, a report of the Officers for the current term, and the numbers of each Degree conferred, and also of the funds of the Degree Lodge, particularizing the sources whence such funds have been derived. He shall enter in a separate book or record, the name of every brother receiving Degrees, together with the name of his Lodge, and date of receiving the said Degrees, and perform such other duties as are prescribed by his charge of office, and the laws and usages of the Order.

15.—The application of a brother for any Degree, with the fee for the same, must be received by his Subordinate Lodge, in which Lodge he shall be balloted for by the members of the Degree for which he applies, when opened in that Degree. If he be not opposed by more than three black balls, he shall be deemed eligible, and a certificate to that effect shall be granted him, which certificate, on being presented to the Degree Lodge, shall be its

authority for conferring the Degree or Degrees applied for.

16.—A Degree Lodge may, with the consent of two-thirds of the members of the Subordinate Lodge or Lodges connected with it, present and voting at a regular meeting of such Subordinate Lodge or Lodges, charge its members

17.—A Subordinate Lodge may provide by its Bye-Laws for the payment to the Degree Lodge of a part or the whole of the regular charge for

Degrees.

18.—Any Degree Lodge shall have power to adopt necessary Bye-Laws, rules and regulations for its government, conformable to this Constitution, and to the Constitution and Laws of the Grand Lodge of the L. P. B. N. A.,

and the laws and usages of this Order.

19.—Degree Lodges shall be sudject to all the laws applying to Subordinate Lodges in the matter of sessions, terms, returns, trials and penalties, and forfeiture of Charter; except that they shall not be required to pay per capita tax to the Grand Lodge.

CONSTITUTION AND GENERAL REGULATIONS FOR THE FORMATION AND GOVERNMENT OF REBEKAH DEGREE LODGES.

1.—Rebekah Degree Lodges may be instituted on the application of ten or more persons in possession of that Degree, five of whom shall be members in good standing of some Subordinate Lodge or Lodges in this jurisdiction, and five wives of Scarlet Degree members in good standing in the Order. Such application shall be signed by the applicants, and shall be accompanied by the Charter Fee of \$5, by certificates of qualification from the Lodges to which the applicants or their busbands may belong, and by a recommendation from the Lodge or Lodges in the city or town from which the application comes.

2.—Rebekah Degree Lodges shall have the power to confer the Degree of Rebekah on such Scarlet Degree members and their wives as present certificates from Subordinate Lodges within this jurisdiction; and also upon widows of Odd Fellows presenting certificates from Lodges of which their husbands were members at the time of their decease. No fee shall be charged for conferring such Degree, but the Lodge may ordain tees of admission and dues, to be paid by all who may be admitted to membership.

3.—Rebekah Degree Lodges shall have power to adopt such Bye-Laws and Rules of Order as they may see fit; provided always, that no such Bye-Laws and Rules of Order shall become operative until after they have been approved by the Grand Lodge of the L. P. B. N. A., or in its recess, by its

Committee on Laws of Subordinates.

4.—Rebekah Degree Lodges shall be subject to all the laws applying to Subordinate Lodges in the matter of sessions, terms, returns, trials and penalties, and forfeiture of Charter, excepting that they shall not be required to pay a per capita tax to this Grand Lodge.

Chisholm, P. G., as there were simply the statements of the accuser and accused, without evidence to support either.

Your Committee recommend that the appeal of Bro. Geo. J. Graham be dismissed.

Representative W. W. Stumbles, jr., D. G. M., from the Committee on Correspondence presented the following, which was adopted:

REPORT OF COMMITTEE ON CORRESPONDENCE.

To the R. W. Grand Lodge, I. O. O. F., Lower Provinces, B. N. A.:

Your Committee would respectfully report, that they have read and passed in review the communications placed in their hands by the Grand

Master and the Grand Secretary.

We observe that a large portion of this correspondence requires no special mention from this committee, such, for instance, as orders for supplies, letters in which cash has been enclosed, and notifications of rejections and expulsions, all of which, requiring answers, have been attended to by the Grand Secretary.

The correspondence in general has been conducted with promptness and discretion by the Grand Master and the Grand Secretary. Your Committee found but very little left for them to do except to commend what has been

so well and faithfully done.

We observed among the correspondence the resignation of the Grand Secretary to the Grand Master. The ground of this resignation is stated in the letter to be the refusal of the Canada Guarantee Company to give bonds to this Lodge for the forthcoming of all moneys and papers received by the Grand Secretary. You are aware that, by a resolution passed at the last session of this Body, the Grand Secretary and Grand Treasurer are required to give bonds in the Canada Guarantee Co. The refusal of the Company to give the bonds was not from any defect in the application papers of Bros. Frazee and Taylor, nor from a want of confidence in them, but because this Lodge is not a corporate body. The refusal of the Grand Master to accept the resignation of the Grand Secretary, and his willingness to accept private bonds from Bros. Frazee and Taylor, should meet with the cordial support and commendation of this Grand Body.

A circular received from the Grand Sire of the Grand Lodge of the U. S., respecting the use of illegal ode cards in Subordinate Lodges was promptly attended to by the Grand Master and Grand Secretary; quite a number of the illegal cards were sent to the Grand Secretary, and were replaced by

legal ones.

Telegrams and letters were received from the Grand Lodges of Michigan, U. S., and Ontario, requiring information respecting wants of the members of the Order who suffered so severely in the late disastrous fire in St. John. These letters and telegrams were forwarded to D. D. G. M. Murdoch, who was in a better position to give the information required than the Grand Secretary. It must be pleasing for this Grand Lodge to learn from examination of the correspondence that the sympathy for our brethren in distress was wide-spread and general throughout the Order. Neither nationality nor distance seemed to be barriers to obstruct the expression of sympathy for those who were sufferers by the great calamity. Nor did this feeling appear to be mere sentiment, for in many instances inquiries for information were accompanied by promises of aid.

Your Committee cannot refrain from speaking in the highest terms of praise of the promptness and dispatch shown by Grand Secretary Frazee in the discharge of his onerous duties as corresponding Secretary of this Lodge. the Comhich was

REPORT OF THE D. D. G. MASTER FOR THE DISTRICT OF ST. JOHN.

DEAR SIR AND BROTHER,—With the close of another year it becomes my duty to report again the progress and present state of the *Order* in this District.

INCREASE.

During the year, which ended with the 30th day of June last, the *Initiations* in this District numbered one hundred and sixty-one (161) sixty-seven (67) of which belonged to the first term and ninety-four (94) to the second.

The increase in membership has been one hundred and thirty-nine (139), and the present strength of the Order here is five hundred and twenty-seven (527). The December per capita amounted to \$132.30, and the June ditto to \$158.10: or a total for the year of \$290.40. These amounts, together with \$7.50 collected for Dispensations, issued during the year, have been forwarded to the Grand Secretary.

APPEALS.

Two appeals have been received during the year,—the first from Bro. Thos. W. Peters, P. G., against the ruling of the Noble Grand of Peacon Lodge, No. 12; and the second from Bro. Joseph Wilson, P. G., against the

ruling of Noble Grand F. L. Hea, of Pioneer Lodge, No. 9.

The ground of Bro. Peters' appeal was, briefly, as follows: At a meeting of Beacon Lodge, held on the 20th day of March, 1878, the I. G. was about to refire to the ante-room to relieve the O. G. without giving the countersign; wherenpon the question was raised by Bro. Peters, could be do so legally. The N. G. decided in the affirmative. Bro. P. appealed to the Lodge, and subsequently to the D. D. G. M., his contention being that the I. G. cannot retire from the Lodgeroom while the Lodge is in session, without addressing the chairs. My decision was as follows, viz.:-

"The law on this point is laid down to clearly on page 34 of the I. C. B. that I have no hesitation in reversing the ruling of the N. G. in this case, and sustaining the appeal of Bio. Past Grand Peters. "No officer or member can enter a Lodge-room, nor reline to the ante-room while the Lodge is open and working as such, without the proper sign (addressing the chairs) except the outside conductor and warden with a candidate; the former when he introduces a candidate (to be initiated), and the latter when retiring with

the candidate after leaving the N. G.

Brother Wilson's appeal was based on the following grounds, viz.;

At a regular meeting of Pioneer Lodge, No. 9, held on the 20th day of April, 1877, a communication was received from Bro. J. S. Hall, setting forth,-

(1) That in February, 1876, he (Bro. J. S. Hall) had applied (through another Brother) for a "visiting card," but through some mistake a "withdrawal card" had been forwarded to him.

(2) That he was much disappointed on receiving said withdrawal card, as he had no wish to leave the Lodge, then nor now; and requested in conse-

quence to be "restored to full membership."

This communication having been read, Bro. F. A. Blakslee moved, " that the application be received and the request complied with," and Brother Joseph Wilson moved in amendment "that the vote granting the withdrawal card be reconsidered."

The N. G. ruled the amendment out of order. Bro. Wilson appealed to the Lodge. The chair was sustained; and a further appeal was then made to the D. D. G. M. on the point of order raised.

Such is a brief outline of the case as put before me under seal of the

Lodge.—My decision was as follows:

"(a) Assuming that the facts of the case, so far as they relate to Bro. Hall, are set forth correctly—and the Lodge by its action, appears to acknowlege their correctness—it follows that no authoritative application having been made by Bro. Hall for a withdrawal card, the action of the Lodge was ultraviris, and did not legally cut him off from membership. His membership continued after the vate, the same as before, and if in good standing other-

wise, his rights remain unimpaired.

- "(b) Had the withdrawal card been granted legally, both the motion and amendment would have been out of order," As the vote by which a withdrawal card is authorized cannot be reconsidered nor rescinded "(Digest, Section 245), but as this was not the case—as the Lodge appears to acknowledge that its action in granting the card was wrong—the proper way to proceed is by reconsideration of the vote which granted the unapplied for withdrawal card. By this means the mistake may be rectified, and the erroneous vote removed from the minutes.
- "(c) As no question decided by the Lodge can be brought before it again otherwise than by reconsideration (Bye-laws, Sec. 187), the original motion of Bro. Blakslee was out of order, and should not have been entertained. And as no question can be reconsidered "unless notice thereof shall have been given at the meeting immediately preceding (Bye-laws, Sec. 187), Bro. Joseph Wilson's amendment was also out of order, as the necessary precedent notice had not been given."

These rulings, I hope, will meet your approval. They were accepted by the Lodges and Brothers interested; and certified copies of the papers relating to each are hereunto annexed.

SILOAM LODGE, No. 29.

In obedience to the authority vested in me by dispensation dated Sept. 7th, 1876, I called to my assistance a sufficient number of known, approved and duly qualified Past Grands, and proceeded to open and constitute the new Lodge, now known and hailed as Siloam, No. 29.

DEDICATION.

Since I last had the honour of reporting the progress of the Order in this District, Prince Albert Lodge, No. 26, have obtained for themselves a new and handsome Lodge-room, and had it fitted up and furnished in a very superior manner. The situation is good, and the hall and ante-rooms are well-arranged, commodious and comfortable, and equal to anything of the kind to be met with in this jurisdiction.

The hall was publicly dedicated on the 24th day of May, last, to "Friendship, Love and Truth, Faith, Hope and Charity," according to the ancient usages of the Order. The ceremonies were conducted by myselt (in your absence) assisted by Past Grand Representative Barnes (Marshall), Rev. Bro. Carey, (Chaplain), and Past Grand William M. McLean, jr., H. C. Vradenburgh, John Rubins, and Andre Cushing as Heralds. There was a large attendance of the elite of Moncton and neighbourhood; and at the close of the ceremonies an eloquent oration was delivered by Deputy Grand Master Stumbles, of Charlottetown.

A large representation of the St. John Lodges with music, &c., went up by special train to witness the proceedings, and deputations were present from Annapolis Royal, Charlottetown, Springhill, Hahrax, Montreal and Brookville. In the evening a literary and musical entertainment was given in the Skating Rink, at which addresses were delivered by the Rev. Bro. Carey (St. John), the Rev. Bro. Pentreath (Moncton), the Hon. Bro. Willis (St. John), and Grand Secretary J. C. P. Frazee of Halifax. The arrangements were generally satisfactory and successful, and the day's proceedings terminated with a fine display of fire-works.

LOSS BY FIRE.

By the calamitous fire which occurred here on the 20th June last, the city Lodges—Pioneer, Beacon, Siloam, and Milicite Encampment—lost hall, furniture, regalia, paraphernalia, books and papers, and have been meeting since (by dispensation) in Peerless Lodge-room, Portland—the Brothers of this Lodge having kindly placed their room and regalia at the service of the sufferers.

The fire which worked so much mischief to our Lodges was great, not only in its extent and consequences, but in the terrible rapidity also, with which it swept across our city, regardless of brick, or stone, or streets, or squares, which under ordinary circumstances would have proved effectual barriers to its progress.

The alarm was given at 2.30 p. M., from a wooden shed or store in York Point, and in an hour from the time it was given, the Robertson brick block and the Barracks—a mile distant—were on fire. In less that five hours the whole of Smyth, Nelson, Dock, Ward, Water, Prince William and Germain streets, to Reed's Point were in ruins. These you may recollect were our principal business streets, and many of the buildings were supposed to be fire-proof. From this it spread eastward, and by midnight (9½ hours after the alarm was given) 200 arres of the city was one mass of seething fire.

This area represents 10 miles of streetage or two-fifths fully of the city proper; and embraced the warehouses of all our heavy importers—all our banking houses except one,— our city buildings, Custom House and General Post Office; all our newspaper offices; our newest and best equipped educational establishments; 3 Preshyterian, 2 Episcopal, 3 Baptist and 3 Methodist churches; the Barracks and Gus Works, the Academy of Music, the Gymnasium, the Dramatic Lyceum and Small's Opera House; Barnes' hotel, the Rogal, the International and the Victoria hotels; about 1609 buildings, 4000 families, and from \$15,000,000 to \$20,000,000 worth of property, real and personal, was destroyed.

In a conflagration such as this, it is not wonderful that the members of our Order suffered severely in their individual as well as their corporate capacity. At the close of the term which ended with the 39th day of June the total membership of the three city Lodges was 360, and of this number 142 had suffered to a greater or less extent by the fire. The loss of some was comparatively trifling, but many lost all they owned, everything belonging to themselves, their wives and children, barely escaping with their lives and the clothing they stood in.

On the Friday following the fire, (June 22nd), a mass meeting was held in Peerless Lodge-room, Portland, to consider the situation; after due deliberation the meeting resolved to maintain its own sufferers, and keep them, if possible, from being recipients of public charity. With this laudable object in view a Relief Committee was formed, composed of members from each Lodge, with myself as chairman; R. Radford Barnes, Treasurer; and John E. Hughes, Secretary. We have been working lard since, and have succeeded so far in tiding through our trouble, but we look forward to the future—to the coming Fall and Winter—with considerable apprehension.

No general appeal has been made yet for assistance—nor is it likely that any will be required—as the spontaneous expressions of sympathy which have reached us from far and near—from Maine, Massachusetts, Rhode Island and New York; from Illinois, Tennessee and California, from Ontario, Quebec and the Maritine Provinces, backed invariably by substantial aid—have given new heart to the sufferers, and enabled the committee to maintain the position taken by the Lodges, when they resolved, with a firm faith in the benevolence of the Brotherhood, to "relieve the distressed," and keep them from becoming objects of public charity; which to an independent and sensitive spirit is worse than death.

tely lich ode rio, aid inlith eep With a view to maintain the independence of the Brotherhood, and save the feelings of the sufferers, it was resolved at the outset, that the names of the recipients should not be divulged to anyone outside of the Committee, and the brothers who may be appointed hereafter to audit the accounts when the work is finished. This resolution has been faithfully maintained and the manner of giving as well as receiving has been made as easy as ite, due regard being had to the claims and circumstances of each.

From the returns furnished by the Lodges the results of the fire in relaction to its effects on individual members appear to have been as follows:—

Many of the sufferers had no insurance, the supposed superiority of our fire department and the general efficiency of our water supply having led to a false security—to a popular belief that it was impossible for St. John to be scourged by fire, as Boston and Chicago had been.

INSTALLATIONS.

In consequence of the confusion caused by the loss of the books and papers of the Lodges, considerable difficulty has been experienced in getting the regular term returns. The last was received on the 31st ult., and has been forwarded together with Grand Lodge dues and dispensation fees, to the G. See'y. A close scrutiny and comparison with former returns may show them to be inaccurate in some particulars, but not, it is believed, to any serious extent. The returns received from Beacon have no seal attached to them; its seal having been lost in the fire.

The elective officers of Peerless Lodge were installed in "regular form," on the 4th day of July, but the appointed ones are not yet installed, as the N. G. has had some trouble in getting the Brothers to accept the offices. The officers of Pioneer—elective and appointed—were installed in "regular form" on the 13th day of July; the officers of Prince Albert on the 18th, and of Siloam on the 23rd ult; but the newly-elected officers of Beacon are not yet installed. The delay is a necessary result of the fire, and will be overcome doubtless in a short time.

REPORT OF THE COMMITTEE ON LEGISLATION.

To the R. W. Grand Lodge, I. O. O. F., of the Lower Provinces of B. N. A.:

Your Committee are of opinion that the incorporation of this Grand Lodge would be of essential benefit to our Order, and recommend that a Committee be appointed at this session to inquire as to the probable expense of a Dominion Act of Incorporation, and be prepared to report at next annual session; also, that the Grand Secretary communicate with Subordinate Lodges as to the probability of their becoming incorporated under such Act, if obtained.

Your Committee would further report that however anxious they may be to obviate trouble in our Subordinate Lodges, in regard to members over six months in arrears, yet they deem it inexpedient at the present time to recommend any change in Section 1 of Article VIII. of the Constitution, as proposed by our Brother Representative DesBrisay.

G. and Secretary, shall be sent to the R. W. Grand Secretary, and such certificate shall be deemed sufficient evidence that such representative is entitled to payment for such expenses.

Whereas, it is well known that there are representatives, as well as members of Subordinate Lodges, in the habit of occasional indulgence in the use of intoxicating beverages, to their own injury, that of their families, and the good name of this Order;

And Whereas, it is expedient that the Grand Lodge should recommend

some action in the premises;

Be it therefore resolved, That this Grand Lodge earnestly recommends Representatives, and members of Subordinate Lodges to the practice of the ennobling virtue of temperance in things useful and beneficial, and abstinence from everything known to be injurious and prejudicial to health; and that a close supervision be had over such of our brethren as transgress in this way, in order that prompt discipline may result to any offending brother in this Grand Lodge, or in the Subordinate Lodges.

Representative G. Murdoch, of No. 9, moved, seconded by Representative John Pringle, G. Con., that the resolution be amended by striking out the preamble. Motion passed.

The resolution, as amended, was then put and carried.

Representative H. A. Taylor, G. Treas., moved that the usual number (500) of the Reports of this meeting be printed. Motion passed.

APPENDIX.

GRAND REPRESENTATIVES' REPORT FOR 1877.

To the R. W. Grand Lodge, I. O. O. F., of the Lower Provinces, B. N. A.:

We, your Representatives to the R. W. Grand Lodge of the United States, of the I. O. O. F, which assembled in the city of Baltimore, Sept. 17th, submit the following Report for publication with the proceedings of the Grand Lodge of the Lower Provinces.

The Grand Lodge had not met in Baltimore for three years previous to the present one. The occasion is one of great interest wherever the Lodge holds its desiberations, and so far as Baltimore was concerned, her well known hospitality was extended to the utmost to her guests from abroad. The grand and fundamental principles of Odd Fellowship, it is well known, had their origin in Baltimore, through Thomas Wildey.

The Grand Lodge members were escorted from their headquarters to Odd Fellows' Hall by the uniformed Patriarchs, who presented a brilliant appearance, the whole procession being enlivened by bands of music. At 9 o'clock, A. M., the Grand Sire took his seat, and proceeded to open the Lodge. The roll of officers was called, together with the names of the Representatives who had been present at the previous session. There was found to be quite a large representation present, all the jurisdictions being represented, with the exception of British Columbia, Manitoba, South Carolina, Wyoming and Switzerland.

The Report of the Grand Sire showed that although the Order has lost in numerical strength in some places, yet in the aggregate there has been an increase in membership, both in Encampments and Subordinate Lodges. The Report is too lengthy for insertion here, but the following extracts will doubtless be interesting and instructive, showing the increase and condition of the Order at the present time.

DECISIONS.

Question. Is it right for the Grand Representatives to give the A. T. P. W. to the Grand Lodge or Encampment, the same as he would the perma-

nent P. W. during the exemplification of the unwritten work?

No. 1. Answer. No; the A. T. P. W. should be communicated by the Grand Representative to the M. W. Grand Master, or Grand Patriarch of the jurisdiction, who will communicate it to the Grand Secretary or Grand Serbe, and cause it to be communicated to the D. D. Grand Masters, and such other installing officers as he may find it necessary to appoint to assist him in the discharge of his official duties.

Question. Is it compulsory on the N. G. of a Degree of Rebekah Lodge to communicate the A. P. W. to one of its members who is divorced from her husband, whether he is still in good standing or has been expelled from the

Order?

No. 2. Answer. If a member (Daughter of Rebekah), upon her own libel (or complaint) against the husband, has obtained a divorce, she would be entitled under section 509 "D," White's Digest, to the A. P. W., and the N. G. of Degree of Rebekah Lodge would be the proper officer to communicate the same. But if the decree of divorce was made upon the husband's libel or complaint against the wife, the A. P. W., should be withheld until the Lodge should be satisfied that she had not been guilty of any immoral conduct. The husband's standing in his Lodge does not affect her standing in the Rebekah Degree Lodge either one way or the other. See section 509 "D," White's Digest.

Question. Are Lodges in this (New Jersey) jurisdiction required to submit their By-Laws or amendments thereto, to our R. W. Grand Lodge,

and have them approved, before they can have force and effect?

No. 3. Answer. The above question is entirely within the control of State Grand Lodges, and with which the Grand Lodge of the United States should not interfere, unless upon appeal in the usual manner. Vol. 8, page 6618, Journal G. L. U. S.

Question. Can an Indian with a withdrawal card be a petitioner for, and

become a charter member of a new Lodge?

No. 4. Answer. No, he cannot be either; the action of the Grand Lodge of the United States, session 1876, page 6977, decided "That no Lodge can lawfully permit an Indian to visit it under any circumstances whatever," which renders him also incompetent as a petitioner for a new Lodge.

No. 5. A brother of an extinct Subordinate Lodge, holding a certificate or card, such as are described and provided for in sections 225 and 226, White's Digest, is entitled to visit upon such certificate or card for one year from the date of its issue; and the N. G's of Subordinate Lodges, when officially requested by the Grand Secretary of the jurisdiction issuing such certificate or card, upon being satisfied of the identity of the individual, should communicate the A. T. P. W. to the brother holding such certificate or card. See 1518 and 1519, White's Digest.

No, 6. The status of a brother holding a dismissal certificate, is specifically defined under the third resolution as reported under Sec. 316, White's Digest, and if he wants to renew his membership, he must pursue the same course as that prescribed for Ancient Odd Fellows in Sec. 64, or as an applicant or petitioner for a charter for a new Lodge, as provided for in Sec. 316,

B," White's Digest.

The Judiciary Committee recommended that the 2nd, 3rd, 4th, 5th and 6th decisions submitted by the M. W. Grand Sire be approved.

INFRINGEMENT OF COPYRIGHT.

It having been brought to the notice of my predecessor that the Order in some of the jurisdictions were using odes supplied by private parties other than those published and furnished by the G. L. of the U. S., and regarding it as an infringement of the copyright, and tending ultimately, if persisted in, to interfere seriously with the revenue, he issued special notices to the Grand Authorities complained of, for their suppression. Finding, upon my induction into office, that there were parties still engaged in the printing, distribution and sale of these illegal odes, I deemed it to be my duty, as well as absolutely necessary for the protection of the revenue of the Grand Lodge, which was beginning to feel the effects of the interference, to issue a circular letter directed to the M. W. Grand Masters and Grand Patriarchs of the different jurisdictions requiring them to forbid the use of all odes other than those issued by the authority of the G. L. of the U. S., a copy of which is herewith submitted.

Responses to this circular have been received from many of the Grand Authorities, giving assurances of a willingness and determination to sustain the effort to stop the unlawful interference with the sale of supplies and the revenue of the Grand Lodge, and at the same time disclosing the existence of a variety of odes or poems differing altogether from the prescribed formula in the work of the Order, and which have been substituted for the regular odes, thus changing the work in violation of Article twenty, By-Laws of the G. L. of the U. S., a notice of which confronts every officer of a Subordinate

Lodge that opens a charge book.

I would respectfully submit, in connection with this subject, that there is an evident desire in many localities to have the various odes of the Order set to appropriate music, something altogether different and better than has been hitherto supplied, and would suggest that this is the proper time to meet this manifest want of the Order in that direction, or to surrender it altogether to private enterprise or to the local jurisdictions.

All of the information upon this subject that has come to my notice, has been given to the Committee on Printing Supplies, who will, I am advised, submit for your consideration a remedy for the evil complained of, and for

which I ask your favorable consideration.

There is also somewhat connected with this subject, though not probably in violation of any copyright, an individual enterprise that is flooding the Order, and ornamenting Lodge-rooms with maps, charts, diplomas and certificates of membership containing a great variety of figures, emblems and mottoes, a large number of which are not to be found in the classified and recognized symbols of our Order, and I most respectfully submit for the consideration of this Grand Lodge whether this privilege or license should not be subject to some regulation or supervision of this Body, which shall at least limit the display of what purports to be emblems of the Order in our Lodge-rooms, to those only that have their proper and recognized signification, and in the event of our ultimate success in that direction, to make these charts what they purport to be—standard works that can be utilized by Encampments, Lodges and Degree Lodges in the exemplification of the ritual.

CANADA.

The Order in the British Provinces of Ontario, Quebec and the Lower Provinces, being an integral part of this R. W. Body, with their Representatives annually with us, holding the same relation as our home jurisdiction, have become so nearly allied to us in interest and feeling, as it is contiguous in territory, that it is no longer referred to amongst us as a foreign country into which the Order has been introduced, but I may be permitted to add

from a personal knowledge afforded by a visit to that jurisdiction, whilst D. G. Sire, that there is no location or Grand jurisdiction anywhere that can boast of being in better hands. Their Representatives have been pressing with commendable patience, but with persistent modesty and zeal upon the consideration of this Grand Lodge for several years, the propriety of adopting a name that would be more cosmopolitan and comprehensive than the present one for a body now exercising authority in other and many different nationalities, and ultimately it may be in every quarter of the globe, and whilst I willing to confess an attachment to the name under which we have won our way to public favor and distinction, and doubtless eminently proper when adopted, I most respectfully submit that the continued success and extension of the Order into other countries seem to create an absolute necessity for the change.

FIRE IN ST. JOHN, NEW BRUNSWICK.

Our brethren in the Lower Provinces, in common with their fellowcitizens, have been visited with a fearful and disastrous conflagration, in which many of them have suffered great loss, besides the destruction of the books, regalia and other property of three Lodges and one Encampment.

Under an anxiety to be properly informed as to the extent of the disaster and privations of the unfortunate sufferers before any general appeal to the Order for relief was recommended, the R. W. Grand Corresponding and Recording Secretary addressed a letter to the R. W. D. D. Grand Sire Andre Cushing, asking information upon the subject. His reply will be presented in the correspondence of that office, giving an account of the losses and misfortunes of our brethren there, but who decline to make any general appeal for relief.

I am happy, however, to know that their brethren in Ontario and other localities voluntarily forwarded liberal contributions for their relief.

EXTRACTS FROM R. W. GRAND SECRETARY'S REPORT.

The Report of the R. W. Grand Secretary is too comprehensive to be inserted here, but the following extracts and concluding sentence of a very able Report will serve to show the opinions of the most experienced and respected officer of the Grand Lodge of the U. S., respecting the present and future prospects of Odd Fellowship.

CONCLUSION OF HISTORIOGRAPHER'S REPORT.

I am sensible of the rapid approach of infirmities, and that the time I could best have spent in this direction has passed. I, therefore, with sincere sorrow, and with keen regret that I could do no more in so grand a cause, hereby resign my place as Historiographer, with my best wishes for the future and final completion of a work so important to Odd Fellowship. I have caused the entire completed manuscript, as detailed in my report of last year, together with a mass of valuable papers accumulated by me during many years, to be deposited in the fire-proof as the property of the Grand Lodge, among which is the original manuscript of the Past Grand's Charge, as first presented, in 1845, to my colleagues on the Revision Committee, Bros. E. H. Chapin and John A. Kennedy. There is no debt owing by the Grand Lodge on account of the History. There is no debt owing has amounted to \$1500; \$1000 to the widow of the lamented Kennedy for his manuscript, and \$500 to the present Historiographer.

MISCELLANEOUS.

The proposed amendment of Bro. Perry, of Ontario, to change the name of the Grand Lodge of the U. S, to the Supreme Grand Lodge of the Independent Order of Odd Fellows was lost, 73 voting for the change and 61 against, a two-third vote being necessary for any change in the Constitution.

The proposed amendment to meet biennially was also lost. No change was made in the mileage and per diem.

The R. W. Grand Corresponding and Recording Secretary addressed

the Lodge as follows, previous to adjournment:

Most Worthy Grand Sire: I rise at this late hour, by your permission to address this Grand Lodge, for which I have to ask its indulgence, prefacing what I have to say with the promise that I shall be brief. It is apparent to you all, my brethren, that old age has overtaken your Grand Secretary, and that, in the evening of his life, his health, which has always been frail, has been gradually declining. Although heretofore I have been, and still am, equal to the requisitions and responsibilities of the office, and my mental vigor has been mercifully preserved, as abundantly appears, yet my physical infirmity is not less manifest. My mind has been struggling, while sitting at this desk during the session, between official duty and pressing private interests. "Duty" has at length prevailed in the issue; in obedience to which I now notify the Grand Lodge that if, by the law of nature, as is reasonably probable, I shall after the end of my present term, be physically disqualified, or unable to serve you longer, it will be your duty to supply the succession adequately. You all know that this is by far the most important office within your gift. I have been honored by this Grand Body, as its incumbent, as no other man in this Order, or perhaps elsewhere, has been honored before, having been continued, by re-election, in office for thirty-seven years, for which I now bow before you with profound gratitude, and with memories of love and emotions of heart which are difficult to describe or to restrain.

The following resolutions were adopted from the Report of the Legislative Committee:

Resolved, That a member of a Subordinate Lodge or Encampment, who is in arrears for weekly or funeral dues more than thirteen weeks, is not entitled to the term password, or to vote in the Lodge or Encampment, but is a contributing member until suspended, dropped or expelled, in accordance with the requirements of the Constitution, and as such is entitled to visit his own Lodge or Encampment. He cannot, however, become entitled to benefits until he shall have paid up in full all dues and fines (weekly and funeral) that have accrued against him up to the day of payment, if the By-Laws of the Lodge or Encampment shall so provide; nor then until the expiration of such time thereafter as may also by the laws be provided as a penalty.

Resolved, That when any member of a Lodge or Encampment shall neglect or refuse to pay the dues fixed by the laws, for the space of one year. the Secretary or Scribe shall report the same to the Noble Grand or Chief Patriarch, and, unless the Lodge or Encampment otherwise direct, such member shall thereupon be suspended, he having been first notified of the action that would be taken, a record of which shall be made upon the minutes. The mere fact of a member being over twelve months in arrears does not constitute him a suspended or dropped member. To render him such the Lodge or Encampment must formally declare him to be suspended.

Resolved, That a Lodge or Encampment cannot refuse to receive, in full or in part, the dues of a member prior to his suspension, and no member can be suspended or dropped from membership in the Order for non-payment of dues, unless, at the time of his suspension, he shall be indebted to the Lodge or Encampment for one year's dues.

Resolved, That all previous legislation inconsistent with the foregoing resolutions, be, and is hereby, repealed.

PROPOSED AMENDMENTS.

Resolved, That Section 5, Article I., Constitution of this Grand Lodge, be amended by inserting in the last line between the words "members" and "of" the word "present," so that the section shall read:

To this Grand Lodge belongs the power to regulate and control the unwritten work of the Order, and to fix and determine the customs and usages in regard to all things which appertain thereto. And to it alone belongs the power to provide and establish suitable lectures and other written work therefor. But the unwritten work of the Order shall in no wise be altered or amended, except by a unanimous vote of this Grand Lodge; nor shall the written work of the Order be in any wise altered or amended, except with the concurrence of four-fifths of the members present of this Grand Lodge.

Resolved, That all appointed officers of any Subordinate Lodge shall be in possession of the Scarlet Degree, except the Chaplain and Scene Supporters.

Much more might be embodied in this Report that would be interesting to members of this jurisdiction, such as the correspondence with the Manchester Unity, appeal cases, several of which were before the Appeal Committee, but too much space would be occupied in the recital of them.

The Grand Lodge agreed to hold its next session at Austin, Texas, U.S.

Officers and Representatives of the Grand Lodge of the Lower Provinces, we thank you for the confidence which you have placed in us, and will feel it our duty to give any additional information within our power to members of the Order.
