WILL NOT VISIT QUEBEC

BECAUSE OF THE DEATH OF PRINCE HENRY OF BATTENBURG.

The Governor-General and Countess of Aberdeen Cancel Their Trip to the Northwest.

Ottawa, Jan. 25.—In consequence of the death of Prince Henry of Battenburg, the Governor-General and Countess of Aberdeen have given up their visit to Quebec.

A telegram was received here yesterday stating that Bishop Labreque of Chateaufort had sent out notices to all his curates, asking them to instruct their people to vote for no man who was not pledged to vote for the Remedial Bill in Parliament.

Charlevoix, where a bye-election takes place to-morrow is Bishop Labreque's diocese. Mr. Clon is the Conservative candidate, and Mr. Anderson the rouge standard-bearer.

SALISBURY A STATESMAN

VARIOUS VIEWS OF IT.

AND ONE OF THE FIRST BANK, SAYS MR. CHAMBERLAIN.

The Colonial Secretary speaks to the People of Birmingham—The Hon. Mr. Chamberlain's Suggestion for Concentrated Action in regard to the United States.

London, Jan. 25.—The Right Hon. Joseph Chamberlain, Secretary of State for the Colonies, delivered a speech at Birmingham yesterday.

He congratulated the country upon having at the head of affairs Lord Salisbury, whose judgment and resolution had placed him in the very first rank among the European statesmen.

Referring to the Gullana boundary dispute, Mr. Chamberlain said that he believed it would be finally settled by the intervention of the United States.

THE SUBJECT OF REV. HAY-ALIKENS' DISCOURSE LAST EVENING.

Rev. W. Hay-Alitken preached two earnest sermons to the congregation of St. James' Cathedral yesterday. That at night on "What Shall I do with Jesus?" contained some remarkable expressions. The wise man in which we live, said the preacher has devised several expedients to answer this question. Expedient No. 1 is, Can we not delegate Jesus Christ to the museum and His religion to the depository of antiquities, for both have had their day. Let us, therefore, place Jesus Christ in the Parthenon, side by side with Socrates, Plato and Aristotle, and let the answer given by Him and his followers.

With great fervor Mr. Alitken combated the theory that Christianity never had achieved more victories than during recent times.

His subject was "The Back Door to Heaven." He contended that the only way to heaven is through the narrow door of Christ. He said that the "back door" theory is a dangerous delusion. He urged that people should not be misled by the promises of a "back door" to heaven, but should seek the true path through Christ.
