Through the mercy of Divine Providence we are again permitted to assemble in peace in our Semi-Annual Session of the Grand Division of Canada East; since our Annual Meeting in January last, our Frontiers have been invaded by bands of lawless murderers and robbers, calling themselves Fenians, still were it not for the valuable lives that have been sacrificed, I think we, as Canadians, have not lost much by the invasion, for we have shewn to the world that we are united, and are determined to repel from our borders the foes of our beloved Sovereign and of our country; our young men have nobly responded to the call to defend our homes, and I am sure that none have been more ready, or have rendered better service than the SONE OF TEMPERANCE.

I am sorry to say that I cannot report as fully as I would wish of the state of our Order in my jurisdiction, from the fact that I have to make the off repeated complaint, of want of punctuality of my deputies in sending me their quarterly Reports. W. P. Instand of sending them, as most of them do, to the Grand Scribe, which causes an additional expense in postage, besides generally long delay, as most of the Reports due in April, have only come into my hands within a few days of our present meeting.

The Reports with a few exceptions, are rather encouraging. In answer to the question, "have you anything to propose for the good of the Order in your District," some of the Deputies say "send us a Lecturer," which

request I am happy to say has been complied with.

I am sorry to see that there has been some little trouble in St. Lawrence Division on points of order, and a charge has been brought against the D. G. W. P. of that district for malfaisance in office; I am afraid we are too apt to forget in the division room, that part of our beautiful opening service which reads "letus avoid all wrangling and vain dispute," &c., however the papers in this case will be laid before you for your consideration and action.

In accordance with a resolution passed at our last Annual Session, the committee appointed for that purpose, have engaged the services of Brother Thomas Hutchings, P.W.P. of Howard Division, (a gentleman who has gives many proofs of his zeal in the Temperance cause,) as travelling Lecturer, and Agent of the Grand Division of Canada East, who I think has already rendered good service to our Order. For the particulars of his mission I would refer you to his Report which will be submitted for your consideration.

Since our last meeting four Charters have been issued to organize new Divisions, and there is a prospect of some more being organized soon.

On the 4th of June last, I had the pleasure of accompanying Brother Hutchings to Sutton, where we re-organized the Washingtonian Division in that place, and from late reports, I am happy to say it is now working with good prospects of again becoming a prosperous Division; on the 2nd of July, inst., I went to Knowlton, in the township of Brome, accompanied by P. G. W. P. Henry Rose, for the purpose of re-organizing the Knowlton Division which ceased working about two years ago, but from the illness of some and absence of others of the parties who had signed the requisition, I was unable at that time to re-organize them, but I have the promise, and have no doubt that I will be called on immediately on my return home to re-organize them, and from the zeal of some of the parties who are interesting themselves in the matter I have no doubt but that there will soon be a large living Division in that place.

I received an application signed by about twenty persons, asking to have a Division opened at West Brome, whereupon a charter was issued, but when I went at the time appointed to corganize them (which happened to be during the Fenian excitement,) a good many of the signers were absent, and it was thought best to defer organizing them until some fature time. There was likewise an application made by some of the inhabitants of West Farsham, to have a Division opened there, but upon going at the time appointed, where I met with Brother Hutchings and Brother Higgins, from Montreal, we could not prevail on a sufficient number to organize, although a Division is destainly very much needed in the place, from the fact that there are twelve or thirteen

piaces in the village licensed for the sale of intoxicating liquors. I have had the pleasure of receiving a report from the D. G. W. P. of St. Andrew's Division. who informs me that the Division in that place has lately been re-organized and is now working, and although he informs me that their numbers are but small (there being only about twenty members,) and their prospects of increase not very good, and that intemperance abounds to a considerable extent, I hope they will not get faint hearted, but stick to the good ship and hope they may yet succeed in rallying many round their banner and doing much good in the

neighbourhood.

I had the pleasure of attending the National Division which met in Montreal, on the 21st of June, on which occasion were assembled representstives from nearly all parts of the United States, and from all our sister Provinces, they where largely composed of men whose talent and position in society, would entitle them to seate, and who would do honour to any Legislative assembly, I certainly feel that our cause is safe and must move steadily forward while it is presided over by such men as were assembled on that occasion, but it is a source of regret to me to think that there are so many in our midst, who from their influence and position, might be the means of doing so much good to our Order if they would only take hold with us, but who stand aloof and seem to think it beneath their notice, especially the clergy, if they were to do what they could for the cause, we would soon be in a very different position in Canada, but I am sorry to say there are too many who are like a reverend gentleman who was present at a meeting where we were endeavouring to open a new Division a few days ago, who said drunkenness was a great evil, and that he had a number of drunkards in his own congregation, and he would bid us God speed in our efforts, but from reasons of his own (which he did not explain) he would not join an organization to try and mitigate the evil.

The most important business transacted at the National Division, was the admission of Ladies to full membership, or rather submitting the matter to the Grand Divisions, and the Negro question. This elicited much discussion, and the Constitution (which says nothing with regard to color) was left unchanged, but Grand Divisions are allowed to regulate the matter as they choose in their own jurisdictions, and are allowed to have separate colored Divisions if

they desire.

I would call your attention to the question of admitting Ladies to full membership, which I am confident will be advantageous to our Order, especially so in the Eastern Townships.

Our Worthy Grand Scribe will inform you of our financial standing. which I hope may be still more favourable than at our last meeting.

Before closing, I would say that I am sure this Grand Division will join me in tendering our sincere thanks to the members of Howard Division, No. 1, for the very handsome manner in which they entertained the Members of

the National Division, during the late session held in Montreal.

Hoping that should we be spared to meet again at our Annual Session in January next, we may be able to report large accessions to our ranks, and that our cause will continue to progress until the use of into sicating liquors as a beverage may be unknown in our land.

The following is a synopsis of the Returns from 21 Divisions for the quarter ending 31st March, 1866. I regret that this synopsis is so incomplete, several working Divisions having as yet failed to send in their returns for the tongard.

Since the annual meeting of this Body, one new Division has been organised at East Hatley, and applications have been made to open Divisions at West Brome and West Farnham. Five old Divisions have been revived.

Perseverance, No. 4, Huntingdon; St. Andrew's No. 9, St. Andrews; Lake Beauport, No. 36, Lake Beauport; Richmond, No. 38, Melbourne: Washingtonian, No. 67, Sutton.

There is every prospect of several old Divisions being revived, and new ones being formed, through the active exertions of our agent, Bro. Hutchings, and had it not been for the Fenian disturbance I should have been enabled to report at this time a much larger number of revived Divisions as well as the opening of several new Divisions as the result of his labours, in the Bastern Townships.

As you all are aware, the National Division Sons of Temperance of N. A. held its annual meeting in Montreal last month. This meeting, it is hoped will be attended with most beneficial results to our beloved Order in this jurisdiction, and give it a higher standing in public estimation than it ever yet has had in this community: indeed, the good effects arising from the meeting are being already experienced in Montreal in the nightly increase of propositions for membership.

This Session was attended by one hundred and twenty Representatives, representing twenty-four Grand Divisions. From the M. W. S. Report it appears that our Order in America now consists of thirty-five Grand Divisions with 1096 Subordinate Divisions in active operation, containing 54,762 members, and 54,203 Lady visitors. That during the past year 29,279 new members have been admitted, and 7,750 members have been expelled for various causes. Massachusetts has the largest number of Lady visitors; Canada West the lessent number of subordinate Divisions—201. Massachusetts and Nova Scotia following with 125 each. The Grand Divisious contain 8,278 members, and

The following constitutional amendments were passed by the National Division at the recent session held in Montres!.

Constitution National Division, Part VIII: In second line strike out "two" and insert "three," thereby changing the per capita tax from Grand Divisions to National Division, to three cents per member.

Constitution of Subordinate Divisions, Part III, Sec. I. Strike out first word." male" and add to section the words, "Provided that females shall not be admitted to membership within the jurisdiction of any Grand Division unless permission first be granted by a two-thirds vote of the Grand Division, nor in any Subordinate Division unless the Division shall so decide by a two-thirds vote, after two weeks notice." This amendment admits females, conditionally into membership.

Art. X. Add: "All decisions of the acting Body shall, however, be and remain in force until reversed by the superior Body in the case"

Chap. VI., Sec. 7. In the first line after "not sustained" insert, "and the Division adopt the Report,"

Lecture Committee Reported as follows :-

Lachute, July 11th, 1866.

To the G. W. P., Officers and Brothers of the Grand Division, Sons of Temperance of Canada East.

We your committee, to whom was referred the procuring of a lecturer for the purpose of resuscitating old Divisions, and forming new ones in your jurisdiction, beg to report that we tried to procure the services of Bro. Manning, but found that his engagements with his church were such that he could not accede to our request. After much exertion we made arrangements with Bro. Hutchings, for three months from 17th May, since which time he has laboured with a great deal of success; more than we could have anticipated from the season of the year, and the Fenian excitement. Much good has been accomplished, and more permanent results would have been attained had the Fenian excitement not unsettled all matters, and prevented several resuscitations, and reorganizations which were in a fair way. We are sorry to add that we fear that Bro. Hutching's services cannot be retained longer than the engagement, which expires in the latter part of August, unless the various subordinate Divisions send in contributions. Out of \$90 subscribed to the fund, \$75 are from Howard Division alone, of course the various Divisions give some in the collections at the meetings; but unless we have a guarantee, we cannot incur the responsibility of a re-engagement. Grand Lecturer read his Report,

Lachute, July 11th, 1866.

Grand Worthy Patriarch, Officers and Brothers of the Grand Division of the Sons of Temperance of Canada East.

Worthy Brothers,

In presenting to you my Report as your Agent and Lecturer at this time, allow me to say that I was taken in some measure by surprise when waited up-

on by the Lecture Committee in April last, soliciting my services as your Agent. And as I did not believe in entering upon any work of that kind without due consideration, and weighing well the responsibility connected therewith, I made the subject a matter of prayer, and as nothing else of any importance was presented to me, I was induced to enter upon the work, looking for guidance and direction to the Great Patriarch above.

The Grand Scribe having selected a route, I began my labours on the 18th day of May, at Lacolle, where I addressed a large audience and obtained a good collection. The Division was not holding its regular meeting, but I am pleased to know that subsequently they have gone to work, their motto being (as one of the Brothers expressed it) "No Surrender." I have no fear of their future success.

I proceeded next day to Clarenceville, had a good meeting, the Episcopal Clergyman in the chair: I think that another visit to this place will result in the re-organization of the Division that formerly existed there.

On the 21st inst. I proceeded to Brockville, and held a meeting which was but poorly attended, but I feel confident that the Division will be re-organized under favourable circumstances. I here obtained 12 signatures to the pledge.

Left next day for Phillipsburg, delivered an address to a good audience, here too I think prospects are fair for the re-organization of the Division, in this place I obtained 18 signatures to the pledge.

Leftnext day for Bedford and addressed a large audience in the Town Hall, the Brethren of the two Divisions appearing in Regalia, I am happy in reporting the Divisions, especially Hungerford Division, in a sound and healthy condition. I obtained 11 signatures to the pledge.

Left next day for North Stanbridge, and lectured in the evening to a fair audience, I am sorry to report this Division inactive, but the Deputy informed me that he had hopes that bye and bye they would be found in good working order. I obtained 11 signatures to the pledge.

Left next day for Pigeon Hill, but as no arrangements were made for a meeting I proceeded to Frelighsburg, and addressed a small audience on Saturday evening, 26th May. I obtained 4 signatures to the pledge and I am not certain whether a Division will be got up there, not having heard from Mr. Smith aince I left; this is not to be wondered at when we take into consideration the state of the country since that time.

The following Monday proceeded to Dunham Flat, delivered an address to a fair audience and obtained 12 signatures to the pledge. I am sorry that I could not make any advancement in the re-organization of the Division, I have hope however, that even yet something may be done in that direction.

I proceeded next day to Abbott's Corner, addressed a large audience, obtained 17 signatures to the pledge, and found a Temperance Society already in active operation, and therefore they were not disposed to organize a Division

The following day proceeded to Sutton, delivered an address to a fair audience, obtained 3 signatures to the pledge, I also obtained the names of 29 persons to re-organize the Division, and at their request I proceeded with the G. W. P. on the 4th of June, and assisted him in the re-organization of the Washingtonian Division under favourable auspices, and I am happy to report from information subsequently received, that at the last meeting in June, they initiated 3 new members and received 15 propositions.

I proceeded next day to West Brome, addressed a large audience, obtained the names of 30 individuals for the opening of a new Division, they having agreed to meet any evening the G. W. P. could attend; accordingly, Monday evening, June 11th, was selected, but it was found when the G. W. P. and Brother H. Rose arrived there, that a sufficient number did not attend to

Left next day for Cowansville, and addressed a good audience in the Congregational Church, the G. W. P. presiding; obtained 12 signatures to the pledge; I am happy to report that the Division here has kept up its regular meetings, although numerically it is not large.

I proceeded next day to East Farnham, and addressed a large audience I believe the cause here to be A 1, the Division being in a prosperous condition.

Postponed my visit to Adamsville, for the purpose of assisting the G. W. P. in the re-organization of the Division at Sutton Flats, on that evening.

No meeting at Farnham Centre, on account of the Fenian excitement.

I proceeded to West Farnham, and addressed a small audience, obtained 2 signatures to the pledge, I also obtained the names of 10 Males and 4 Females, to open a new Division at this place.

Next day I proceeded to Granby, but in consequence of the late arrival of the train, and the hour of meeting having passed, my meeting had to be abandoned for the time being.

I proceeded the following day to West Shefford, addressed a small audience, composed chiefly of the old members of the Division. I am in hopes, from what information I could gather, that this once flourishing Division, may be speedily brought into the field again.

Omitted my meeting at Shefford Mountain, by consent of the friends and the Grand Scribe, for the purpose of spending the Conference Sabbath in Montreal

On Monday I proceeded to Waterloo, and addressed a fair audience particularly upon their present position; after the meeting a resolution was passed to meet the following Saturday to re-organize the Division. I am sorry to find upon subsequent enquiry that a prominent member is trying to organize a Lodge of the I. O. of Good Templars; I feel confident if Mr. Noynes could be prevailed upon to lay aside his opposition, that the Division at Waterloo could be again put in good working order.

I proceeded next day to Frost Village, could not hold any meeting as no arrangements had been made.

The next day I proceeded to Warden, and addressed a small audience; I found the Division still alive but struggling for existence, they hope to succeed.

I proceeded next day to Knowlton, addressed a small audience upon the present state of affairs in that locality, obtained the names of 21 individuals for the re-organization of the Division, and made the necessary arrangements to have the same effected on Monday evening 2nd of July. I am sorry that the G. W. P. and Brother Rose, were not able from unavoidable circumstances to accomplish the object. The G. W. P. informs me that no doubt exists as to its being successfully carried out in a short time.

I proceeded next day to Massawippi Village, addressed the friends of the cause and obtained 9 signatures to the pledge. They have an old Total Abstinence Society in successful operation; at their request I addressed them again the next day, Sunday, in the afternoon, a fair audience being in attendance, upon the subject of Temperance.

I proceeded next day to East Hatley, and addressed a small audience, obtained the names of 15 applicants for the organization of a new Division, and subsequently made arrangements with the Rev. Mr. Duff, to open said Division, on the evening of Monday, July 2nd. I trust the work was successfully accomplished.

The next day I proceeded to Waterville, could not hold a meeting in consequence of some misuaderstanding existing between the "Good Templars," and the person to whom the notices were sent; tried at the last hour to have a meeting, but the evening was so stormy that the meeting was a failure.

I proceeded next day to Lennoxville, addressed a good audience, and I am happy in reporting the Division in a sound and healthy condition. I obtained 3 signatures to the pledge.

This completed my appointments, after which I returned to Montreal, and remained during the Session of the National Division.

I proceeded again to make a short tour to fill in the time up to the Semi-Annual Session of the Grand Division, to be held at Lachute on the 11th inst.

Accordingly I began my labours by addressing a large concourse at a Pic-Nie, held at Marlow, in Stanstead. On the evening of the next day I lectured to a large-audience, obtained 17 signatures to the pledge. There is a Lodge of "Good Templars," in this place.

The next day I proceeded to South Stukely, addressed a small audience, obtained 4 signatures to the pledge; met with some opposition at the meeting, the result of which will be of benefit to the cause.

I proceeded next day to Shefford Mountain, lectured to a small assembly, chieffy members of the Division, obtained 4 signatures to the pledge; I am happy to report this Division doing well, and hopes are entertained of continued prosperity.

The next day I proceeded to South Granby, had no meeting in consequence of a very heavy thunderstorm that prevailed just at the time fixed for holding the meeting.

I proceeded next day to Granby Village, addressed a fair audience (but small for that place), obtained 6 signatures to the pledge; I am pleased to be able to report the Granby Division in good working order and up to the mark upon the subject of Temperance.

The next day I held a meeting at West Farnham, for the purpose of opening a new Division (having previously obtained the necessary names), but I am sorry to say that the object sought for was not consummated for various reasons, the principal one being, that in the opinion of the G. W. P. Bro. Stevenson, and Bro. Higgins, who kindly came to my help, it was deemed inexpedient at present to press the organization of a Division upon them.

I proceeded next day to Adamsville and attended a meeting of that Division, assisted at the public installation of their officers and afterwards delivered to the brethren and friends an address upon the subject of Temperance, and obtained 10 signatures to the pledge. I am very happy in reporting this Division as doing well.

I proceeded on Monday to St. Johns, and addressed a small audience, obtained 5 signatures to the pledge and found upon enquiry that it was no use to try to re-organize the Division, at least for the present. The feeling of the friends at the meeting was favourable, but they have worked so long, and with no good results, that they are discouraged.

This finished my tour, and I returned to Montreal the same evening in order to give you my report at this Semi-annual Session.

Officers and Brothers of this Grand Division: I have tried to give you a full and detailed account of my tour and now to give you a general idea of the cause. I would say that the Temperance question, take it as a whole, is in a low state, and will require active and persevering efforts to be put forth for the final and complete accomplishment of the work we have begun.
