REPORT

OF THE

COMMITTEE OF MANAGEMENT FOR THE YEAR 1874.

The Committee of Management have the honor to lay before the Members the 39th Annual Report.

Relief has been granted by our Society during the past year in seventy-two (72) cases of distress, comprising ninety five (95) persons in all, 65 men, 14 women, and 16 children. Each case was as strictly investigated as could be before aid was granted. Several looked very doubtful, but your Committee are satisfied that in the majority of cases the relief was both timely and well-deserved. As an instance of the difficulty of deciding in some cases, as well as with a view of impressing on members the necessity of accepting every story with considerable allowance, your Committee would just refer to three individuals-John Lowe, a respectably connected young man from England, John Watson and Alfred Gault, Gardeners, men in whom we took considerable interest, and for whose benefit we went to a good deal of trouble, and who, to our very great annoyance, turned out to be rank imposters Had they not so suddenly transferred themselves to other fields of operations, your Committee would have considered it their duty to take proceedings against them. The total amount expended in charity is \$707.97. For details of this expenditure and further information on the subject, see the Report of the Sub-Committee of Charity.

Two persons have been buried in our lot at Mount Hermon Cemetery during the past year, making three persons in all who now repose there.

In the Treasurer's Report will be found full information as to the financial affairs of the Society. We have disposed of five thousand dollars (\$5,000) of Quebec Corporation debentures at one per cent premium, and re-invested the amount in Stadacona Bank at 11 per cent premium.

Our arrangements with the Finlay Asylum and Ladies' Protestant Home continue to be satisfactory, and the authorities of both are ever ready to promote the interests of our Society.

We are also again indebted to our physician, J. A. Sewell, Esq., M.D., for gratuitous professional services, always cheerfully rendered.

We have to thank the Richeliqu Company for a free pass to Montreal, and the Quebec and Gulf Ports Steamship Company for several favors received.

On St. George's eve our Anniversary service was held in the Cathedral, when Revd. C. W. Rawson preached an appropriate sermon to a crowded congregation, and Revd. M. M. Fothergill assisted in the service. Mr. F. W. Mills, of Ottawa, kindly agreed to conduct the musical portion of the service, in which the ladies and gentlemen of the choir and others lent their very valuable assistance, to all of whom the Society is very much indebted. The collection in aid of the Charitable Fund amounted to \$102.46.

On the evening of St. George's Day, the members and their friends, to the number of about 100, dined together at the Russell House, where in social and friendly intercourse, a very pleasant evening was spent. This mode of colebrating the Day was adopted almost unanimously by our sister Societies throughout the Dominion and the neighbouring States.

Your Committee have to deplore the loss by death during the past year of four members, viz., Mr. T. H. Reed, a life member, Mr. Charles Poston, also a life member, Mr. F. H. Andrews, and Mr. Joseph Elliot, ordinary members. The latter gentleman had been a member but a few months when death removed him from among us.

In the last Annual Report regret was expressed at the limited membership of the Society, and members were appealed to to endeavour to add to the list. Your Committee have therefore great satisfaction in stating that through the exertions of several gentlemen, seventeen new names have been enrolled-4 Life and 13 Ordinary. Whilst, however, contemplating this increase with satisfaction, we would urge upon members generally not to relax their efforts, but to endeavor to make every Englishman in Quebec a member of our Society, It should be borne in mind, in view of the anticipated improvement in the affairs of our city, that we may probably soon have a very large influx of English residents, and the demands upon our Society will be proportionately increased. We may be called upon in the near future to take a position in regard to our immigrant fellow-countrymen such as our sister Society in Montreal takes to-day, a Society whose operations are upon a scale many times greater than ours, and whose income, large as it is, is, if we mistake not, scarcely adequate to the demands made upon it at present. Under these circumstances we feel confident that we will not appeal in vain to the Englishmen of Quebec to support the St. George's Society, and thus help to roll up a fund which will aid, comfort and protect many an honest but needy Englishman, when having landed here among strangers, he has to battle against the hardships which often assail the immigrant, and against opposition and discouragement from various quarters.

Seventy-two cases of distress have been relieved during the past year, comprising 95 persons, 65 men, 14-women and 16 children.

the lungs and disease of the heart); the third was a female who had been for some time ill in the Jeffery Hale Hospital, and was not likely to recover. They were all very grateful indeed to be enabled through the medium of our Society to rejoin their friends in England.

Of those partially assisted to return Home, one case was that of a man having with him his wife and three children who had searched in vain for employment in Ontario and Quebec, in consequence of his only knowing one particular branch of the shoemaking trade. Some charitably disposed gentlemen having subscribed \$20, this Society contributed \$28, and the Dominion Steamship Company kindly gave them all a passage Home for the \$48. We also partially assisted Home two sick and useless men, and later on two ladies in reduced circumstances, cases in which the amount advanced was certainly well spent.

The Sub-Committee have been applied to on several occasions by young men out of employment desiring to be sent Home, but they were determined on no account (unless under very exceptional circumstances), to break through the rule, which is to send no one Home except cases of great age or infirmity. They have refused no less than twelve applications of this sort during the past twelve months.

Two persons were buried by the Society in our lot at Mount Hermon. Their names were Elijah Green, formerly a soldier in the 17th Regiment, and George Cooper, a farm labourer.

Situations were found for several applicants.

A few persons may have been relieved whose necessities were the result of their own improvidence, and some, perhaps, who were not all they pretended to be; but the only individuals known to have imposed on our Society to any great extent are three whose names are mentioned in the Report of the Committee of Management. These worthies having obtained from the Society on certain conditions board, lodging and clothing, and situations having been found for them with great difficulty, thought proper to run away from these situations shortly afterwards, taking with them all they had obtained from us, and one of them taking also an advance of wages received by him from his employer. Very possibly they may have since victimised other societies in the same way. These cases show the necessity of some mutual arrangement by which St. George's Societies in various parts of the country could warn each other of the advent of such gentry.

Your Sub-Committee consider also that it would be very beneficial to all parties were some scheme devised by which this Society could be placed in communication with sister societies and colonization societies in the Eastern Townships, and elsewhere throughout the Dominion, with the view of obtaining some reliable data as to the number and classes of people for whom work could be provided by these Societies in their several districts.

The Right Revd. George Jehosaphat Mountain, D. D., D. C. L., Lord Bishop of Quebec, was the second son of Bishop Jacob Mountain, the first Anglican Bishop of Quebec: He was born 27th July, 1 89, at Norwich, England, came to Canada with his father, 1793, and died after a brief illness at Barfield, his country seat, on 5th Jany, 1863. He was nineteen years Rector of Quebec, and was co secrated Bishop 14th Yebruary, 1836. He was a diligent visitor among his flock. And in the dreadful visitations of cholera in 1832 and 834, he literally lived night and day among the dying and the dead, while in 847, when the province was visited with the plague of typhus fever, and the poor emigrants were dying by thousands at the Quarantine station, the Bishop took his turn at Grosse Isle regularly with the rest of the lergy; and again when the cholera visited Quebec, in 1-49 and 1854, he was diligent in visiting the hospitals. During many years and up to the time of his death, Bishop Mountain, besides his life membership, contributed regularly to the Society a donation equal to four annual subscriptions, and at all times he took a great interest in its proceedings.
