

THE DEMOCRATS OVERWHELMED.

New York Republican By Over 100,000 Majority.

William L. Wilson, the Author of the Original Features of the Present Tariff Bill, Defeated for Congress in West Virginia.

Forty-one states of the American Union held elections yesterday, and so far as returns had been received by The World up to 3 a.m. the result shows an overwhelming defeat of the Democrats in almost every state.

New York has gone Republican by over 100,000 majority. Senator Hill is defeated by Ex-Vice-President Morton for Governor, and Ex-Mayor Grant is defeated for the mayoralty by W. T. Strong.

The vote in New York city for Governor was Hill 121,052, Morton 121,500. Of course the Parkhurst moral movement will claim the credit for the defeat of Tammany, but the presence of Ex-President Harrison, Gov. McKinley and other Republicans of national importance, who are best able to judge the effects resulting from the tampering with the protection policy of the United States, has had much to do with the sweeping Republican victory.

The defeat of Tammany is not so much a surprise in New York as might be expected, as betting men all along have been offering odds on Strong for Mayor and Morton for Governor.

The New York delegation to Congress will stand 29 Republicans to 5 Democrats, compared with 11 Republicans and 23 Democrats at last election. The state legislature is Republican by 81 to 65.

How Dr. Parkhurst Views It. The result of the election was received with great enthusiasm by the opponents of Tammany Hall. Dr. Parkhurst came into the Committee of Headquarters at 7.30 o'clock and was immediately surrounded and congratulated by those present.

Dr. Parkhurst said that the victory signifies first that the people are getting their eyes open, and that their consciences are awake. In the second place, that although our American institutions were put to a severe test, the better element has prevailed and good municipal government is assured.

Neither Senator Hill nor Gov. Fenton would discuss the results of the election. Governor-elect Morton said "I accept the result of to-day's election as the protest of the people of the Empire State against false theories and practices in Federal and State government, and the corruption of the political system in New York city. I am profoundly gratified by the high honor conferred upon me by the citizens of this great state and of the grave responsibilities which will devolve upon me as the result of their action."

Mr. Morton received the telegram from Ohio: "Hearty congratulations on your unprecedented victory, which will be hailed with joy by Republicans everywhere. Signed, William McKinley."

The result of the vote on the Constitution amendments in New York will not be made known until to-day afternoon, the indication are that they are carried. The city is delighted at the consolidation of all the cities and towns contiguous to New York into one great municipality.

Although Nebraska Republicans were divided and the Democrats united with the Populists, the returns show a Republican gain.

In Kansas "Sockets Jerry" Simpson (Democrat) is defeated by Lang (Republican). Maryland the solid Democrat front has been broken, and the Republicans have made unprecedented gains.

The Republicans of Wisconsin have carried the state by over 15,000 plurality for Governor. The state ticket is Republican.

Louisiana returned a full Democratic delegation to Congress, despite the bolt of the sugar planters.

Deny, the Republican candidate, has carried the Seventh Congress District of Kentucky. This is the district represented by W. C. P. Breckinridge, defeated in the famous Pollard scandal case.

Breckinridge was defeated but he is a primary by Oregon and the latter is now a Democratic State.

Indiana elected only minor state officers, but the result on the state and Congress tickets, which went strongly Republican, will be generally interpreted as an endorsement of Ex-President Harrison, who has made an earnest campaign in the state, as a result he will probably be a candidate before the convention for a third nomination for President in 1896, but McKinley will doubtless defeat him.

The returns from Texas, where the Populists boasted they would capture the state officers and a majority of the Congress delegation, shows that the Democrats have retained the state, but by a reduced majority.

The Republican plurality in Illinois is over 70,000.
