There are many things in the County requiring Government attention. A man who will seek to secure such attention, in a proper spirit, is required. Such a man as Mr. Snow is a very good one for the few manufacturers of Montreal, Toronto and other large centres, and the "struggling politicians" may use it, in these hard times, as a bait with which to deceive the more ignorant of the people, but it is not one that can be argued with success among the Canadian people at large. The party advocating such a tariff will be soundly beaten on the merits of their policy.

Dangerous Candidates.

The Protectionists of Canada ask the electors to send candidates to Parliament who will vote for a retaliatory tariff. Sir John A. Macdonald explains that the retaliatory tariff means duties high enough to keep out foreign manufactures. These, he says, need not be quite so high as the United States duties. Now, if he or any of his followers will explain to the electors why they do not wish to see their surplus manufactures under the new tariff they will settle a puzzling question. Canada, under a high tariff, must have surplus stock to be "slaughtered" just the same as they have in the United States and if her manufacturers do not find a "slaughter market" they will be ruined. Perhaps, however, the manufacturers can make enough out of the consumer's protection to let their surplus stocks rot. In any case, the consumer will "pay the piper." The trade returns show that the "slaughtering" is based on very small foundations and reasonable people ask how it is, if protection is such a benefit to a country, that the Americans who have so much of it, are forced to "slaughter" their goods in the Canadian market. The protectionists, however, only confine themselves to the question in the abstract. It would not be compatible with their dignity and superior intelligence to descend to particulars. Protectionists ought as far as possible, to be kept out of Parliament. They suit the Montreal, Toronto and other manufacturing rings, but are not the men for the country at large.

Mr. Vanderville has been trying to cut off the Grand Trunk from its communications with Detroit and Chicago and so ruin its thorough freight business. Manager Hickox, however, has lately returned from England with the required financial backing, and it is thought the Grand Trunk and Great Western will combine to obtain the desired connection. If it is necessary the Grand Trunk will have its own line to Chicago, even if an independent road has to be built between Detroit and Chicago. The Grand Trunk would doubtless meet with every facility in carrying out its project from the people of the West, who have always given it liberal support, and Mr. Vanderville will probably regret his undertaking.

Nepisiguit Rough Waters.

The Montreal Times says that Deputy Sheriff Gault and H. Morrison, Esq., of Sussex, returned the other day from a fishing trip up North on Jacques River, where they were successful in catching about 180 trout of average size, some weighing as high as 2 lbs. The larger trout are further up the river than the Nepisiguit, but were not so successful. The reason why anglers do not meet with success on the rough waters of the Nepisiguit is because they are not prepared to take out a pay for fishing licenses there at a dollar a day per rod. It ought to be generally known to anglers that we hope the Ziegler will make a note of the fact—that the pools of the Rough Waters are regularly fished, both

from the shore and canoes, by persons who live in the vicinity. Without entering upon a discussion respecting the exercise of their privileges by these people, it certainly seems strange that one class of citizens of the country should be required to pay for what another class is allowed to enjoy free of charge. For instance, Overseer Hickson, of Bathurst, issues a Departmental License to A, who, perhaps, has travelled a hundred miles for the purpose of fishing for salmon in the "Rough Waters." Mr. Hickson, in filling the license, is very particular in specifying the limits within which the license is permitted to fish. The license is given to the holder in the exclusive occupation of the waters specified for the number of days covered by his license. He accordingly engages the resident canoe man, paying them good wages. He pitches his tent where the license is to be exercised, and, naturally, thinks he will have fair fishing. It is all a delusion. He may have the privilege of fishing one or two pools, per day, if he gets at them very early in the morning. If he does not get the neighbors and relatives of the very men who are commended as trusty guides will have caught or disturbed every fish from which he might get a rise during the day. He is faithfully taken from pool to pool over a mile or two of rough water, but the result is at best very unsatisfactory.

The Government in Ontario.
