After eighteen years' successful work among children of this Province needing a home, the Committee have pleasure in reporting that the Home has had very liberal support during the past year. The collectors gratefully acknowledge the cheerful readiness with which subscribers have responded to their calls, many of them expressing a willingness to increase their subscription should it be required.

The general management has been conducted by the Ladies' Committee with Mrs. Walker as matron, who is to be commended for her unremitting and motherly care of 30 many little ones.

Dr. Milne has again kindly given his professional services to occupants of the Home when

needed—the Committee gratefully acknowledge generosity in this matter.

Services, such as hair cutting, etc., have all been rendered gratis, for which thanks are due.

The total income for the year amounted \$4,689.85, and the expenditure to \$2,868.37, compared with \$2,152 80, and \$3,510 38, respectively for 1889.

During the year alterations and improvements were made to the building at an outlay of \$505 68

British Columbia
PROTESTANT ORPHANS' HOME

CONSTITUTION,

(Adopted 27th October, 1873.)

INCORPORATED 11TH JULY. 1883.

1. This Institution shall be called the "British Columbia Protestant Orphans' Home."

2. The object of this Institution is to receive and to provide a home for orphan, destitute and other children, under the age of ten years, requiring such care; and to educate them in the Protestant faith, and instruct them in the elements of secular knowledge.

3. The Management of this Institution shall be vested in a Committee chosen from the subscribers, at the Annual Meeting to be held on the second Tuesday of December in each year, said committee to consist of four representatives from each Protestant denomination in Victoria, of whom at least one shall be a Clergyman, and not fewer than two Laymen, and one-third of whom shall constitute a quorum for the transaction of general business.

4. It shall be the duty of such Committee at their first meeting, to be held not later than one week after their election, to appoint from their own number, a President, Secretary and Treasurer; to meet at least once a quarter, and oftener if required; to provide for the support of the institution by means of voluntary contributions and otherwise, as they may deem advisable.

5. The Committee shall also, at their first meeting after election, appoint a committee of ladies composed of an equal number from each denomination to take charge of the internal management of the Institution. Such Committee of Ladies shall appoint their officers and make their own regulations equitably according to the spirit of this Constitution and the basis on which the Association is formed. On approved monthly requisition they may draw on the Treasurer for necessary funds, and shall therewith pay all bills. They shall also present to the President a monthly report of the state of the finances and the condition of the Institution.

6. The religious training of these orphans shall be conducted according to the doctrines and tenets held by the orthodox Protestant Churches. In this Constitution those Churches are esteemed orthodox which hold as the foundation of their faith, the sufficiency and authority of the Holy Scripture for salvation—Holy Scripture being the commonly received books of the Old and New Testament,—so that whatsoever is not read therein or may not be

proved thereby, is not to be required of any that should be believed as an article of the Christian Faith or be thought requisite or necessary to salvation (Art. 6, Ch. of Eng.); and which also hold the articles of the Apostles' Creed as truths of our common redemption, on the ground that they may be proved by most certain warrants of Holy Scripture. All, therefore, who hold any office or authority over the orphans shall be and continue to be Protestants of good character and sound in the faith. A form of prayers prepared for the purpose, together with portions of the Old and New Testament Scriptures, shall be read morning and evening daily.

7. The orphans shall—in charge of the matron—regularly attend Divine Service on Sunday (mornings) in the Victoria Churches of such of the orthodox Protestant denominations as are or shall be from time to time represented on the General Committee, as follows:—That is to say, the attendance shall be given in quarterly (tri-monthly) periods at the services of each such denomination in succession. In the case of any such denomination having regular service in more than one church in Victoria, the quarter's attendance pertaining to that denomination may be equally divided among its several churches. Attendances at any other times shall be in the discretion of the General Committee, as shall also other questions or exceptional cases that may from time to time arise.

aforesaid, in quarterly rotation, shall be the Minister or Chaplain of the orphans, with pastoral authority over them for that time as over a portion of his own flock, providing he does not in the exercise of such authority violate any Rule of this Constitution.

No alteration shall be made in this Constitution except by a vote of two-thirds of the whole Committee sanctioned by a majority of the subscribers present at a general meeting, of which thirty days' notice shall be given. Such notice to specify the changes recommended for the consideration of the meeting.

10. It shall be lawful for the Committee from time to time to make, vary and alter by-laws for the government of the institution, and for all matters and things relating to the conduct and management of its affairs, provided that the same be not inconsistent with the foregoing Constitution, and that notice of any proposed alteration be given at a regular meeting of the Committee at least one month previously to such alteration being made.
