The injury was very meagre, and his sister, Mrs. J. P. Mason, left by C. P. R. for Boston tonight.

Joseph McElroy is the youngest of two sons of the late Isaac McElroy, who, in years gone by, conducted a large liquor business here. He is about forty years of age, is married and has two children here.

CANADIAN PORTS To Get the Bulk of Large Traffic Montreal, Quebec and St. John Will Be Favored by the Grand Trunk Pacific Project.

The Grand Trunk management, in announcing the appointment of the Hon. Mr. Rainville, speaker of the legislative assembly of Quebec, says that one or perhaps two more French-Canadian representatives will be added to the board of directors of the Grand Trunk Pacific Company.

WILL TAP TWO DIVISIONS At North Bay the main trunk line from the Pacific coast will bifurcate into two divisions—motor nerves, so to speak—one of which will carry the stream by way of Toronto to Montreal, and the other striking across the Ottawa River between Lumsden and Mattawa, and thence through the lake region of Quebec. Their first object will be to bring all the traffic that can be handled to Montreal, Quebec and St. John, and take the surplus to Portland.

THE GAMBY CHARGES.

The shocking statement made by Mr. Gamby on the floor of the Ontario legislature has caused a great sensation. This particular exposure was a great surprise because no one supposed that Mr. Gamby was engaged in the praiseworthy duty of bringing to justice a group of public criminals.

While every one knew that the recent succession of crimes could not go on for the benefit of the government at Ottawa and the government at Toronto without the approval of the ministers at both capitals, it has been difficult to connect the higher offenders in parliament who could be influenced by a cash bribe, or by any less vulgar but equally corrupt payment, that member would move over to the government side.

Those who disapprove of the stealing of seats and the purchase of members will have no manner of sympathy with the attacks of the government organs on Mr. Gamby. If Mr. Gamby is telling the truth, it is clear that those who are most furious against him believe that he is telling the truth. "This base fellow Gamby," says one, "comes forward to declare that he has been offered and accepted a bribe."

If Mr. Gamby tells the truth he proved his own good faith by taking a trustworthiness of his own party into his confidence, and by confiding in him every action taken. These two did not cause the crime to be committed, but they caused it to be exposed.

THE CROP OF RAILWAY PROJECTS.

On various occasions before the railway committee of parliament Mr. Blair has denounced the charter mongers, as he calls them, who are not railway builders but who procure charters to speculate on the railway companies.

The Grand Trunk Railway Company is satisfied with Portland as a terminus. But no government could put through parliament a measure granting further subsidies to a road whose eastern terminus is in a foreign country.

Various railway charters and lines of railway wholly or partly constructed cover these routes or some part of them. Notices have already been given of several applications for additional charters.

MR. DOBSON AND THE TURK. Rev. William Dobson, formerly pastor of the Centenary church in this city, now living at Windsor, is an opponent of the reverse order. He is apt to gravitate to the unpopular side.

The premier stated that by the constitution lieutenant governors held office during the pleasure of the federal government, except that they could not be removed without cause until the end of the five years term.

MR. WILFRID AND MR. TARTE. It is perhaps not material to the public whether Mr. Tarte resigned his portfolio or was turned out of the government. But it appears that while Sir Wilfrid claims to have dismissed Mr. Tarte, and while in fact he did go to the governor general with the request for Mr. Tarte's removal from office, Mr. Tarte had before that verbally and by letter tendered his resignation. The premier declined to consider the resignation when Mr. Tarte offered it in person, though he now says that he had made up his mind to dismiss him. Nor did Sir Wilfrid do so on the letter, but proceeded to demand a resignation which he had already received, and to dismiss a minister who had already dismissed himself.

JOSEPH HOWE. The Nova Scotia legislature is performing a long deferred duty in making a grant for a monument to Joseph Howe. Howe was, without doubt, for several years of his life, the most potent personal influence in his native province. Whether in a larger field he would have done as much, it is difficult to say.

POSTER INTERVIEWED. TORONTO, March 19.—Hon. G. E. Foster, conservative candidate in the present Nova Scotia election, who was defeated by Hon. J. D. Grant, the liberal candidate, accuses his defeat for making a mistake in his estimate of the Nova Scotia political situation. He does not believe the tariff question had any significance in the campaign, and says he has not the least doubt the farmers and the small business men of Nova Scotia generally, are strongly in favor of adequate protection of Canadian products, and especially in respect to the wool and the woolen goods.

PARISBORO NEWS. PARISBORO, N. S., March 19.—John H. Gillespie and his associates, who have recently taken up more than 100 square miles of coal area, are about organizing a company and will soon commence drilling for coal. The tug Clayton is having a new engine put in which will greatly increase her power, as it is much larger than the old one.

JOE HOWE MONUMENT. HALIFAX, March 18.—In the house of assembly today Premier Murray announced that the government intended at this session to ask for a grant of money to erect a monument to the late Hon. Joseph Howe. Previous to this resolution had been unanimously adopted asking the government to do this. Citizens have already subscribed about \$2,000, and the parliamentary vote will probably be \$3,000.
