In an address to the students of the Royal Dental Hospital, of London, Dr. Osler said :

" You have just one gospel to preach, and that is the gospel of cleanliness of the mouth, the cleanliness of the teeth, and the cleanliness of the throat—these three things must be your text throughout life."

### ORAL HYGIENE

—the hygiene of the mouth. " There is not any one single thing more important to the public in the whole region of hygiene than that, and it is with that you, as practitioners, will have to deal."

Also Dr. Brown, of Chicago, says: " If the mouths could be systemically examined by competent persons, and instructions given and enforced with regard to the intelligent use of brushes and antiseptic solutions, the death-rate of this country would be materially lessened, and the percentage of illness much reduced, and a stronger and a more vigorous race result in consequence of these prophylactic measures."

" By tabulated proofs of undoubted authenticity, no fewer than thirty-eight different infections may be traced with more or less directness to the human mouth as the focal or starting point."—Professor Miller.

# HYGIENE OF THE MOUTH



DO YOU KNOW—that your teeth can be saved, even if they have decayed?

DO YOU KNOW—that a tooth decaying early in life can be properly cared for and saved?

DO YOU KNOW—that you should not wait until your teeth ache before going to the dentist?

DO YOU KNOW—that a tooth with a gum-boil, which is an abscess, need not be extracted? it can be saved.

DO YOU KNOW—that you should never lose a tooth?

DO YOU KNOW—that it ought never to be necessary to wear artificial teeth? the natural teeth ought to last a life time, and would do with proper care and attention.

DO YOU KNOW—that artificial teeth should be cleaned as often as those that are not artificial, if not more often?

DO YOU KNOW—that your mouth will become sore if your tooth plate is not kept clean ?

DO YOU KNOW—that there are some people who are particularly careful and neat in every respect but their mouths, which are often filthy. Are you such a person ?

DO YOU KNOW—that tuberculosis is killing more people than any other disease ? thousands die of it every year.

DO YOU KNOW—that tuberculosis is our greatest enemy ?

DO YOU KNOW—that tuberculosis is directly caused by microbes taken into the system, in almost every case through the mouth ?

DO YOU KNOW—that tuberculosis is always preventable by proper living, and by keeping the mouth in a hygienic condition ?

DO YOU KNOW—that a low state of health favors the development of tuberculosis ?

DO YOU KNOW—that a foul mouth—full of rotteness and decay, is one of the commonest, if not the commonest causes of a low state of health ? and therefore one of the conditions which most favor the development of tuberculosis ?

DO YOU KNOW—that teeth left to decay, and roots with running abscesses, so that every particle of food or liquid that is swallowed is charged with pus and disease germs, are bound to impair the health of the individual and so favor the growth of tuberculosis ?

DO YOU KNOW—that the mouth is the main entrance to the lungs and the stomach, if the mouth be foul, how can the lungs and stomach be clean and healthy ?

DO YOU KNOW—that an unclean mouth pollutes the whole system and ought no more to be tolerated than the keeping of the household garbage on your front door-step to pollute the whole dwelling ?

DO YOU KNOW—that to keep the mouth in a hygienic condition you should receive proper dental attention at least every six months.

DO YOU KNOW—that you should clean the teeth after every meal, also on arising and before retiring ? and that you should use a properly shaped tooth-brush ?

DO YOU KNOW—that for spongy and inflamed gums and general abnormal conditions of the mouth you should use an antiseptic mouth-wash together with daily massage or friction of the gums ?

For a number of years the dental profession has realized the necessity of giving proper instruction to the public in oral hygiene, the functions and care of the teeth and adjoining parts, and their relation to other parts of the body. The profession sees the necessity of educating the parents and teachers, that they in turn may educate the children, as to the absolute necessity of keeping the teeth in good condition if the health is to be maintained. And seeing that the child of to-day is the parent of to-morrow, it is a matter of far-reaching importance that every child should be taught early to care for the teeth and maintain the mouth in a healthy condition. It is a matter, not merely of individual, but of national importance. Diseased teeth mean impaired nutrition, and impaired nutrition spells the deterioration of the human race.

## TEN RULES FOR THE CARE OF THE TEETH AND MOUTH.\*

---

1st.—Omit to wash your face rather than neglect cleansing your mouth and teeth.

2nd.—Instruct your children as early as possible to take care of their teeth. The neglect of youth is not to be repaired later in life.

3rd.—Beware of sweets and too soft bread. Active mastication of firm, thick-crustcd rye bread is the best natural preventative against disease of the teeth.

4th.—Do not forget, above all, to cleanse the mouth before retiring to sleep. He who only cleanses in the morning covers the well after the child has fallen in.

5th.—Mechanical cleansing, by the aid of brush and pick, is the foundation of all artificial care of the teeth.

6th.—Antiseptic, but harmless, mouth washes and suitable powders are entirely commendable to perfect the artificial care of the teeth and mouth. Applications which cauterize the mucous membrane or decalcify the teeth, are to be unconditionally rejected.

7th.—The teeth should be examined at regular intervals in order that starting points of decay may be detected and remedied before they have spread far.

8th.—Tartar is to be removed from time to time.

9th.—Diseased teeth and roots incapable of retention should be removed under all circumstances, no matter whether they are painful or not at the time.

## THE MOUTH

The germs have to pass through the mouth, then down the throat, and enter the system through the stomach. For this reason, many people are continually swallowing pus from decayed teeth and tartar from old roots or stumps. Apart from tartar on the teeth, there are substances of which less notice is taken, namely, layers of filth that may cover artificial teeth and plates, or broken stumps beneath them.

The germs from these might be swallowed, enter the stomach, and cause irritation of the stomach, or gastritis as it is called, or may pave the way to tuberculosis.

The proper time to begin the treatment of any form of indigestion or tuberculosis is at the very commencement.

## HEED THE WARNING

Keep the mouth in a healthy state, so that you can chew your food properly. Instruct children early in life to care for the teeth—as habits formed in childhood are more likely to be carried out through life.

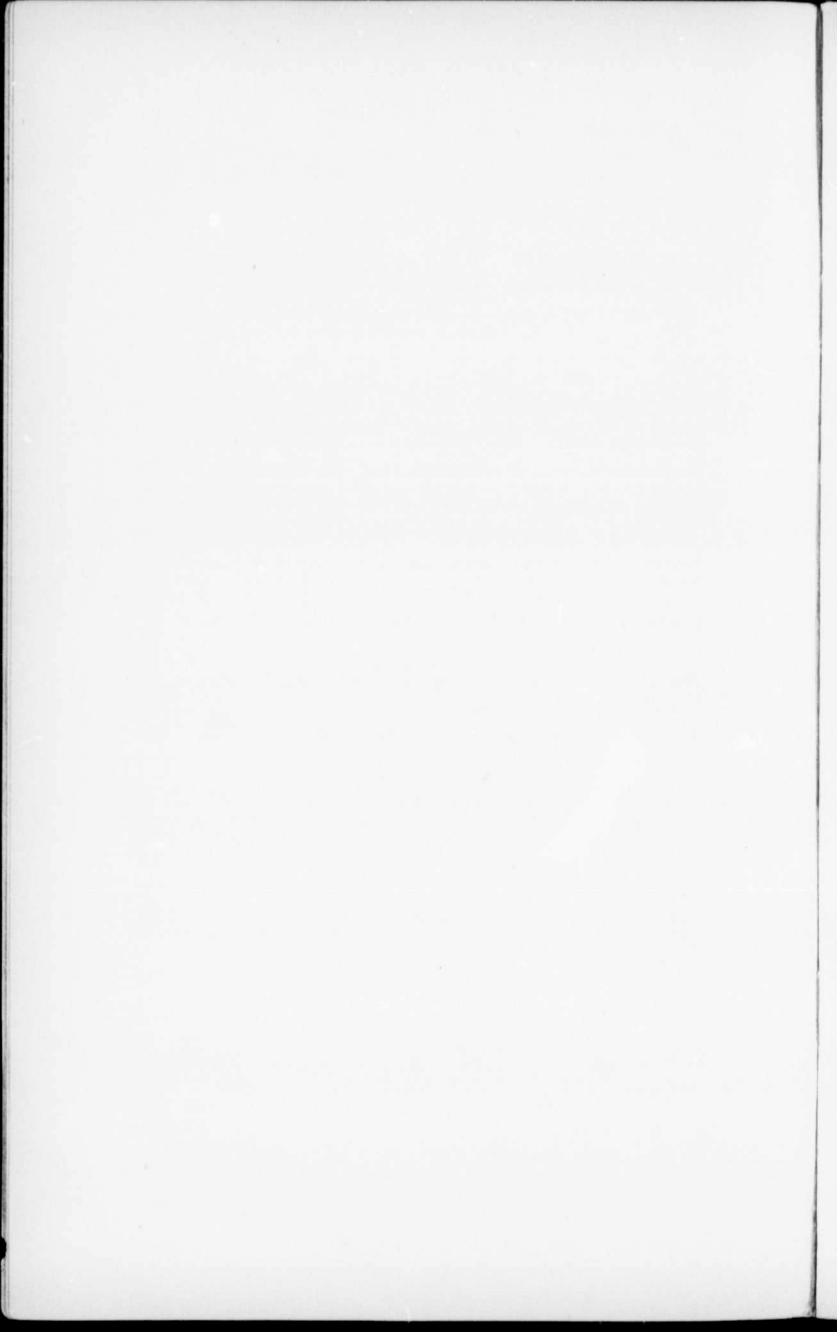

## NORTHERN ONTARIO FIRE RELIEF FUND

Toronto, February 26th, 1914.

**To the Subscribers**

**to the Northern Ontario Fire Relief Fund :**

At the instigation of the Board of Trade of the City of Toronto, the Northern Ontario Fire Relief Committee was formed on July 12th, 1911, to enlist the sympathy and support of the citizens of Ontario generally in providing a liberal measure of relief for needy residents of Northern Ontario who had suffered loss in the great forest fires which had just taken place in the districts adjacent to Cochrane, Porcupine, Matheson, Sudbury, and including the towns of Cochrane, Pottsville, Porcupine and Golden City.

In submitting herewith a Report of the administration of the funds subscribed, the Committee sincerely thanks the donors for their very generous and prompt response to the appeal for aid which resulted in total cash contributions of \$60,483.64 (see page 25). The Committee also gratefully acknowledges donations in goods made by many firms, and clothing and domestic articles forwarded by churches, societies, etc. The promptitude and administrative ability with which the T. Eaton Co., Ltd., forwarded and distributed a car of food, clothing and medicinal supplies at Porcupine was a great factor in lessening the suffering of many at that point.

Too great praise cannot be given the Committees of citizens at the various centres for the excellent work done in distributing relief to the needy, and for their untiring and heroic efforts in searching, especially in the Porcupine District, for those unfortunate ones who lost their lives. The physicians of the burnt districts and neighboring towns also rendered admirable service in connection with the sick and wounded.

The thanks of the Committee are due and are hereby tendered the Dominion Government for tents supplied, the transportation and telegraph companies for free transmission of goods and messages, and the press for the assistance given in making the needs of the residents in the burned areas known throughout the Dominion and for the valuable publicity given the work of the Committee.

The Committee has accepted, with deep appreciation, on behalf of the residents of the Porcupine Dis-

tract, a plot of land generously donated by Mr. W. S. Edwards, to be used as a cemetery for the general use of the whole Porcupine District. This property, which consists of six acres and which is now known as Edwards' Point Cemetery, is the South-east part of Lot No. 11, Concession No. 3, in the Township of Whitney, lying East of Porcupine Lake, in the District of Sudbury. The Patent for the property has been made out in the name of the Township of Whitney, and has been filed by the Department of Lands, Forests and Mines with the Local Master of Titles for the District of Sudbury, at Sudbury, Ont., and the Certificate of Ownership has been filed by the Committee with the Corporation of the Municipality of the Township of Whitney. The Township of Whitney has, by By-law, undertaken the proper care and maintenance of the property. In this cemetery have been buried twenty of the sixty-eight victims of the fire, being those who were not claimed by relatives or friends, or who could not be identified. As full particulars as could be obtained regarding each victim have also been filed with the Local Master of Titles for the District of Sudbury, the Mining Recorder at Porcupine and the Township of Whitney, and a suitable granite monument erected in Edwards' Point Cemetery, carrying the following inscription:—

“Erected by the Citizens of Canada, through the Northern Ontario Fire Relief Committee of the Toronto Board of Trade, to the memory of those who suffered and lost their lives in the great holocaust that swept this district, July 11, 1911.”

The Committee has, through the various local committees, rendered aid to all those made needy by reason of the fire, particular attention being given to widows and orphans. Grants have also been made towards the rebuilding of two schools at Porcupine and one at Matheson; Cochrane not being assisted in this regard, as the school there was replaced through Government aid.

After all approved claims for relief had been met, there remained in the hands of the Committee a balance of about \$18,000.00. A very careful investigation was made by a special officer, under the direction of the Committee, into the conditions existing in the Cochrane and Porcupine Districts, with the result that the Committee felt the erection and maintenance of a suitable hospital or hospitals in these districts would be a wise use for the balance of the funds on hand. Failing, however, after several attempts, through their official repre-

sentative, to arrange satisfactory terms for the establishment of a hospital at Porcupine, and finding that they had no power by law to disburse the funds on hand except for the specific purpose for which such funds had been subscribed, namely, the relief of fire sufferers in Northern Ontario, the High Court Division of the Supreme Court of Ontario was petitioned for such direction or order of the Court as might be deemed necessary for the administration of the money on hand. A copy of this petition will be found on page 28. Representatives of the Porcupine Mine Owners, South Porcupine Board of Trade, Townships of Whitney and Tisdale in Porcupine, the Town of Cochrane, Cochrane Board of Trade, Cochrane Hospital Board, the Attorney-General and the Northern Ontario Fire Relief Committee, were present at the hearing, and, on October 17th, 1913, the Honourable Mr. Justice Middleton delivered judgment ordering an equal division of the funds to be used in establishing a hospital at or near the Town of Cochrane, and a hospital at some place in the Porcupine Mining Division, under conditions as set forth in the Judgment. (For copy of Judgment, see page 31.)

As will be noted in the Order of the Court, issued October 17th, 1913, the Committee is now relieved and discharged with respect to all liability with regard to any moneys dealt with under the Order, save the liability to deal with them as therein directed.

Full details regarding all payments have been kept by the local committees, acting in a large measure under the direction of the Central Committee at Toronto, which Committee also kept detailed accounts of subscriptions and all outlays. These have been audited by Messrs. Clarkson, Gordon & Dilworth, of Toronto, and a certificate as to their correctness is appended to the statement of the funds. (See page 27.)

All of which is respectfully submitted.

## PETITION

IN THE SUPREME COURT OF ONTARIO.

HIGH COURT DIVISION.

IN THE MATTER OF The Trusts of  
the Northern Ontario Fire Relief  
Fund.

AND IN THE MATTER OF the Trustee  
Act and the Mortmain and Charit-  
able Uses Act.

To the Honourable the Judges of the Supreme Court of  
Ontario.

The Petition of Robert S. Gourlay and Alexander Laird,  
of the City of Toronto, Esquires,  
Sheweth as follows:—

On or about the 11th day of July, 1911, a disastrous fire  
having occurred in the district known as "Northern  
Ontario," a circular was issued by the Toronto Board of  
Trade, calling for subscriptions for the relief of the fire  
sufferers, such circular being as follows:—

"Toronto, July 12th, 1911.

"To the Members of the Board.

"Gentlemen,—

"A special meeting of the Council was held this a.m.  
to consider what steps should be taken to afford some  
measure of relief for the Northern Ontario fire sufferers.

"It was resolved that the Board of Trade, through a Com-  
mittee to be called the Northern Ontario Fire Relief Com-  
mittee, should take the necessary steps to enlist the sym-  
pathy and support of Members of the Board of Trade and  
citizens generally in providing a liberal measure of relief  
for the residents in the burned districts. Also, that the  
sum of \$1,000.00 be donated from the funds of the Board  
of Trade, and, further, that the co-operation of the City  
authorities be enlisted.

"A Committee composed of the following members was  
then duly appointed:

"Mayor Geary.

"Mr. R. S. Gourlay.

"Mr. J. F. Ellis.

"Mr. Alex. Laird.

"Mr. R. Home Smith.

"Mr. W. G. MacKendrick.

"At a subsequent meeting Mr. Alex. Laird was elected Treasurer, and subscriptions to the Fund may be sent to that gentleman, care of the Canadian Bank of Commerce, Toronto, or through the Board of Trade.

"We have the pleasure to report that the City, through the Board of Control, have cheerfully endorsed the movement, and contributed \$5,000.00.

"Yours faithfully,

"F. G. Morley,

"Secretary."

2. Pursuant to such circular, moneys were received by the Northern Ontario Fire Relief Committee at Toronto, of which Committee the Applicants are respectively the Chairman and the Treasurer, such subscriptions amounting in all to \$55,388.75, as per statement of receipts and disbursements marked as an exhibit to the affidavit in support of this Petition. In addition, certain subscriptions, amounting to \$4,297.89, were received at Porcupine, and certain subscriptions, amounting to \$809.50, were received at Cochrane, the total amounts of receipts being \$60,496.14.

3. The Committee then proceeded to use the said fund for the purpose of relieving the fire sufferers, and, in so doing, have expended \$42,393.41, leaving a balance at the credit of the Fund of \$18,102.73, from which are to be deducted certain expenses not yet definitely ascertained, leaving the sum of over \$15,000 in the hands of the Committee.

4. In the opinion of your Petitioners and the Committee, the objects of this charitable trust, as they were set out in the circular upon which the subscriptions were obtained, are at an end, and the fire sufferers have, as far as possible, been relieved, and your Petitioners are desirous of disposing of the benefit of the balance of the fund for some charitable purpose of a kindred kind in the district known as Northern Ontario.

5. Not having in view any limitation of their powers in that regard, your Petitioners have been considering with various local bodies using the fund in question for the purpose of a Public Hospital to be situated in the neighborhood of the townships of Tisdale and Whitney, and had entered into negotiations with certain local representatives of those townships, as appears in the correspondence and resolutions exhibited to the affidavits in support of this Petition, and had also entered into certain negotiations with the town of Cochrane, which latter town has, as your Petitioners are advised and believe, a site for the

Hospital, and has made provisions for taking care of its maintenance for the future.

6. Your Petitioners desire to submit for the approval of the Court a scheme for the disposition of the balance of the fund in their hands, and suggest to the Court that the same shall be disposed of as follows, assuming that your Petitioners have the right to apply in respect to the fund in the hands of one A. E. D. Bruce, amounting to \$1,000:

To the Hospital at the Hollinger Mine.....	\$1,000.00
To the Hospital known as "The Berwick Moreing Bungalow" .....	1,500.00
To the Hospital at Pottsville and Golden City, maintained by Mrs. Bridgman.....	2,500.00
And the balance of the fund to the Cochrane General Hospital.	

7. Your Petitioners, therefore, ask that some such scheme as above proposed be sanctioned and approved of by the Court, or that there may be made such direction or order of the Court as shall be deemed necessary for the administration of the balance of the fund belonging to the said charitable trust.

And your Petitioners will ever pray.

## JUDGMENT

IN THE SUPREME COURT OF ONTARIO.

The Honourable Mr. Justice } Friday, the 17th day of  
Middleton. } October, A.D. 1913.

IN THE MATTER OF The Trusts of  
the Northern Ontario Fire Relief  
Fund,

AND IN THE MATTER OF the Trustee  
Act and the Mortmain and Charit-  
able Uses Act.

Upon the presentation of a Petition presented to this Court, on Tuesday, the 10th day of April, 1913, by A. C. McMaster, Esquire, Counsel on behalf of the Northern Ontario Fire Relief Committee, for an order disposing of the \$19,221.72, stated to be balance of the moneys in their hands known as the Northern Ontario Fire Relief Fund, in the presence of H. E. Rose, Esquire, K.C., Counsel for the Corporation of the Township of Tisdale, for the Dome Mines, Ltd., for the South Porcupine Board of Trade, and for the Corporation of the Township of Whitney; S. A. Jones, Esquire, K.C., for the Corporation of the Town of Cochrane, for the Cochrane Board of Trade, and for the Cochrane Hospital Board; J. B. Holden, Esquire, for the mine owners at Porcupine; and J. R. Cartwright, Esquire, K.C., Deputy-Attorney-General, upon hearing read the said Petition and affidavits of John McClelland, R. S. Gourlay, A. St. Léger Trigge, Alexander Laird, Otto Thorning and Percy Arthur Robins, filed, and the exhibits therein referred to, and the cross-examination of the said John McClelland upon his said affidavit, and upon hearing counsel aforesaid, and after one enlargement of this application,

1. THIS COURT DOTH ORDER, that the Trustees pay to the Official Guardian \$200.00 to be expended in further relieving Mrs. Wm. Gohr, the widow of one of the fire sufferers.

2. THIS COURT DOTH FURTHER ORDER, that the sum of \$19,221.72, now in the hands of the said Committee, less the sum of \$200.00 to be paid to the Official Guardian, as aforesaid, and less the costs hereinafter



mentioned, be divided equally between the Porcupine Mining Division and the District of Cochrane, the sum of \$1,000.00 already in the hands of the Local Committee at Porcupine to be regarded as part of the one-half share to be paid to the Porcupine Mining Division, and the sum of \$300.00, the value of certain hospital material already in possession of the said District of Cochrane, to be regarded as part of the one-half share to be paid to the District of Cochrane, such funds to be applied in establishing a hospital at or near the Town of Cochrane and a hospital at some place in the Porcupine Mining Division to be agreed upon by the Councils of the Townships of Whitney and Tisdale and the Municipality of Timmins, and approved by a Judge in Chambers and, in event of disagreement, to be determined by a Judge in Chambers, to be used for the care of the indigent and unfortunate in the said Mining Division, upon reasonable terms, the title thereto to be vested in a Board of Trustees or in the Municipality, and the said funds shall be paid to such corporation, trustees, or other parties, and in such manner as may be satisfactory to the Attorney-General, but no part of the fund shall be paid over until satisfactory provision is made by the respective Municipalities for the furnishing of a free site and for adequate maintenance, such free site and maintenance to be secured and guaranteed in such way as shall be satisfactory to the Attorney-General.

3. AND THIS COURT DOTH ORDER, that the said Trustees be relieved and discharged with respect to all liability with regard to any moneys dealt with under this order, save the liability to deal with them as herein directed.

4. AND THIS COURT DOTH FURTHER ORDER, that the costs of all parties of and incidental to this application be paid out of the said funds forthwith after taxation, those of the Trustees being taxed and paid as between solicitor and client, as also the Trustees' proper costs incurred in the course of the administration of the trust.
