General exports (G) comprise all three categories and in the general trade system, the sum of (b) and (c) may be tabulated as re-exports. Special exports (S) comprise categories (a) and (c). Semi-special exports (Si) are defined to equal national exports, i.e. category (a). 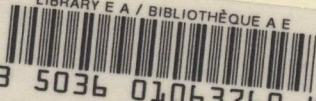
