# CONSTITUTION AND BY-LAWS.



## ARTICLE I.

### NAME.

The Club shall be known as the "TACHÉ HILL SLIDING CLUB."

## ARTICLE II.

### COLORS.

The colours of the Club shall be cardinal red and light blue.

## ARTICLE III.

### COSTUME.

The Costume of the Club shall be: Tuque light blue with band of cardinal red, blanket coat cardinal red with light blue piping, CAPUCHON lined with light blue, blanket trousers with light blue stripes, stockings and sash light blue.

## ARTICLE IV.

### THE BADGE.

The members badge shall be selected annually by the Executive Committee and shall be furnished by the Treasurer to each member only on payment of full seasons dues. The privileged members or ladies badge furnished by

the Secretary shall also be selected annually by the Committee and shall be of a different color to the members badge and will admit the recipients to the privileges of the Hill at all times during club hours. When using the Hill, badges must be worn in a conspicuous place and are non-transferable and if used by any other than the rightful owner they shall be confiscated.

#### ARTICLE V.

#### MEMBERS.

The Club shall be composed of Honorary Life, Honorary, Active and Privileged members

#### ARTICLE VI.

#### OFFICERS.

The officers of the Club shall consist of a President Vice President, Secretary, Treasurer and a Committee of eight members ; all officers to be *ex-officio* members of the Committee ; all to be elected at the annual general meeting by ballot and to constitute the Executive Committee of the Club to whom shall be intrusted its general management. In Case of a vacancy occurring in any office the Committee shall elect a member of the Club to fill the vacant office.

#### ARTICLE VII.

#### QUORUM.

For all meetings of the Club 8 members shall form a quorum For meetings of the Executive Committee four members shall form a quorum, one of whom must be an officer of the Club.

ARTICLE VIII.  
CANDIDATES.

Every candidate must be proposed and seconded at a meeting of the Committee. Voting shall in such cases, be by ballot, two black balls being sufficient to reject a candidate. No candidate who has been elected shall enjoy any privilege of the Club until his contribution shall have been paid and he receives from the Treasurer a certified membership card which will admit him to the Slides.

ARTICLE IX.  
SUBSCRIPTION.

The entrance fee for an active member shall be \$1.00 and annual subscription \$4.00. Every member shall pay into the Club funds the sum of \$2.00 on or before the 1st December, and \$2.00 on or before the 1st January annually. The name of any member seven days in arrears of his contribution shall be brought before the Committee by the Treasurer. On or before the 1st Monday in January the Secretary shall notify all members in arrears (quoting this rule) and one week subsequent to that day the committee may have a list of members, in arrears posted in the Club house for the space of one month; and thereupon it shall be optional with the committee to strike off the membership roll, without further notice the names of all those so posted.

ARTICLE X.  
HONORARY MEMBERS.

Qualification for Honorary membership shall be election by the Committee. There shall be no specified fee

for honorary members it being optional with themselves as to the amount they may desire to contribute.

#### ARTICLE XI.

#### HONORARY LIFE MEMBERS.

Qualification for Honorary Life Membership shall be election by the Committee and the payment of a fee of \$10.00.

An Honorary member, on contributing \$10.00, becomes *de facto*, an Hon. Life Member.

#### ARTICLE XII.

#### PRIVILEGED D MEMBERS.

Members have the privilege of introducing as (Privileged Members) any ladies residing in Ottawa and both ladies and gentlemen non residents, invitations for whom must be obtained from the Secretary, it being desired that no blank forms be issued to members.

#### ARTICLE XIII.

#### PRESIDENT.

The President shall have general supervision over all matters affecting the Club and its interests. He will preside over all the meetings of the Club and its Committee ; and shall see that the Constitution and By-Laws are strictly adhered to.

#### ARTICLE XIV.

#### VICE PRESIDENT.

The Vice-President shall assist the President in his various duties, and in his absence shall exercise his authority.

## ARTICLE XV.

## SECRETARY.

The Secretary shall carry on all correspondence on Club matters under the direction of the Committee, and shall keep a record of all General and Committee meetings etc.

## ARTICLE XVI.

## TREASURER.

The Treasurer shall receive all subscriptions, and shall keep an accurate account of the Club finances. He will make no payments from Club funds without the authority of the Committee, and on payment by members of December dues he shall issue to each a membership card, which shall be available for that month only, and on payment of seasons dues in full, he shall issue to each a season membership card and an active members club badge, only to be furnished on payment of full seasons dues.

## ARTICLE XVIII.

## CONSTITUTION.

A copy of the Constitution and By-Laws shall be supplied by the Secretary to each member of the Club.



## ARTICLE XVIII.

## AMENDMENTS.

This Constitution may be altered or amended at any meeting of the Club specially called for that purpose, or at the Annual Meeting, by a vote of two-thirds of the members present.
