This made it neces-"ary to try the case over again this June. Missouri has been hot on the trail of the bucketshops for a long time. The St. Louis concerns have been practically put out of business by Governor Folk, who insisted upon enforcing the law passed by the last legislature of Missouri, pro-viding a term of five years in the peni-tentiary as a punishment for men con-victed of conducting bucketshops. Time was when these fraudulent grain and stock marts were as thick in Chicago as mushrooms in spring, but today it is de clared twenty would be a fair estimate of the number. In the last year only two have been located and prosecuted. A crusade against the others is impending. It is claimed by those who are familiar with the situation that just now the Chi-cago bucketshops have a "king," who pos-sesses a strong political pull, and exacts a heavy tribute from every concern of this sort in the city, on penalty of having them raided and closed up if they fail to add to his graft-pile. It is estimated by those who have stu-died the situation closely that today there probably are 1,000 bucketshops operating throughout the United States, whose busi-ness having their headquarters in Cincin-nati. These, however, either are under indictment or have been forced to quit business on account of the recent crusade there.

No other form of gambling has been more disastrous to the public than "buck-etshopping," because the likeness of a bucketshop in every outward feature to regular and reputable commission houses makes it the most insidious. A bucket-shop is a gambling device with all the paraphernalia of a brokenage house. The transactions are wagers, mere gambling under the guise only of commercial trans-actions. Like the lottery and the faro bank, the bucketshop finds its profits in the losses of its customers. As a matter of fact, all other forms of gambling or swindling are commonplace and compara-tively innocent when compared with the bucketshop, which has caused more wrecks, more dismantled fortunes and more suffering by the innocent than any other get-rich-quick fraud. Forgery, em-bezzlement, suicide, are its products. Bo ingeniously have the fake concerns shammed the legitimate methods of boards of trade, where the delivery of commodities dealt in is required under a penalty of dismissal, that even the so-phisticated have been fooled. It is a com-mon practice for the big bucketshop con-erns to maintain "exchanges," where ired employes of the concern pretend to bords of trade, where dagerous. All the quotations are stolen by means of wire itaping. It is impossible for the bucket-hops to secure these market prices from a legitimate board of trade, so they are compelled to steal them by hiring thieves to tap wires, or fake them up in some way. For example, if a customer "buys" 1,000 bush-els of May wheat he puts up a margin based on the last quotation. If this was \$1 per bushel he would put up \$10, or 1 cent per bushel, in order to make the deal. He has bought no real wheat or stock; he has made a bet. The shop has no interest in this, except to check the \$10 up to its profit. If "wheat goes down" three-quarters of a cent the mar-gin is wiped out, for the bucketshop charges one-fourth of a cent "commis-sion." On the other hand, if wheat should advance one cent per bushel, the customer would make only three-fourths of a cent—the other one-fourth going to the sham "broker." Wheat has to ad-vance a cent and a quarter before the cus-tomer can make a cent profit; while on ne other hand, if it drops only three-ione of the 'sure thing' games.
