## THE GILCHRIST SCHOLARSHIP

Won by Mr. Walter O. Murray, A University Graduate.

The gratifying intelligence was received here Monday that Mr. Walter O. Murray, a graduate of the University of New Brunswick, had won the Gilchrist scholarship.

In this city, in 1886, at a dinner given in his honor for having won the Gilchrist scholarship, Mr. A. W. Duff said that "three years later, when the competition would again be open to New Brunswickers, he hoped to have the pleasure of welcoming to Edinburgh, another graduate of the University of New Brunswick, and now comes the word that Mr. Murray, a first cousin of Mr. Duff, has this year won the prize. Mr. Murray is son of Dr. Murray of St. John's, Kings County, and is now 21 years of age.

He was prepared for college at the Fredericton College School, from which he graduated four years ago at the head of the class, winning first place in the English, classical and modern languages.

His Freshman year at college he won the Marquis of Lorne's medal for classical, and graduated in 1890 at the head of the class, with honors in mathematics and winning the mathematical Scholarship, the Alumni gold medal for Latin essay, and the Governor General's gold medal for his essay on "The History of the University of New Brunswick."

He was successful in obtaining a Grammar School license. In the competition for the scholarship Mr. Murray stood third on the list and led the contingent of five from Canada who tried the contest, but four of whom succeeded in getting on the honors list. Mr. Murray's history reflects great credit on his own ability and application as a student and also on the New Brunswick University.

During the last three years, with two terms of five months each in the year, the school turned out 110 teachers who had been fully equal to the demand. In view of the fact that the province was well supplied with teachers, it was decided to change the term to nine months, in order to afford better opportunities for the students training for the profession. It was felt that a small number came to the school who would be dismissed unsatisfactorily, but these were dismissed with the large number of students in attendance. He himself had placed the number at one hundred and fifty and it had only fallen five short. It would be noted that every county was
