# THE FIFTIETH ANNUAL REPORT

## OF

### THE MONTREAL GENERAL HOSPITAL.

The Annual Meeting of the Corporation of the Montreal General Hospital was held on the 21st May. Mr. T. M. Taylor was called to the Chair, and the Secretary read the following report :—

Gentlemen of the Corporation of the Montreal General Hospital, in conformity with long established custom, I have now the honor of submitting the Annual report—and it is the fiftieth—of the proceedings of the Board of Governors during the year which terminated on the 30th April last, together with a brief sketch of the history of the Hospital since its foundation.

The amount received as “income” during the year has been \$32771, 68, the sources of which will be found in the Treasurer’s “Financial Statement” appended to this report. It will be noticed that \$4000 of this sum belong to the income of 1871, and were included in last year’s report, although they had not been received until after the closing of last year’s Accounts. This will reduce the proper income of the year to \$28771, 68.

The ordinary expenditure of the year has been.....	\$22413.13

This is the first time for many years that the receipts have exceeded the expenditure, and the circumstance arises not so much from the fact that the outlay in the past year has been \$2592 less than in 1870-71, but that the collections in the city have been very good, reaching the handsome sum of \$11346.28 as against \$7390.68 in the year immediately preceding, or about fifty per cent. more.

While this large increase in the Annual Collections is chiefly due to the generosity of the citizens and the larger number of collectors who kindly called for subscriptions in the several wards, not a little of it is owing to the personal interest which Mr. R. Muir, the Chairman of a Committee on Collections appointed last year, took in procuring gentlemen to perform the work of collecting, in which work he himself participated.

Another pleasing feature is the increasing interest manifested by the employés of the manufacturing and other establishments of the City in the support of the Hospital; their contributions during the year exceeding those of 1870-71 by \$482.73.

In the list of churches in which collections have been taken up in aid of the Hospital will be found the names of five situated in several parts of the country, a gratifying evidence of the favor in which this charity is held outside of Montreal.\*

The number of in-door patients treated during the year has been one thousand five hundred and ninety-five (1595), which is an increase of thirty-six over that of the year immediately preceding it, and of two hundred and three (203) over that of 1869-70:

This year has been marked by one of those severe visitations of small-pox which have been unfortunately of too frequent occurrence in this community. Although the actual admissions to the small-pox hospital have fallen short of the admissions in 1868-69 in the ratio of 114 to 150, the mortality of the disease during the present visitation has exceeded that of any year for the past twelve years as well as their average mortality.

So that while the average mortality from small-pox during the year just expired has been 1 in 3.45, it had been only 1 in 10.3 in the preceding twelve years. Unfortunately during last winter a number of the patients in the Hospital proper—for the small-pox wards are in a detached building exclusively devoted to small-pox cases—were attacked with that virulent disease. In consequence, the Committee of Management asked the views of the Medical Board of the Society as to the propriety of excluding small-pox patients from the present Hospital buildings. The Board unanimously recommended that step in the interests of the public and of the patients in the general wards, on the ground that (owing to the proximity of the Small-pox Hospital to the main building, to the want of a kitchen and lavatory in the building devoted to small-pox, and to the circumstance that the subjects of small-pox presented themselves along with the other patients for admission to the Hospital) it was found impossible altogether to prevent communication between the two establishments. The views of the Governors being quite in harmony with those of the Medical Board, it was resolved at a special meeting to act upon them and Messrs. Ferguson, Wm. Lunn, and T. M. Taylor were nominated a Committee to wait upon the Mayor and Corporation of the city with the view of inducing them to provide an hospital for small-pox patients exclusively, as is done in other cities of less wealth and magnitude than ours. It is a matter of great regret that as yet no decision has been arrived at; the Governors of the General Hospital are ready to co-operate with the City authorities in providing and administering an institution so necessary to the safety of the lives of the citizens at large as well as of the sick poor, and to the reputation of the city, as a Small-pox Hospital.

Last November a Committee was appointed to revise the By-laws of the Society, and, in consequence, several important alterations of and additions to the existing By-laws have been passed by the Governors, and will be to-day submitted for the approval of the Corporation.

It is matter for congratulation that while the list of Life-Governors has not been reduced by death during the year, it has received an accession of sixteen new names: Sir A. T. Galt, Messrs. Henry Archbald, James Coristine, T. A. Dawes, J. J. Day, Q.C., James Ferrier, jun., A. F. Gault, J. H. Joseph, Robert Linton, Edward Mackay, Robert Nicholson, Wm. Watson Ogilvie, Wm. The building for a Children's Hospital, promised in the last Annual Report to be called the "Morland Wing," in commemoration of the late Mr. Morland, will be erected this year, as Messrs. Thomas Cramp and George Stephen have lately promised the Committee of Management \$10,000 for that purpose, inclusive of the Morland legacy of \$1000.

It need scarcely be observed that the maintenance of the Children's Hospital will very considerably reduce the surplus in the Treasurer's hands, and that it will be altogether expended when the extensive repairs now required in the basement of the building, and certain improvements in the drains and the heating apparatus necessary to the sanitary condition of the Hospital, have been effected.

It affords the Committee of Management pleasure to testify to the faithfulness with which the Attending Physicians, the Resident Medical Officers, the Steward, Matron and Nurses have performed their respective duties. The thanks of the Society are especially due to the following gentlemen who, as collectors, have advocated the claims of the Hospital in the several wards: Messrs. W. B. Cumming, James Rose, Robert Muir, J. J. Arnton, R. W. Shepherd, T. M. Bryson, N. B. Corse, C. D. Proctor, George Rogers, Wm. Henderson, John Phelan, A. W. Hood, John McDougall, Geo. S. Brush, J. G. Davie, Jas. Lillie, Adam Stephenson.

As this is the *fiftieth* year since the Society of the Montreal General Hospital obtained its Royal Charter, it may not be inappropriate to give in this its Fiftieth Annual Report a short sketch of the history of the institution, more especially during the earlier years of its growth.

From the records of the Society it appears that in 1819, owing to the increase in the population of the city and the great influx of immigrants from the United Kingdom, some of whom suffered from contagious fevers and other diseases not admissible into the Hotel Dieu nunnery, that institution was found inadequate to the reception of the indigent sick, and in consequence four rooms were hired in a house in Chaboillez Square as a temporary hospital, by a number of philanthropic persons, conspicuous amongst whom were the Rev. John Bethune, the Rev. Henry Esson, and Staff-surgeon Dr. Blackwood. After a year's experience of the new institution, it was thought highly desirable to erect a building which might give permanency to the establishment, and provide for a larger number of persons.

Accordingly, on the 25th April, 1820, a meeting of subscribers for the establishment of a General Hospital in the city was held in the Court House, the Hon. John Richardson in the Chair, when the following gentlemen were unanimously elected Managers of the institution: Samuel Gerrard, Hon. J. Richardson, J. W. Clarke, F. W. Ermatinger, James Leslie, George Garden, T. McCord, Robert Gillespie, David Ross, Thomas Blackwood, Horatio Gates, J. Frothingham, J. T. Barrett, John Try, Thomas Phillips, John Fisher, sen., Robert Armour, W. Millar, George Moffatt, Jabez DeWitt, Jacob DeWitt, James Woolrich, Thomas A. Turner, H. T. Driscoll, John Molson, sen., S. Sewell, W. M. Porter, Thomas Torrance, George Auldjo, John Torrance, B. Gibb, Wm. Gray, Alex. Skakel, Andrew Porteous, Esqs.; Samuel Gerrard was appointed Treasurer, and Dr. Christie, Secretary; Drs. Robertson, Caldwell, Blackwood, Farrenden and Christie were elected Medical Attendants.

The next day Isaac Winslow Clarke was elected President, and the Hon. John Richardson, the Rev. John Bethune, the Rev. Henry Esson, the Rev. Mr. Hick, Thomas Blackwood and Horatio Gates, Vice-presidents for the year. A "Sub-committee" "to provide for and superintend the household economy of the institution" was appointed, consisting of the following persons: Messrs. John Frothingham, J. T. Barrett, J. Try, J. Fisher, Jacob DeWitt, Jabez DeWitt, John Torrance and Alex. Skakel, and a short code of rules and regulations was agreed upon. A moderate-sized house on the north side of Craig street, two doors east of DeBleury street, was hired as a temporary building, and to it the patients were removed from the primitive institution in Chaboillez Square.

In November, 1820, the land upon which the Hospital now stands, and which was known as Marshall's nursery, was purchased, and the citizens of Montreal, with a liberality that gave promise of future munificence, immediately subscribed over £2000 to erect a suitable permanent building to be called "the Montreal General Hospital." It is noteworthy as indicating the catholicity of feeling which characterized the Montreal Protestants in those days (for the money was mainly subscribed by Protestants, and the enterprise in its inception, prosecution, and sustentation appertained to Protestants) that the Institution was devoted to "the reception of patients of all diseases usually admitted into such hospitals in Great Britain, without distinction of religious denomination."

6th June, 1821, and it was ready for the reception of patients the following May. It was considered capable of receiving 70 patients, and 421 were treated within its walls the first year of its existence. The building and land cost £5856, and a debt of £3688 remained upon it, which was advanced by three gentlemen, the Hon. John Richardson, Hon. Wm. McGillivray and Samuel Gerrard, Esq.

In January, 1823, His Majesty George the IVth granted a charter to the institution, and thereby secured it upon a permanent basis. At this early period of its history, the Hospital was chiefly maintained by the subscriptions of the citizens, by collections in the Protestant churches, and by a small annual grant from the Provincial Legislature. During the first five years, the sums subscribed by the citizens ranged from £416 to £700 per annum, amounts which compare favourably with the handsome subscriptions now received, when the comparatively small population of those days is taken into account. In the year 1831 an important event in the history of the institution occurred. The number of patients admitted annually had been steadily increasing so that the building had become inadequate to their accommodation, and the death that year of the Hon. John Richardson (who had from the beginning of the benevolent work taken an active personal interest in its promotion, and had been President of the Governing Body from 1821 to 1831) furnished the occasion for extending its capabilities of usefulness.

The governors were so sensible of the services rendered to the Hospital by their President, that they resolved to record their recognition of those services by erecting a permanent memorial to commemorate them. At first it was proposed to erect a monument in the Hospital, but afterwards, on the motion of the late Andrew Shaw, it was unanimously decided to perpetuate the memory of their distinguished colleague by building a wing to the Hospital to be called the Richardson wing—than which no memorial could have been in greater harmony with the character of the man. The following extract from the report for the year 1831–32 deserves to be inserted here:—

“To conclude this report without noticing the loss which the institution has sustained by the death of the late Hon. John Richardson, its first President, or rather its father, would be highly improper. To enumerate to many of the members all that he did for the Hospital would be unnecessary, and would extend this report to too great length. A few facts therefore shall only be stated. He was present at the first meeting held for its erection, and his name stands first in the list of

subscribers, and to the interest he took in carrying the design into execution the inhabitants of Montreal are mainly indebted for an institution of so much public utility. He was elected its President, and continued to perform, with paternal care, the duties of that office while he lived, and was never absent from a meeting of the Governors except when his legislative duties called him to Quebec. When the funds of the Hospital were low or totally expended, a sum of money was frequently given, as from "a Friend" by the hands of this respected individual."

In a short time the sum of £2232.14.7 was collected for the Richardson Memorial Fund, of which £1885.1.3 were contributed by Montreal, £220 by the city of Quebec, and £127.13.4 by friends in Upper Canada. The Richardson wing was completed in 1832, and towards the close of that year two of its wards were occupied by convalescent patients. It proved a very necessary addition to the institution, for, strange as it may appear now, 1853 in-door patients were treated in the Hospital in the year 1831-32, before the Richardson wing had been built, and 1717 in the year 1832-33, which was the first year of its occupation; and these numbers have been but twice attained since, viz., in 1842-43, when the in-door patients numbered 1735, and in 1847-48, when they reached 2061.

The Hon. John Molson, who had been Vice-president of the institution from 1823, succeeded to the office of President in 1831, on the death of the Hon. John Richardson, and held it till his own death in 1835, when Samuel Gerrard, Esq., was made President, and John Molson, Esq., Vice-president. In 1856, after twenty years of faithful service, Mr. Gerrard resigned the Presidential Chair on the ground of advanced age, and the Hon. John Molson was promoted to the vacant seat, while the Rev. Dr. Bethune, Dean of Montreal, was for the second time elected Vice-president.

Perhaps the next event worthy of notice is the death of Alexander Skakel, LL.D., who had been the indefatigable Secretary of the institution and one of its most influential friends from the year 1823 to 1846. Not satisfied with his efforts in its behalf during his life, he bequeathed to the Hospital the whole of his immoveable property, which proved a valuable addition to its Endowment Fund.

The year 1848 was a memorable one in the history of this institution. At a special meeting of the governors in March of that year, the much respected widow of the late Hon. Chief Justice Reid communicated through her friend the late Hon. Peter McGill her desire to build

Mrs. Reid regarded such a building not only as the noblest monument that could be erected to the memory of her beloved and venerated husband, but as an appropriate realization of his oft-expressed wishes and sentiments. This munificent offer was of course accepted by the Governors. A Committee was appointed to superintend the immediate erection of the said wing, and by a deed executed on 30th May, 1849, the benevolent lady conveyed to the Society the now well-known Reid wing, the first and as yet only portion of the building provided by individual munificence.

In the year 1859, some amendments were made to the Original Charter, the chief of which were the following: Under the original, members of corporation were persons who had given a donation of £5 and continued to pay £1 annually towards the support of the Hospital. Under the Amended Charter annual contributors of \$5 became members of the Corporation, and the qualifications of Elected Governors were reduced so as to include annual contributors of \$12. The quorum of Governors for the transaction of business was reduced from seven to five, and instead of thirteen Elected Governors chosen annually, the number was fixed at twelve, of whom six were to be elected for two years and six for one year. The amount of real estate that the Corporation might acquire and hold, and the time that it might hold it, were fixed, and a provision was made for the investment of the proceeds of the sale of real estate and of all monies appertaining to the Permanent Fund.

A measure highly conducive to the sanitary welfare of the Hospital as well as to its appearance was effected in 1866. Some objectionable buildings situated immediately in front of the Hospital had for many years proved disagreeable to the Governors. The property was purchased, the building removed, and the vacant ground added to that previously in possession of the Society, the effect of which was to secure a large open square in front of the institution capable of providing an ample supply of fresh air to the inmates. The cost of this property (\$4800) was generously borne equally by Mr. Wm. Molson and Mr. J. G. Mackenzie.

It had long been felt desirable by the Governors that a separate building for the treatment of the more dangerous contagious diseases should be erected in connection with this charity. In 1867 it was resolved to build one in the rear of, but quite detached from, the Richardson wing; and in May, 1868, the Fever Hospital, a brick building capable of receiving 40 ordinary patients and possessed of several private wards for

private patients, was ready for occupation. It cost \$10,674, but it is pleasing to be able to add that Mr. William Molson again spontaneously gave proof of his interest in the sick-poor, this time by the munificent donation of \$5000, or about half the cost of the Fever Hospital.

It was about this time that an effort was made by the Governors to obtain a large addition to the Endowment Fund, which, although not successful, resulted in the following handsome contributions to that fund.

The year 1869 is memorable for the death of Mr. John Redpath, whose devotion to the welfare of the Hospital was well known to and duly appreciated by the Governors. For twenty-two years he was a faithful member of its Board of Management, and for ten years the President of its Board of Governors. In the latter office Mr. William Molson became his successor. In the year following the institution was again deprived by death of one of its active friends. Although but a comparatively short time connected with the Hospital the late Mr. Thomas Morland became so well known to the citizens as one of its most zealous managers that, as has been previously stated, some of his friends have lately raised a memorial fund for the purpose of making some useful addition to the Hospital building, as an appropriate commemoration of his valuable services in the interests of the institution.

Having thus far briefly glanced at the more important facts in the history of the foundation, growth and administration of the Hospital, it may be well to notice the work it has done.

During the 52 years of the existence of the Hospital which terminated in April, 1872, the number of patients that have been treated within its walls has been 55,948, or an average of 1076 patients annually. In addition 192,948 applications for out-door relief have been attended to. A vast multitude of sick and suffering persons truly! But who can estimate the amount of suffering and sorrow represented by these figures, or the relief comfort and solace afforded by this invaluable charity to these 56,000 sick persons and through them to their relatives and friends?

But the benefits which have been conferred by the Hospital may not be estimated by the mere number of the patients treated within its walls. Let it be remembered that when it was founded, the only other hospital in the city, the venerable Hotel Dieu, did not admit persons suffering from contagious diseases, and the "General Hospital" was established to meet that want in benevolent enterprise as well as for other objects.

Indeed by far the greater proportion of the diseases treated in the Hospital up to the year 1849 consisted of fevers, as will appear from the following statement.

When it is borne in mind that about one half of these fever-cases were of the variety called Typhus, one of the most contagious diseases, it may be imagined perhaps what the citizens of Montreal, and people of this country generally, owe to this institution which provided for immigrants and others suffering from fever an asylum in which they might be separated from the rest of the inhabitants. Those who remember the scenes of 1847 in Montreal and throughout Canada will be able to appreciate the force of these remarks. At that time, in spite of quarantine regulations below Quebec, fever sheds at Point St. Charles, and our Hospital, its capacity enlarged by sheds erected on the ground so as to hold 250 beds, Typhus fever spread amongst the citizens and more or less along the great lines of travel throughout the country, and many clergymen, nurses, physicians, students and benevolent persons, besides multitudes of the general public, fell victims to the disease.

It is a matter of some surprise how the institution in its earlier days, before the Reid wing and the Fever Hospital had been built, received into its wards so many patients as 1600, 1700, 1800 per annum, and in one year 2061. The largest number treated in one year since then has been in the last year (1871-72), when 1595 patients occupied its beds. In explanation of this it may be stated that, owing to original defects in the water-closets of the Hospital, it was found necessary

some years ago to construct new ones upon a larger scale, with bath-rooms attached, and for that purpose two small wards, and the House Surgeon's room, all in the body of the house, had to be sacrificed. Further, it was thought best to give two of the wards in the same building for Nurses' dormitories, another to the Assistant House Surgeon, and a fourth for a patients' reading-room, so that there remain but two wards for sick persons in the main building.

It has been already shewn that, in the earlier years of the Hospital's history, fever patients, who were chiefly immigrants, constituted a large proportion of the admissions. Fortunately, since 1848, fever has not been largely prevalent either amongst immigrants or citizens, and consequently there have been fewer sick seeking admission. During the last 12 years, however, there has been a steady and considerable annual augmentation in the number of in-door patients, due chiefly to the growth of the population of the city, and the augmentation would have been greater had not the Committee of Management, because of the limited resources of the charity, endeavored to limit the admissions.

It is natural in a retrospect like this to look over the list of names of the men who first gave form and life to an institution which has proved so useful, and has gained such a hold upon the community, with a view of learning how many of these have survived the flight of half a century. Six gentlemen out of the original founders and Governors of the institution are still living amongst us, the Very Reverend the Dean of Montreal, the Honorable James Leslie, and Messrs. William Molson, W. Lunn, Archibald Ferguson, and John Mackenzie: and if they are not entitled to a Hospital "Golden Wedding," they are certainly deserving of the congratulations and thanks of this Society as men whom "it delighteth to honour." One of these gentlemen is now our President, the third of his family to occupy that office, and two of them, Mr. Lunn and Mr. Ferguson, are still active members of the Committee of Management.

Of that Band of Brothers who in the early days of the Hospital performed their part of the charitable work to which this institution is consecrated, but one remains. Drs. Blackwood, Christie, Farrenden, Stephenson, Robertson, Caldwell, Holmes, Loedel, Lyons, Diehl, Vallée, Racey, Bruneau, Hall, Crawford, and Sewell, have long passed away—Dr. Campbell alone remains. He has served the Institution as an attending physician from 1835 to 1854 and since then has continued to render it good service as a "Consulting Physician"; and long may he be spared to do so.

It is a noticeable feature in the history of this institution that all the great additions made to its buildings have been erected as monuments in memoriam of some deceased friend of the institution. Still more noble would it be were this Corporation, in the name of the wealthy citizens of Montreal, to resolve at this its Annual Meeting to erect an entirely new set of buildings in accordance with the latest scientific and economic improvements, upon some suitable site, where it should stand as another monument amongst the many now standing, of the benevolence and munificence of the inhabitants of this prosperous city.
