## EDUCATIONAL.

The Government have made an excellent choice, in the appointment of Wm. Crockett, A. M., as Chief Superintendent of Education, one which will meet with the approval of the people generally. Mr. Crockett, who is a native of Scotland, came to this country in his youth. He spent a number of years in the Northern part of New Brunswick—in St. John's and Northumberland—where as a teacher he gave evidence of more than ordinary ability, possessing in addition to a thorough education, indomitable perseverance, the power to grapple with and overcome the difficulties incident to the profession, and other traits of character which have made him a success in his career, which has been a rising one from the outset. Possessing eminent qualifications as a teacher, it was no surprise to his friends when he was chosen Principal of the Provincial Normal School at its founding, in which position he has more than met the expectations of his friends, winning from Dr. Rand, the then Superintendent of Education in the province, as well as the respect and esteem of the hundreds of pupils who have attended that institution. He has filled other educational positions at the Capital, having been examiner of the City Schools in Fredericton and also examiner for degrees in the University. The success achieved in the various positions held in the past is an assurance that as Chief Superintendent of Education in this Province, Mr. Crockett will prove the right man in the right place. Being thoroughly practical he will doubtless discover the changes necessary to make the present educational system still more successful than it has been. That this can be done there is no doubt whatever, and Mr. Crockett will rise in public estimation when he sets to work to make the necessary changes. One of the first changes we hope to see him make is to strike from the list of books now in use the bulky and hard-to-be-comprehended volume devoted to Canadian History, and substitute in its place a comprehensive hand-book capable of being mastered by the great majority of school children. Mr. Crockett enters upon the duties of his new position with the best wishes of his friends in the Province and elsewhere.

The new Principal of the Normal School is Eldon Mullin, A. B., (son of the late Joseph Mullin, also a teacher), a native of Cambridge, Queens County, N. B. attended the University in 1866-67, but was unable to finish his course there, owing to the death of his father. He was one of the teaching staff in Kings County for some time, and proved a successful instructor, the ability displayed by him receiving the recognition of the Government, who in 1879 appointed him Inspector of Schools for District No. 7, embracing York and a part of Carleton County. Being a diligent student, he continued the study of the University Course, and in 1881 received his degree.

Of his successor we can speak from personal knowledge. George W. Mersemer, A. B., is the new Inspector for District No. 7, a native of Doaktown, Northumberland Co.—a Northern boy who has acquired himself most creditably in the honorable profession he has chosen. As a teacher he has been eminently successful, and in all his engagements fully meeting, if not surpassing the high yet reasonable expectations of his many friends and well wishers. Thoroughly practical, and enjoying the advantages of a fine intellectual training, he enters upon his work with a determination to succeed, and those for whom he has labored, as well as many who have witnessed his work in the school room, will bear cheerful testimony to his worth as an instructor of the young. We unite with many others in congratulating friend Mersemer on his new position, and trust that he will be able to make many successful representations made by this Union, that the Local Administration has decided to notify the Messrs. Nelson, who publish the series of Readers, etc. now in use in the public schools, that if arrangements are not made to have the printing and binding done in this Province, the Government will send itself called upon to have a new series prepared.

Nelson will hardly consent to such an arrangement, the probabilities are that a new series of books, published in our own Province, and giving considerable employment to printers and book-binders, will be the order of the day in the near future. We are glad to see the *Telegraph* supporting this measure of protection, which, if carried out, will be mutually advantageous to publishers and printers and the public generally.

means of knowing what any of the letters—excepting the one registered—contained. Arrived at Mr. Alier's I did not go into the department where letters are sorted, I went into his store merely and, on invitation by him, went into what I took to be his private office in connection with his business.

Nothing was there stated in my presence or hearing in reference to any letter. It is therefore not true that I adopted a false statement, nor saw the large envelope you speak of. It may or may not have existed. I know nothing of what took place between the Sheriff and Mr. Alier in his office.

You make no charges against me as to the Little Shipigan Post Office where it is alleged that registered letters were taken. I will simply state that I was not in it at all.

Engineers at Mayague have me-  
morandum of the bridge erected

**Spurious Issues of the Union**  
**Bank of P. E. Island.**

Among the counterfeit Canadian  
currency that has been made, says the  
Telegram, there are two specimens  
on the Union Bank of P. E. Island,  
Charlottetown. One of these is in the  
old issue, of the denomination of \$25,  
being a photograph of a lithograph.  
This was the kind of notes found on  
Lefrere, which caused his sentence to  
the Penitentiary for a few years  
ago. Very few of them are met with  
now. More recently there has been  
another counterfeit on the same issue.  
Letter A. It is a poor specimen, but  
despite this, many have been deceived.  
It is thus described:—

Letter A. Dated March 1st, 1875,  
bank of P. E. Island, similar to an in-  
terior wood cut. Easily detected at  
sight by careful holders of money,  
but very liable to deceive the careless.  
Fully one quarter inch shorter than  
the genuine bills. "British American  
Bank Note Co., Montreal," is en-  
tirely omitted in the centre portion of  
the bottom border. The line "Dom-  
inion of Canada" over vignette en-  
graving of dog and wolf, is without any  
shading, which is also the case with  
the line "of Prince Edward Island,"  
and "on demand" beneath. Back of  
note bad and unlike genuine. Lathe  
work patterns very coarse. Title of  
banker omitted.

The first warning that such counter-  
feits had been made from a station  
on the P. E. Island, was the receipt of  
a letter from the London, Ontario, and  
north of Ontario, and there were  
a few floated, but where they came from  
it was impossible to learn. Then the  
counterfeiters were discovered, and the  
bank of P. E. Island was informed,  
but it will be revived again no  
doubt, when it is learned that speci-  
mens of the second edition of these  
counterfeits have been passed in  
Fredericton. It is considered that the  
counterfeits are not engravings but  
from etchings. These are all two  
dollars bills. Another specimen is a  
Dominion note raised from \$1 to  
\$2. There are very few of these  
believed to be in existence. Then it  
was found that these were on the face  
of the plate was changed, so that over  
the figure one, at the right and left of  
the front on the original, "one" was  
placed in Roman.

The American Company of Old  
Furniture, having been in the city  
last week, and completed the third  
revision of the Minor Prophets, and  
the notes were sent to England on  
the 10th inst. The English company will  
complete its work in January, and  
that the American company will not  
be behind in the extension of the  
revised Old Testament will be issued  
in the spring.

**Farm and Household.**  
**Floor Covering.**

A new process for covering floors  
is described as follows: The floor  
is thoroughly cleaned. The holes  
and cracks are then filled with paper  
putty, made by soaking newspapers  
in a paste made as follows: To one  
pound of flour add three quarts of  
water and a tablespoonful of grog  
alum, and mix thoroughly. The  
floor is coated with this paste, and  
then a thickness of manila or hard-  
ware paper is put on. This is al-  
lowed to dry thoroughly. The ma-  
nilla paper is then covered with paste,  
and a layer of wall paper of any style  
or design desired is put on. After  
allowing this to dry thoroughly, it is  
covered with two or three more coats  
of sizing made by dissolving half a  
pound of white glue in two quarts of  
water. After this is allowed to dry  
the surface is given one coat of  
"hard oil finish varnish," which can  
be bought already prepared. This is  
allowed to dry thoroughly, and the  
floor is ready for use. The process  
is represented to be durable and  
cheap; and, besides taking the place  
of matting, carpets, oilcloths, or like  
coverings, makes the floor air tight,  
and permits of its being washed.

Do Your Work Thoroughly.—  
This is especially necessary in farm  
work. Half-way work is little better  
than no work. When you undertake  
to exterminate thistles, or daisies, or  
quack grass, do it. Don't rest satisfied  
with trying and with partial suc-  
cess. Plough them under and keep  
them there by repeated ploughings.  
When you hoe a crop do it in such  
manner that there will be no living  
weeds left behind your hoe. Good  
work is the cheapest.

Mr. James Bell attributes his agri-  
cultural success to the habit of  
guarding against little leaks. For one  
thing, his stock consume or make  
into manure all his stalks and straw.  
In one Kansas farmer's words: "early  
autumn" sorghum cane there is a yield  
of 150 gallons an acre at forty cents  
a gallon. The seed is worth fifty  
cents a bushel for stock food at  
twenty cents a bushel for the acre.
