An Act to amend the Upper Canada Municipal Act of 1858.

HER Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows :

1. The three hundred and ninety-ninth section of the Act of the Parliament of this Province, intituled, *An Act respecting the Municipal Institutions of Upper Canada*, passed at the last Session of this present Parliament, is amended by striking out the words "other than the Division Courts, and for all officers connected with such Courts," and substituting therefor and adding the words following, that is to say: "including the Division Court for the Division in which such Court House is situate, and for all officers connected with such Courts; and it shall be the duty of the Township Councils to provide all necessary and proper accommodation for the Division Courts in the Townships respectively in which such Division Courts are held, and when such Divisions embrace more than one Township or parts of two or more Townships, then the amount which shall be rateably borne by such Townships respectively for which such Division Court is held, shall be fixed by the Judge of the County Court and the Warden and Sheriff of the County or Counties in which such Townships are situate, or any two of them."
