These figures show that wherever it is possible to employ more clerks, and increase salaries and expenses, it is done, and the country has to pay for the pleasure of having a Reform Government. The above figures are only a few items in the Supply Bill, as we cannot go through the whole list, but the total amount voted for ordinary expenses in 1875 was \$11,399,730.36, and in 1876, \$13,360,992.70, an increase of \$1,961,262.34.

What advantage has the country gained by the change of Government?

Are we more prosperous? Offering more inducements to immigrants to come and settle? Is capital seeking investment in the country? Read Mr. Agent-General Jenkins' letter to the intending emigrants not to come to Canada. Read the weekly list of insolvents and see if commercially we are more prosperous. No better index of the state of the country can be given than the monthly statements published in the *Gazette* of the receipts from customs and other sources. Unfortunately these show a most wonderful falling off. For July, August and September the receipts were \$5,312,451.44 against \$6,972,385.88 for the same period last year, showing a decrease of \$1,660,934.44. The expenditures for the same period in 1875 was \$6,402,554.89, and in 1876, \$7,008,427.14, showing an increase of \$1,605,872.25. The revenue decreasing and the expenditures increasing!

We leave these figures for the taxpayers' consideration, and think we are justified in asking "Whither are we drifting?"
