

TELEGRAPH NEWS.

OTTAWA, April 10. Whelan has been confined for a week, and a strong military guard has been placed on the goal where he is confined.

There is a rumor that P. Buckley has given a clue to facts that will convict Whelan.

London, 9th. Fenian trials which were to have commenced during the holidays have been postponed to 20th.

All doubts of the safety of Dr. Livingstone the African explorer, are now dispelled. Sir Frederick Marchmont, who received a letter from the distinguished traveller, which came by way of Zanzibar. Dr. Livingstone writes that he is in good health, that his journey of exploration has been successful, and that he will soon return to England.

The Grand Jury have brought bills of indictment against all the prisoners (except O'Neil) who were charged by the coroner's jury with complicity in the Clerkenwell outrage.

Montreal, 9th. At a meeting of the city Council this p. m. it was unanimously resolved that the funeral expenses of Mr. McGee be borne by the city, and that the Mayor be authorized to offer a reward of \$2000 for the arrest of the murderer.

The wife of Whelan was arrested last night at her residence, Alexander street.

The formation of a large manufacturing establishment here, disappeared suddenly last Saturday night. He was a well known Peelian proclivity, and is suspected of being implicated in the assassination.

At a meeting of the St. Patrick's Society, Mr. Devlin denounced assassination in strong terms. Resolutions were passed expressing sorrow and indignation at the crime, and heartily sympathizing with the widow. Other national societies passed similar resolutions.

London, April 10. The War Office is receipt of late despatches from the British Expedition in Africa, operating for the relief of the English captives. Gen. Napier Commander of the British forces reached Lat. 21.

The Abyssinian King, Theodoros, was at Mekelela ready for siege.

His forces consisted of about five thousand of effective men and 27 large guns.

Gen. Napier already completed plans for general assault on works.

New York, April 11. A Montreal Special dated yesterday says, that St. Eustache, a man named Leban and his wife, who were in the habit of robbing and murdering wayfarers and travellers who stopped at their house, they attacked a traveller.

The man with no axe and the wife with a razor the traveller knocked down his assailants, and the wife mistaking her husband for him cut his throat. She has been arrested and confessed all of her past horrible transactions. Three skeletons were found in the house.

ANOTHER CHURCH DIFFICULTY.

There is it seems, a clergyman of the name of Voysey, in the diocese of York who has lately been receiving some measure of notice from a petition having some time ago been presented to Convocation against him setting forth that he denies all the fundamental doctrines of Christianity not excepting that of the Incarnation. In discussing this petition, very strong language was employed by some of the Right Reverend fathers of the Church. The Bishop of Ely characterized Mr. V.'s writings as "outrageous." The Bishop of Gloucester said they "were even monstrous." The Bishop of Salisbury declared that they were even so wicked that he could not possibly read extracts from them in Convocation, though similar extracts for the purpose of establishing his charge against a man whose writings are spoken of in each language ought to be tried, and if these things are so, cashiered. Our readers will accordingly be prepared to hear that proceedings have been instituted against the offending brother. Not at all. Nothing is to be done. He is to be left to preach on to his some 280 parishioners as he may think best, no man forbidding him. He may laugh at what he regards as the fond conceit of the Incarnation, or the Trinity, or the Resurrection, or whatever he may choose, it does not matter. Samuel of Oxford says his books are very dull, heavy affairs, and consequently the best thing is to let him and them alone. Others say he does not come within the jurisdiction of Canterbury, but the true reason is that though he taught all that is alleged against him, nothing could be done. He still keeps within the law, and the law guarantees him the possession of his cure. Perhaps Convocation is wise not to meddle with matters which it cannot satisfactorily settle. It would have saved some trouble and some scandal had the Episcopal authorities learned this some time ago. But what is to be said of a Church where the grand argument against presenting a man for extremely heretical opinions is that his writings are very dull and prosy, a prosecution would be about the best advertisement which could be thought of, and would secure for them the run of the season? Surely, in that case, Colenso ought not to have been meddled with. Well, perhaps it is his case which teaches the Right Reverend fathers that the better part of courage is discretion."—Globe

RAILWAY OFFERS.—The following offers respecting the Intercolonial Railway have been made to the Canadian Government:

From Mr. Burpee, to build the road from Apolauqui to Miramichi River for \$32,500 per mile, from Apolauqui to Restigouche, including bridge over Miramichi River for \$33,000 per mile.

From Charles Fox & Sons, London, England offering themselves as Consulting Engineers to Government, for \$3,000 a year and expenses, and five guineas for every day spent out of London.

From Henry Osburn and others, of Calais Maine, offering to build the road from Riviere du Loup, to Woodstock, N. B., for \$35,000 per mile for a subsidy of \$30,000 and hand it over to Government.

From Montreal, Aljan, and others, of Montreal, from Riviere du Loup to Fredericton, for \$3,000,000 if company own the road, or \$7,000,000 if handed over to Government.—Highest grades 60 feet to mile.

From Told and others, of St. Stephen, N. B., from Riviere du Loup to Woodstock, for \$6,000,000.

From Mr. Light of New Brunswick, by North Shore route to Truro, for \$17,000,000.

From Mr. Beck, of Montreal, same route as Light, \$23,000,000 per mile. Line to be located by Government.

From a Quebec Company, same route, for \$14,800,000.

Dominion Militia Bill.

On the 8th ult., the hon. Mr. Cartier, Minister of Militia, introduced the new Militia Bill in a speech of six hours length. He referred to the defeat of two Militia Bills in the Canadian Parliament, and spoke approvingly of the maritime element of the Eastern Provinces. The Bill divides the Militia Force into Active and Reserved. The Dominion is to be divided into nine Districts.—Ontario 4, Quebec 3, New Brunswick 1, and Nova Scotia 1, with a Staff Commander at the head of each Division. The employments of the New Brunswick and Nova Scotia fishermen are not to be interfered with for purposes of Drill, except in case of emergency. The Dominion contains 700,000 men capable of defending their country—of whom 100,000 are in the Maritime Provinces.

Mr. Cartier paid New Brunswick a very high compliment,—he is reported to have "praised the New Brunswick Militia system as having heretofore been the best in the Dominion." This led us to refer to some documents, from which we found, that the Law so justly commended by the Minister of Militia was drawn up by Colonel ANDERSON, some time in January 1865, and afterwards referred to a Special Commission of Colonels of County Battalions, the hon. Mr. Tilley and others. The law might have been made more effective, but we understand at the time that the strictest economy was enjoined.

The efficient state of the Militia and the great economy practised, while Col. Anderson was Adjutant General was acknowledged, and we noticed in the Royal Gazette some months ago, a letter in which he could not miss the proposed New Brunswick law—the drill being excessive and useless, and the pay of Volunteers, 50 cents would be no inducement to them. The Staff proposed was outrageous—indeed it had the appearance of creating unnecessary offices with handsome salaries.

Persons competent to give an opinion on Military matters, have expressed the hope (in which we heartily participate) that Colonel Anderson's qualifications and excellent administrative ability will be as fully appreciated at Ottawa as they are in New Brunswick, and that he will be appointed Staff Commander of this Provincial District, as there is no other officer better qualified to carry out efficiently the Military regulations, and certainly none whose appointment would be so popular.

INTERCOLONIAL SURVEY.—We notice in the Carleton Sentinel of the 11th inst., a laudatory paragraph on the success of Deputy Hartley's survey of the portion of the line allotted to him, which must be gratifying to all who are in favor of a Western Central or Frontier Route. The writer says that "the distance surveyed 15 miles, comprises the most difficult section of the whole survey; the average grade per mile is only 43 feet, &c." It appears that Mr. Hartley left his staff and came to Woodstock to report by telegram to Mr. Fleming the result of his operations. From an Ottawa paper and other sources we learned that Mr. Hartley was appointed assistant to Mr. Buck, and was to report to him, and that Mr. Buck was to report to Mr. Fleming.—And it is not a breach of official etiquette to make known information which should have at least been furnished through the proper channel to Mr. Fleming before being made public. Our own experience warrants the belief that the information should have been placed before the Privy Council before being published. Mr. Buck we understand has sent a report

of his survey to Mr. Fleming, but we are not aware of its contents either privately or publicly.

The assassination of the Hon. Thomas D'Arcy McGee has created universal horror throughout the Dominion. Upwards of \$25,000 Reward has been offered for the apprehension of the murderer. Several persons were arrested, but afterwards released. A man named Whelan has been arrested, with a loaded revolver on his person at the time, one of the chambers of which had been recently discharged, but reloaded. He is still in custody—strong suspicions are entertained of his being the murderer. Eulogies on the late lamented statesman the most brilliant orator in the Dominion, were pronounced by the Premier, McKenzie, Cartier, Chabreau, Campbell, McDonald of Nova Scotia, Anglin and others. Mr. McGee was a native of Carlingford, Ireland, was born on the 13th April 1825, and would have been 43 years old had he lived one week longer. He was interred at Montreal on Monday last. The flags throughout the Dominion were at half mast.

From late accounts it appears that the Hon. Joseph Howe's Repeal Mission is doomed to fail. His interview with the Colonial Secretary the Duke of Buckingham, was of an unsatisfactory nature. The Duke's remark, that the Government could not satisfy itself at this early day, by reversing the deliberate and well-considered course arrived at, when it advised the Queen to sanction the British American Act last year—is tantamount to a refusal to entertain any further negotiation.

We notice in a late London paper, a letter from a correspondent in Boston which speaks in very high terms of a young friend, Mr. Henry F. Magee, brother of Mr. Magee of our town. From the letter we learn that Mr. Magee has had charge of the Emigrant department of the large business house of Warren & Co., owners of the line of steamers between Boston and the Mother Country. Mr. M's aptitude for business, thorough knowledge of his countrymen, unbounded kindness and generosity to emigrants, have made him so popular, that he has become an indispensable adjunct to the respectable and wealthy establishment which he serves, and of which it is not improbable he may ere long become a partner.

DUMBARTON.—A fire took place on Saturday night last, at Dumbarton, which destroyed the Station building, occupied by Mr. Trenholm as a store and residence. The fire originated it is said, owing to a defective chimney. Mr. Trenholm's stock and part of his furniture together with the building were consumed. The stock and furniture were understood to be partially insured.

A fire also occurred at Richmond Station which we learn destroyed three buildings.

The weather was unusually cold during the past few days. A fall of snow took place which has made fair travelling in the country. How truly the poet wrote—"Winter lingers in the lap of Spring."—Two years ago at this time, gardeners and farmers were preparing the land for crops; but the ground at present is as hard apparently, as it was in February. The sun is now so powerful, that snow and frost will soon disappear.

The Montreal papers contain the eulogies pronounced in the House of Commons on the late Mr. McGee. They are very fine, truthful, and full of genuine feeling. It is pleasing to know that his widow and children are to be taken care of by the Government.

The Archbishop of Halifax was so much affected by the intelligence of Mr. McGee's death, that he was unable to attend the services at the Cathedral at the close of the week. On 22d, solemn obsequies for the Mighty Dead are to be held in the Cathedral which will be draped in mourning.

The Concert of the Baptist Sabbath School will take place this evening, in the Baptist Chapel. The public are respectfully invited to attend.
