An Act respecting the Western Alberta Railway
Company.

WHEREAS the provisional directors of The Western Alberta Railway Company have by their petition prayed that it be enacted as hereinafter set forth and it is expedient to grant the prayer of the said petition: Therefore Her Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows:—

Preamble.

1. The railway of the Company shall be commenced and fifteen per cent of the amount of the capital stock expended thereon before the first day of December, one thousand nine hundred and two, and shall be completed and put in operation before the first day of December one thousand nine hundred and five, otherwise the powers conferred upon the Company by chapter 90 of the statutes of 1898 shall cease and be null and void as respects so much of the railway as then remains
uncompleted.
