**An Act to legalize and confirm the acts and proceedings
of the Municipal Council of the Township of Brantford.**

WHEREAS by the Upper Canada Municipal Corporations Act of Preamble
1849, it is among other things enacted; that the meetings of each
Township Municipality shall be held within the Township; And whereas
certain sittings of the Municipal Council of the Township of Brantford
5 have, from motives of convenience to the parties concerned, been held in
the Town of Brantford, beyond the limits of the said Township, in conse-
quence of which doubts have existed as to the legality of the acts and pro-
ceedings of the Council of the said Township, though no legal proceedings
have at any time been taken in order to impeach or question the same, or
10 any part thereof; And whereas the said Municipal Council have petitioned
for the legalization and confirmation of their Acts and proceedings, and
it is expedient to grant the prayer of the said Petition; Therefore Her
Majesty, &c., enacts as follows:

I. All the acts and proceedings of the Municipal Council of the said
15 Township of Brantford, in so far as such acts and proceedings may have
been or may be held to be in any wise irregular, illegal, or void, in conse-
quence of such Acts having been passed and such proceedings having
been had, during any sitting of the said Municipal Council which may have
been held beyond the limits of the said Township of Brantford, are hereby
0 declared to be, and the same are hereby legalized and confirmed.

II. This Act shall be held to be a public Act.
