## NEW MAN WHO POURED OIL ON TORCH CAN CAUSE "PICTON" FIRE

### Unexpected Evidence of Jas. Kane at Inquest Explains Outbreak of Saturday's Fatal Blaze—Officials Secured Admission.

### JURY CENSURES COMPANY FOR THE POOR FIRE DRILL

That George Kieskie came to his death by being suffocated on the steamer Picton on Sept. 21 as a result of an outbreak of fire caused by an inexperienced hand accidentally dropping his torch. We find the company negligent in not enforcing discipline in the handling of the fire fighting appliances.

—Coroner Wilson's Jury.

A sensation was sprung last night at Coroner Wilson's inquest into the death of George Kieskie, who died on the burning steamer "Picton" last Saturday, when James Kane, a laborer, residing at 86 Sherbourne-street, who had been hired as a wiper at noon on Saturday by Pettit, the second engineer, told in the box how he accidentally set the boat on fire.

The R. and O. Navigation Co. officials have been in Toronto since Sunday afternoon investigating the cause of the fire, and late yesterday afternoon, after close examination, Kane admitted what he knew.

A man of thirty-six years of age, sharp looking, with pointed features, Kane at first was afraid of the consequences and did not tell all to the officials. Later he made a clean breast of it.

Called to the box after several witnesses had been fruitfully examined, Kane began to answer the crown attorney's questions in his own plain way, how he had been taken on the job as wiper about noon Saturday, telling how the second engineer had instructed and helped him to clean the piston rods of the big engines, of his leaving for his boarding house to change his clothes and his return to the boat. His torch had melted oil and down on the lower deck of the engine he had noticed a large oil tank. Down he went to fill his can, which would be needed later when the boat got out for shore. The coal oil tank was about 4 ft. high and about 4 ft. in length, and had about 4 or 5 ft. from the boiler.

How It Happened.

"I tried to fill my lamp lighted from the oil. Somehow I dropped a half pint of oil, and it caught fire and a sudden blaze went up. I called to the engineer to bring a pail of water. I went there as a green hand and was not employed in this boat before."

"That's how this fire took place," asked Mr. Drayton.

"Yes," said Kane.

"The fire burned your fingers and you let the torch drop?"

"Yes, I did it accidentally. Coming out of the box somehow the light caught and I got excited and dropped it. The oil went over my hand."

"Where was the torch when it caught?"

"About 8 inches off the wick. I don't know, but somehow it caught."

The fire spread quickly, and the men had no opportunity of putting it out. He had rushed to get a pail of water. He said he had been quite sober.

Crown Attorney Drayton drew from the half-dozen other witnesses the admissions that, although the fire appliances were in good order, as demanded by the Dominion Government, still there was not the discipline nor the ability to cope with the emergency that had arisen.

Appliances on the Picton.

Capt. Redfern, the first witness, said that the fire appliances were inspected by the government last spring. There were forty-five full crews, and the government required twenty men to operate the appliances. The last fire drill was held on Aug. 27. The reason the appliances were not able to cope with the fire was that the pump was in the engine-room, where the fire broke out.

A. Demontigny, the chief engineer for three seasons, said that the fire fighting apparatus on board was first-class. It consisted of five steam and two hand pumps. There was about thirty or forty gallons of oil on hand, kept in separate tanks, removed from the furnace. There was not over a pound of dirty waste in the engine-room.

Joseph Pettit, the second engineer, was on the watch. Kieskie and another man were on deck. They had not been in the fire-hole for 15 minutes. Witness heard Kane call fire. The hose was working inside a minute. He went to the engine-room and stayed there about 8 or 10 minutes. When he first saw the fire there was lots of smoke.

Witness saw Kieskie and told him to go and tell everybody to get out.

"He did," continued the witness, "and came back, and I told him to save himself."

To the coroner witness said that the world of the boat was in the engine-room, and that he had conveyed to all parts of the boat by sending a man. There was no special signal.

Capt. Johnston, mechanical superintendent of the R. & O. Line, said torches were much more convenient than electric lights.

REFUSED TO BE TAXED.

## CANADA THE LAND OF SPLENDID OPPORTUNITY

### Bishop of London Looks for Day When Dominion Will Be Backbone of British Empire.

NIAGARA FALLS, Ont., Sept. 23.—(Special.)—His Lordship the Bishop of London addressed an audience of some 4000 people to-night in Olympia, Rink, Niagara Falls South. The gathering represented every creed, not of the Niagara district alone, but of the American frontier as well. Baptist, Methodist, Roman Catholic and Presbyterian vied with the Anglicans to make the visit of the great churchman auspicious for the Dominion.

Special trains brought delegations from Hamilton, Welland, St. Catharines and from the villages for miles about.

Bishop DuMoulin of Niagara introduced Bishop Ingram, who was given an ovation. He took for the text of his talk, "The Garden of Canada and the Garden of Souls," contrasting the conditions there and in his diocese as regards the opportunities afforded for spiritual and physical development.

"Never have I seen such glorious children, strong, well fed and happy as here," he said, "and the bishop of the slums, stunted and ill fed and sad. I feel that I wish they might share the advancement of yours."

The bishop also contrasted the observance of the Sabbath here and in London. Canada, he said, he found was a religious country, while in London the very opposite was true.

"I confidently look forward to the day when this great land shall be the backbone of the empire, a country of nearly one hundred million people," continued the bishop. "Canada spells opportunity and opportunity which men of all lands will be quick to grasp."

Then his lordship reverted to his work in London, telling of conditions as here in the diocese of the clergy. Much of their ministry, he said, had of necessity to be given over to a defence of Christianity, which was assailed on all sides by the distressed poor.

His lordship left after the meeting for Buffalo with the Right Rev. W. D. Walker, Bishop of Western New York. He will spend to-night with Bishop Walker, and will leave in the morning for New York.

During his stay here he was the guest of Bishop DuMoulin and Rural Dean Bevan.

He met the clergy of the Niagara district and Western New York at luncheon at 2 o'clock at the Clifton Hotel, and later dined with Bishop Walker and Bishop DuMoulin.

## FEMALE "FAGIN" ROBBED GIRL THEVES

### Miss Elizabeth Maloney Alleged to Have Profited from Youngsters' Pilferings.

Is Mrs. Elizabeth Maloney, 79 Jarvis-street, a female Fagin? Her 12-year-old niece says so. The woman is charged with receiving stolen property from little Bertha Wilson, her 12-year-old niece, and 10-year-old Irene Drake, who was arrested Saturday afternoon in the Eaton store by Detective Geo. Kennedy, while they were engaged in the exciting operation of purse snatching.

Mrs. Maloney was arrested by Detective Kennedy at her home yesterday, upon information furnished by the chief constable.

Bertha Wilson told the detectives that her aunt had sent her out to steal and had reaped the fruits of her crimes, which were extensively pilfered. The girl told that she had given the woman over \$100 which she had stolen from purses. Once her aunt bought her a little fur hat out of the proceeds of \$30 which she took from a chateleine. So far from being amateur, the child is an expert pickpocket.

A search of her premises on Jarvis-street unearthed a deal of property for which the detectives want owners.

There is a small diamond ring, upon which are engraved the initials "E. E. R." a buckle ring with two red stones and one missing; a gold ring with two small diamonds with an opal between; an oblong amethyst with a gold flower set in a gold ring; a gold thimble engraved "H. A. K."; a silver thimble marked "G"; a pair of gold earrings in the shape of a knotted cord; a brown alligator purse containing car tickets and Hamilton boat tickets; a read leather purse with one American dollar bill, and numerous coins, among which is a Columbian half dollar.

In addition to this property Detective Kennedy wants an owner for a brown glass purse containing \$13, which was stolen Saturday.

## STEAMER NIMICK WRECKED CAPTAIN AND 5 DROWNED

### Canadian Members of the Crew Weir Rescued—The Machinery Broke Down in Heavy Gale and Vessel Was Smashed Into Pieces on Vermilion Point—Some Bodies Recovered.

CAPTAIN RANDALL, Algonac, JOHN JOHNSTON, Glasgow, Mich. LOUIS DUBEY, Detroit. THOMAS PARENT, Port Huron. A fireman and watchman from Chicago, names unknown.

SAULT STE. MARIE, Sept. 23.—(Special.)—One of the most disastrous wrecks on the lakes this season occurred Saturday night at 11 o'clock, when the steamer Alexandra Nimick went ashore at Vermilion Point and Capt. Randall and five of the crew were drowned.

A heavy northwest gale was blowing at the time and when off the point, 13 miles above White Fish, the Nimick's machinery suddenly broke down. The steamer was driven about helplessly in the waves and finally beached on the point, where the heavy pounding of the waves soon broke her to pieces.

Life-Saving Station No. 9 is located on the point and thru the heroic efforts of the life-savers 11 of the crew were saved. They were unable to save Capt. Randall and five of the crew, who were washed ashore by the heavy seas. Early Sunday morning three bodies were washed ashore by the waves. A searching party, headed by Mate Gordon, is looking for the remaining three.

Bodies at the Soo.

The first news of the wreck was received at Grand Marais by phone from the scene of the wreck, and the tug of the Great Lakes Co. went to the rescue. She arrived at the Soo this morning about 11 o'clock, carrying the three bodies washed ashore and 11 survivors.

The sailors say the steamer grounded about 7.30 o'clock Saturday evening and before being beached waves were continually washing completely over her and the ship began taking water. She was filling so rapidly that the captain deemed it best to run her ashore. This was done, but immediately upon striking the bow went to pieces, casting the men who were lost into the waves. Only those who were in the stern escaped.

A yawl boat was launched and ten men made way in her. The sailors say the chief engineer threw himself into the water and swam ashore. The drowned men were:

Capt. Randall, Algonac, John Johnston, Glasgow, Mich. Louis Rubey, Detroit. Thomas Parent, Port Huron. A fireman and a watchman, from Chicago, unknown.

Of these men Johnston and the unknown fireman were brought to the Soo this morning.

## THE TRUTH ABOUT THE WESTERN TROUBLE

### World Commissioner Writes of the Sentiment and the Situation on the Pacific Coast.

(Special Correspondence of The World.)

VANCOUVER, Sept. 17.—The whole trouble with British Columbia and the Japanese immigration rests in the determination of the people of this province to look at the problem as one of Canadian responsibility. It is in no way remarkable that labor organizers from the other side of the line should see the difficulty in this convenient light; but that representatives of the people, and the people themselves, when they express their opinions, should cut the matter short at the point of federal authority, implies if anything their resolve not to have the issue they see confronting them sidetracked on lines of foreign politics and international rights.

The story of the development of the trouble introduced with Asiatic labor is short and simple. The Chinese who were first brought in for railway construction proved to be steady and methodical workers, and settlement along the Fraser River and in the interior country assimilated them as well, perhaps, as it is possible for yellow men to blend into the process of white colonization.

Chinese Good Workers.

It is not gainsaid that the Chinese supplied good railway building labor, that they had a worker's character in the canneries, that they have done well as small gardeners and domestic servants, and that, so far as they have taken to commerce, they have invariably proved themselves honest. What they were needed for in the beginning was to supply coarser labor; and most white people, who have in the past been averse to having them utilized in the wider economy of the country.

For a time this feeling against the Chinese remained passive, but as they increased in numbers the advisability of restriction was practically admitted in the terms of a new law, which after a time was increased to \$500. The Chinese have paid this heavy tribute and have uncomplainingly advanced themselves in spite of it.

I have been talking to a member of a large Toronto house who has been going business for years in British Columbia, and he says that he estimates the Chinese population of the province to-day at 60,000, and he and the business men of his acquaintance cannot attribute the loss of a single dollar to Chinese dishonesty.

So that the character they have borne, together with the constantly increasing need for their labor, has been an antidote to the white man's sentiment towards his yellow hewers of wood and dressers of skins, which after a time was increased to \$500. The Chinese have paid this heavy tribute and have uncomplainingly advanced themselves in spite of it.

When the Hindoos were brought in last year it was with a flavor of Bill Nye's grievance that white labor called for a broad and free trade against all Asiatics. The Chinese were given the head tax; and the Hindoos, by reason of physical inferiority and inability to handle the work, were more likely to give a set-back than a fresh impetus to Asiatic immigration. However, Vancouver at that time took the notion of a conference in England. Even those persons who, at the commencement of the conference, had the view that a mere discussion of the problems for which it was called to consider would be a step toward the prevention of war, admit their hopes were unjustified, and they now are among the first to condemn the entire proceedings, describing them as a waste of time.

This failure to deal with the great questions included in the program is credited largely to defects in the constitution of the conference by which the delegates were expected to perform in a few months what properly was the work of years.

Even the international prize court, which is one of the results of the conference is likely to accomplish English authorities on international law say, cannot be submitted to British jurisdiction until it has been fully considered and accepted by the government. The question of a reduction in expenditures for armaments, which Sir Henry Campbell-Bannerman and the peace advocates hoped would be seriously taken up by the conference, long since has been forgotten.

### DASH FOR NORTH POLE.

The yacht left Dr. Cook and a Norwegian steward at Etah, 190 miles from the north pole, together with provisions. Both will take Esquimaux and dogs and make a dash for the pole.

For a time this feeling against the Chinese remained passive, but as they increased in numbers the advisability of restriction was practically admitted in the terms of a new law, which after a time was increased to \$500. The Chinese have paid this heavy tribute and have uncomplainingly advanced themselves in spite of it.

I have been talking to a member of a large Toronto house who has been going business for years in British Columbia, and he says that he estimates the Chinese population of the province to-day at 60,000, and he and the business men of his acquaintance cannot attribute the loss of a single dollar to Chinese dishonesty.

So that the character they have borne, together with the constantly increasing need for their labor, has been an antidote to the white man's sentiment towards his yellow hewers of wood and dressers of skins, which after a time was increased to \$500. The Chinese have paid this heavy tribute and have uncomplainingly advanced themselves in spite of it.

When the Hindoos were brought in last year it was with a flavor of Bill Nye's grievance that white labor called for a broad and free trade against all Asiatics. The Chinese were given the head tax; and the Hindoos, by reason of physical inferiority and inability to handle the work, were more likely to give a set-back than a fresh impetus to Asiatic immigration. However, Vancouver at that time took the notion of a conference in England. Even those persons who, at the commencement of the conference, had the view that a mere discussion of the problems for which it was called to consider would be a step toward the prevention of war, admit their hopes were unjustified, and they now are among the first to condemn the entire proceedings, describing them as a waste of time.

This failure to deal with the great questions included in the program is credited largely to defects in the constitution of the conference by which the delegates were expected to perform in a few months what properly was the work of years.

Even the international prize court, which is one of the results of the conference is likely to accomplish English authorities on international law say, cannot be submitted to British jurisdiction until it has been fully considered and accepted by the government. The question of a reduction in expenditures for armaments, which Sir Henry Campbell-Bannerman and the peace advocates hoped would be seriously taken up by the conference, long since has been forgotten.

### DASH FOR NORTH POLE.

Dr. Cook 190 Miles Away From the Goal.

NORTH SYDNEY, Sept. 23.—(Special.)—The Gloucester yacht, John R. Bradley, which left here in July with Dr. Cook of New York and J. R. Bradley, the famous hunter, on an exploring trip in Greenland, is on the way here, and is expected to arrive in a few days.

The yacht left Dr. Cook and a Norwegian steward at Etah, 190 miles from the north pole, together with provisions. Both will take Esquimaux and dogs and make a dash for the pole.

Dr. Cook accompanied Peary on a previous trip north, and is confident of making good where Peary failed. Mrs. Cook and family are at Margaree, C.B.

INQUEST ON INFANT BODY THROWS NO NEW LIGHT

Hamilton Mystery Remains Unsolved—General News of Ambitious City.

HAMILTON, Sept. 23.—(Special.)—The inquest on the body of the infant found in Mrs. Simpson's shed on North James-street was concluded this evening without throwing any light on the identity of the mother. The verdict was that it came to its death thru exposure.

Detective Huckle, one of the jury-men, wanted his colleagues to censure the police for neglecting the case. C.P.P. OCEAN RATES CUT.

Minimum First Cabin on Empresses Down to \$55.  
 MONTREAL, Sept. 23.—The first indication of the Canadian lines taking a hand in the Atlantic rate war is the announcement this morning by the Canadian Pacific Atlantic Steamship Line of the following minimum rates, effective at once and until further notice, from Montreal to Liverpool:  
 On Empress of Britain and Empress of Ireland, first cabin, \$55; second cabin, \$42.50.  
 On S.S. Lake Manitoba—first cabin, \$45; second cabin, \$35.  
 On Lake Champlain and Lake Erie (one class cabin ships), \$40.  
 The rates westbound from Liverpool are not yet affected, but it is expected that, commencing Nov. 1, the rates now obtaining to Liverpool will become effective from Liverpool.

DREADNOUGHT GUNS.

New Battleships Will Have Eight 13.5 Gups 50 Feet Long.  
 LONDON, Sept. 23.—At the admiralty, it is said that all the vessels of the Dreadnought class now building shall be armed with eight new type 13.5 gups, so disposed that they all can be fired on either broadside.  
 The new weapon will be 60 feet long and a shell from it, it is calculated, will pierce 20-inch Krupp steel armor at a range of 3000 yards.

Engineer's Hands Tied at To-Day's Conference—Exemption Given Its Quietus.  
 A special meeting of the city council will be held on Thursday evening to decide the viaduct question. This agreement was reached at yesterday's session, after Ald. Geary had succeeded in making the understanding clear to City Engineer Rust, in his conference with engineers representing the railways, is not authorized to add anything to the viaduct arrangement that may be made. Ald. Geary, who spoke at some length in support of the plan of elevated tracks, said he had decided whether the scheme should include the raising of all the tracks or merely those used for thru traffic. If the railway commission had not been asked to consider the viaduct, it could apply to the federal government with more assurance of success than could the city. The good work that has been done by the board of trade in obtaining expression of public opinion on the viaduct was evidenced in the submitting of a petition, signed by many citizens in favor of elevated tracks. Exemption Sidetracked.  
 The proposal to apply for legislation for the \$700 exemption was overwhelmed by the contention that it would result in the city being allowed to use the Harbor-street playgrounds and libraries.

PUPILS TRANSFERRED.

150 Leave Harbord for Annex in Public School.  
 Senior Principal Embree and Principal Hagarty of the Harbord Collegiate buried the hatchet yesterday, and 150 pupils of the collegiate paraded to the five rooms in King Edward School set apart as an annex to the institute. The teachers who accompanied them are Messrs. L. A. Kennedy, teacher of literature; Fletcher, science; McKinley, Latin and drill; Keast, mathematics, and Miss Ketcheson.

DEFENCE CLAIMS HE WAS ONLY AN EMPLOYEE.

OTTAWA, Sept. 23.—(Special.)—Today, in the police court, D. Denenberg, who was arrested in Montreal on an order from Kenora to Kenora, was charged with stealing jewelry to the value of \$2000 from Gustave Graub of Toronto.  
 M. J. Gorman, who represented Denenberg, claimed that Denenberg was merely an employee of a man named Jack Kaplan, who conducted a store in this city, but who unexpectedly left Ottawa, leaving Denenberg in charge of goods shipped him by Graub.  
 The goods also disappeared, and Denenberg, who is the grandfather of Kaplan's wife, is now accused of having obtained the jewelry at his Montreal address.  
 Bail was refused.

TROLLEY TO G.T.P.

Will Run From Kenora Along the Winnipeg River.  
 KENORA, Sept. 23.—(Special.)—A company has been formed for the promotion of an electrical railway to run from Kenora to Keewatin, and thence along the Winnipeg River, where it will connect up with the G.T.P.  
 The government has been applied to for land necessary for the purpose, and the town's power will be utilized for that object.

MAUND BUILDERS' RELICS FOR TORONTO UNIVERSITY

Prof. Montgomery Secures Many Valuable Specimens in Souris, Man., District.

Professor Montgomery of the University of Toronto, who has been prosecuting researches in the Souris district of Manitoba for relics of the ancient mound builders, has secured many valuable specimens in Souris, Man., District.  
 No mounds have ever been found near Souris, but on the banks of the Souris River, where the north and south Antler Creeks join the main stream, there are some twenty mounds.  
 In the vicinity of Souris the professor has secured many relics, of which seven of these are of the Maund type, a 10 complete human skeletons and besides numerous pieces of broken pottery, two whole urns. The mounds were found to be typical of those found in Dakota and further south with one exception. In this he found the complete set of six buffaloes, which had evidently been buried with a sacrificial purpose.  
 Eight large boxes and five crates of specimens were shipped to the Toronto University. Professor Montgomery believes that these mounds were built at least 700 years ago.  
 Recently W. S. Wilson discovered the remains of a Maund village, which a squaw was buried, perhaps a century ago. Bead ornaments were the relics by which the village was identified. There is evidence of an Indian village on the banks of Plum Creek, where numerous arrow heads and broken pieces of pottery have been found, turned up by the plow. The style of pottery indicates that it is probably 500 years since the village was there.  
 Recently W. S. Wilson discovered an Indian sweat bath, constructed of willows and young birch trees. It was a curious expression of the Indian's method of treating disease. This was created by Professor Montgomery and sent to Toronto University.

Risky to Drink City Water Boiling Won't Better It.

Every day 40,000 gallons of sewage pour into the lake from the Dufferin Street sewer. It is thought that much of this sewage gets into the intake which brings Toronto's water supply into YOUR house. The Medical Health Officer of Toronto recommended citizens to boil their drinking water at the time the infection first appeared.

Dr. Amyot Says City Water Contains Some Sewage Bacteria.

"Boil the drinking water," is the advice of Dr. Amyot, the Provincial Analyst, to the people of Toronto.  
 "The water has been infected for the last two and a half weeks, and still is," said Dr. Amyot. "It has been fairly clear all summer until recently. I do not know where it comes from, but there is sewage bacteria in the water."

WANT FRUIT INSPECTOR.

Grocers' Section of Retail Merchants Voice Their Indignation.

The grocers section of the Retail Merchants' Association held their first monthly meeting of the fall season last night.

The report of the joint committee of fruit dealers, butchers and grocers was received by the appointment of a fruit inspector, and the decision reached was that a representative should visit Ottawa and lay the facts before the Hon. Mr. Fisher.

There was quite a discussion over the very unsatisfactory yield of the fruit this season. It was stated that it has been the poorest yield for the last twenty years, and that the fruit has been dearer in proportion to the quantity than has been ever known to the knowledge of those present.

Complaints were made that of the large quantities of fruit which came in the bottom layer was much poorer than the top, and this is one of the greatest needs for a fruit inspector.

Reduction in Ocean Rates. The C.P.R. steamship department notified their representative, Mr. S. J. Sharp, in Toronto to-day, of a general reduction in the minimum rates in both saloon and intermediate class, taking effect immediately.

CUMMINGS CONVICTED AND BAIL IS REFUSED

Toronto Junction Man Is Found Guilty by Jury on a Revolt-ing Charge.

George R. Cummings, the elderly Toronto Junction undertaker, was found guilty in the sessions yesterday of sending obscene and disgraceful letters to Lena Tucker. He will be sentenced by Judge Winchester at the close of the sessions. The extreme penalty is two years in the Central Prison. No bail was accepted and Cummings was locked up. Mrs. Cummings stuck with her husband through the trial and was present when the verdict was announced. Her head was bowed in the attitude of prayer during the judge's charge. Cummings' friends assembled outside from the commencement of the trial.

In his address to the jury, County Crown Attorney Drayton pointed out several instances of the prisoner's conduct which had endeavored to blacken the name of the girl to whom he had written protestations of love, and whom he had chased over the city in a vain attempt to get her back to him again. "On one hand, gentlemen of the jury," said Mr. Drayton, in closing his address, "you have the girl, the circumstances and the letters, and on the other hand, the man—and I should not have said man. He tried to blackguard the girl's character and endeavor to besmirch her name. He could hardly realize what she had done for him. He said she 'had made a man' of him. He was wrong. She had not made a man of him. He is today the thing that he was before."

When the court opened in the morning the crown attorney asked Cummings for the memorandum book containing the list of men whom Lena Tucker had said she had been intimate with. Cummings said that the book had probably been destroyed. "Here's a letter you wrote, addressed to Miss Pansy Tucker," said the crown officer. Cummings admitted that Pansy is a younger sister of Lena's. Mr. Drayton read a note from Cummings asking her to meet him on Carlton-street, which was addressed to his friend George. He explained that this meeting was to get from the girl an explanation of a statement of her sister.

"You said before in the box that you never did anything to Lena Tucker for which you should reproach yourself. Is that true?" asked the crown officer. Cummings admitted that he had never done anything to her. "Well, any man would be ashamed, I suppose," he replied. "Were you in love with the girl after she left?"

"I liked the girl as anyone would like a girl whom you wanted to see 'right,' he replied. "What did you put an 'x' after your name in these letters for?"

After much hesitation Cummings said it signified kindness. "You say," said the attorney, "that you liked the girl, but you did not 'do' her. What did you mean by that?" Cummings admitted that it was used, as others use it for "kiss."

He said he had said it with his opinion he expressed to Miss Tucker in a letter that she had made a man of him. Declarations of love, advice that she should pray for him, and that he would be better off if she would leave him, he said, to keep her quiet. "She threatened to expose me," said Cummings. His presents to her she returned. A ring and a Bible she mailed to him after she ran away. He told her at that meeting that he was an unmarried man.

Mr. Armstrong addressed the jury in the afternoon. He said the charge against Cummings was that he had written to the girl in a letter in which he had said that he was a blackguard. "We have the evidence that this woman threatened to expose me," said the lawyer. "Cummings swears that she threatened him if it took three years. Would anyone but a prostitute write this? When love turns to hate, anything may happen."

Cummings had gone after the girl on the grounds that she had written to him better to be had with only him, and with no other man. Counsel pointed out that there was one postcard which never went thru the mails, which he claimed was written by the girl to herself in her effort to ruin Cummings. Several letters he also pointed to the girl.

The crown attorney pointed out to the jury that the case was not between a respectable man and a respectable girl. "This man was not respectable," he said. "This man allured the girl to sleep with his own daughter. That man used the name of the Almighty Father in a lustful letter."

ANOTHER MILITARY CAMP VICTIM. OTTAWA, Sept. 23.—(Special.)—A special from Pembroke to Ottawa to-day says: "The death of Pte. Fred Lett, a young Englishman, on Saturday evening here from typhoid fever, contracted at Petawawa camp, has again started considerable gossip. He is the third victim and at present there are seven other soldiers suffering with the same disease in the Pembroke Hospital. Complaints will be made to the minister of militia."

and likewise lost some considerable quantity of its blood a week ago.

Two Views. See him in a Calgary hotel where he is exclusively employed for waiting on tables and the Jap is faultless. But when with a Russian cap thrust back upon his black head, he strides with military pace along the platform of a Fraser River town he affords material for different impressions. The police authorities of Vancouver caught the correct impression of him, no doubt, after the recent riot when the Japanese residents of Powell-street sent word to neither about protective measures because they preferred being allowed to protect themselves. The mob also got a similar impression, for instead of the Japanese it was the Chinese quarter it essayed to clean out.

It is only the truth to say that the mob was a comparatively harmless affair, accidentally collected, so far as the motive of attacking either the Chinese or the Japanese impelled it. And as it is an ill-wind blows nobody good, so the hasty violence of a week ago may prove to have been a profitable experience. It has demonstrated the great injury that a real outbreak of popular fury might and probably would, entail. It has made the Japanese quarter an armed camp and it has frightened many of the harmless Chinese so much that they had the money they would pull out of British Columbia. But it will only bring in the Jap in greater numbers than ever.

Still They Come. There are at the present moment, large reinforcements of brown men on the Pacific Coast, near Victoria, whilst others will follow. For the cry is still they come.

But this is not the most serious part of it. Hamar Greenwood, M.P., speaking to the Canadian Club of Winnipeg on the Monday after the outbreak, said very truly that it had brought Canada right into the centre of foreign politics. And by so doing a real obstacle was introduced to the intention which the intelligent people of British Columbia have met at heart. That intention, as has been said at the outset, is to force the necessity for the restriction of Asiatics upon the attention of the government of Canada and insist that it shall be treated strictly as a Canadian problem. British Columbia realizes to-day that it cannot stick by its claim of a domestic issue if there are to be any more charivaris, serious or otherwise, in the Japanese quarter of Vancouver. And there will not be any more. The lesson has had its effect. But what is evident is that deliberate plans will be set on foot to secure restrictive laws that can and will be enforced.

There is no getting away from the needs of the railways; the mines, the mills, the canneries and the fruit-growing areas of British Columbia for coarse labor, cheap or dear. The Chinese who have been supplying a good deal of this labor so far with the all-enduring patience that pleases the white man best, have become the greatest sufferers thru no fault of their own, but by the very irony of fate. STOCK MARKETS QUIET AT SMALL REDUCTIONS

Prices Are Shaded at New York and Also on the Canadian Exchanges.

World Office, Monday Evening, Sept. 23. The Toronto market lacked bullish initiative to-day in the main and in the majority of cases prices were either steady or lower. The loss of the Pictou steamship brought lower quotations for Richelleu, but no dealings transpired in this issue on the market. The small increase in the net earnings of the Canadian Pacific for August were not entirely satisfactory and no strong support was shown for the issue even at the present figure. General Electric and its stock suffered under pressure of sales as the transactions show. The one strong feature of to-day's market was 'Twin City,' which was up to 96 and on the New York market. The president's statement regarding the dividend on this stock is being backed up by support in the market and is expected to rise in this security ascribed. The interest in to-day's market from investors was small and only the limited amount of offerings accounted for the small general declines.

ness in methods of reform. This began long ago in the east. It is coming now in the west, where thousands of workers will be thrown out of employment by cut-out in copper production. Other allied industries will naturally follow suit. Every one is retrenching. Universal retrenchment means contraction of demand in all directions, and in turn means less demand for labor, lower wages, less purchasing power, slow reversal, and tending of the business tide.

But all this is temporary. The stock market has discounted it. Prices will rise until the next violent government assault. Then there will be another decline, but a less violent one. Each time the attack is renewed, the effects become more unpopular, the effects less severe. This is the natural law in prices, and investors should take advantage of it. WIRELESS STATION READY FOR COMMERCIAL GRAMS

Marconi Will Stay at Glace Bay till First Over Water Message is Despatched.

SYDNEY, N. S., Sept. 23.—Signor Marconi reached Sydney this morning and at once proceeded to Glace Bay to inspect his wireless telegraph station. He said he intended remaining in Cape Breton till the station is opened, which would be in about three weeks. There was some teasing to do and then they would get down to work.

"We shall have just a few friends present at the opening," he said. "We shall have some gentlemen of the press, but outside of these men we shall have no prominent men. We sent cables to the King of England and the king of Italy some time ago, when we first started, and when we begin commercial work we shall do by sending two or three messages to some of the more influential newspapers. We shall not show about it, but go along quietly. The press people have been good to us and we shall now be good to them. We have overcome all obstacles, and are you now sure of success?"

"Yes, we have surmounted all the difficulties and we are sure of success." The inventor said the continental Morse system would be used, but if the ordinary Morse code was better than that would be used. About twenty words a minute would be the speed. The Canadian Pacific and Western Union have connections with the station, Signor Marconi said, and he hoped to do business with both companies. Asked if the cable companies would reduce their rates he said he would not be surprised. If they did, it would be a good thing for the public.

The wireless messages will be received at Clifton Island, with the Cornwall station as a second string, to help out Clifton. "Bad weather will have no effect on our system, provided it does not damage our masts and poles. Lightning storms will do us no harm," said Marconi. "After the messages reach Clifton the government lines will take hold of them. The company has a contract with the British Government and the latter will look after the company's messages. The company has also a contract with the Canadian Government, and can use the I. C. R. wires."

PLUMBER CAME TO TOWN. Breach of the alien labor law is alleged against Fred Armstrong, master plumber, the complainant, on behalf of the local union, being Bernard M. Johnston of Cadmus, Pa.

In the police court yesterday he said that, having answered an advertisement in Philadelphia for plumbers, he was asked to sign the following contract: "In reply to your advertisement, I have been informed that there was a strike among the plumbers and steamfitters at the City of Toronto, and that I could secure employment by applying to the Employers' Association at that point, but that no contract could be given with me which I would be guaranteed employment. "As I am without means, I have been assisted to the extent of having my railway fare advanced for me. I am leaving this city on my own initiative for the purpose of seeking employment at my trade."

Johnston said the paper was folded so that he could not see what he had signed. He said he had been given to understand there was no "trouble" on here. He was told by Armstrong he would get 42 1-2 cents an hour. Reaching Toronto he applied for work to Geo. McGuire. McGuire, in remanding the case until Thursday, said there had been no evidence as yet offered to show that Armstrong had arranged for Johnston's transportation, contrary to the act. A similar charge against Geo. McGuire may be laid.


