An Act to charge the Corporation of the City of Toronto with the payment of the expense of taking care of, supporting and maintaining, certain prisoners in the Common Goal of the United Counties of York and Peel.

WHEREAS the Corporation of the United Counties of York and Preamble. Peel, have, by their petition, represented that they have paid the expenses of taking care of, supporting and maintaining, in the Common Jail of the said United Counties, the prisoners committed by the Police 5 Magistrate and other Magistrates of the City of Toronto, for crimes and other offences committed within the territorial limits of the said City, from the first day of January, in the year of Our Lord one thousand eight hundred and fifty-seven, to the thirtieth day of November. in the year of Our Lord one thousand eight hundred and fifty-eight, 10 without having been compensated therefor by the said City of Toronto; and the said Corporation of the said United Counties have prayed that such expense incurred during the period aforesaid for the purposes aforesaid, be made a debt chargeable upon and payable by the Corporation of the said City of Toronto to the said Corporation of the United 15 Counties of York and Peel, and that the amount of such debt may be ascertained by arbitration in the manner provided by the three hundred and fifty-eighth section of the Act respecting the Municipal Institutions of Upper Canada, and it is just that the prayer of the said Petitioners should be granted: Therefore, Her Majesty, by and with the advice 20 and consent of the Legislative Council and Assembly of Canada, enacts as follows:

1. The expense incurred by the Corporation of the United Counties The said exof York and Peel, in taking care of, supporting and maintaining, the penses to be persons committed to the Common Goal of the said United Counties, City to the 25 between the first day of January, in the year of Our Lord one thousand United Councight hundred and fifty-seven, and the thirtieth day of November, in ties. the year of Our Lord one thousand eight hundred and fifty-eight, by the Police Magistrate and other Magistrates of the City of Toronto, for crimes or offences committed within the territorial limits of the said 30 City, shall be borne by the Corporation of the said City of Toronto, and be paid to the said Corporation of the United Counties of York and Peel.
