

NEW WESTMINSTER, B. C., 8th February, 1893.

To the Grand Lodge of British Columbia, I. O. O. F.:

REPRESENTATIVES,—It affords me much pleasure to extend to you a cordial greeting and a fraternal welcome, and to be able to present my report at this our nineteenth annual session.

The increase to our membership has exceeded that of any previous year since our institution, in fact the increase is more than equal to the entire strength of the order in this Province up to the year 1883, this in itself speaks very highly for the esteem and general popularity of the order throughout the country.

The membership in the Auxiliary Benefit Endowment Association has largely increased in numbers, which already shows the advantage of having a canvasser for this branch of the order, but there is still room for improvement.

I am pleased to observe that the "Team Work" has taken such a strong hold on most of the city Lodges, and when once introduced its vast superiority over the old style of work is so apparent that it requires no argument to convince any Lodge of this fact.

No very serious questions have arisen during my term of office. My duties have been of a very pleasant character.

#### APPEALS.

March 30, 1892, received an appeal from Bro. Benj. T. Conger, P. G. of Morse Lodge, No. 257, of California, through the Grand Master of California, on behalf of Bro. David Green, of Dominion Lodge, No. 4, protesting against the manner in which Bro. Green was refused benefits, tried, found guilty and expelled for having used the Order for his own purposes. Bro. Green has not complied with Section IV., Rule I, Constitution of Subordinates: "All appeals shall be presented within twenty days from the action of the Lodge appealed from." I therefore rule that the appeal of the aforesaid Brother is out of date.

I received an appeal from the General Relief Committee of Seattle, through the Grand Master of Washington, against the action of Dominion Lodge, No. 4, in refusing to reimburse said Committee the amount of \$90.00, being sick benefits paid to Bro. Cowan of said Lodge. The point of dispute, as raised by the Lodge, is that the Lodge was not properly notified. This, I consider, immaterial, as Bro. Cowan held a card in date at the time he was taken sick. Therefore, on the 22nd June, 1892, I gave a decision against Dominion Lodge, No. 4, and at the same time requested them to forward the amount due to the General Relief Committee of Seattle. Shortly after this I received a reply from Dominion Lodge, No. 4, stating that they would pay the money into my hands under protest and that I might send it to Scattle, if I thought proper to do so, but the Lodge would appeal from my decision to the Grand Lodge of British Columbia at its next session. On August the 4th I received a post office order from Dominion Lodge, No. 4, for the \$90.00, which I at once deposited in the Savings Bank department of the Bank of British Columbia, where it now lies awaiting the decision of the Grand Lodge, as I did not wish to incur any personal responsibility in the affair, as would be the case in the event of the Grand Lodge reversing my decision.

May 9, 1892, received an appeal from Victoria Lodge, No. 1, against the decision of the D. D. G. M. of District No. 1, by his answering the following question in the affirmative: "Is a brother entitled to benefits who is out of standing for two weeks, then pays his dues and reports himself sick for three weeks previous"? I decided that the brother was not entitled to benefits. See Article IV., Section 4, Constitution of Subordinates: "When a member's account shows an indebtedness of three months' dues the brother shall not

be entitled to benefits." Also, By-laws of Victoria Lodge, No. 1, Article XIX, Section 1, page 47, line 20, "Benefits shall not commence more than one week previous to the date of being reported sick."

January 30, 1893, Bro. J. Wriglesworth, P. G. M., appealed against the action of Dominion Lodge, No. 4, in refusing him benefits on two occasions. I cannot give a decision in the case, as I have not had time to hear from Dominion Lodge in the matter. I will, therefore, hand all papers connected with this case to my successor in office.

May 26th, 1892, paid an official visit to Western Star Lodge, No. 10, Vancouver.

June 15th, 1892, visited Black Diamond Lodge, No. 5, Nanaimo.

The affair concluded with a short musical programme. I must congratulate Cloverdale Lodge, No. 15, on the neat and tidy appearance of their hall; there is certainly quite a contrast between their present premises and those used on the occasion of their institution.

#### QUESTIONS.

On March 15th, 1892, from Cloverdale Lodge, No. 15: "Has a Subordinate Lodge power to say that they will meet only once in two weeks?" Answer, No. See Article X, Section one, Constitution of Subordinates: "All terms shall commence on the first day of January and July in each year." Also, see White's Digest, section 1437: "When Lodges have half-yearly terms their meetings must be held weekly." This question arose from the fact that the Committee on Laws of Subordinates, at our last session did not observe that Cloverdale had a bi-weekly meeting clause inserted in their by-laws, and as a consequence the Grand Lodge passed these by-laws in an incorrect state, on the recommendation of the aforesaid committee.

On June 10th, 1892, from Excelsior Lodge, No. 7: "Is it a violation of the rules of Oddfellowship for a Lodge to donate a lot or portion of a lot in a cemetery

#### SUGGESTIONS.

I would suggest that the Grand Lodge procure a cheap set of regalia and paraphernalia to be used by newly Instituted Lodges, until such time as a proper set can be secured from some of the eastern manufacturers, which would require about two months.

There is frequently quite a lot of trouble in this matter of regalia with Lodges situated in remote parts of the Province, which have to work at quite a disadvantage for the first month or so. Of course, in the case of new Lodges in the cities, where the Order now exists, this difficulty does not exist.

I would also recommend that this Grand Lodge hold a secret session, and that our Grand Representatives be requested to rehearse the "unwritten work" at same. As matters now stand several of our Past Grands and Grand Instructors differ to a considerable extent in giving instructions. I consider it is about time that this matter of unwritten work should be brought to your notice. It is certainly a very important question and one which should not be lost sight of.

Annexed are the reports of my District Deputies so far as received, together with such comments thereon as I have deemed advisable to make. I also enclose a report from Bro. D. Welsh, P. G., Official Canvasser for the Auxiliary Benefit Endowment Association.

As my term of office is now expiring and I am about to surrender its responsibilities to another, it is pleasing to me to be able to say to you that during this year which is just ending, our Order has more than kept pace with the advancement and general prosperity of the Province, and from what information I have in my possession it is clearly evident that the future is bright and full of promise. My relation with the Order in general has been of a cordial, fraternal and truly pleasing character.

I sincerely thank you for the honor which you conferred on me a year ago.

I have endeavored to perform the duties incumbent to the position, to the utmost of my ability, if I have not given you satisfaction I feel that your charity is sufficiently extended to overlook any unavoidable mistakes or unintentional blunders.

I teel deeply grateful for the kind assistance which I have received from my associate in office, Grand Secretary Davey, and to all officers and members of the Order who have in any way assisted me during my term of office.

- 6th. That the Association agree to pay one thousand dollars as a Death Benefit, or such amount as shall be realized from one assessment.

GRAND SECRETARY'S OFFICE, VICTORIA, B. C., 6th February, 1893.

To the Grand Lodge of British Columbia, I. O. O. F.:

DEAR SIRS AND BROTHERS,—In compliance with the requirements of the law, I beg to lay before you a report of the transactions of this office for the past year, and of the standing of the Order in this jurisdiction on the 31st December, 1892.

The directions of last session to procure Digests, and supply the same to the District Deputy Grand Masters for their official use, has been complied with, ten digests have been purchased and furnished accordingly.

The instruction as to new Grand Lodge regalia has been carried out, new collars have been obtained from the M. C. Lilley & Co., of Columbus, Ohio.

I regret to announce that death has again invaded our ranks and removed from our midst our esteemed Brother Charles Gowen, P.G.M., whose cheery lace and genial manner were familiar to the old members of this Grand Lodge. He was for many years a prominent and active worker for our Order in this Province, was present at the institution of this Grand Lodge, and was appointed to the office of Grand Marshal. He also filled the office of Grand Master for the year 1879-1880. He died on 8th December, 1892, and in accordance with precedent and the expressed wish of many brothers, I called on the members of the Grand Lodge by advertisement, to attend his funeral. I beg to recommend that a memorial page be inserted in the printed proceedings of this session.

The first veteran jewel applied for in this jurisdiction, has been supplied to Bro. Geo. Norris, P.G., of Black Diamond Lodge, No. 5, Nanaimo, and as there are several brothers who are entitled to wear this honorable decoration, I trust they will also take an early advantage of this privilege.

An appeal was received from Dominion Lodge, No. 4, against the decision of the Grand Master ordering it to pay the sum of \$90 to the General Relief Committee of Seattle, Wash., for 9 weeks sick benefits advanced to a member of that Lodge, and was immediately transmitted to the Committee on Appeals.

It will be seen by the foregoing that the finances of the Grand Lodge are in a very satisfactory state, the Revenue has exceeded the Estimate by \$477, and the balance in the Grand Treasurer's hands is \$389.31 more than the estimate.

In this connection I would remark that no provision has hitherto been made in the Estimate for the purchase of the necessary supplies for Subordinate Lodges, whose requirements at present are considerable and steadily growing. As the Sovereign Grand Lodge insist on all orders being accompanied by cash, and as it would be more convenient and satisfactory in every respect, I would suggest that a standing resolution be passed at this Grand Lodge requiring that all orders for supplies from this office must be in future accompanied by the requisite amount, observing that this is the practice in other Jurisdictions.

I think it will be conceded that the progress we have made in the past year is very gratifying, and that notwithstanding the keen competition which now exists between Societies similar to our own, we have succeeded in maintaining the position we have so long occupied as the foremost Society in this Province in point of numbers, funds and the amount of benefits we dispense.

This pre-eminence we should be proud of and strive by every legitimate means to uphold. The success which has attended in such a marked manner the Institution of "Centennial" Lodge, No. 20, at Nanaimo, enabling it to report a membership of one hundred and four, in little more than six months after organization, illustrates what a few zealous and active brothers may do.

Another very pleasing feature of the reports is the reduction in the average sickness experienced and amount of Benefits per member paid during the year, attributable no doubt to the influx of young and healthy members. The average available assets per member also shows an appreciable increase. These figures prove conclusively that our Lodges are in a more satisfactory condition to-day than they were twelve months ago.

Although the increase in Lodges and members necessarily entails additional work in this office, I view the growth and prosperity with great pleasure, and feel a justifiable pride in being identified with such a noble Institution whose principles and objects not only deserve but command success, sentiments which I am sure are shared in by you all.

# AUXILIARY ENDOWMENT BENEFIT ASSOCIATION.

GRAND SECRETARY'S OFFICE, VICTORIA, B. C., 6th February, 1893.

To the Grand Lodge of British Columbia, I. O. O. F.:

DEAR SIRS AND BROTHERS,—As Secretary of the above Association, I have much pleasure in presenting you with a report of its proceedings for the past twelve months.

The action of the Grand Lodge at its last session in authorizing the appointment of a special agent to canvas the jurisdiction on behalf of this Association, has been acted on, and Bro. D. Welsh, P.G., of New Westminster, was commissioned to undertake this duty. The remuneration paid at the start was \$1 for each new member secured, but it was found to be inadequate, and was subsequently increased to \$1.50.

The success met with through this arrangement has been encouraging, the agent has visited all the Lodges within reasonable distance of his home, and as a result we have added 83 new members to our roll, the great majority of whom are young men, thus reducing the average age and decreasing the probable cost of the insurance offered. It is anticipated that like encouraging results will attend the next year's work, and that the Association will in a short time assume respectable proportions. To secure if possible this object, it is proposed to make a special effort in the ensuing year by printing and distributing copies of this report, and other information amongst the members, and by requesting every Lodge, not

having an agent of the Association, to appoint one of its members as such to look after its interests.

One death has occurred since my last report viz., Bro. Chas. Gowen, P.G.M., of Victoria Lodge, No. 1, and the sum of \$267.05, the amount realized by assessment No. 11, has been paid to the beneficiary of the deceased. Another assessment is now in course of collection to meet this loss.

The following statement shows the membership of the Association at this date, and the amounts of money collected, disbursed and now remaining on hand:

This Association was organized 1st April, 1884, and since that date has paid 14 death claims aggregating \$2820.50. To meet these claims 11 assessments have been levied, which have realized \$2181.80, and \$638.70 has been taken from the Reserve Fund to make up the difference.

The Reserve Fund consists of back assessments paid by members on reinstatement after suspension, and the balance of amount received for dues after the expenses of management have been met.

The cost to the average age member of 40 years from the commencement of the Association has been \$16.50 for assessment and \$13.50 for dues, a total of \$30 for nine years, or an average of \$3.33 per year, and this cost could be materially decreased if the membership were larger.

The simplicity of the system of this Association, the economy of its management and its trifling cost should recommend it to the brotherhood of this jurisdiction, and if all who are eligible were to join it, we should be able to pay a benefit of about \$2000.

Trusting that next years efforts may be exceptionally successful, and asking the co-operation and assistance of the entire membership to that end, so that we may be all mutually benefitted,

The Grand Marshal having declared all the Representatives present duly qualified, and the Grand Chaplain, Bro. Rev. J. W. Venable, offered prayer, the Grand Lodge was declared open for business by the Deputy Grand Sire, Jl. T. Campbell.

The representation has increased during the last year, making the total membership 197.

#### GRAND SIRE'S REPORT.

The Grand Sire submitted his report for the past year, abstracts of which are here given for your information.

#### CONDITION OF THE ORDER.

The report of the Grand Secretary, whose energetic devotion to the duties of his office I take pleasure in commending, will exhibit to you in attractive detail the we derful progress made by the Order during the year 1891. A tabulated st took in I totals is herewith given. The net increase of active Lodge membership from January 1st, 1891, to January 1st, 1892, was 48,807. This is the largest increase ever made in a single year, in the history of the Order. The Lodge membership in good standing, on the first of last January, had reached the enormous total of 721,146, and including the Sisters of Rebekah Lodges, 802,881. The expenditures for relief, the test of the operative fraternity of the Order, during 1891, were \$3,176,382.08. It is interesting to compare the relative progress of the Order with that made by our English brethren. On January 1st, 1890, the membership of the Manchester Unity of Odd Fellows exceeded our membership by 14,316. On January 1st, 1892, the membership of the Independent Order of Odd Fellows exceeded that of the Manchester Unity by 33,378. The total membership of both Orders on January 1st, 1892, aggregated 1,572,384, a membership largely greater than that of any benevolent society on the face of the globe. # DECISIONS.

I herewith enumerate the decisions rendered by me, since I resumed the duties of my office. The decisions rendered by the Acting Grand Sire, are included in his official report to me as heretofore stated:

1. It is within the power of a State Grand Lodge, to which application is made for the use of the name of the Order, to decide whether or not the enterprise for which such application is made, comes within the legitimate uses of the Order; but the decision of such State Grand Lodge must be in pursuance of the legislation of the Sovereign Grand Lodge, and especially in furtherance of the specific prohibitions and general tenor of the resolution of the Sovereign Grand Lodge, found on page 12,677 of the Revised Journal of 1891. Such decision must, of course, also be made subject to the revisory jurisdiction of the Sovereign Grand Lodge.

3. It is not within the power of a Grand Master, or Grand Lodge, to grant permission to a Subordinate Lodge, or Rebekah Lodge, to hold meetings alternately, in two separate towns.

- 4. The Constitution of the Grand Lodge of Minnesota provides, that that Body "shall be composed of the duly qualified Past Grands of all the Subordinate Lodges within the State," and does not in any way restrict its legislative power to any representative basis whatever.
- Held, That for the purpose of establishing the fact that a quorum of Lodges is present at roll-call, a Past Grand of any Lodge in good standing, may answer for his Lodge, whether he be a duly elected Representative or not.
- 6. The provisions of Section 1,211, White's Digest, do not nulify or abrogate the general law, (or a specific provision in the Constitution of a Rebekah Lodge, in affirmance of the general law), declaring that good standing in a Subordinate Lodge is essential to retention of membership by a brother in a Rebekah Lodge. It was never intended by the legislation embodied in Section 1,211, to make Rebekah Lodges, at least so far as their make members are concerned, separate and independent organizations, with the power residing in male members to retain their membership, without regard to, and independent of their membership and standing in their Subordinate Lodges.
- Membership in a Rebekah Lodge is terminated by suspension for nonpayment of dues in the Subordinate Lodge.
- 8. Membership in a Rebekah Lodge is terminated by taking a Withdrawal Card in the Subordinate Lodge.

As the receipt of a Withdrawal Card from a Subordinate Lodge, destroys the good standing of the member in such Subordinate Lodge, and as good standing in his Subordinate Lodge is essential to his retention of membership in his Rebekah Lodge, it necessarily follows that the taking of a Withdrawal Card terminates his membership in the Rebekah Lodge.

9. Membership in the Rebekah Lodge, is dependent upon continuous good standing in a Subordinate Lodge, as a Brother of the Degree of Truth.

The law permitting a brother to hold his membership in his Encampment for twelve months after taking a Withdrawal Card, is by reason of a specific enactment (Section 954, White's Digest), which does not include membership in a Rebekah Lodge.

- 16. The provision in the Constitution of a Rebekah Degree Lodge, "that no member shall be eligible to the office of Noble Grand, unless previous service is shown in the office of Vice Grand in a Subordinate Lodge, or Rebekah Degree Lodge," is invalid in so far as the requirement in regard to previous service in a Subordinate Lodge as affecting eligibility to office in a Rebekah Degree Lodge is concerned, being in conflict with decision No. 8, of the Acting Grand Sire, reported on page 12,355, Revised Journal of 1891.
- 18. If the Noble Grand-elect shall be excused by the Lodge, on account of sickness or disability, from attendance at the time when he should have presented himself for installation, and if the Lodge shall continue to excuse him on account of such sickness or disability, up to the time when he shall present himself for installation during the term for which he was elected, then upon his so presenting

himself, he is entitled to be installed and, if he serves until the expiration of his term, will be entitled to the honors thereof. The Sitting Past Grand having been inducted into that office at the time the other officers were installed, including the Vice Grand, should have, thereafter, occupied his chair as Sitting Past Grand, and the Vice Grand, under Section 961 of White's Digest, should have occupied the chair and discharged the duties of Noble Grand.

- 37. It is contrary to law, in conferring the Initiatory Degree, to admit to the Lodge room all the candidates except one, and, after obligating them, permit them to witness the initation ceremony on the other candidate.
- 38. Ques.—Is it proper for the Noble Grand to appoint upon a committee to retire and examine a visitor, a Past Grand belonging to another Lodge, who is a possession of the A. T. P. W. through his official position in the Order?
- Ans.—Strictly speaking, it is not within the power of a Noble Grand of a Lodge to appoint upon a committee a member of any other Lodge, because the possession of the power to appoint pre-supposes the possession of the power to compel service. But if a member of another Lodge, possessing the A. T. P. W., is willing to serve upon such committee, I take it, that unless objection is made, the Noble Grand has the right to request and permit such service.
- 45. Ques.—Can a Grand Officer who has taken a Withdrawal Card from his Subordinate Lodge or Encampment, perform any official duties as such officer until he has deposited his Card with a Subordinate Lodge or Encampment?

Aus. - No.

- 46. Ques.—How do you construe Section 883, Digest of 1889, which says that a Grand Officer does not vacate his office for the space of one month after taking a Withdrawal Card from his Subordinate Lodge or Encampment.
- Ans.—My construction of Section 883, taken in connection with certain other sections hereinafter mentioned, is that while a Grand Officer does not "vacate his office" for the space of one month after taking a Withdrawal Card, yet the exercise of the functions of his office is suspended, until he deposits his Card in another Lodge or Encampment.
- 47. Ques.—How do you construe Section 883, Digest of 1889, in connection with Sections 790 and 793, on the same subject?

Ans.—My construction of the sections named, together with Sections 895 and 896, is as follows: A Grand Officer taking a Withdrawal Card, has a right to deposit the same within one month, in another Lodge or Encampment, or to immediately deposit it in his State Grand Body accompanying an application for a Charter for a new Lodge or Encampment. During the time between his taking the Card and depositing it in another Lodge or Encampment, or during the time between the taking of the Card and the institution of a new Lodge or Encampment of which he becomes a Charter member, the discharge by him of the functions of his office is suspended, to be revived (if before the expiration of his term), upon the deposit of his Withdrawal Card, or the institution of a new Lodge or Encampment, as aforesaid. I think the above is the only construction of the law,

- 48. Ques.—Can a Grand Officer, who has taken a Withdrawal Card from his Subordinate Lodge or Encampment, under these sections of the law, deposit his Withdrawal Card in his Grand Body for issuing of a charter for a new Subordinate Lodge or Encampment, sign the same as such Grand Officer, and institute such Subordinate Body legally under the law, as such Grand Officer?
- Ans.—He can deposit the Card, of course, but although a Grand Officer, by taking a Withdrawal Card does not thereby "vacate his office," yet the discharge of the duties by him is suspended, as I have above stated, and during the period of such suspension, and until he resumes the duties incident to his office, as stated in my answer to the preceding question, the duties of the office devolve upon the Deputy Grand Master, or Grand High Priest, as the case may be. (See Section 895.)
- 49. Ques.—1s it legal for a Grand Lodge to assume the payment of sick benefits in its Jurisdiction, taxing all its Subordinate Lodges to provide a fund for that purpose?

Ans. -No.

50. Ques.—Is is legal for a Grand Lodge to form a sick benefit fund, to which such of its Subordinate Lodges as may be willing, can contribute such sums as the Grand Lodge shall name, and out of which sick benefits shall be paid to the members of such contributing Lodges only?

Ans. -No.

51. Ques. Is it legal for a Grand Lodge to undertake the payment of any benefits?

Ans. No.

In my opinion, under the laws and polity of the Order, as at present existent and operative, Subordinate Bodies are charged with the duty of providing and dispensing benefits to their members entitled to the same, and this duty cannot be assumed by, or transferred to, Subordinate Grand Bodies.

- 52. A Grand Representative, not being a Past Chief Patriarch, or Past High Priest, is not entitled to sit in a Grand Encampment. (See Section 590, White's Digest.)
- 53. A member of a Lodge entering a Lodge room while the Lodge is in recess, should be required to retire and work his way in, according to law, when the Lodge resumes its regular session.
- 54. A person elected to membership in a Rebekah Degree Lodge, must have the Degree conferred upon him in the Lodge in which he was elected. The right and duty of conferring this Degree, which is equivalent to initiation, cannot be transferred to another and different Lodge.

# REPORT OF THE DEPUTY GRAND SIRE (ACTING GRAND SIRE).

Hon. C. M. Busbee, Grand Sire, I. O. O. F.:

DEAR SIR AND BROTHER,—I have the honor to submit to you the following report of my administration of the office of Grand Sire, from the adjournment of the Sovereign Grand Lodge in September, 1891, until your resumption of the duties of the position in January last. Routine work, the issuing of Dispensations, examining of Constitutions, etc., coming within the direct cognizance of the Grand Secretary, will be reported to you by that officer.

#### DECISIONS

- 1. A report of a Committee on Character must be signed by a majority of the committee. Two so-called reports, one in favor of the applicant and one against, each signed by a single member of the committee, are not proper reports to be received and acted upon by the Lodge.
- 2. Non-beneficial members are entitled to the same rights and privileges as beneficial members, except in the matter of benefits; they can vote and hold office.
- 3. A brother paying up arrears of dues while ill, and dying before he became beneficial, the Lodge is not required to refund the arrears so paid.
- 4. While a candidate's application for membership must be received and acted upon at regular meetings, his initiation may take place at a special meeting called in accordance with the By-laws.
- 5. The election and installation into office of a member who is disqualified by law for such office, is null and void, and should be so declared by the proper authority in the Jurisdiction, and the vacancy filled according to law.
- 6. A Subordinate, or Rebekah Degree Lodge, may use any form of Floor Work it prefers, provided it conforms in all respects to the Ritual; the forms authorized by the Sovereign Grand Lodge are only guides, and are not obligatory. But if a Lodge uses any other form than that provided by the Sovereign Grand Lodge, it is not proper to print and publish the same, as it must of necessity contain reference to the Ritual and ceremonies of the Order, which can only be printed or published by authority of the Sovereign Grand Lodge.
- 7. A Lodge may procure as many copies of the authorized Floor Work as it requires, but they should be retained in the custody of the Lodge, for the use of its officers; they are not to be sold to, or held by, individual members as personal property.
- 11. It is the duty of Grand Representatives to report to their several Jurisdictions, all enactments of the Sovereign Grand Lodge, in the matter of general law, and it is the duty of the Executive Officers of the Jurisdictions to communicate the same to their Subordinates. But the failure of either Grand Representatives, or Executive Officers, to perform their duty in the premises, would not render the law inoperative. All general laws come into force on the 1st of January

following their adoption (unless otherwise ordered by the Sovereign Grand Lodge) whether the same have been officially announced by the officers of the Jurisdictions or not. The publication of the proceedings of the Sovereign Grand Lodge is, in effect, an official announcement of law by that body.

We have not given you all the decisions, but only those which we think will be of use and a benefit to this Jurisdiction, to have printed in these proceedings.

As all the brothers do not possess copies of the proceedings of the Sovereign Grand Lodge, and therefore have not the same opportunity of persuing the appeal cases and the decisions thereon, we submit two of the most important.

To the Sovereign Grand Lodge of the Independent Order of Odd Fellows:

Your Committee on Appeals to whom was referred the appeal of Harper Wilson, P. G. P., from the decision of the Grand Lodge of Manitoba, would respectfully report that they have carefully considered the same, and find the following to be the facts:

At the last session of the Grand Lodge of Manitoba the following question was submitted to the Judiciary Committee: Minnehaha Lodge, No. 7, having a By-law providing in case of a contagious disease, the Lodge, instead of appointing brothers to watch, might hire a nurse and pay for the same out of the funds of the Lodge, to wit:

"A brother taken sick while more than thirteen weeks in arrears, would the N. G. be justified in having brothers sit up with him, or in case he had a contagious disease, could the Lodge hire a nurse and pay for the same out of the funds of the Lodge?"

The Judiciary Committee reported thereon as follows:

"It is a fundamental principle of Odd Fellowship that a brother in arrears for dues, who is not suspended, is entitled to be visited by the officers of his Lodge and cared for in sickness, although he may not be entitled to pecuniary benefit. (See White's Digest, clause 49) and submitted the following:

"Resolved, That the foregoing report be adopted;" which upon being put to a vote was declared lost.

From this decision of the Grand Lodge, Bro. Wilson asked and obtained leave and appeals to this Grand Lodge.

The Judiciary Committee, beyond question, reported the law of this Grand Body and of the Order correctly, and the Grand Lodge of Manitoba erred in refusing to adopt its report. We therefore offer the following:

Resolved, That the decision of the Grand Lodge of Manitoba be reversed and the appeal of Harper Wilson be sustained.

To the Sovereign Grand Lodge of the Independent Order of Odd Fellows :

The Committee on Appeals to whom was referred the appeal of Union Lodge, No. 14, I. O. O. F., appellant, and W. L. Stafford, appellee, have had the same under consideration, and report:

The following appear to be the facts as stated in the case. Brother Wallington, a member of Union Lodge, No. 14, I. O. O. F., Winnipeg, Manitoba, was taken ill on Monday, December 28th, 1891, as shown by physician's certificate of same date and was unable to work from noon that day. On the evening of that day Bro. Wallington was reported sick. The following week the Visiting Committee reported to the Lodge that he was still ill, but not entitled to benefits.

A subsequent meeting brought from the committee a report against the payment of benefits, and the Lodge adopted the report.

On January 27th, 1892, Bro. Wallington died. In February, Bro. W. L. Stafford, of Union Lodge, on behalf of Mrs. Wallington, the widow, appealed to the Grand Lodge from the action of the Lodge in refusing benefits. The report of the Appeal Committee of the Grand Lodge was adverse to the action of the Lodge, which report was adopted by the Grand Lodge, and from this decision Union Lodge now appeal.

There is but a single question in the case which your committee deem it necessary to consider in reaching a determination thereof.

It appears from the record that Bro. Wallington, by his receipt for dues dated September 14th, 1891, was clearly in good standing until the last meeting night in December, and was taken sick at noon December 28th, eight hours before the Lodge met on the evening of that day. Being sick and disabled, and in consequence thereof deprived of attending his Lodge that evening to pay his dues, the assertion that he was in arrears could not be lawfully made until the next meeting night, which was January 4th.

Now it is a fundamental principle of the Order that dues accrue from week to week and benefits are payable weekly, fractions of a week are not considered in either case. That dues, if paid to a Secretary between Lodge meetings, are credited to the brother, as of the meeting night subsequent to the day they are paid.

Therefore, if Bro. Wallington, on account of disability was deprived of paying his dues on the meeting night of December 28th, 1891, he could not be declared non-beneficial until January 4th, 1892. According to the record, it appears that he was beneficial to the time he was taken sick and having been beneficial when so taken sick, he could not become non-beneficial during that illness. The Lodge should have retained so much of the brother's benefits as would have accrued to keep him in good standing during his sickness.

Your Committee would, therefore, recommend the adoption of the following:

Resolved, That the appeal of Union Lodge, No. 14, I. O. O. F., be dismissed, and the action of the Grand Lodge of Manitoba, Canada, be sustained.

#### NEW LEGISLATION.

#### INSURANCE AND ENDOWMENT ASSOCIATIONS.

As we have in this Jurisdiction an Auxiliary Endowment Association, we deem it necessary as well as right and proper, that all the resolutions of the Sovereign Grand Lodge bearing on this subject should be laid before you.

We, therefore, present the resolutions in full.

To the Sovereign Grand Lodge of the Independent Order of Odd Fellows:

The Committee on Insurance, appointed at the session of this Body at St. Louis, in 1891, respectfully submits this, its report. The preamble and resolutions under which this Committee was appointed, read as follows. (Journal page 12,657.):

WHEREAS, A difference of opinion exists among the members of the Order relative to the meaning and scope of the laws relative to fraternal insurance; be it

Resolved, That all laws of the Sovereign Grand Lodge, relative to fraternal insurance, together with all decisions based upon such laws, including those made or reported at this session, be referred to the Special Committee on Insurance, with power to report such amendments or changes in existing laws as will tend to promote the welfare of the Order and protect its members, or will better define the privileges of such fraternal insurance companies and the power of the various Grand Lodges relative thereto.

We should simply compel the companies to give to us all the information obtainable as to their condition; bring that information home to the insured or applicant for insurance, to the end that he may reach his own opinion and conclusions intelligently.

Your committee recommends the adoption of the following resolutions:

Resolved, First—That every Association doing a life or accident, or life and accident business, and using the name of the Order or claiming to be an Odd Fellows' Insurance Company, or the membership of which is limited, by its charter, articles of association, fundamental law, by-laws, resolutions or practice, to members of this Order, shall on or before the first day of June, of each year hereafter, file with the Grand Secretary of the Sovereign Grand Lodge, and of the Grand Lodge of every Jurisdiction in which it proposes to transact business, a copy of its charter, articles of incorporation, fundamental law, by-laws, and all amendments thereto, and of all resolutions and action had by the company or association affecting the liability or status of persons insured therein, verified by affidavits of its President, Secretary and Treasurer, and signed by said officers and the Directors or Managers of such company or association.

Second—That at the same time, every such company or association shall file with the Secretary of the Sovereign Grand Lodge, and of the Grand Lodge of every Jurisdiction in which it proposes to transact business, a report similarly

verified, for the year ending on the 31st day of December, or prior thereto, setting forth:

- 1st. Full name of corporation and principal place of business.
- and. Date of incorporation and commencement of business.
- 3rd. Character of business.
- 4th. Names and Residences of President, Secretary, Treasurer and Directors or Managers.
  - 5th. Number of policies in force on December 31st of previous year.
- 6th. Number of policies in force on December 31st of the year covered by the report.
- 7th. A list of all losses paid during the preceding year, giving name of the assured, his residence, amount paid and cause of death.
  - 8th. Number of new policies issued during the year.
  - 9th. Number of policies lapsed during the year.
  - 10th. Amount of entrance fee.
  - 11th. Amount of periodical dues.
  - 12th. Maximum amount of risk on any one life.
- 13th. Whether policies issued for a specified amount to be paid, or amount dependent upon assessment.
- 14th. What portion of premiums (if any) is set apart for mortuary purposes, and what for expenses.
  - 15th. How is mortuary fund invested.
  - 16th. Whether the association issues endowment certificates.
- 17th. Are assessments graded on any table of mortality? How are they graded.
  - 18th. How and when are Officers and Directors elected?
  - 19th. What medical examinations are required before issuing policies?
- 20th. What amount of money will an ordinary assessment for the payment of a single certificate yield?
  - 21st. Has the Association an emergency or reserve fund?
  - 22nd. What is the amount?
  - 23rd. How is it invested?
  - 24th. For what purpose is it used?
- 25th. A list of all the assessments laid during the year, their purpose in detail of assessment, and amount realized on such.

#### STATEMENT OF ASSETS.

- 26th. Cost value of real estate, its character, and how and when acquired?
- 27th. Description of encumbrances thereon, and for what purpose created?
- 28th. Loans and how secured; details?
- 29th. Bonds, stock, etc., owned absolute; details?
- 30th. Agents' ledger balances?
- 31st. Cash in office?
- 32nd. Cash in banks, and what banks?
- 33rd. All other assets in detail?
- 34th. Are any of your funds loaned to any Officer or Director of your Company, or are they or any of them interested in such loans directly or indirectly, or in any way responsible therefor.

#### STATEMENT OF LIABILITIES.

- 35th. Losses due or unpaid?
- 36th. Taxes due and unpaid?
- 37th. Salaries, rents and officers' expenses due and unpaid?
- 38th. Borrowed money?
- 39th. Advanced assessments?
- 40th. All other liabilities, indicating their character?

Third. At the same time such Association shall file with the Secretary of the Sovereign Grand Lodge, a certificate from the Insurance Department (if any there be issuing certificates to assessment companies) of the State, Territory or Province under the laws of which such Association is incorporated or formed, setting forth that said Association is authorized to do a life or accident, or life and accident insurance business, and that it has complied with the requirements of such Insurance Department.

Fourth. Such Company shall also at the same time file with the Secretary of the Grand Lodge of the Jurisdiction in which it proposes to transact business, a duplicate of said certificate and also a certificate from the Insurance Department (if any there be issuing certificates to Assessment Companies) of the State in which it so purposes to transact business, showing that it has complied with the laws of such State and is legally entitled to do business therein.

Fifth. Upon the filing of the reports and certificates hereinbefore provided for, with the Grand Secretary of the Sovereign Grand Lodge, it shall be the duty of the Grand Sire and Grand Secretary to issue to such Company a certificate setting forth that it has complied with the laws of the I. O. O. F. relative to organizations for the transaction of life or accident or life and accident insurance, and is entitled to transact such business for the period of one year from the date of such certificate in the territorial limits of such Grand Lodge or Lodges, as through its

officers shall grant permission for that purpose under the Laws of the Order. Said certificate shall set forth distinctly that neither the Sovereign Grand Lodge nor State Grand Lodge or Subordinate Lodges are in any way responsible for the engagements or contracts of such Company or Association, nor shall the certificate be considered or assume to be an endorsement or recommendation of said Association nor of its solvency or responsibility.

Such certificate shall entitle such Company to transact its business in the territorial limits of such Grand Lodges, as through its officers shall grant such permission as hereinafter provided.

Sixth. Upon filing with any Grand Secretary of any Grand Lodge, the cericate and reports, hereinbefore provided for, together with the above-mentioned rificate from the Grand Sire and Secretary of the Sovereign Grand Lodge, it shall be the duty of the Grand Master and Grand Secretary of such Jurisdiction, to issue to such Company or Association, a certificate substantially in the form hereinbefore provided for, to be issued by the Grand Sire and Secretary of the Sovereign Grand Lodge, and containing the same reservation, namely, that neither the Sovereign Grand Lodge, nor Grand Subordinate Lodges are in any way responsible for the engagements or contracts of such Company or Association, nor shall the certificate be considered or assumed to be an endorsement or recommendation of such Association, nor or of its solvency or responsibility.

Such certificate shall entitle such Company to transact its business in the territorial limits of such Grand Lodge; provided, however, that the Grand Lodge of any Jurisdiction may by resolution prohibit the granting of certificates of permission as herein provided for, to be issued by its Grand Master or Secretary to all insurance associations. Any action heretofore had by any Grand Lodge prohibiting insurance associations from doing business within its Jurisdiction shall remain unaffected by these resolutions.

It shall be the duty of all insurance companies or associations obtaining certificates as aforesaid to attach to each policy issued by it, a copy of such certificates and also of its character, articles of association, and by-laws or fundamental law, and amendments thereto, and of its last preceding report filed, or required to be filed with the Secretary of the Sovereign Grand Lodge or Grand Lodges.

Eighth. It shall be the duty of each association obtaining a license as aforesaid to mail on or before the first day of July in each year to each one of its insured members, or policy holders, a copy of the last preceding statement filed or required to be filed by it as hereintofore provided.

Ninth. Nothing herein contained shall be construed to permit the representative of any such association to solicit insurance in Lodge rooms, or while the Lodge is in session.

Tenth. Any violation of, or omission to perform and comply with the provisions of these resolutions shall work a forfeiture of the license granted.

Eleventh. Each association receiving such certificate, shall pay to the Secretary of the Sovereign Grand Lodge at the time of the filing of the annual report,

the sum of ten dollars, and a similar sum to each Grand Lodge Jurisdiction, granting such permission or certificate. Duplicates shall be furnished at the rate of one dollar each. The Secretary of the Sovereign Grand Lodge shall provide the certificates of authority to be used by the State Grand Jurisdictions, in blank form, at fifty cents each.

Twelfth. Any member of the I. O. O. F. who shall after July the 1st, 1893, in any capacity, directly or indirectly solicit, or attempt to solicit from any other member of this Order any life, or accident insurance for any association or company of the character specified in resolution numbered first of these series, which has failed to obtain the certificates, herebefore provided for, shall be liable, on trial and conviction, to be suspended or expelled from the Order.

#### MINIMUM BENEFIT LAW.

The resolution of P. G. Sire Sanders, amending the resolution found on page 12,760, Revised Journal, 1891, will, we think, settle this vexed question.

· To the Sovereign Grand Lodge of the Independent Order of Odd Fellows:

Your Committee on Legislation, to whom was referred the resolution of P. G. S. Sanders, the resolution of Rep. Semmes, of Alabama, and that of Rep. Thomas, of Utah, proposing amendments to the legislation of 1891, fixing a minimum benefit of two dollars per week—as also, the resolution of Rep. Miles, of Ohio, proposing the repeal of said legislation of 1891, beg to report that we find that the three propositions, first above referred to, are substantially the same, and tend to make more plain the intent of the legislation of 1891.

Having duly considered the subject, we recommend the adoption of the resolution offered by P. G. Sire Sanders, viz.:

Resolved, That the resolution adopted at the Annual Session of 1891, and as found on page 12,670, Revised Journal, be amended by adding at the end of word "member" in the third line of said resolution, the following words, "entitled to sick benefits by the Constitution or By-Laws of his Lodge," so that said resolution will read as follows, viz.:

Resolved, That it be and is hereby made obligatory upon each Subordinate Lodge of the Order to pay from its funds, during the continuance of the disability, a weekly benefit of not less than two dollars to every member entitled to sick benefits by the Constitution or By-Laws of his Lodge, who shall be disabled by sickness or bodily injury, from following his usual occupation, or otherwise earning a livelihood for himself; provided such disability be not the result of his own vice or immorality; provided, however, that Subordinate Grand Lodges may provide that when a member shall receive one full year's benefits, the weekly benefits thereafter to such member, may be fixed at not less than one dollar per week."

To the Sovereign Grand Lodge of the Independent Order of Odd Fellows:

Vour Committee on the Degree of Rebekah, to whom was referred the resolution offered by Rep. Rea, of Pennsylvania, asking that a sister who is a Past

Noble Grand of a Rebekah Lodge, and holds a commission from a Grand Master as his Deputy over Rebekah Lodges, may be specially deputed to institute a Rebekah Lodge, respectfully report that they have fully considered the same, and recommend the following:

Resolved, That a sister who is a Past Noble Grand of a Rebekah Lodge and in good standing, may be deputized by the Grand Master of the Jurisdiction in which she resides, to institute a Rebekah Lodge, or Lodges, and all provisions inconsistent herewith are hereby repealed.

#### MISCELLANEOUS.

It was resolved almost unanimously to remove the headquarters of the Sovereign Grand Lodge, back to its add and original home, Baltimore, Maryland, the cradle of Oddfellowship, where, in the opinion of your Representatives, it rightfully belongs, and we hope it may never again be taken from thence.

The next session of the Sovereign Grand Lodge will be held in Milwaukee, Wisconsin, that city receiving 101 votes to 65 for Chattanooga, Tennessee.

Dr. Cl. T. Campbell, of London, Ontario, succeeded Chas. M. Busbee to the office of Grand Sire, and J. W. Stebbins, of New York, was elected Deputy Grand Sire.

The question of admitting candidates into this Order at eighteen years of age, we are sorry to say, was again defeated.

The following were submitted and adopted in regard to what no doubt will be one of the grandest demonstrations in the history of Oddfellowship, to be held at Chicago during the World's Columbian Exposition, in September, 1893.

#### DEPUTY GRAND SIRE'S ACTIONS—PARADE OF 1893.

The matter of a general parade of the Order during the Columbian Exposition in Chicago in 1893, was left in the hands of the Grand Sire and the Commander of the Patriarchs Militant. In order to the successful carrying out of such a demonstration, it seemed to me that the active co-operation of the Odd Fellows of Illinois, should be secured, at as early a date as possible; and as the Grand Lodge of Illinois met in November, I requested Gen. Underwood to place himself in communication with that Body, which he did; the result being that a local committee was appointed to consult with you, and assist in conducting the affair to a successful issue. As there will be many details in the management of the parade, which will require the personal attendance of an officer of the Sovereign Grand Lodge, I requested Past Grand Sire Underwood, who resides in Chicago, to act for the Grand Sire as a Marshal-General.

To the Sovereign Grand Lodge of the Independent Order of Odd Fellows:

Vour Special Committee, to whom was referred that part of the report of the acting Grand Sire, that part of the report of the General Commanding the Patriarchs Militant, and the resolutions of Past Grand Sire Nicholson, all relating to the proposed demonstration at Chicago during the World's Columbian Exposition in 1893, have duly considered the subject, and would report that we com-

mend the prompt action of the Grand Sire (acting), in the premises, and fully concur in the view expressed by him, as well as in the action of P. G. Sire Underwood in presenting the matter to the Grand Lodge of Illinois, and asking the co-operation of that Jurisdiction. Your committee is gratified to know that the Grand Lodge and Grand Encampment of Illinois took action at their session in November, 1891, to heartily co-operate with this Grand Body, in making all necessary preparations, and in every way possible assisting in making the proposed demonstration a grand success.

As will be seen by reference to the Appendix to the Report of the Commander of the Patriarchs Militant, the Grand Lodge of Illinois raised a Special Committee of eight to act in conjunction with the Committee of this Grand Body.

Your committee is informed that said Committee has held several meetings, which have also been attended by Past Grand Sire Underwood, and the scope and extent of the proposed demonstration discussed.

Your Committee note the communication from the Special Committee of the Grand Lodge of Illinois, suggesting that the week commencing June 26th, 1893, be selected as the period to be devoted to the Independent Order of Odd Fellows' celebration, etc., and while your committee fully appreciate the fact that the date indicated would be a most desirable season to visit Chicago and a favorable time for the great demonstration, but considering the fact that this Grand Body has decided to hold its annual session in 1893 in the neighboring city of Milwaukee, your committee believe that a date just preceding or subsequent to said annual session would better meet the views of this Grand Body, and would also be a favorable time to secure a large attendance from all Jurisdictions.

We realize that to make such a display as will be expected of our great Order to inaugurate and successfully carry out a celebration on an occasion when the eyes of the whole civilized world will be upon us; to assure a celebration that will be highly creditable to an organization of 800,000 members will require the active earnest, cordial co-operation of every Jurisdiction subordinate to this Grand Body, as well as great diligence and much labor on the part of the committees that may be charged with the details.

To the end that the co-operation of every Jurisdiction, which is so essential, may be had, and that the proposed parade, demonstration or celebration to be had in the City of Chicago during the World's Columbian Exposition in 1893, may be worthy of the great Independent Order of Odd Fellows, we recommend the adoption of the following, which, with slight modification, and some additions, are the resolutions offered by Past Grand Sire Nicholson, viz:

Resolved, That the action of the Grand Sire (acting), and of P. G. Sire Underwood, in the premises, be and are hereby approved.

Resolved, That the fourth Monday in September, 1893, be, and is hereby fixed for a grand demonstration of the Order in the City of Chicago, in honor of Christopher Columbus, and the settlement and civilization of America.

Resolved, That the Grand Sire be, and is hereby authorized and requested to invite the respective Grand Lodges and Grand Encampments, under the Juris-

diction of the Sovereign Grand Lodge, to participate as hodies or by delegations at the fraternal demonstration at Chicago.

Resolved, That the Grand Lodges and Grand Encampments be requested to invite the Subordinate Lodges and Encampments, under their respective Jurisdictions, to participate with them in the demonstration.

Resolved, That as a further exhibit of the growth and advancement of the Order, there will be held in Chicago, on Saturday before the third Monday in September, 1893, a National Convention of the Degree of Rebekah, to be held under the auspices of the State Convention of Illinois, and to be temporarily organized by its officers.

Resolved, That in the recognition and approval of the proposed celebration, Lodges and Encampments shall have sufficient warrant to make appropriations to carry out the objects of the demonstration, in such a manner as they in their judgment shall deem proper.

Resolved, That an informal meeting of this Grand Lodge be convened at Chicago on the fourth Monday in September, 1893, at 9 o'clock A. M.

Resolved, That in addition to the Grand Sire and the General of the Patriarchs Militant, there be a committee of nine appointed to make such arrangements as may be necessary to carry the above resolutions into effect, and to co-operate with the Committee of the Grand Lodge and Grand Encampment of Illinois, in making the proposed demonstration successful and creditable to the Order.

#### VISITING CARDS.

To the Sovereign Grand Lodge of the Independent Order of Odd Fellows:

Vour Committee on Legislation, to whom was referred the resolution of Rep. Miles, of Ohio; also the resolution of Rep. Neither candidate having received a majority of the votes cast, a second ballot was spread, the name of J. E. Phillips, P. G. M., being dropped, and the following result announced:

Rep. W. H. Gardiner, No. 13, gave the following notice of motion, which was referred to the Committee on Legislation:

I hereby give notice, that I will to-morrow move to amend Section I, Article 2, of the Constitution of Rebekah Degree Lodges, by striking out the word "two" in lines 27 and 28, and insert the word "six" in lieu thereof, so as to make the paragraph read: "And if no more than six black balls shall appear, the candidate shall be declared elected; but if more than six black balls appear, the candidate shall be deemed rejected."

B. W. Shiles, P. G. M., No. 3, gave the following notice of motion, which was referred to the Committee on Legislation:

At to-morrow's session I will move that the rules of the Auxiliary Endowment Association be amended by inserting the

following: "All members in good standing of Rebekah Lodges of the I. O. O. F., shall be eligible to membership in this Association on the same terms as members of the Subordinate Lodges; provided, that a medical certificate of good health shall be furnished in such cases, if required."

Report read from Committee on Appeals, which was on motion, laid on the table until to-morrow.

To the Grand Lodge of British Columbia I. O. O. F.:

Vour Committee on Appeals have had under consideration the appeal of Dominion Lodge, No. 4, against the decision of the Grand Master directing it to pay the sum of \$90 to the General Relief Committee of Seattle, Wash., for nine weeks' Sick Benefits advanced to Bro. Henry Cowan, a member of said Lodge.

From the papers submitted it appears that this brother, who was residing near Seattle, reported himself to the General Relief Committee of that city as having been sick for nine weeks, and being in possession of a Visiting Card in date and furnishing the Committee with a medical certificate of sickness and incapacity to work covering a period of about eight weeks, the committee paid him \$90 for nine weeks' Sick Benefits.

The grounds of appeal as stuted by the Lodge, are, that as the Committee did not visit the brother during his illness, it should not have paid the amount in dispute without communicating with the Lodge and receiving authority to do so, and refers to Section 2, Article XX., of its By-Laws, in support of this contention, also Article 115 of White's Digest.

With respect to the first ground, it is alleged by the Committee that the Lodge was specially notified on 23rd August, 1891, which was during the brother's sickness according to the medical certificate, although in a former communication from the Commit : it is stated that Bro. Cowan did not report himself until after he was wet The Lodge avers it has no knowledge of such intimation. Your Committee are of opinion that this objection does not relieve the Lodge from liability. The possession of the Visiting Card in date is sufficient authority to pay a member Benefits when sick, and although the Committee did not visit the brother during sickness, he produced the medical certificate which is sufficient evidence of the fact. The By-Law referred to simply requires the production of such a certificate in the event of the residence of a brother at a point remote from his Lodge, and Section 115 of White's Digest, relied on by the Lodge, makes it imperative on a Lodge or General Relief Committee to promptly render the same fraternal sympathy and attention to a traveling or sojourning sick brother as they would bestow on a brother of their own Lodge, and to pay him the pecuniary benefits shown on his Card.

The appeal appears to be grounded on a mistaken idea of the Lodge, that it is essential for a Lodge or General Relief Committee to notify a brother's Lodge of the fact that he is sick and to receive special authority to pay him Benefits,

Royal City Lodge, No. 13.—Requiring medical certificate of candidate for initiation; formation of Contingent Fund; duties of Trustees.

Acme Lodge, No. 14. - Changing night of meeting.

Duncans Lodge, No. 17.-Altering night of meeting.

In consequence of a reported decision by a judge of one of the law courts of the United States, as to when "arrears of dues" commence to affect a brother's standing in relation to his claim for sick benefits, in all cases where these words occur in Bylaws that have been submitted to us, we have recommended the Lodge to adopt some other expression less equivocal, such as, "owing three months dues," or, "indebted to the Lodge in the sum of three dollars for dues," where the dues are

one dollar per month, the only exception being the case of Centennial Lodge, No. 20, where dues are payable in advance.

NEW WESTMINSTER, B. C., 10th February, 1893.

To the Grand Lodge of British Columbia I. O. O. F.:

Your Committee, to whom was referred the matter of revising the Rules of the Auxiliary Endowment Benefit Association, beg to report that we have duly considered the same and recommend that the following changes be made in the Rules in question:

Page 3-Name and Objects:—Alter the name of the Association, to "The Odd Fellows' Relief Association of British Columbia."

Page 3—Membership:—After the word "standing" in line one, insert the words "under the age of 55 years."

Page 4:—After the word "provided" in fifth line, insert the words "also a satisfactory Medical Certificate."

Page 4:—Strike out the words "ceases from any cause whatever to hold membership in a Subordinate Lodge of Odd Fellows" in lines 9 and 10, and insert the words "be expelled from the Order for cause."

Page 7-Fees, Dues and Assessments:-Line 3, strike out the words "One dollar" and insert "Two dollars and fifty cents." Line 3, after the word "and" insert the words "the applicant shall, if accepted, pay." Line 4, after the word "assessment" insert the words "within sixty days of the Certificate of Membership." Line 6, strike out the words "these amounts" and insert "the Application Fee of two dollars and fifty cents." Line 7, after the word "him" insert the words "the applicant must also pay the cost of the Medical Certificate." Line 14, after the word "benefit" insert the following, "Until the Endowment Fund shall consist of at least two thousand dollars, there shall be an assessment levied on the members at the usual rate of assessment on the first day of January, March, May, July, September and November, and when the sum on hand shall consist of two thousand dollars, it shall be discontinued, but whenever it shall be less than two thousand dollars the assessments shall be resumed as above." Line 24, after the word "suspension" insert the words "provided that he furnishes a Certificate of good health signed by the N. G. of the nearest Lodge to his place of residence and by an acceptable physician."

Page 9—Benefits:—Line 10, strike out the word "thirty" and insert the word "ninety."

Page 10:—Line 2, strike out all the words of the section after the word "the" and insert in lieu thereof the following, "sum of one thousand dollars, if there be that amount on hand in the Endowment Fund, and if there be not one thousand dollars on hand, then the order shall be for the full amount at that time in the Endowment Fund, which shall be paid over to the beneficiaries of the deceased in full settlement of all claims."

We would also recommend that the Grand Master appoint an agent in each District, as may be recommended by the Lodges, to further the interests of the Association.
