Sudden Death.

The sad and sudden death of Howard J. Ingram, son of Mr. George Ingram, of Newcastle, and for the past two years an employee of The Advocate office, occurred at 5.30 o'clock on Monday morning after only a few hours illness. 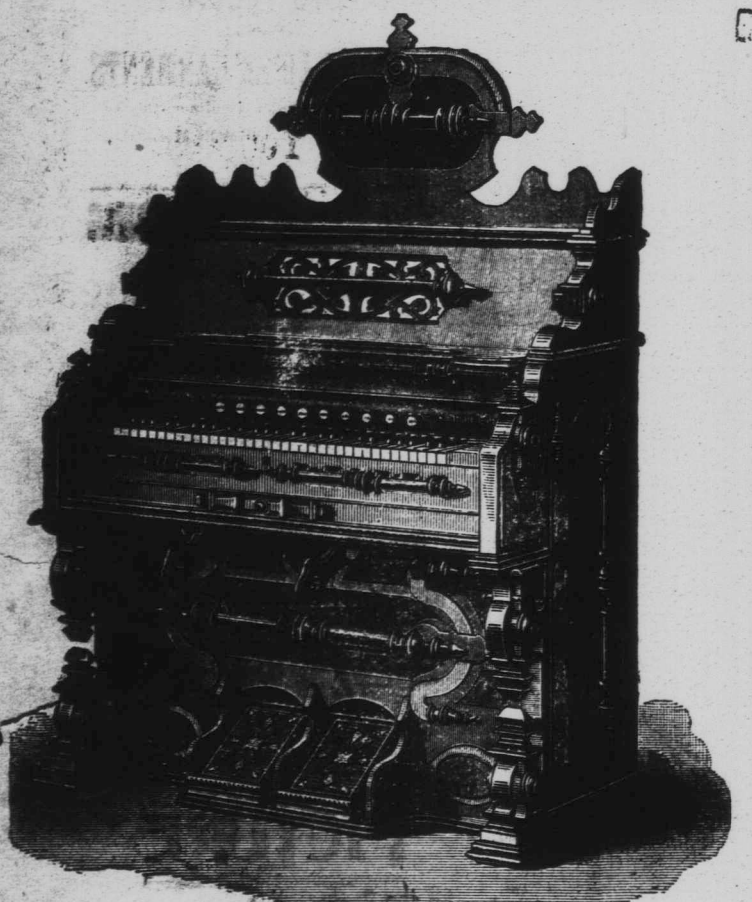

NEWFOUNDLAND.

The St. John's Telegram, the organ of the government of Newfoundland, is quoted as authority for the statement that at the ensuing session of the legislature the question of confederation will be considered, and submitted to a plebiscite of the electorate. Should a favorable verdict be given by the people, a scheme of union would be carried into effect at once without dissolving the legislature and making another appeal to the people. We have not noted the date of the Legislature, which reference is made, but it would not be surprising to find this course followed by the colonial government of the Island.—Halifax Herald.

A BAFILING POINT.

WHICH TROUBLES THE GOVERNMENT IN THE LIZBIE BORDEN CASE.

Boston, Dec. 8.—It is thought that the arraignment of Lizzie Borden for the murder of her parents will take place in about two weeks, when the prisoner will be taken into court at Fall River to plead. At that time, it is understood, a special session of the court will be arranged for and time and place set for the trial. The Providence Journal says that one of the baffling points in the investigation by the government was the evidence submitted at the preliminary trial it was developed that, upon the arrival of the police officers at the scene of the murder, they lifted the covers from the stove and discovered the dying embers of a fire, with the presence of ashes, the latter giving indications that an attempt had been made to burn something. It is known that the grand jury was told that a dress was burned in the stove on the day of the murder, but there is no evidence to show that it belonged to Lizzie Borden.
