

The G.W.P. read his report as follows:

Officers and Members,-

With grateful emotions to the bounteous giver of all good, we convene once more as Sons of Temperance in our Annual Session. We meet as brethren, with lofty purpose and benevolent aim. Our object is clearly defined and well understood, by the public generally, and especially by the abettors of strong drink. This is one cause of thanksgiving. The verdict of the world's conscience is evidently in favor of total abstinence, but in many cases the voice of the inward monitor is silenced by the love of money which is the root of all evil.

Never before were we as an organization in this Province permitted to review historical events covering a space of twenty-five years. We do it at this time with mingled emotions of gratitude and humiliation. The evident good that has been accomplished awakens our grateful feelings to the Great Patriarch above, whose smile and benediction are essential to success in all moral enterprises. We are humbled in view of the fact that intemperance with deadly grasp still clings to so large a portion of our fellow-creatures.

We are pained with the thought that the partial failure of our movement has given energy and courage to the enemies of temperance. The backslidings of multitudes, and the apathy of others have produced those results. The christian church may well share with us in those feelings of humiliation. co-operated with us, or allowed us to co-operate with her, in suppressing in the right way, the appalling evils of intemperance, the devastations of alcohol would have been stayed many years ago. But the evil still exists, and is presented before us, on every hand, in all its horrid deformity and frightful magnitude. Its colossal proportions are truly alarming! Like the statue of Apollos—the colossus at Rhodes, which stretched across the entrance of the harbor, this monster stretches over land and sea so that vessels with their cargoes, and railroads with their freight may travel between its legs.

In its financial aspect it is like the image of gold on the plain of Dura, with the multitude bowing down thereto, in association with music and mirth, while genuine teetotallers are like the little band of pledged ones who on that occa-

sion dared to oppose the popular feeling, because it was wrong.

We cannot remain unmoved while seeing and feeling the miseries occasioned by intemperance. Could we at a glance obtain a distinct view of all the wretched homes made so by intemperance—the heart broken wives of drunkards, with their pining, spirit-crushed little ones, the unbroken procession of young men towards the pit of endless destruction, the fearful loss of female virtue in connection with the hellish traffic, we would be scarcely able to restrain within due bounds the rising feelings of indignation against the hateful We would be strongly tempted, were there any probability of success, to use lynch law, or any other law that would end the cruel work.

In the meantime we must pursue the path of duty in the midst of discouraging circumstances. If anything can be done to infuse new life into our ranks let it be done speedily. If it can be shown that there is a reasonable probability, that a separate National Division for British America would give energy and influence to our noble Order, let us resort to the proper means to obtain it. A unanimous request from the Grand Divisions of the British Colonies in North America will doubtless meet with success. But if it can be shown (which we gravely doubt) that there is an equal probability that the spread of temperance will take place as well by retaining, as by severing the connection. let the union be unsevered. It will be for you decide this question. We must have time to ventilate it in a serious mood. I shall also ask your concurrence in disposing of a brief communication on the subject from the Most Worthy Patriarch.

The subject of an Agent and Lecturer still presses itself upon our attention. The vitality of our organization largely depends upon this department of our work.

We shall also be required to say, not only on paper, but in the most practicable manner that the Abstainer, with its instructive pages, shall still continue its silent yet powerful agency, or allow it to sink into oblivion, as all its early contemporaries in America have done. If the temperance people of the Province will let it die, I shall go in mourning for a time, but will steadily refuse to read the burial service over the houry headed veteran.

A summary of intelligence from almost all my Deputies, as well as from other sources of information may be given in a few words. First, a few Divisions are prospering; Second, many are just about holding their own; Thirdly, a few are preparing to die. For numerical information respecting this jurisdiction I refer you to the report of the Grand Scribe.

Let us not ignore or forget the temperance organizations that embrace our early youthful population. If bright rays of hope encircle any portion of the temperance work of our day, more than any other, they are to be found gather-

ing around Juvenile organizations.

In conclusion allow me to express my deep sense of obligation to the officers of the Grand Division, especially to the Grand Scribe, for effective cooperation and wise counsel, and for the uniform courtesy manifested toward me by the Sons of Temperance generally, during the period of my incumbency.

The Grand Scribe read the following report, which, on motion, was referred to Committee on state of the Order:

TO THE GRAND DIVISION SONS OF TEMPERANCE -- PROVINCE OF NOVA SCOTIA: Worthy Brothers, -In presenting my Seventeenth Annual Report, I take the opportunity of extending a hearty greeting to the members of the Grand Division on their assembling in twenty-fifth Annual Session. Having worked as a Grand body for over a quarter of a century, it is our duty to acknowledge the kindness of a Supreme being who has blessed the efforts of our organization which has been the medium of accomplishing much good in connection with the Temperance movement. Trusting in the Almighty for help, our aim should be to so plan the operations of this branch of "our widely extended Order," that our records twenty-five years hence will contain reports of greater success in the Temperance reform than we can presently boast of. As an organization, the Sons of Temperance has been in active operation for a period of thirty-one years; and has long outlived the prognostications of those who wished its early demise. It is gratifying to know that our Order is as healthy as ever it was-even if it has been necessary to use the pruning knife in removing useless branches. Notwithstanding younger Orders have taken the field as competitors, and presented a bold front and made a good show, the "Old Order" is not yet prepared to stand aside after sowing good seed in order that others may reap a rich harvest. No; having but just attained our full strength of manhood, we will persevere and labor on until our mission is Properly guided, there may be room for all without a clashing of The desire of all should be, not so much a selfish extension of interests. particular Societies as the extension of the principles of Total Abstinence. Any one who has noticed the number of drunkards who have been reformed during the past twenty years, cannot but admit that a large proportion -perhaps nine-tenths-have been reclaimed through the instrumentality of our Divisions. Many a man in the Order blesses it for the good it has done him. To some extent our Order is n social one; and it is on such influences we must depend, in a great measure, for its efficiency, its power and its success. The true welfare of society demands that we should exercise the right to reform the evils arising from the sale and use of intoxicating beverages, and it is principally through the social influences of our association, and the restraining power of the Total Abstinence pledge that we seek to provide a safeguard, and place a barrier against the encroachments and direful effects of intemperance. To protect the young, to strengthen the weak and save the degraded are our main objects. There is one privilege we should strive for, and this is the privilege of conquering and overcoming the gigantic evil of the drinking customs, and to do this we must be carnest and active, and united in

the one common purpose of urging an endless warfare against the liquor traffic in all its branches. As an organization, we cannot expect to accomplish much in the way indicated, unless we have competent agents and lecturers in the field. That there is a probability of our Agency Committee securing the services, at an early day, of a brother as Agent, I have pleasure in announcing. Should the Committee he successful, it will be necessary to increase the amount now in the Agency fund. It is to be hoped that when that department is in operation, our well-to-do temperance men will not withhold their assistance, but respond with a liberal hand. A great many men think that by refraining from intoxicating liquors they are doing all that is required of them. In this they are mistaken, as it needs work, in addition to Total Abstinence, and contributions in money to help the cause.

In the jurisdiction there was not much activity in the Order during the past six or seven months; but present indications bid us hope for an active winter

campaign, as a number of the Divisions are resuming work with vigor.

Since the July Quarterly Session, a new Division—WATERVALE, No. 327—was organized by P.G.W.P. David Marshall, on August 6th, at Watervale,

West River, Pictou County.

Seven new Divisions have been organized during the year, viz: four in Pictou County, and one each in the counties of King's, Cape Breton and Hants. Several old Divisions have also been resuscitated, and I have pleasure in announcing that Champion, which surrendered its charter at close of last year, resumed work at beginning of present quarter. I have received a communieation from Margaree in reference to the re-organization of one or more of the Divisions formerly located there, with the prospect of at least one of them getting to work without delay.

I cannot give precise information respecting some of the Divisions, not having heard from them for some time. So far as I can learn, North American, Crystal Spring. Gold Hunter, LaHave, Melrose, and Flower West Pubnico

are not working.

Without including any of those named, there are 121 Divisions supposed to be in working order-except Hopewell which has had to suspend meetings in consequence of the destruction of its property by fire.

Springside, Welcome and Gladstone Divisions have decided to admit females

to membership.

I am in receipt of 200 copies of a circular from the Most Worthy Scribe, referring to action of the National Division on the Memorial from the Provincial Grand Divisions asking for a Charter for a National Division for the Provinces, with the request that a copy be forwarded to each Subordinate Division. As the proceedings of the National Division do not show any action authorizing the document to be so referred, I consulted with the Grand Officers and a number of the old members, as to whether the circular should be immediately sent to the Subordinates, or be withheld until the Grand Division at this Annual Session would give instructions in the matter. It was concluded that it would be advisable to wait action of this meeting. I have, therefore, re-

That this Grand Division would hereby express its high appreciation of the brotherly kindness of the Grand Division of P. E. Island, in sending as a deputation to this Grand Division the excellent brethren Scott and Trowan.

We have enjoyed much their fellowship and mature addresses in our deliberations, particularly their remarks on the especial subject of their deputation. Through them we would convey our fraternal regards to our brethren of the Order in P. E. Island.

On motion of P.G.W.P. Brown, seconded by R. S. Blois, a vote of thanks was passed to the Superintendent of the Government Railways, and to the Manager of the Windsor and Annapolis Railway, for making a reduction in travelling fares over their respective roads.

On motion, the report of Committee on Communications was taken from the table, and the resolution referring to a National Division for the Provinces adopted, after a brief discussion, by a unanimous vote. [The question was discussed at length at the afternoon sitting. G. S.]

The clause in report of Committee on State of the Order, relating to the same subject was then taken from the table and passed, and the report adopted as a whole as follows:

The Committee on the State of the Order beg to report that on examination of the interesting documents placed in their hands, and from other sources of information, they are forced to the unwelcome conclusion that the Order generally, with a few honourable exceptions, is not in as prosperous a condition as

could be desired. Such a state of things calls for serious reflection and earnest inquiry as to the causes of declension and the means best adapted to bring about a reform.

Without attempting a full discussion of these matters, (which would be impossible in a brief report) your Committee would express their decided opinion that one of the chief causes of this state of things is the want of a suitable agent in the field. Such an agent having the good of the cause at heart—fully awake to the ruinous effects of the ruin traffic—both here and hereafter—unbiassed by any sectional, sectarian or political prejudices, and throwing his whole energies into the work, would in the judgment of your Committee do more to remedy the evils complained of than any other means that could be employed.

Your Committee are exceedingly gratified to learn that negotiations are going on with a Brother whose well known talents and energetic character give promise of usefulness in that department; and should the Agency Committee be successful in securing his services permanently, great good to the

cause would result.

Your Committee are of opinion that the meagre circulation of temperance literature may be regarded as a great cause of declension. They believe that the circulation of the Abstainer ought to be increased ten-fold, and temperance tracts should be scattered broad cast over the land. This might be a part of the work of the agent, and the beneficial results would soon be seen.

Another cause of want of progress is the almost entire lack of effort in relation to the young. Almost nothing is done in the country to gather in the youthful members of the communities and train them up in the work. Your Committee would earnestly recommend the formation of Bands of Hope and Cadets of Temperance in connection with the Divisions throughout the country.

Your Committee would recommend to our older members a regular attendance at the meetings of their several Divisions. The leaving of the work to young members, induces diversions rather than serious engagement in work, and thus tends to cause some who might be made good workers to grow indif-

ferent, and gradually become non-attendants.

Your Committee would also urge as a means of improving the condition of our Order, more outside work on the part of Subordinate Divisions. The tendency to be satisfied with labour in the Division room is too apparent. The holding of public temperance meetings would greatly tend to keep alive the

interests of the cause generally.

The subject of the formation of a separate National Division for the British Provinces will be brought forward for discussion in another form and therefore needs only a passing reference here. Your Committee, however, are prepared to say, that while they fully endorse the sentiments contained in the resolution passed by the late session of the National Division in relation to this subject, they are nevertheless convinced that the time has come when a separate organization is required in these Provinces, not as a rival institution, but heartily co-operating with the great body in the United States with which we have been so long and so pleasantly connected.

In conclusion your Committee are fully convinced of the necessity of a thorough revival of the temperance cause, and that it is the duty of all philanthropists, whether engaged in connnection with the pulpit, the press or the platform, to give their united energies for the accomplishment of this much desired end.
