An Act to authorize the Courts of Queen's Bench, Common Pleas and Chancery in Upper Canada to admit William Wise Cobb to practise as an Attorney and Solicitor therein respectively.

An Act to authorise the Courts of Queen's Bench, Common Pleas and Chancery in Upper Canada, to admit William Wise Cobb to practise as an Attorney and Solicitor therein respectively.

WHEREAS William Wise Cobb hath by his Petition set forth, that he hath been duly admitted as an Attorney and Solicitor in her Majesty's Superior Courts of Common Law and Equity at Westminster, and hath produced his admissions therein; That he was then serving under 5 Articles of Clerkship to a practitioner in this Province, and that he is desirous forthwith to practise as an Attorney and Solicitor, and hath prayed that an Act may be passed to authorise the Courts of Queen's Bench, Common Pleas and Chancery for Upper Canada to admit him to practise as an Attorney and Solicitor therein respectively: And where- 10 as it is reasonable and expedient to grant the prayer of the said Petition; Therefore Her Majesty, &c., enacts as follows:

I. It shall and may be lawful for the said Court of Queen's Bench, the said Court of Common Pleas, and the said Court of Chancery for Upper Canada, in their discretion to admit the said William Wise 15 Cobb to practise as an Attorney and Solicitor therein respectively, any law or statute to the contrary notwithstanding.
