An Act to incorporate the Sherbrooke Manufacturing Company.

An Act to incorporate the Sherbrooke Manufacturing Company.

HEREAS Alexander Tilloch Galt, Edward Hale, R. W. Heneker, Preamble. John Moore, Henry Machin, Thomas Wily and Thomas Galt, have by their l'etition to the Legislature represented, that they are desirous of commencing and carrying on the business of manufacturing Cotton Goods, 5 in the Town of Sherbrooke, and that an Act incorporating them as a Company is necessary to enable them advantageously to conduct and manage the said business; And whereas the said undertaking will tend to develope the capabilities and advance the interests of the Province: Therefore Her Majesty &c., enacts as follows:

10 I. The persons aforesaid, or such of them and all such other persons as Company shall become Shareholders in the said Company, shall be and are hereby incorporated. ordained, constituted and appointed to be a body corporate and politic in law, in fact and in name for the purpose aforesaid, by the style and title of the "Sherbrooke Manufacturing Company:" And shall by that 15 name be authorized and empowered to carry on at the Town of Sherbrooke, Business of the business of manufacturing and working Cotton in all its branches and to Company. establish and carry on works for making printed cotton goods, and shall for such purposes be authorized to purchase, hold, and use such land and water power as may be necessary for properly carrying on such business, 20 and also to erect and maintain the necessary mills and buildings, machinery and appurtenances therefor.

II. III. The said Alexander T. Galt, Edward Hale, R. W. Heneker, John First Direc-Moore and Henry Machin, shall be and are hereby constituted and appointed tors. the first Directors of the said Company, and shall hold their office until 35 others shall, under the provisions of this Act, be elected by the Share-holders, and shall until that time constitute the Board of Directors of the said Company, with power to open Stock Books and make calls on the shares subscribed in such Books, and shall call a meeting of subscribers for the election of Directors in manner hereinafter provided.

Opening Stock Book and alloting shares. IV. The said Directors are hereby empowered to take all necessary measures for opening the Stock Books, for the subscription of parties desirous to become Shareholders in the said Company, and to determine and allot to parties subscribing for stock in the said Company, the number of shares (if any) that parties so subscribing may have and hold in the 5 Capital Stock aforesaid; And the said Directors shall cause an entry to be made in the records of their proceedings and in the Stockholders' Book, of the stock so allotted and assigned to parties subscribing as aforesaid, and the Secretary of the said Company shall notify the respective parties in writing of such allocation and assignment, and upon such entries being 10 made the rights and liabilities of such Shareholders shall accrue in respect of his, her or their particular interest in the said Company.

V. The stock, property and concerns of the said Company shall be man-

aged by a Board of not less than three, nor more than five Directors, who shall respectively be Stockholders in the said Company, and who shall be 15 annually elected by the Stockholders on the second Monday in July in each year, and notice of the time and place of holding such election shall be published not less than ten days previous thereto, in one of the newspapers published in the Town of Sherbrooke, and the election shall be made by such of the Stockholders as shall attend for that purpose either in person 20 or by proxy: And if such election shall not be held on the day so appointed. it shall be the duty of the Directors to cause such election to be held within thirty days after the day so appointed, when such election shall take place at a time and place to be notified by the Directors in one of the newspapers published in the said Town, at which such election shall be made in 25 manner hereinbefore appointed; and all acts of Directors of the said Company, shall be valid and binding, as against the said Company, until their successors shall be elected; And it shall be the duty of the Directors to submit to such annual meeting of the Stockholders a Report stating the amount of the Capital of the said Company, and the proportion 30 thereof actually paid in, and the amount of the existing debts of the Company, which Report shall be signed by the Chairman or President, and a majority of the Directors of the said Company, and a copy thereof subscribed as aforesaid shall, within fourteen days from the date of such

All elections of Directors shall be by ballot, and each Stockholder shall be entitled to as many votes as he owns shares of Stock in the said Company; And the persons receiving the greatest number of votes shall be Directors, and when any vacancy shall happen amongst the Directors by death, resignation or otherwise, it shall be filled for the 40 remainder of the year in such manner as may be provided by the Bylaws of the Company.

VII. The said Company shall have a Chairman or President, who shall be elected by the Directors from among themselves, and also such subordinate officers as the Company by its By-laws may require, who 45 may be elected or appointed, and required to give such security for the faithful performance of the duties of their respective offices, as the Company by its By-laws may provide.

Directors to make calls on Stock.

VIII. It shall be lawful for the Directors of the said Company to call in and demand from the Stockholders thereof respectively, all sums of 50 money by them subscribed, at such time and in such payments or instalments as such Directors shall deem proper; and if any Stockholder or

XI. The Stock of the said Company shall be deemed personal estate, Stock to be and shall be transferable in such manner as shall be prescribed by the personalty and By-laws of the Company; but no share shall be transferable until all how transferprevious calls thereon shall have been fully paid in, or it shall have been 50 declared forfeited for the non-payment of calls thereon; and it shall not be lawful for the said Company to use any of its funds in the purchase of any stock in any other company.

XII. It shall be lawful for the said Company from time to time to borrow money horrow, either in this Province or elsewhere, all such sum or sums of money (not exceeding in all at any time an amount equal to one-half of the capital of the Company as hereinbefore authorized) as they may find expedient, and to make the bonds, debentures, or other securities they shall grant for the sums so borrowed, payable either in currency or And issue De- in sterling, with interest, and at such place or places within or without this Province as they may deem advisable, and such bonds or other securities may be made payable to bearer or transferable by simple indorsement or otherwise, and may be in such form as the Directors for the 10 And mortgage time being may see fit; and the said Directors may hypothecate, mortgage or pledge the lands, revenues and other property of the said Com-

It shall be the duty of the Directors of the said Company to 20 holders &c., to cause a Book to be kept by the Treasurer or Clerk thereof, containing in to Sharehold- alphabetical order the names of all persons who are or have been Stockholders of the said Company, and shewing their places of residence, the number of shares of stock held by them respectively, and the time when they respectively became the owners of such shares, and also a statement 25 of all the existing debts and liabilities of the said Company and of the amount of its stock actually paid in; which Book shall, during the usual business hours of the day, in every day, except Sundays and obligatory holidays, be open for the inspection of Stockholders of the Company and their personal representatives, at the office of the said Company, in the 30 said Town of Sherbrooke.

XV. It shall be lawful for a majority of the Stockholders of the said pital provided Company present at any Annual General Meeting thereof, to determine for.

that the Capital of the Company be increased to any amount not exceeding in the whole one hundred and twenty-five thousand pounds, 35 and such capital may then be so increased either by subscription among the then Stockholders, or the admission of new Stockholders, or otherwise as such majority shall determine; and the Directors of the Company for the time shall and may then open Stock Books, allot Shares, receive Subscriptions, make calls and recover the amount, or 40, forfeit and dispose of the shares on which they shall be unpaid, and may otherwise deal with, and with respect to, such new Stock and the Subscribers for and holders thereof, as hereinbefore provided with regard to the original Stock of the Company and the holders, and the holders and subscribers for New Stock shall have the like rights and liabilities in 45 respect thereof as the holders of and subscribers for the original Stock in respect thereof: And such increase may be made either at one time and meeting to the amount above mentioned, or at two or more times or meetings, for part thereof at each, so as the whole amount aforesaid 50 be never exceeded.

XVI. It shall be lawful for the Municipal Council of the said Town Town of Sherbrooke may of Sherbrooke to lend to the said Company, out of any money belonging

to the Corporation of the said Town, any sum not exceeding twenty lend money to thousand pounds, currency, for such term and upon such conditions as the Company. the said Council and the said Company shall agree upon, provided the repayment of the money so lent be secured by a first mortgage or hypothec 5 on the real property of the Company, and provided also, that the By law of the said Council authorizing such loan be approved by a majority of the Municipal Electors of the said Town, in the manner provided by the second section of the Act passed in the sixteenth year of Her Majesty's Reign, intituled An Act to establish a Consolidated Municipal Loan Fund for Upper

10 Canada, which act has been since extended to Lower Canada: And it And grant exshall also be lawful for the said Council, by By-law, to exempt the said emption from Company and their property from the payment of any assessment, to the a certain time. Corporation of the said Town, for any period not extending more than five years beyond the time when the Company shall actually commence 15 the manufacture of Cotton goods.

XVII. The Municipal Council of the said Town may apply for or Certain funds towards the loan to the said Company hereinbefore authorized the proceeds may be apof any debentures secured upon the Lower Canada Municipal Loan plied for such Fund, and delivered to the said Corporation of the said Tournell Inc. Fund, and delivered to the said Corporation of the said Town or its 20 Treasurer before the passing of this Act.

XVIII. The Statute of this Province passed in the twelfth year of Her Interpretation Majesty's Reign, chapter tenth, and known, cited, and referred to as Act. "The Interpretation Act," shall, so far as it can be made applicable apply to this Act.
