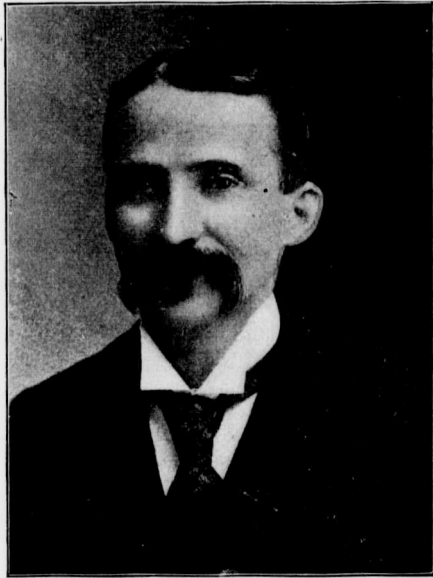
# Robert Scott,

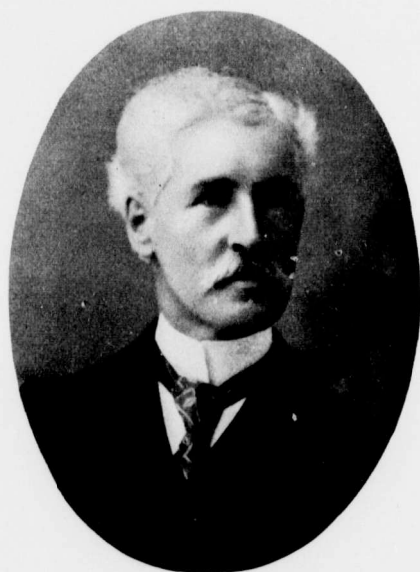
# William Perley Cunningham,

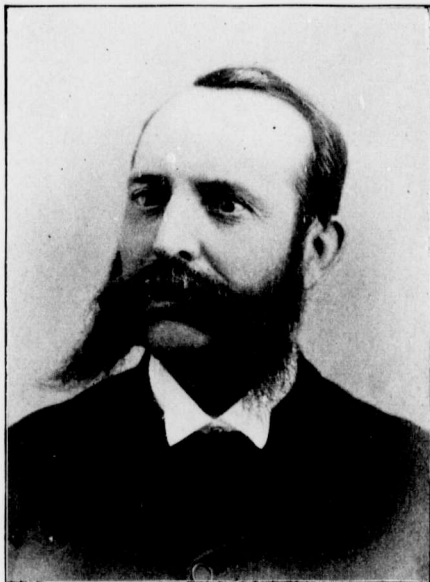

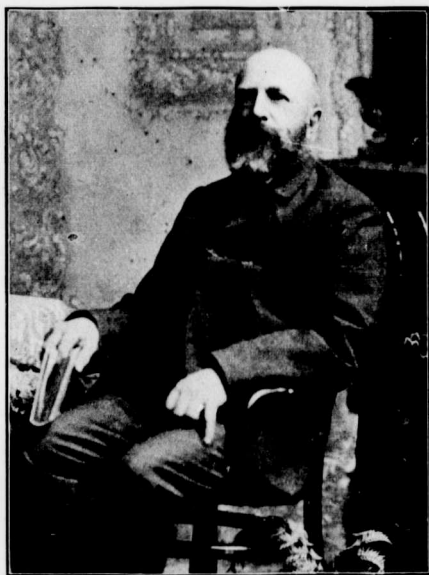
# Thomas Symmes,

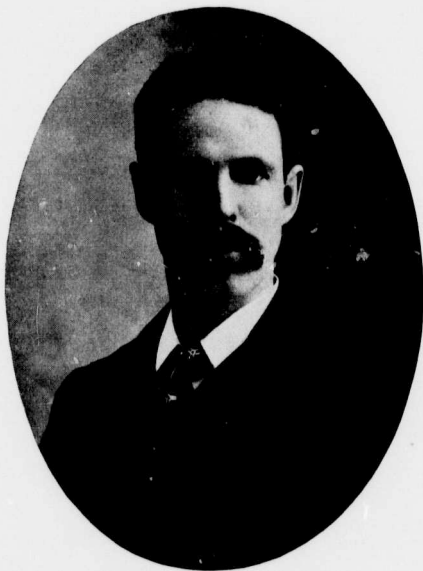

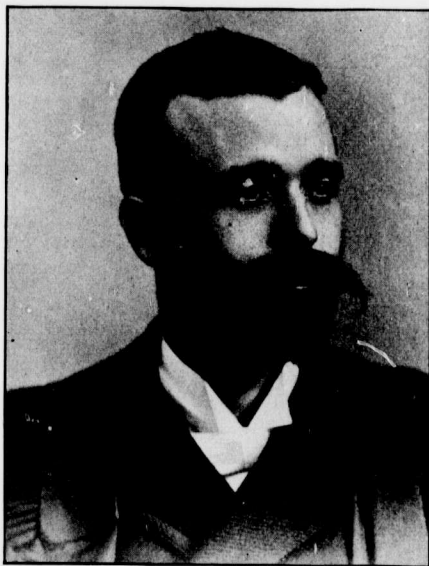

Was born at St. Barthelemi, on the 28th of May 1859. He was elected Mayor by acclamation on January 16th, 1900, it being the first office he has consented to hold.

MR. LAURENDEAU is a lawyer by profession, being a member of the Beauharnois legal firm of Seers & Laurendeau. He is the attorney for the Beauharnois Branch of the Merchants Bank of Canada, of the New York Central & Hudson River Railway Co., and also a member of the School Board.

As Crown prosecutor, in 1895, MR. LAURENDEAU succeeded in securing a conviction in the Shortis murder case, in which trial Shortis was defended by Messrs. J. N. Greenshields, H. C. St. Pierre and Geo. C. Foster, the well known attorneys of Montreal. This was considered a great victory for MR. LAURENDEAU, and attracted much comment throughout the country.

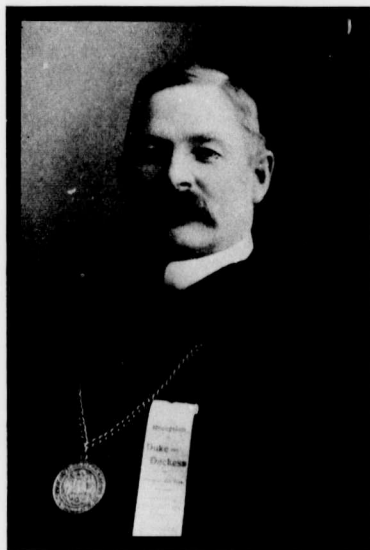
# Robert James Graham,

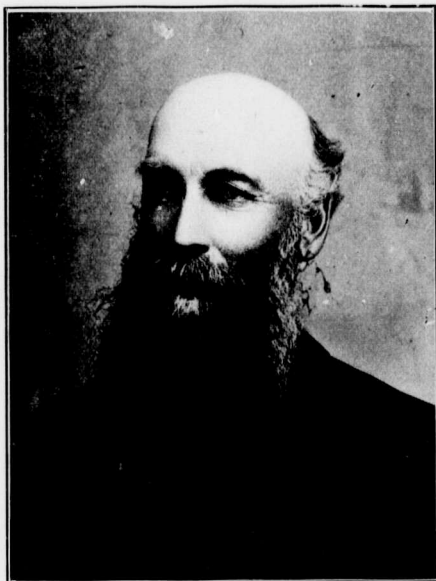

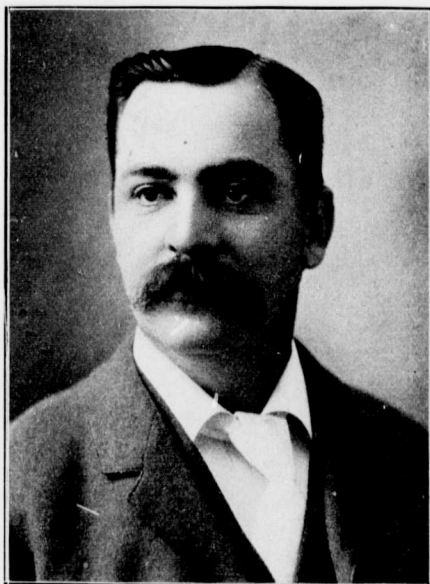
# Thomas Thauburn,

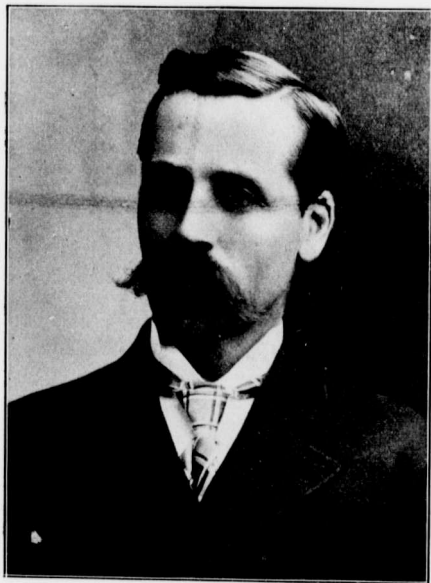
# David B. Wood,

MAYOR WOOD was on the Aldermanic Board for five years previous to his elevation to the Mayor's chair. He also served as President of the City Reform Association for several years. He is a Past Master of the Brantford Masonic Lodge and Past Chief Ranger of the I.O.F. He is a member of the Board of Trade and engaged in business as a miller and dealer in grain, etc. It is interesting to note the improvements in the City of Brantford made during MAYOR Woods' régime. The flood prevention work has been completed; the main line of the Grand Trunk Railway has been diverted so as to reach the city; the Street Railway has been vastly improved and extended under new management, and connects with Paris and other towns; a handsome monument has been erected to the boys who fell in South Africa; the Carnegie Library is under way; the parks have been enlarged and beautified and building operations are double in value to any former period in the city's life. A general advance in all lines is on in Brantford.

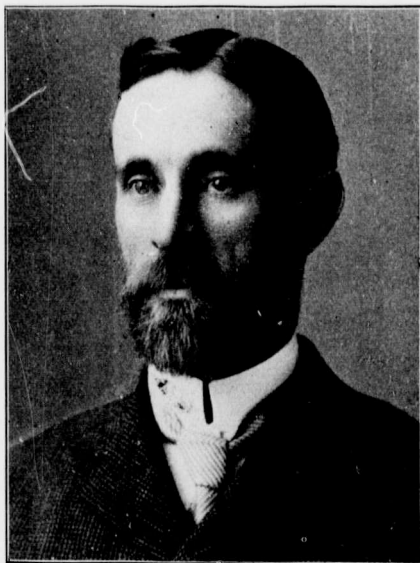
# Thomas Underwood,

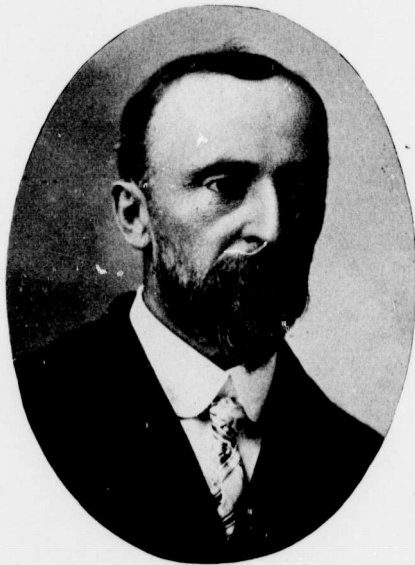

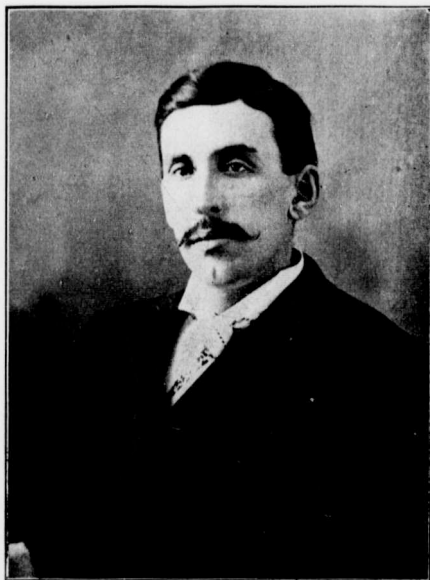

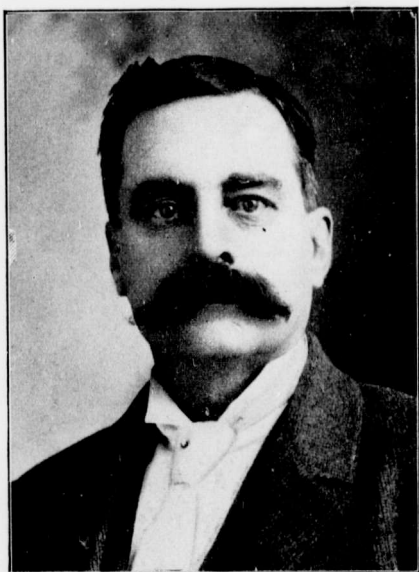
# Frank Williams,

After a short sojourn in London, England, his native city, Mr. Williams came to Manitoba in 1884 and has been practically in the Carman district ever since—sixteen years at least in Carman. He is an expert accountant, and has made a special study of municipal work and auditing. He has done considerable service to the provincial government as an auditor of municipal accounts. He is Deputy Registrar in the Lands Titles office at Carman, and does a considerable business in handling collections for various companies.

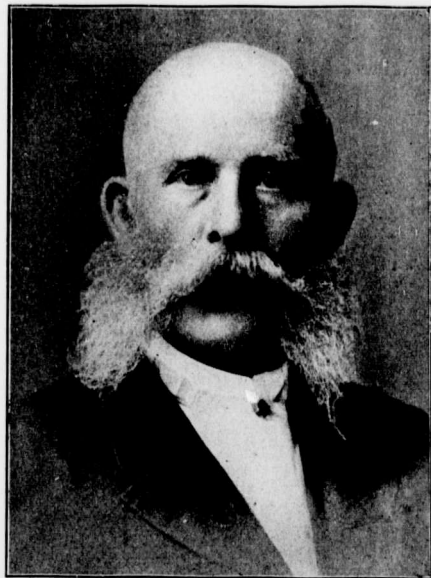
# Thomas Jackson, Sr.,

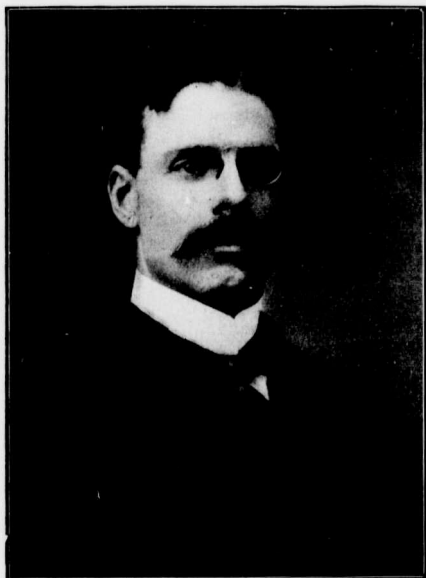
# Henry C. Macauley,

Was born at Lindsay, Ontario, where he received his education and spent his boyhood days. In 1885 he made his first venture away from the paternal roof, entering the employ of the Minnesota and Ontario Lumber Company at the Lake of the Woods, where he remained two years. His first employment with that company was as a common laborer in the woods where he swung an axe, drove team and rolled logs. His promotion was rapid and at the time of his departure for the West he was assistant manager of the company. Upon arriving at Victoria he entered the employ of the Victoria Lumber and Manufacturing Company as accountant. That position he held for three years, and then joined the firm of Cowan & Wilson, wholesale grocers, as city salesman. He remained with the firm a year in that capacity and then took charge of their business office under a three years' agreement, a contract which was subsequently renewed for another period of three years. At the completion of the last contract, MR. MACAULEY for the first time entered business for himself, the firm being known as Sprate & Macauley, general shipping and brokerage. The firm continued in business until May 1898, when it was dissolved, MR. MACAULEY joining hands with his brother, James S. Macauley, opening up a general merchandise establishment in Dawson in June, 1898. Prior to that time the name of Macauley was well known along the Yukon river, "Jim" having been engaged in trading with the interior since the Birch River excitement of 1895, and none was better or more favorably known than he.

The firm of Macauley Bros. is one of the strongest in the city, their retail store is on First Avenue, below the Fairview Hotel, the wholesale being on Third Avenue. One of the best evidences of MR. MACAULEY'S faith in the stability of Dawson is shown by his erection last summer of one of the finest residences in the city at a cost of \$8,000.—From the "*Dawson News*," February 7th, 1902.

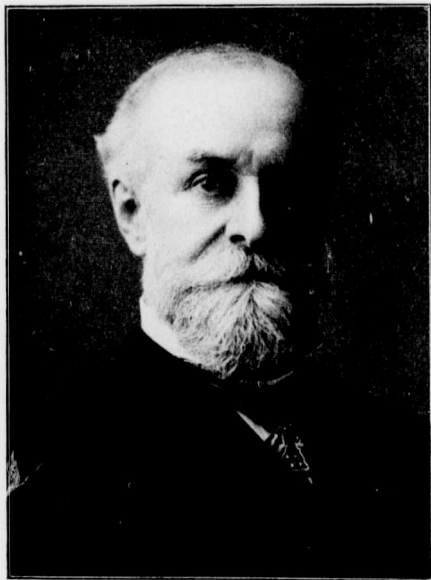
# Edward Wilkes Rathbun,

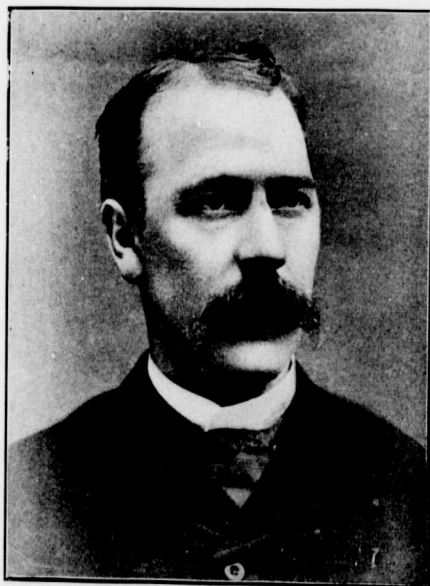

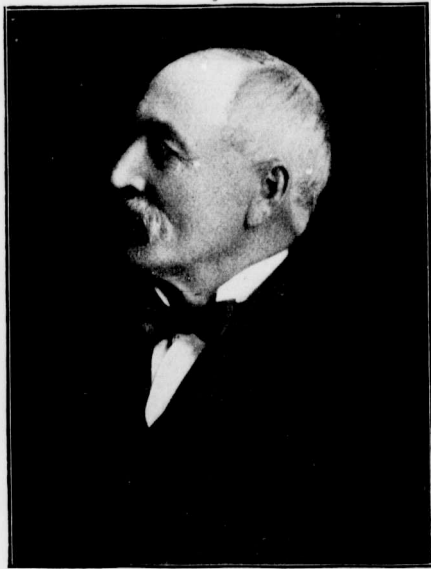
# Norman McIntyre,

His father engaging in business as a farmer in the Township of Glenely, County Grey within seven miles of Durham. Young McIntyre got what schooling he could between seasons until he was fourteen years of age, when he was fortunate enough to secure a position at \$6 per month. At eighteen years of age he engaged in teaming from Durham to Guelph. The railroad came and made his business unprofitable, and he started a livery. This he sold in 1882, and went into the square timber business on a small scale. In this line Mr. McIntyre has been successful, and for the past fifteen years has taken from \$50,000 to \$75,000 worth through to Quebec each spring.

Both parties combined in electing Mr. McIntyre to the Mayoralty on the 6th of January, 1902, his term expiring in January, 1903. He has given very little time to politics heretofore, this being the only office he has ever consented to hold.

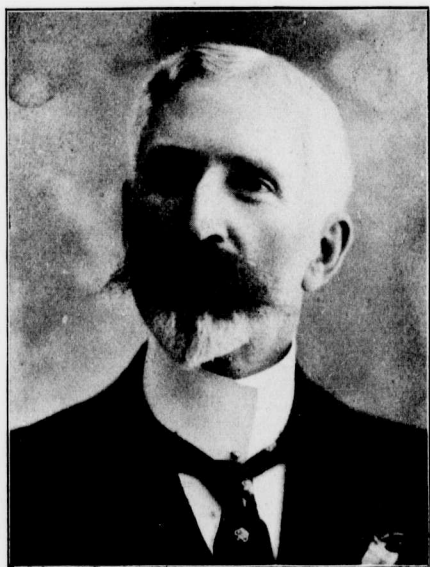
# Robert R. C. G. McCorkill, M.D.
