London, Sept. 25.

Paris, Sept. 25.  
The Moniteur publishes the following news from Spain—  
Gen. Korta, commanding the royal troops, is marching his forces to attack Seville. The men are in good spirits.  
The report that the Queen of Spain had crossed the frontier into France is premature.  
She still remains at San Sebastian but it is rumored that she leaves for Pau in the department of the lower Pyrenees.

Montreal, Sept. 25.  
Owing to the rain it was found impossible to continue the cricket match this morning and it was therefore a draw.  
The All England scored in their first innings 310, and the Canadians only 28.  
The Eleven left this morning for Boston.

New York, Sept. 25.  
Silas James and his cousin Charles T. James were hanged to day at Worcester, Mass., for the murder of Joseph G. Clark.

Two regiments of Royal troops sent from Madrid to put down the insurrection at Cadix, are reported to have revolted while on the road, and gone over to the rebel ranks.

Robinson, Ryan,

and Brooke, and their able engineers. All parties employed on their section of the road seem to be well pleased, and no doubt from the portion now completed, it will compare favorably with any part of the line between the St. Croix and Carleton.—Ibid.

MILITIA APPOINTMENTS.—We learn that Brevet Lt. Colonel W. B. Robinson has been appointed District Major, or Inspecting Field Officer, for the Southern District of New Brunswick, which include St. John and adjoining Counties; that Lt. Colonel A. C. Ory at present in command of the St. John Volunteers Battalion and Deputy Adjutant General, has been appointed to the district comprising the Northern Counties; and Lt. Col. Innes of Charlottetown has been appointed over the Western District. We also understand that Captain John Hewitson, of the York County Volunteers, has been appointed Paymaster for the whole Province. Since a law has been enacted providing for these offices, we do not know that better appointments could have been made.—Globe.

## The Standard.

SAINT ANDREWS, SEP. 30, 1868.  
The sea of politics is becoming ruffled; at one time there is a gentle ripple on its placid surface, at another a small wave, until there appears as at present to be an incipient storm. The ship of State however is to have a new Captain; it is now settled that Lord Monck is to be succeeded by Sir John Young, who was recently Governor of New South Wales having been appointed in 1860. He is in the 61st year of his age, is an Irishman by birth, was educated at Eaton and Oxford, a lawyer by profession, was a Treasury Lord in 1844, Chief Secretary for Ireland in 1852, Member of Parliament for Cavan from 1851 to 1855, and Lord High Commissioner of the Ionian Islands from 1855 to 59. He is owner of a large estate in Cavan. It is probable he will be prepared to accept the proffered allowance voted by the Dominion Parliament last Session, which a majority of the people of all shades of politics in the Dominion expect will be insisted upon by the Parliament.

Some of the Ontario papers speak of other changes, last week they reported that Attorney General Weimore is to fill the position on Bench vacated by Lieut. Governor Wilmot. Should this prove correct, it shows that the Government do not fear opening up a constituency—why should they? If the people will, it, they will elect A or B without regard to their political tendencies, then to represent them, who will carry out their expressed and well understood wishes.

The Toronto "Telegraph" states that arrangements have been made with leading gentlemen in Montreal, to have the Contracts for building the Intercolonial Railway. This can hardly be correct, it would involve the destruction of the Government, and raise an opposition in the Maritime Provinces more powerful than repeal, and would lead to a united effort to cut loose from the British American Act.

St. George.—A correspondent states that a Camp for eight days drill, was commenced Monday week, under command of Lt. Col. Wetmore—the Battery of Artillery, Captain Bolton, and the Infantry under their respective captains. The Battalion he says presented a soldierly bearing, and the men conducted themselves in such a manner as to elicit the commendation of their Colonel. The officers we learn are well up in drill, and put the men through the drill and various exercises with great precision. The Battery it is said is one of the finest in the Province, and for their time and opportunities are equal to any in performing their duty.

MISSIONS.—The Annual Meeting on behalf of the Methodist Foreign Missionary Society will be held (D. V.) in the Methodist Church on Friday evening, the 2nd Oct., commencing at 7 p. m. Revd. Messrs. Lathern, of St. John, Sprague, of Milltown, and Keay, Rattray and Wilson, of St. Andrews, will address the meeting. The public are respectfully invited to attend.

A collection will be taken in aid of the mission funds.  
The Dominion Cabinet met on Monday last. It is probable that during the sitting several appointments will be made, some of which we have already named. There is one which we as well as many others, are anxiously looking forward to and trust that the gentleman entitled to it may be appointed.

# The Catholic Pic Nic.

One of those pleasant pastimes termed "Pic Nics," and the last for the season, was held here on Thursday last. Arrangements had been made to hold the Pic Nic on Wednesday, but rain having fallen during the previous night and the next morning, the Managers decided to postpone it until the next day.—The excursionists from Woodstock and St. Stephen were sadly disappointed as indeed were the townspeople, particularly as great interest was felt in the success of the undertaking. The weather having cleared up during Wednesday night, the sun shone out in all his regal splendor on Thursday morning, the atmosphere was clear and warm, and the day turned out all that could be desired.

At ten o'clock numbers of well dressed people might be seen wending their way afoot and in carriages to the Pic Nic grounds, which had been tastefully decorated with flags. The charming spot selected for the purpose, Mr. O'Neill's farm, situated in the rear of the town, commands a magnificent view of the Bay and Islands, extending from Chamecock round to Mascareen, Clamecock head and the American shore above Eastport—the N. B. & C. Railway forming the base line of the farm. On the grounds some spirited young men had erected a large rustic bower of evergreens, and within were the Refreshment tables laden with the delicacies of the season, an abundance of the substantial, and presided over by the bills said by "charming young ladies," whose golden and auburn hair mingled their hues like those clouds which we see floating above and around the setting sun, and who were willing and anxious to serve all who required a good dinner—to which it is needless to add great justice was done by numbers; still the supply of some single influence was equal, nay surpassed the large demand.

Shortly after the grounds were opened for admission, the little steamer "Tyro" with excursionists from St. George, and the "Helle Brown" from Calais and St. Stephen with visitors and the St. Stephen Cornet Band arrived and proceeded to the grounds, where an elevated platform had been erected for the band, and close by an enclosure made for the town, who chose to indulge in the Terpsichorean art.

During the day the various sports were entered into with much spirit, races, leaping, climbing the grassed poll, throwing the hammer, and archery. At about 4 o'clock the great event of the day drew crowds to the high bank to witness the Boat Race. Five racing gigs were entered, viz: two from St. Andrews, "New Thetis" and "Young Neptune" two from St. Stephen, the "Forget me Not" and "Black Snake," and one from Calais, the "Old Thetis" owned by the St. Stephen club. The distance was three miles, beginning at the town, St. Stephen, the "Forget me Not" and "Black Snake" to a flag boat anchored near the bar leading to Ministers Island.—The pistol having missed fire the St. Stephen boats which were next the steamer heard the snap, started and were several feet ahead before the St. Andrews crews gave way.—"Black Snake" lead off, followed by "Old Thetis" next came the "New Thetis" and was rapidly passing the "Black Snake" which crossed out of her line and into the "New Thetis" foiling and starting some of the bits. The collision is believed to have been designed, at least it was so expressed by numbers who saw it and for the information of all concerned we quote the 2d article of Boat racing:—

"Any boat swerving from a direct course in order to impede the other boat, shall be ruled out."  
The New Thetis notwithstanding the delay soon overtook and passed the Old Thetis, and on the lone stretch kept her place until within a short distance of the Judges' boat, when the Calais crew by vigorous strokes lessened the distance, but the New Thetis won the race by about a length and a half. The "Young Neptune" came in third, and had she made a straighter course, might have been in as soon as the Calais crew. The time made by the New Thetis, was 20 minutes less one second, and the prizes were \$40 and \$20.

The races over and tea being ready the Refreshment tables were rapidly filled, and tea and coffee with abundance of cake and other good things were done ample justice to. After tea while the people were enjoying themselves on the grounds an interesting scene presented itself viz: the Train from Woodstock with passenger cars and cars filled with lumber; and the hope was expressed that ere many years a train from Quebec would pass over the same line. We said in a previous issue that "the Catholic Pic Nics" are "always well managed," and the one on Thursday last has proved the truthfulness of our statement. The committee who carried out so successfully the arrangements are deserving of great praise. The receipts we learn were nearly \$600, but had the weather been favorable on the previ-

ous day we may safely say the amount would have been doubled. A general expression of satisfaction was given with reference to the day's proceedings.

Had Mr. Grant been on the grounds with his camera, he could have taken a view of the assemblage and boat race, &c., which would have been bought up readily, and paid him.  
As a wind up to the affair, a ball was given in Gove's Hall during the evening, which was largely attended; dancing was kept up with great spirit, and a supper provided which was enjoyed by the large company.

We record with much satisfaction, that during the day and evening, not a solitary case of intoxication was witnessed. Indeed the only beverages on the grounds were those which soothe the nerves and invigorate the body "tea and coffee."

DEATH OF MR. HARTLY.—A telegram received here this morning, announces the death of Mr. Hartly, C. E. and M. P. P. for Carleton, at Fredericton last night.

Cable despatches of the 28th state that the revolution in Spain is progressing. The insurgents are beating the Royal troops, and the fleet has joined the rebels and has bombarded Cartagena. Marshal Serrano is driving the Royal troops before him.

Two prisoners escaped from the Penitentiary at St. John last week. One of them has since been taken, named Mills. The other, Harlow, is still at large. A reward of \$100 has been offered for his apprehension.

The American papers by some means obtain earlier intelligence than the journals in the Maritime provinces from Canada. Acts going into force and removal of exactions are published in Boston and New York papers before they reach this Province by telegraph.

The returns of the Grand Trunk Railroad for August amount to \$627,018, for the Great Western \$269,017.

At the Dominion Competition, a native of this County, Major McAdam took most valuable prize of \$500 sent from this Province.

Our Marksmen returned by the steamer yesterday morning from the shooting at Lapraire. They had a very pleasant trip, and carried off a good many prizes.—Globe.

Blank bonds will continue to be furnished gratuitously as heretofore.

**WHEREAS** by an Act passed in the 29th year of Her Majesty's reign, intitled: "An Act to provide against the introduction and spreading of disorders affecting certain animals," authority is given to the Governor in Council to take such measures as may appear to be necessary in order to prevent the introduction of contagious or infectious disorders affecting cattle and other animals, and to check such disorders from spreading if introduced;

And whereas a contagious disease or epidemic, affecting Horned Cattle, prevails in many parts of the United States of America, and is increasing and extending its ravages; and whereas it is expedient in order to prevent the introduction of the same into the Province of Quebec and Ontario, hereinafter constituting the Province of Canada, that the importation of Horned Cattle, from the United States of America, should be prohibited;

His Excellency in Council, on the recommendation of the Honorable the Minister of Customs, and under the authority given by the said Act, has been pleased to order, and it is hereby ordered, that from and after the date hereof, and until this order shall have been altered or revoked, the importation from the United States of America, or introduction therefrom into the Provinces of Quebec and Ontario, hereinafter constituting the Province of Canada, or into any part thereof, of Horned Cattle be and the same is hereby prohibited.
