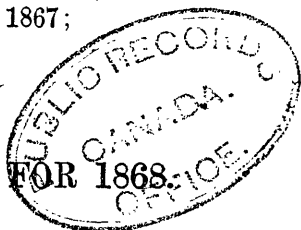

[MEMO.—The Revised Statutes as reported upon by the Commissioners, with some modifications, were passed in the First Session of 1854, but during the same Session 20 other Acts were enacted, which are embraced in the Second Volume of the Revised Statutes, from page 1 to 107, and are included in the Index to that volume. These later Acts *are also* referred to in the present Index, in order that it may cover all passed since the Revision of the Statutes. The Acts by the Local Legislature of New Brunswick, since the 1st July 1867, *are referred to in Italics.*]
