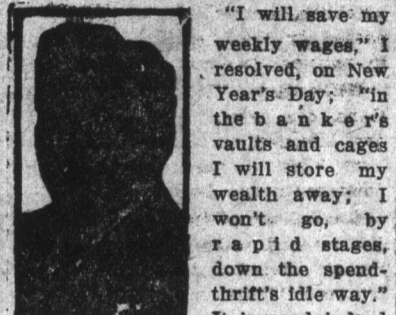

No Recognition of Russia Until Propagandists Cease Activities

Sydney Miners Hope for Early Settlement —U.M.W. Uphold President Lewis.

NO RECOGNITION UNTIL PROPAGANDIST ACTIVITIES CEASE.

TORONTO, Ont., Jan. 28.

A cable to the Mail and Empire from London says the following facts were developed to-day during intensive activity on the part of Premier MacDonald at the Foreign Office. Great Britain will not recognize the Russian Soviet at present, owing to the necessity for advance negotiations concerning the propaganda activities of the Third Internationale directed from Moscow in British territory. It is not so much Communist activities in England that the Labor Government fears, but alleged plots on the borders of India, particularly in Afghanistan. James O'Grady, Ambassador designate to Russia, will however, proceed shortly to Moscow when the Russians give satisfactory assurances. Britain will not ask Russia to acknowledge prewar debts before recognition.

FEELING OPTIMISTIC BUT PROGRESS SLOW.

SYDNEY, Jan. 27.

The week end saw no developments in the Nova Scotia coal miners' strike that would prove a basis for hopes of an early settlement. The wage conferences that have been progressing behind closed doors for the past week between sub-committees of the miners and Besco officials, adjourned yesterday noon and will resume tomorrow afternoon, but their only report so far has been that no agreement has been reached. There is an apparent spirit of optimism among the miners and a belief that settlement will be reached this week on a mutually satisfactory basis, but just what transpired to justify this hope has not been made known.

THIRTY-SEVEN DEAD.

JOHNSON CITY, Ill., Jan. 28.

Reports of the coal mine disaster state that thirty-seven are dead and six seriously injured, while eight others suffered burns about the head.

CONFIDENCE IN J. L. LEWIS.

INDIANAPOLIS, Jan. 28.

BERLIN, Jan. 28.

An alleged Communist plot for the overthrow of the Government was brought to light to-day in the debate of the Finance Committee of the Wurttemberg Parliament, according to advices from Stuttgart. Large quantities of explosives are said to have been seized.

MARVELOUS ESCAPE FROM DEATH.

MONCTON, Jan. 27.

John Cormier, of Fox Creek, near here, was driving a horse and sleigh across the railway track at Sunny Brae last night when the Maritime Express from Halifax crashed into it, killed the horse, splintered the sleigh and carried Cormier on the pilot clear to Moncton round house, before the crew knew of the accident. Cormier with a fractured arm and bruises lives to tell the tale and doctors hold out every hope for his complete recovery.

MURDERER'S CONFESSION.

AURORA, Ill., Jan. 28.

Warren Lincoln to-day confessed to the police that he had shot and killed his wife and her brother, Byron Shoup, Jan. 10, 1923, and that he had modified their heads in a concrete block which would be found in the city dump. The police visited the dump and the concrete block was discovered which, when broken up, disclosed the two heads. Lincoln swooned when the block fell apart. He is said to be a relative of the great liberator.

NOT A SAILOR LOST ON THE 'LAKES' LAST YEAR.

DETROIT, Jan. 28.

Not a Lake seaman lost his life in shipwreck during the 1923 navigation season, President William Livingstone declared in his annual report to the Lake Carriers Association, made public here to-day. Cross-examination of J. J. Miller by Mr. Lewis:

Q—Do you remember when it was before I left?

A—When was that?

A—December 1922.

Q—Then it might have been December 1920 or prior?

A—Yes.

Q—What happened to that draft? Was it presented for acceptance or payment?

A—Acceptance.

Q—What happened to it?

A—it was gradually reduced by himself.

COMMISSIONER—How do you mean? By counter-account?

A—No, by payments himself.

MR. LEWIS—He drew on your company for an amount of money, what amount, do you know?

A—I do not.

Q—Was it large or small?

A—it would be a couple of thousand dollars.

Q—The company owed it to him?

A—No.

Q—Upon what theory was it done? An account of logs which he could not supply.

COMMISSIONER—I think you must have misunderstood what is meant. It is a document which a man draws upon a man who owes him money.

(Conversation about Mr. Angus Walker took place with Mr. Miller and Mr. Lewis which could not be heard.)

MR. LEWIS—They were notes instead of drafts?

A—Yes.

Q—Promissory notes?

A—Yes.

Q—When you have told us that this document came forward for acceptance you did not say it was a note.

A—I was not sure.

COMMISSIONER—I am afraid that you are not at all sure about Mr. Templeman?

MR. LEWIS—And perhaps not entirely sure about any other matter.

COMMISSIONER—Several others.

MR. LEWIS—Forgiveness seems to thrive in Newfoundland.

COMMISSIONER—Not confined to Newfoundland but a particularly prosperous plant in Newfoundland. I believe it grows throughout the world, but particularly strong here.

MR. LEWIS—You are not quite sure whether documents from Templeman were drafts or notes are you? There was a series of them, I take it?

the bank statements; but the statements you made and which were sent in to head office in Sydney from Wabana, that was what was doctored up in this case?

A.—No, sir. It was not doctored. COMMISSIONER—He has already said that nothing was doctored.

MR. LEWIS—Well, I don't see how he could explain the discrepancy between the bank balance, as shown by the bank statements, as it must necessarily have been shown.

COMMISSIONER—He says he does not know. The suggestion he makes is, the people in Sydney were hiding it, or that they did not see it.

MR. LEWIS—There was nothing on the statement to prevent their checking it, and if they did check it they would have found nothing they did not know?

(Witness' answer could not be heard.)

COMMISSIONER—He did not cover it, because it was covered already, according to him. We shall, I think, be better able to judge of those things when we see the documents, which, with Mr. Knight's kind co-operation, we may see. (To Witness): Who would be the person at Sydney before whom these monthly returns would go?

A.—Mr. A. S. Tasman.

Q.—And if he found anything that wanted a little explanation, to what person would he go at Sydney?

A.—He was chief accountant.

Q.—Was there a general manager or a managing director there? Who was head?

A.—Mr. McDougall was manager.

Q.—So that Mr. Tasman would likely go to Mr. McDougall?

A.—Either to him or to Mr. Gillis.

MR. LEWIS—How many workmen did you have at Wabana, Mr. Miller, say in August, 1920?

WITNESS—We had about 1200 or 1400.

MR. LEWIS—And that meant 1200 or 1400 pay roll cheques every month?

A.—Yes. Upon the Bank of Nova Scotia at Wabana.

Q.—And were those workmen all residents of Wabana? Or a large number?

A.—About 40% were transient.

Q.—Coming and going?

A.—Yes. New men taken on and old men dropping off.

Q.—And those dropping out would drop out generally at the time the pay roll cheques were given out, would they not?

A.—Not necessarily. They used to give eight days' notice, regardless of pay day and generally left the Island.

Q.—Has it not happened in a good many cases that cheques issued were not actually presented at the bank and returned to your office until later, say a month later?

A.—There may have been a few.

Q.—And would a man leaving, at the end of eight days carry with him all his earnings up to the date of leaving?

A.—Yes.

Q.—He would get his cheque as he left?

A.—Yes, with his discharge slip.

Q.—Mr. Miller, do you think that Mr. Tasman can supply all the information necessary about your office?

A.—Yes.

MR. LEWIS—I think you testified that you surrendered to Sir Richard Squires various cheques representing the various transactions. (Appendix are cheques which were identified by witness and marked and put in evidence):—

August 7th, No. 1154 . . . \$ 5,972.75
August 14th, No. 1155 . . . 5,000.00
August 16th, No. 1156 . . . 5,000.00

for your sister and all that time you do not know to whom you owe it?

A.—I passed it to my sister.

MR. LEWIS—That is what you did with the money; we want to know what you did with the cheque?

A.—I can get it from my sister and let you have it to-morrow.

COMMISSIONER—That will not do; she can tell about it herself.

MR. LEWIS—Did you give any promissory note at the time you borrowed that \$2000?

A.—I do not remember.

MR. LEWIS—I suppose you walked up to some good friend and asked him for a loan for a few days?

COMMISSIONER—No, that would not fill the bill. You mean for a few years. Can that really be done in Newfoundland. One can go to a friend and ask him for a loan of a couple of thousand dollars for three years, need not pay him any interest, and his friend will hand over the money? I expect there is a snag somewhere.

MR. LEWIS—Did you make a memorandum of it?

A.—If I did I do not remember.

Q.—You are testifying only from memory as to all these transactions?

A.—Yes.

Q.—Did your sister tell you or did you tell her of the use to which this two thousand dollars was to be put?

A.—I do not remember anywhere in particular about the two thousand dollars, other than the total.

Q.—You have included this cheque for \$2000 in the lump sum of \$46,493.05 and which you claim was a part of that amount, and you also claim that Sir Richard Squires received; and all you are able to say about it is that the \$2000 was turned over by you to your sister and without any knowledge whatever as to the use she was to make of it. You say it was borrowed from a friend; that you made no record of it; you cannot remember the name of your friend and you have no recollection as to the purpose it was turned over to your sister for?

A.—At the present moment I cannot remember. The forty-six thousand dollars covering all those cheques were verified and put to the credit of Sir Richard Squires' account.

A.—By whom were they verified?

A.—By Mr. Meaney first, and by Mr. Tasman and Mr. Kempton, the Sydney Auditors, afterwards.

Q.—Was there included in that statement the item of \$380 represented by this cheque?

A.—Yes, I think so.

Q.—I think you testified that that item represented some expenditure made by you of some character. Is that true?

A.—Yes, that was in connection with the Bay-de-Verde bye-election for sending the men home to vote.

Q.—When was that expenditure made?

A.—Likely in 1920.

Q.—Have you any recollection when it actually occurred?

A.—My recollection that the Bay-de-Verde Bye-election took place in the early part of June, 1920.

MR. LEWIS—Had you made any claim or submitted any statement to Sir Richard of that expenditure in that connection at that time?

A.—My sister brought me a blank cheque to cover them all, but it was so much later that I did not know if it would be good or not then, so I advanced the cash. I had two alternatives: to make the payment on pay rolls or pay it myself; so I paid it myself.

Q.—Did you make a record to whom you paid the money?

A.—Yes, I got a receipt from Mr. Cramm for it. It is home, but I can find it.

COMMISSIONER—I would like to see it.

Q.—Was that bill rendered to you shortly after June 1920?

A.—I am not sure about the dates, but it was sometime after.

Q.—In what way was it paid?

A.—In cash.

Q.—And you never have been reimbursed down to March 19th, 1921?

A.—No.

Q.—Had you ever made any demand or claim upon Sir Richard Squires or any other person for re-payment to you of that \$380?

A.—I am not sure that I did.

Q.—Had you asked anyone to refund that money to you?

A.—I mentioned it to my sister.

COMMISSIONER—She was managing the affairs of Sir Richard's office. Did you ask her to refund it or did

WITNESS—Do you wish to get the disbursements?

COMMISSIONER—You have told us that you borrowed \$2,000.00 from a friend can you tell us does that cheque represent the \$2,000.00 that you borrowed from your friend?

A.—Yes.

MR. LEWIS—Does the date upon the cheque, March 19th, 1921, indicate to you that the loan which you negotiated with your friends was at or about the same date?

A.—It was made up of two or three different amounts.

Q.—Then it does not represent the \$2,000.00 that you borrowed from your friend?

A.—The total, yes.

COMMISSIONER—He says now that he borrowed it at different times. The \$2,000.00 was borrowed in several sums?

WITNESS—In two or three amounts.

COMMISSIONER—Were they all from the same friend?

WITNESS—Saturday afternoon. To pay the Daily Star wages.

MR. LEWIS—And this \$2,000.00 was borrowed from your friends and turned over to your sister on this Saturday?

A.—Between \$900.00 and \$1,000.00.

Q.—And when was the balance turned over, and under what circumstances?

A.—It was to cover the balance of the Bay de Verde bye-election.

Q.—How much was that balance?

A.—We sent home about 300 men averaging about \$2.50 a day. It would likely be between \$2,000.00 and \$2,500.00.

Q.—These men were sent home to vote?

A.—Yes.

MR. LEWIS—That was money of your own, Mr. Miller that you expended?

A.—Clear of what I had borrowed.

COMMISSIONER—You spent some and borrowed the rest. Is that what you mean?

A.—Yes.

MR. LEWIS—How much of your own money did you expend?

A.—It must have cost me about \$700.00 or \$800.00.

Q.—Was any of the money of the Dominion Iron and Steel Company expended by you for election purposes at that time?

A.—Nothing clear of that cheque.

Q.—Does that cheque represent any money that belonged to the Dominion Iron and Steel Company expended by you for election purposes?

A.—No, that cheque was separate.

Q.—This cheque then is what you originally said it was, borrowed money?

A.—Yes.

Q.—Does the money that you expended for sending the men home, or any part of that money, represent money that was the property of the Dominion Iron and Steel Company?

A.—No, the balance was my own.

Q.—You testified yesterday, I think, that there was money due and owing to you on March 19th, 1921, for expenses incurred in connection with the Bay de Verde election amounting to \$380, and my recollection is, that you stated that that money was money that you expended in connection with the Bay de Verde election.

Q.—Will you be good enough to explain how it happens that you had one cheque for \$380 representing monies advanced by you in connection with the Bay de Verde election, and another cheque for \$2000 a considerable part of which you say also represented expenses incurred in connection with the Bay de Verde election?

A.—A part of that cheque was the balance for the Bay de Verde bye-election.

Q.—Why did you not get a cheque representing the entire expenditure?

A.—Because I had to give Cramm this amount.

Q.—Then you paid it to Cramm prior to the receipt of this cheque?

A.—Yes.

COMMISSIONER—I think you told us yesterday that you had a document or receipt from Mr. Cramm, did you find that?

A.—No, I could not find it, but Mr. Cramm can confirm it.

MR. LEWIS—There was no particular reason for keeping a separate account of monies that you paid to Mr. Cramm, for monies that you paid to other people, was there?

A.—No more than that all the bills were not put in at the time.

Q.—Can you tell us just how much money you expended or claim to have expended in connection with the Bay de Verde bye-election, for which you required repayment from Sir Richard Squires?

A.—There was \$1000 on the \$2000 cheque and \$380. That was all that was outstanding.

MR. LEWIS—Now, will you honour turn to your notes, and see if Mr. Miller did not say only five minutes ago that he spent between \$2000 and \$2500 sending these men home to vote. Now his last answer is that the total amount was \$1380.

COMMISSIONER—You have also told us that the total amount spent to send the men home was between \$2,000.00 and \$2,500.00. How was the balance paid?

A.—It was never paid. It is still outstanding.

Q.—To whom is it due?

A.—To me.

MR. LEWIS—How much is still due to you on that account?

A.—There would be about \$800.00 of \$900.00.

Q.—And the election occurred in June, 1920?

A.—No, that election was in June 1920.

COMMISSIONER—It is agreed that the election was in June 1920. If you can agree upon that it will be alright.

MR. LEWIS—It is agreed that it was on June 24th. Are you still of opinion that in March 1921, and in fact at a date considerably later than March 1921 you received a cheque from your sister.

COMMISSIONER—It can't be later than March.

MR. LEWIS—The cheque is dated March, but

COMMISSIONER—These cheques were changed for the Daily Star cheque which is itself dated in March, 1921.

COMMISSIONER—Nine months after the election had some of the bills not been given in?

A.—They were all paid by myself.

Q.—If you paid the bills before March then the question still remains, why did you not include the cheques for the balance?

A.—Because when Sir Richard arrived home the amount was completed for \$46,000.00. It was held up.

Q.—When he came home you agreed to him on a figure of \$46,000.00. Why did you not include all the sums that you had expended.

A.—That was all the records that Miss Miller had at the time.

Q.—Had you not got the bills?

A.—No, I just had the memo.

Q.—Why was your memo not complete showing all you had paid.

A.—Because I was trying to get the first amounts paid first.

Q.—You included the \$2,000.00 and the \$380.00 and what I don't quite understand for the moment is, why you did not include the eight or nine hundred dollars which you say is still left outstanding. Can you give us any reason why that was not included at the time when you got the \$46,000.00 other cheque?

A.—I don't know why I didn't put it in, sir.

MR. LEWIS—You never called upon Sir Richard for the payment of that nine hundred or eight hundred dollars, you never put in any claim for it?

A.—No.

COMMISSIONER—(Repeating)—"I have never made any claim for the balance."

MR. LEWIS—The claims represented by the \$2,000.00 cheque, I suppose you turned over to your sister at the time you got it, did you not?

A.—The Daily Star amount was turned over to my sister.

Q.—The balance, when was that turned over?

A.—That was paid at Wabana.

COMMISSIONER—Did your sister give you any documents regarding the transactions?

A.—No.

MR. LEWIS—Did you turn over to your sister at the time the cheque was issued to you, any memo, say written evidence of your claim against Sir Richard aggregating \$2,000.00 at that time?

A.—No.

Q.—And she issued the cheque to

(Continued from Page 6.) you entirely upon your statement that you had used that amount. A—She would have a record of it. MR. LEWIS—The cheque of \$2,000 represented nine or ten hundred dollars in cash, which you turned over to her and the balance was money you had used at Wabana? Q—Roughly, yes. Q—Then the ten hundred and upward represented the balance of the \$2,000; she had no evidence whatever, except your statement? A—Yes, she came to Wabana with a cheque (blank) from Sir Richard. Q—So that she took your word for an expenditure of a thousand dollars and upwards; issued to you a cheque drawn by her against the bank account of Sir Richard Squires for this amount? A—Yes. Q—Now Mr. Miller, a slight draft of August 14th which I show you in evidence, drawn upon you and forwarded for collection, payable at sight; was subsequently paid at Wabana as the evidence shows? COMMISSIONER—That is the one on which the date of payment is inflexible? A—Yes, that is the one, your honor. COMMISSIONER—So that date of payment is left in doubt? MR. LEWIS—That was paid somewhere about the 17th or 18th? COMMISSIONER—I don't know how he can tell. MR. LEWIS—What was the usual course between St. John's and Wabana. A cheque deposited in the Bank at Nova Scotia in St. John's dated August 14th; when would it be likely to be presented at Wabana for payment? A—Between three and five days. COMMISSIONER—The quickest we have had is two days and the longest was six. MR. LEWIS—Was this draft discounted when it was presented and placed to the credit of Sir R. Squires, at that time, do you know? A—I have no recollection any more than the amount was credited to his account. MR. LEWIS—Was there any money to your credit sufficient to pay this cheque when presented? A—How much is it for? Q—\$5,000. A—No, I would not have had it. COMMISSIONER—Apparently it was never presented to him. MR. LEWIS—Now, I show you a cheque of \$5,000 dated August 16th, already in evidence, in whose handwriting is it? A—It looks like one of the bank clerks. Q—Where was it actually prepared, here at St. John's or at Wabana?

tion balance or certified statement of the balance as at March 31st. A—Yes. Q—My recollection is that prior to March these drafts and one note had gone through the Bank and aggregated upwards of \$43,000 or \$45,000 or \$46,000. COMMISSIONER—They aggregated \$43,000. A—Yes. MR. LEWIS—Was there any question raised, to your knowledge, about the discrepancy between the books of the company at Wabana and the Bank balance of the Bank of Nova Scotia at East Wabana by the Price Waterhouse Company in March 31st, 1921? COMMISSIONER—Did they call attention to a discrepancy? A—No sir. Q—You have said that they called upon the Bank at East Wabana for a reconciliation statement? A—Yes. Q—Was the reconciliation statement which they required, a statement that would reconcile the bank statement with the Company's statement at that date? A—No. The bank statement should show \$46,000 short. Q—Did it? A—Yes. COMMISSIONER—\$43,000 it was at that time. Q—Didn't Price and Waterhouse Co. comment upon that? A—Yes. MR. LEWIS—Was any action taken by the Dominion Iron and Steel Co. against you in connection with the \$43,000 shortage at that time; after that audit? A—No sir. Q—Then it is a fact that the Company's auditors made the quarterly audit some time in March? A—The outside auditors did it monthly. Q—Did they come to Wabana to make that audit? A—They were down twice in 1922. Q—Were they there in March 1921? A—No. Q—Then they did not audit your books in March 1921. A—They had our returns in Sydney, payrolls, vouchers and cheques. Q—Yes, but your payrolls probably showed an excess covering the amount

of discrepancy between your books and the bank books. The bank statement would show the shortage and your pay rolls and disbursement items would show an excess to the extent of \$46,000. Q—Our record would show the correct amount. COMMISSIONER—The pay rolls would be correct? A—Yes. Q—There was no inflation; the suggestion seems to be that your pay rolls were inflated to cover the shortage due there. MR. LEWIS—The witness's testimony stands that there was \$46,000 of the company's money paid out of the East Wabana Bank; the bank statement showed that fact; the bank books showed that that money had been paid out and that made a discrepancy between the Bank books and the books of the company. The auditors were sent there, an audit was made and the discrepancy was not discovered. COMMISSIONER—It must have been hidden by some jugglery. MR. LEWIS—"Jugglery" is an excellent word, your honor. Q—Price Waterhouse and Company came upon the scene; was that an occasion or did they audit annually? A—Annually. Q—At the end of March? A—The 31st is the end of the fiscal year. I think they had their quarterly audit at St. John's. Q—Did they have it at Wabana or Sydney on March 31st? A—Sydney. Q—Then the story is, as it stands on the records and as you recall it, that the \$43,000 of the company's money and upwards, was withdrawn from the bank at East Wabana in satisfaction of the drafts, to which you were a party and by your direction those times would probably be entered on the books of the company and the discrepancy between the books and the bank showed an amount equal to the withdrawal, that those records were transferred to the office at Sydney submitted to Price and Waterhouse Company and your own auditors and no charge or claim was made against you when the account at Wabana did not satisfactorily give to you any source of any shortage or discrepancy in your account; is that true? There was no record in your book. COMMISSIONER—There is a discrepancy in the bank books and the result is that you send the bank statement with your own books and the two don't agree to that extent. Is it your story that that was the state of things; that the papers that went to Sydney showed a discrepancy but you were never called upon or asked to explain anything with regard to it, there was no charge made against you in respect of it? A—The bank certificate would be sent direct to them, we would have nothing to do with that, the auditors would want to have a certificate. Q—Didn't you have a bank statement? A—I had the statement but no certificate. Q—But the statement showed the withdrawal of \$43,000. A—It would show it short. Q—The books contained no reference to it? A—No. Q—The bank statement would show it, but you would not? A—No. Q—The two sets of documents did not agree, one showed the \$43,000 shortage and the other didn't? A—Yes. Q—Was no explanation ever asked from you, or your attention never called to the fact? A—Mr. Gillis knew about it in 1920 and he transferred \$20,000.00 of that amount to Sydney, the balance was left at Wabana. We could not take care of the whole amount. COMMISSIONER—Then the auditors, as far as you know, never asked you about it? WITNESS—If they asked about it it would likely be through Mr. Gillis, as he was superintendent. Q—But they never asked you for any? A—No. MR. LEWIS—No inquiry was made of any sort. A—It was never made to me, sir. Q—You testified, Mr. Miller, that the \$339 cheque was for disbursements in connection with the Bay de Verde bye-election. Who was the candidate? A—Mr. Cave. Q—And the money was expended in his interests? A—Yes. Q—Did you ever ask Mr. Cave to refund that money to you? A—I had nothing to do with him, sir. Q—You were working on his behalf,

only, or is it a list showing the extent of each shareholder's holdings? A—It has the names and the shares. Q—If that is so, and the information can be obtained by anybody at the expense of a little amount of money, then I think you will have to answer the question. WITNESS—I should like to know what bearing it has on the case. I could get the information, and show it to you this afternoon. Would that be alright? COMMISSIONER—What do you say, Mr. Lewis, do you object to the answer being left until this afternoon? MR. LEWIS—I had intended to follow this line of questioning until the close of the morning session. COMMISSIONER—Well, what would your next question be? MR. LEWIS—My next question would have been as to whether he acquired larger interests and so on. I propose, if I am permitted, to find out how this witness has accumulated interests during the past four years. COMMISSIONER—Is the object to suggest that he has improperly himself acquired money? MR. LEWIS—The object is to obtain information for use when the time comes in my argument before your honor, in order that I may know the facts of the situation, and will be in a position to argue about it. COMMISSIONER—I must not allow cross-examination to become oppressive. I shall still ask in your question put to Sir Richard the witness? MR. LEWIS—It is for this reason: I think it will be shown, as a result of this investigation, that the witness was in 1920 an employee of the Steel Company at a salary of \$225 per month. COMMISSIONER—I assume you wish to show that before this transaction he was a poor man, and after that he was a rich one. Even supposing you can show that, has it anything to do with this question? MR. LEWIS—It has to do with the question of the bona fides of Mr. Miller. In his testimony he makes a declaration that he paid over the use of Sir Richard Squires sums of money which were paid from the treasury of the company at his direction, and which were raised by him. COMMISSIONER—He does not say that, except as far as the \$2,000 and \$339 amounts are concerned. He did not say he paid the other amount—the Bank paid that. MR. LEWIS—The money was paid by his direction by the Bank. COMMISSIONER—Not by his direction; by the fact that he did not try to stop it. He could not direct the bank to pay over to Sir Richard Squires the amount of a draft drawn upon himself with no sanction from Sir Richard Squires to do so. Somebody in the bank must have done that. That is why I wanted to get Mr. Glennie. The question is were there amounts for under-lying reasons, in fact purposes of the company, paid to Sir Richard Squires, and the answer is yes, that it is so. Money of the Dominion Company was in fact paid Sir Richard Squires in his office. Q—Was that done with the knowledge and approval of Sir Richard Squires? MR. LEWIS—Sir Richard was abroad, and the witness has a sister to whom a power of attorney was given. Certain money was obtained from several sources, one of them being Dominion Steel and Iron Co., . . . COMMISSIONER—The only one which I have to deal with. MR. LEWIS—And from other people from whom he (the witness) borrowed money and claims to have applied these moneys for the benefit of Sir Richard Squires. Now his sister, having the power of attorney for Sir Richard Squires, and being manager and accountant in Sir Richard's office, it was her duty to keep a record of the moneys that were borrowed on behalf of Sir Richard Squires. There should have been a record in the books. I think the testimony given shows that the books were not written up, in fact that they were in a chaotic condition. COMMISSIONER—A great many entries were not made that ought to have been made, but what that connects I have to find out. There are occasions you know when people prefer not to make entries. MR. War Memorial Tablet

UNVEILED AT GEORGE ST. CHURCH.

George St. Methodist Church was the scene of a touching and impressive ceremony yesterday morning, when His Excellency the Governor unveiled the Memorial Tablet, which had been erected by the congregation to perpetuate the memory of their fellow members who made the Supreme Sacrifice in the Great War.

Among the distinguished visitors present were the Prime Minister, many officers of the Regiment and the Brigades, Deputy Major Martin, the Inspector General of Constabulary, and Major W. March representing the G.W.V.A. The Governor, having delivered a short address, laid a beautiful wreath below the Tablet. He was followed by the Prime Minister, next by Mr. C. H. Steer with the wreath given by the Church, and Major March paid a like tribute on behalf of the G.W.V.A. The friends and relatives then placed their floral tributes at the foot of the Tablet, and such was the number of wreaths deposited, that it appeared to rise from a mound of variegated columns.

His Excellency then delivered the following address:—

Your Minister has asked me to address you briefly on this solemn occasion, and I have hesitatingly consented to do so. I fear, however, there is very little, if anything, that I can say to you this morning, and more particularly to the relatives and friends of those brave men whose names are indelibly inscribed not only on your beautiful Memorial but in the hearts of the people of Newfoundland, that has not already been conveyed to you by those whose privilege and duty it is to comfort the bereaved and the distressed. Yet I should not wish you to go away at the end of this service with the idea that the unveiling of this Tablet closes this heroic but tragic chapter in our Island Story. Your dear ones responded voluntarily to the Call of Conscience, and did their duty by their God, their King, and their Country, and they were called upon to make the Supreme Sacrifice and they willingly laid down their lives for those ideals which we treasure most. In doing so they had every confidence that Right would win out. True, they are no longer with us, but our religion and our faith are worth anything those lives were not lived in vain; they are certainly not lost. The body may be hurt and killed, but the spirit is indestructible. It lives on. What we term death is but a change that comes to all alike, and if we have faith this change is merely a transition.

To-day your hearts are sore, you are in mental distress at the remembrance of those who gallantly and heroically we commemorate in the Memorial Tablet I have unveiled, and I would that I could offer you a palliative to your heartache. The All Loving Father in His infinite wisdom has used them for His own good purpose, and has himself recorded their individual services. May I urge you therefore to be not unduly cast down or dejected. They have left us a glorious, never-to-be-forgotten, and imperishable example; and the legacy that they have bequeathed to you, and to each one of us, may be briefly summed up in the words, "Duty and Service" and we shall be honouring them in the best way possible by maintaining these high ideals for which they themselves voluntarily and gladly fought and fell. They assuredly believed that the life of the Christian is continuous and marching on, and Faith gave them this belief.

They say that he is dead.
We know so little in this world of ours.
Yet when the fall and winter kill the green,
And when the sun sets o'er the western hill,
We do not say that Earth is dead;
We do not say that Light is dead;
For we have seen the spring in its lush glory,
And we have seen the sunrise,
And what we see we know is true.
So this we know: that all that seems to die,
But changes—
And so the lovely frame that once held him,
No longer holds him—that is all;
Even as the waning day no longer holds the sun,
As winter melts before the rush of spring;
So does that frame which I called him,
But which was not him, any more than you dead tree
Yield to another frame . . .
I hear the murmur of the ice-clad brook,
I hear a robin sing a note of spring.
The Tablet is an artistic piece of work in bronze, and bears the following inscription and names:—

"To the Glory of God and in grateful remembrance of those members of this congregation who laid down their lives in the Great War, 1914-1918, that the inhabitants of our Island may in peace and quietness serve Thee, O God."

The service which preceded the unveiling ceremony was conducted by Rev. R. E. Fairbairn, the pastor, who preached an eloquent, impressive and most appropriate sermon from the text "These are dead in the Faith, Heb. 11-13." The solo by Mrs. Christian "In Flanders Field," and the Anthem "Who are These," and "Crossing the Bar," by the Choir, were beautifully rendered, and "The Dear March in Saut," and "Chopin's Funeral March," were played by the Organist Mr. Gordon Christian. The congregation of George Street Church will long remember the last honors they paid to those gallant men who willingly and uncomplainingly gave their lives for their country. To-day the Church will be open to visitors in order to enable them to view the Tablet and the flowers.
