

CENTRAL HALL, YARMOUTH, 24TH OCTOBER, 1849.

Grand Division met according to adjournment, and opened in due form : G. W. P. William Burrill in the chair.

Minutes of yesterday's Session read, and approved.

A memorial was read from representatives to the Grand Division from Halifax and vicinity.

On motion, voted, that the G. D. go into a Committee of the whole, with reference to the subject matter of the foregoing memorial : which Committee subsequently submitted the following

REPORT:

The G. D. in a Committee of the whole with reference to the removal of the chartered locality of the G. D., beg leave to submit the following resolution as embodying the opinion of the Committee.

following resolution as embodying the opinion of the Committee. Resolved, That the National Division he respectfully requested to locate the Grand Division of Nova Scotia in Halifax and Yarmouth; the annual meeting to be held alternately in these places.

The Committee on the state of the Order in Nova Scotia, respectfully suggest, that the duty laid upon them is such as to require more time, than the present Session of the G. D. will allow, to enable them to prepare such a report as the circumstances of the Order demand;—they beg leave therefore to submit their final Report at the next quarterly meeting of the G. D.

They have the pleasure of believing that the circumstances of the Order in this Province are highly prosperous, and such as to inspire us all with gratitude to God, and lead us to hope with reference to the future;—and though there may be some causes for regret from the want of zeal and strict integrity on the part of a few who have united with us, still they are confident that the Order is progressing, and proving itself a minister of good to the people of this Province. Afternoon Session, Oct. 25.

Grand Division opened in due form; all the officers present.

Minutes of morning session read and approved. $O_{\rm H}$ motion, voted, to accept the report of the committee of the whole.

On motion to adopt said report, the privilege of voting by Divisions was asked for by Brs. L. E. Van Buskirk, C. B. Naylor, and A. Hichborn, and granted.

It was ruled by the G. W. P. that no representative has power under the constitution of the G. D. to cast the entire vote of his division, provided he is the only representative from such division present: and that, in order to throw the entire vote of the division, all the representatives, to which said division from the number of its members was entitled, must be present and vote.

An appeal from this decision of the chair was had. and on the question, "Will the G.D. sustain the Chair in its decision?" the vote, which was taken by yeas and nays, was as follows:

The decision of the Chair being sustained, the vote on the adoption of the Report of the Committee of the whole was had, and resulted in favor of the adoption— 25 in the affirmative, 1 in the negative.

Br. A. Hichborn gave notice of his intention to appeal from the decision of the Grand Division with reference to the matter of voting by divisions, to the National Division.

The following resolution, moved by R. M. Barratt, and seconded by J. B. Bond, was unanimously passed:

Resolved, That should the National Division, in accordance with the vote just passed, sanction the removal of this Grand Division, that its next annual session be held in Halifax.

The following resolutions were unanimously passed:

1. Resolved, That the next Quarterly Session of the Grand Division be held in Lunenburg the last Wednesday in January next.

2. Resolved, That the second Quarterly Session of the Grand Division be held in Cornwallis the last Wednesday in April next.

3. Resolved, That the third Quarterly Session of the Grand Division be held in Pictou the last Wednesday in July.

The following resolution was moved by J. W. Hall, seconded by C. B. Naylor:

Resolved, That a Committee be appointed for the purpose of framing a petition to be presented to the House of Assembly, praying that a Charter of Incorporation may be granted to the Grand Division, for the greater security of the funds and other properties of the Grand and Subordinate Divisions

On motion, it was voted, that the consideration of the above resolution be deferred until the next quarterly meeting at Lunenburg.

Adjourned till 7 o'clock, at Acadia Hall.

Evening Session, 7 o'clock, 25th.

Grand Division opened in due form,-G. W. P. in the chair. Officers all present.

On motion, voted unanimously, that the sum of thirty pounds be paid Br. J. Tooker for his services as Grand Scribe. On motion, voted, that the Grand Division proceed to the election of officers for the ensuing year.

The candidates for G. W. P. were Brs. Rev. J. Mc-Murray, and E. Sterns;—the ballot resulted as follows: Rev. J. McMurray, 29

E. Sterns, 10—necessary to a choice, 20. Majority in favor of Rev. J. McMurray, 9—and he was declared duly elected G. W. P. for the ensuing year.

The candidates for G. W. A. were Brs. L. E. Van Buskirk, E. Sterns, Jas. Rogers, J. Budd;—the ballot was as follows :—L. E. Van Buskirk, 24; E. Sterns, 4; J. Budd, 5; Jas. Rogers, 8;—whole number, 41; necessary to choice, 22. Majority in favor of Br. L. E. Van Buskirk, 2—and he was declared elected as G. W. A. for the ensuing year.

The candidates for G. S. were Brs. Rev. A. Hichborn, W. A. S. Blewitt, and E. M. Cowling. The ballot resulted in the choice of Br. Rev. A. Hichborn, on the second trial, there being no cloice by the first, by a majority of 2, and he was declared as duly elected as G. S. for the ensuing year.

The candidates for G. T. were Brs. C. B. Naylor, Jno. Campbell, and James Starr. Br. Campbell was elected on the second balloting by a majority of 1, and declared to be duly elected G. T. for the ensuing year.

Br. Rev. G. H. Porter was unanimously elected as Grand Chaplain for the ensuing year.

Br. Benj. Zwicker was elected as G. C. on the fourth ballot by a majority of 2, and declared as duly elected to the office of G. C. for the ensuing year.

Br. E. M. Cowling was duly elected G. Sen. on the fourth ballot, by a majority of 2, and declared as G. Sen. for the ensuing year.

The officers elect were then duly installed into their respective stations.

Voted to excuse Br. A. Hichborn as Chairman of Committee of Appeals; and appoint Br. C. B. Naylor, in his stead.

On motion, voted that Brs. Harley, Tooker and Redding, be a committee to make arrangements for said public meeting.

On motion, voted to adjourn till 10 o'clock to-morr ow. G. D. closed in due form.

FRIDAY Morning, 26th Oct.

Grand Division opened in due form, pursuant to adjournment: G. W. P. in the chair.

On motion, voted to remain in permanent session until the business of the session be finished.

On motion, voted to indefinitely postpone the consideration of the above resolution.

Resolved. That the Temperance Gazette, published at Yarmouth by Br. H. C. Flint, be the acknowledged Organ of the Order of the Sons of Temperance in this Province.

Passed.

On motion, voted to adopt the suggestion of the National Division so far as to recommend to the several Subordinate Divisions under the jurisdiction of this Grand Division, the necessity and importance of holding public meetings on the subject of Temperance, at least every three months.

The following Resolution was moved by Br. G. S. Brown:

Resolved, That this Grand Division go into the enquiry of the number of members necessary in a Subordinate Division to constitute a constitutional working quorum.

On the question being taken the Resolution was lost.

Br. A. M. Gidney offered the following Resolution :

Resolved, That this Grand Division deem it incompatible with the spirit of our Order to admit Subordinate Divisions to retain their Charters who have dwindled in numbers to less than ten members; and that Subordinate Divisions will not be regarded in a capacity to do business with a quorum of less than nine.

On the question being taken, the Resolution was passed. Subsequently, a reconsideration was moved of the Resolution, and carried; and on the final vote, the Resolution was lost.

P. G. W. P. William Burrill gave notice of an intention to appeal from the decision of this Grand Division on the above matter, to the National Division.

On motion, voted to instruct the G.S. to have three hundred copies of the records of the proceedings of this Annual Meeting printed, for the use of members and Subordinate Divisions.

On motion, voted that the sum of Two Pounds and Ten Shillings be paid to Br. F. W. Redding, to remunerate him for expenses incurred at the meeting of the G. D.

On motion, voted that the travelling expenses of the Officers of the G.D. be paid from the funds of the G.D.

On motion, voted that the thanks of this Grand Division be extended to the people of Yarmouth for their hospitality and kindness during the meeting of the Grand Division.

On motion, voted to adjourn, to meet in Lunenburg the last Wednesday in January, 1850.
