# ABSTRACT OF ACT OF INCORPORATION.

(*Vide 7th Vict., Cap. 68, and 14th and 15th Vict. Cap. 171.*)

1. For the encouragement and support of Missionaries, and Clergymen of the United Church of England and Ireland, and for creating a fund towards the augmentation of the stipends of poor Clergymen, and towards making a provision for those who may be incapacitated by age or infirmity, and for the Widows and Orphans of the Clergy of the said Church.
2. For the encouragement of Education and the support of Day Schools and Sunday Schools in conformity with the principles of the said Church.
3. For granting assistance, where it may be necessary, to those who may be preparing for the Ministry of the Gospel in the said Church within the Diocese.
4. For circulating in the said Diocese, the Holy Scriptures, the Book of Common Prayer of the said Church, and such other Books and Tracts as shall be approved by the Central Board or Managing Committee of the said Association.
5. For obtaining and granting aid towards the erection, endowment and maintenance of Churches according to the establishment of the said Church in the said Diocese, the creation and maintenance of Parsonage Houses, the setting apart of Burial Grounds and Church Yards, the endowment and support of Parsonages and Rectories according to the said establishment, and the management of all matters relating to such endowments.
6. The said Corporation or the Central Board thereof, or such other Executive and Managing Committee thereof, as shall from time to time be appointed and authorized by the By-laws, rules and regulations, which may be made and passed for the government of the said Corporation, shall have power and authority to alienate or exchange; and to demise, let and lease for any term of years, such messuages, lands, tenements, hereditaments and immoveable property as shall be given, granted, purchased, appropriated, devised, or bequeathed to the said Corporation, for all or any of the purposes aforesaid, and to have receive and take the purchase money, consideration or price, rents, issues, or profits thereof.
7. The Corporation and their successors, shall and may from time to time, hold meetings of the said Corporation, which shall be called together in such manner, and at such times, and at such place as shall be directed and appointed by the by-laws, rules and regulations of the same, to transact the business of the said Corporation, and shall and may at any such meeting elect such persons to be members of the said Corporation, as they or the major part of them then present shall think fit. No act or thing done in any such assembly or meeting of the said Corporation shall be valid or effectual, unless six persons of such Corporation, at the least, shall be present, and the major part of them consenting thereto.
8. The said Corporation or the major part of those present at any of the meetings of the said Corporation to be held in the manner aforesaid, shall and may make and ordain any constitution, by-laws, rules and regulations, which to them or the major part of them then present, not being fewer in number than six, as aforesaid, shall seem meet, reasonable or requisite, touching and concerning the well ordering and governing of the affairs

and business of the said Corporation, and the due administering and improving of the property thereof, as aforesaid, and such constitution, by-laws, rules and regulations in like manner from time to time, to abrogate, repeal, change or alter, as may be found expedient, which constitution, by-laws, rules and regulations shall be binding upon, and shall be observed, performed and kept by the members of the said Corporation.

2. No such constitution, by-law, rule or regulation of the said Church Society of the Diocese of Quebec, nor any abrogation, repeal, change or alteration of the same, shall be of any force or effect until it shall have been sanctioned and confirmed by the Bishop administering the Diocese for the time being, by writing under his hand.

## GENERAL BY-LAWS.

### ART. I.

His Excellency the Governor General, if a Member of the Church of England, shall be requested to become Patron of the Society.

The President of the Society shall be the Lord Bishop of Quebec, or Bishop administering the Diocese, and the Vice-Presidents shall consist of such Chairmen of the different District Associations, hereinafter provided for, as are Members of the Corporation, and such other persons as shall be nominated at the general annual meeting of the Society, from among the Members of the Corporation.

The President shall have the custody of the Seal of the Society.

### ART. II.

#### OF THE TREASURER.

The Treasurer shall receive all subscriptions, donations, rents, issues and profits payable to the Society, for which purpose a paid collector or collectors may be employed.

Such moneys shall be deposited in such Bank or Banks as shall be from time to time indicated, or approved of by the Central Board.

No money shall be paid by the Treasurer without the authority of a resolution of the Central Board, certified by the Secretary, expressing the name of the person to whom, and the purpose for which the money is to be paid.

The Treasurer shall also have the custody of all deeds, bonds, securities, and other documents relating to the property of the Society, which after registration shall be deposited in one of the approved Banks, unless otherwise specially ordered by the Central Board, and shall submit his accounts at the stated periodical meetings of the Board.

### ART. III.

#### OF THE SECRETARY.

The Secretary shall keep the minutes of all the proceedings of the Society, as well as of the Central Board, and shall be subject to the direction and control of the Central Board in all his duties and proceedings. He shall be allowed a salary and travelling expenses under the direction of the Central Board, and may appoint an assistant, subject to the control and approval of the Board, provided that such appointment shall entail no additional burden upon the Society.

The Treasurer, the Secretary, the Auditors, and other necessary Officers, of the Society, shall be appointed by the Central Board. These appointments shall not be for any specified period, but may be cancelled at the pleasure of the Central Board.

### ART. IV.

#### OF MEETINGS OF THE SOCIETY.

The Society shall meet annually on the second Wednesday in January at Quebec, whereof not less than fifteen days notice shall be given by the Secretary, in at least one of the leading newspapers of Quebec, and elsewhere as may seem to him expedient. A special meeting of the Society may be called at any time by the President, or in his absence from the Diocese, or in the event of a vacancy in the See, by two of the Vice-Presidents, and ten other Members of the Society, by a written order to the Secretary, who shall notify the same in the manner hereinbefore provided in respect of the annual meetings.

## ARTICLE V.

## OF THE CORPORATION.

All Members of the Church of England, subscribing ten shillings per annum shall be capable of being elected Members of the Corporation. But no person shall enjoy any of the privileges of Membership, whose subscription is more than one year in arrear. The annual subscriptions shall be considered due upon the first day of January in each year.

Members of the Church of England giving a contribution in one sum of twelve pounds ten shilling shall be eligible as Life Members.

Contributors and subscribers may limit and direct any portion, not exceeding one half of their contributions and subscriptions, to be applied, under direction of the Central Board, to any one of the five objects specified in the Constitution of the Society.

## ARTICLE VI.

## OF THE CENTRAL BOARD.

There shall be a Central Board for the management of the general business of the Society, consisting of the President, the Vice-Presidents, and other Officers of the Society, the Incumbent, and Church-Wardens of every Church or Chapel of the United Church of England and Ireland within the Diocese, being Members of the Corporation, and of such others as shall be chosen annually at the general meeting of the Society from among the Members of the Corporation.

The Board shall meet four times a year at Quebec on the Wednesdays nearest to the 15th of May, the 10th of July, the 10th of October, and on the Thursday next after the Annual Meeting.

Special meetings may be called by the President, or in his absence from the Diocese, or in the event of a vacancy in the See, by two of the Vice-Presidents, and four Members of the Board; and not less than seven Members present at any meeting shall form a quorum. When a sufficient number of Members to form a quorum shall not assemble on the regular day of meeting, the Members present shall have power to adjourn to another day, and so on *toties quoties*, until a quorum shall be found; and business shall and may then be proceeded with. It is one of the rules of the Central Board that no application for a grant of money shall be entertained, unless such application shall have reached the hands of the Secretary a fortnight at least before the next ensuing meeting of the Board.

The Central Board shall have authority to make such rules as may be necessary for the Government of its own affairs, provided that none of them be contrary to, or inconsistent with, the spirit of the Constitution or By-laws of the Society.

The Central Board shall be held to be accountable to the Corporation and shall report to the annual meeting a general statement of its proceedings, and of all moneys received and expended during the preceding year, submitting at the same time a list of Officers for the year then commencing.

The Central Board shall make no grant of money for the benefit of any Parish or Mission unless the subscriptions for the preceding year from such Parish or Mission shall have reached the hands of the Treasurer of the Society.

No portion of the Society's funds shall be employed in augmenting the stipends of officiating clergymen, in supporting schools, or in erecting Churches or Parsonage Houses, within the limits of the City of Quebec.

## ARTICLE VII.

## OF DISTRICT ASSOCIATIONS.

In connexion and correspondence with the Central Board, there shall be formed District Associations, except in the City of Quebec and the Banlieues thereof, to be composed of the Clergy, and all other Members of the Society resident within the bounds of such Districts, a contribution of five shillings per annum constituting Membership of such District Associations. The District Associations, except as hereinbefore excepted, shall continue as heretofore settled by the Central Board of the Society before its incorporation until otherwise hereafter determined by the Central Board.

The Senior Clergyman holding a Pastoral charge within such bounds, and being a Member of such Association, shall, *ex-officio* be Chairman thereof. They may have a Secretary and Treasurer, and shall meet at such places as they may themselves determine; at one of which meetings the Officers shall be appointed, and a report of the proceedings of the year read.

The District Associations shall have authority to make rules for the government of their own affairs, provided such rules be not contrary to, or inconsistent with, the Constitution or By-laws of the Society. They shall report annually to the Central Board, at least one month before the annual general meeting of the Society and at such other times as the Secretary, on behalf of the Board, shall require, a statement of their proceedings, and a detailed account of the moneys received and expended by them during the year.

One-half of all the moneys paid into the hands of the Treasurers of the District Associations, respectively, and not specially appropriated by the contributors, as provided for by Article V. shall be transmitted to the Treasurer of the Society, to be at the disposal of the Central Board, and the remaining half of all such collections shall, when required, be expended within the Parish or District in which they have been made, for such objects only as are specified in the Constitution of this Society. All moneys, remaining unappropriated at the general annual meeting of the District Association, shall be forthwith transmitted to the Treasurer of the Society, to be at the disposal of the Central Board.

## ARTICLE VIII.

## OF SUB-COMMITTEES OF THE SOCIETY.

For the more effectually carrying out the designs of this Society, the Clergyman and Churchwardens in every Parish and Missionary Station and the Minister and Wardens of every Chapelry within the Diocese, shall be a Sub-Committee of the Society in correspondence with the District Association within whose bounds such Parish or Missionary Station is situated, or in Quebec with the Central Board, through the Secretary of the Society. This Committee shall meet as often, and at such periods, as they themselves shall decide to be most convenient, inviting the co-operation of all the Parishioners in their deliberations and designs. They shall collect subscriptions and donations from the Members of the Church in such manner as they shall deem most effective, and endeavour, by every means in their power, to augment the resources of the Society. All moneys raised by such Sub-Committees shall be remitted to the Treasurer of the District Association, or to the Treasurer of the Society, where such moneys shall have been raised within the City and Banlieues of Quebec.

## ARTICLE IX.

## OF SERMONS.

One sermon at least shall be preached during the year within the limits of each Parish, Station or Chapelry, on such Sunday as the Bishop shall appoint, in favor of one or more of the objects of the Society, and a collection shall then be made in aid thereof, the proceeds of which shall forthwith be remitted to the Treasurer of the Society. Any Parish, Station or Chapelry in which such sermons shall not have been preached, shall not be considered entitled to any grant or benefit from the Society until a sermon shall have been so preached.

## ARTICLE X.

## OF THE LAY COMMITTEE OF THE SOCIETY.

A Lay Committee, consisting of not less than thirteen members, shall be chosen at the first meeting of the Central Board after the annual meeting of the Society, from among the members of the Corporation. Three members shall form a quorum, and they shall have power to fill up any vacancy or vacancies which may arise within their own body, and shall be governed by the constitution, rules and regulations adopted and in force before the incorporation of the Society, until the same shall be altered by the Committee, or by the Society at the general meeting.

The proceedings of the Lay Committee shall be subject to the sanction of the Bishop of the Diocese. The Clerical and other members of the Central Board may attend at any of the general meetings of the Committee and may propose and discuss matters therein, but shall have no vote. The committee shall report their proceedings to the Central Board at their stated meetings.

The objects of this Committee shall be:

*First.*—The placing the Clergymen, now resident, and doing duty in the Province, upon a just footing as regards the sufficiency and permanency of their incomes.

*Secondly.*—The providing for the permanent and adequate support of an increased number of clergymen, so that, with the least possible delay, the members of the Church, in every portion of the Diocese, may have the means of access to a Church within a practicable distance.

*Thirdly.*—The building, in every place where it may be required, a church of stone or brick, upon a well considered plan as to dimensions, external form, and internal arrangement, keeping in view the probability of its requiring enlargement.

*Fourthly.*—The building, in a good situation, convenient to the Church, a comfortable Parsonage of brick or stone, the plan of which should be carefully considered, with reference to size and internal arrangement, and should admit of additions being made, with the sanction of the Bishop.

*Fifthly.*—The insuring such Churches or Parsonages against losses by fire.

*Sixthly.*—The procuring an adequate and permanent support for all the institutions, authorities and functionaries, suitable and appertaining to the establishment of the Church of England in this Diocese.

*Seventhly.*—The investing all life subscriptions, unless so far as the application of these may be otherwise limited by the Contributors, in a permanent and accumulating fund, of which the interest only shall be applied to the general purposes of the Society.

*Eighthly.*—The encouraging the formation of a Local Endowment Fund, at every station or place having a Church or Clergyman, by Special Contributions, or by setting apart a portion of the pew rents, to form an ac-



accumulating fund, until the net income shall in each case amount to fifty pounds per annum; for the more effectual promotion of which object the Society will engage, whenever such fund shall be formed and shall amount to one hundred pounds, invested in bank stock, or other public securities, to add thereto an amount not exceeding one hundred pounds, provided always that such investment shall stand in the name of the President of the Society.

*Ninthly.*—The management and the superintendence of all lands belonging to the Society.

#### ARTICLE XI

All meetings of the Society, of the Central Board, and of District Associations, shall be opened by the following prayers—(*see any of the Society's Reports*),—or such others as the Bishop may appoint.

No alteration or amendment in the Constitution or By-laws of the Society shall be made unless such alteration or amendment shall be proposed at one and adopted at another General Meeting of the Society, provided that not less than one month intervene between the two meetings, and that the object of the Meetings be stated in the advertisement by which they are called.

At all meetings of the Society, of the Central Board, or of Committees, the Chairman, in case of an equality of votes, shall have a double or casting vote.

#### ARTICLE XII

Whereas some Members of the Church, who are not unmindful of the great spiritual wants of their own neighborhood, still feel constrained in pious gratitude for the blessings they enjoy, to allot something, however small, from the means with which a Gracious Providence has blessed them, towards the spread of the glorious Gospel among the nations, which still sit in darkness; the Society will gladly receive and forward to the Society for the Propagation of the Gospel, the Church Missionary Society or the London Society for promoting Christianity among the Jews, whatever sums may be given for the conversion and instruction of the Heathen or the Jews.

## CHURCH SOCIETY.

ANNUAL MEETING ON 11TH JANUARY, 1854.

The Annual General Meeting of the Church Society of the Diocese of Quebec, being its Twelfth Anniversary, was held on Wednesday, the 11th day of January, 1854.

Divine Service having been previously held in the Cathedral; the Lord Bishop took the Chair, and Prayers were said.

The Secretary acquainted the Meeting that the Lord Bishop had signified his assent, as President of the Society, under his hand, to the change in the Fiscal year of the Society, and the period at which its Annual Meetings shall be held in future.

The Report having been read by the Secretary, it was moved by the Rev. Dr. Falloon, and seconded by the Hon. Wm. Walker, and

## REPORT

*Of the Central Board of the Church Society of the Diocese of Quebec, for the HALF year ending the 31st of December, 1853.*

Every effort which is made for the propagation of the Gospel by individual members of the Church, by associations connected with her, or by the Church herself, should be undertaken in the spirit of Faith and Hope and Prayer, for in so doing only are we authorized to expect from above the grace of Perseverance which is promised to faithful obedience, and that blessing which shall render our labours instrumental in the salvation of immortal souls, to the glory of our blessed Redeemer.

Holding this truth in remembrance, the Central Board of the Church Society would commence in tendering this its Twelfth Report by faithfully offering humble and hearty thanks to Almighty God for the measure of success which has hitherto been vouchsafed to the exertions of the Society, and by humbly praying to the "Father of lights from whom cometh every good and perfect gift," that He may continue to pour down upon us the dew of His blessing, that we may please him both in will and deed, and be enabled, by enlarging the borders and strengthening the stakes of the Church for which his Beloved Son died, to promote the knowledge and practice of religion and virtue.

The period for which your Board has this day to render an account, being a broken one, renders it impossible to compare its receipts with those detailed in former reports, which have hitherto embraced a whole year, but they can very confidently affirm that there is no danger of any diminution of its annual income, and that the increasing interest taken in the objects for which the Society was organized and recent events in the Diocese connected with the government and discipline of the Church, cause them to bless God and take courage for the future, for in proportion as men learn to appreciate their privileges as Churchmen so will they realize their responsibilities as Christians, and remember the duty incumbent upon them, of providing, as far as lies within their power for the temporal wants of "Christ's Church militant here upon earth."

The Society meets this day at an unaccustomed season of the year, but we have not been called together unadvisedly or suddenly. The late zealous and efficient Treasurer of the Society—than whom, no man had its interests more at heart—finding that difficulties were daily arising and inaccuracies constantly occurring in keeping the accounts, in consequence of some of the Members of the Corporation having been in the habit of paying their subscriptions in the month of July, and some in the month of January, gave notice at the general meeting held on the 12th day of January, 1853—the proceedings of which were published in the Ecclesiastical Gazette—that he would move at the next General Meeting "that from and after next July the Annual General Meeting of the Society shall take place in January—that Articles 7 and 9 of the By-Laws be altered to that effect, and that for the future the financial year of the Society be from the 1st of January to the 31st of December."

In pursuance of this notice Mr. Symes proposed his resolution at the General Meeting in July last, which was seconded by H. S. Scott, Esq., and adopted without a dissentient voice having been raised against it, and in consequence notices were printed on the covers of the Annual Report that the meeting would be held this day, coupled with a request that the Reports of District Associations, the Accounts of District Treasurers, and Lists of the Subscribers in the several Missions for the half year preceding this meeting should be transmitted to the Secretary on or before the 10th day of December last. Subsequently a circular to the same effect was addressed to each Clergyman in the Diocese by the Secretary, and the Lord Bishop who was in England upon business connected with the welfare of the Church during the time that these changes were proposed, has since, as President of the Society, given his formal sanction to them.

Slight inconveniences, as were to be expected, have occurred in some of the Districts in consequence of these alterations, and prevented the subscriptions for the last six months from being collected. In others and especially in the city and neighbourhood of Quebec, and at Point Levi, little or no difficulty has been experienced, the subscribers having cheerfully paid in their contributions with the view of relieving the Society from an irregular and complicated system of accounts. It is not anticipated that there will eventually be any pecuniary loss to the Society by these alterations, for even in the Districts where the difficulties in collecting the last half year's subscriptions have been greatest, very confident hopes have been expressed that the arrears will be easily obtained, together with the subscriptions for the year upon which we have just been privileged to enter, but even should some small deficiency accrue in any District, it will be amply compensated for by the more regular income, and a more simple mode of keeping the accounts of the parent Society.

Advantages, on the other hand, it is hoped will result to the Society from the alteration of the time for holding the annual meeting from summer, when the mercantile and agricultural portions of our population are so fully occupied, to winter, when they have more leisure from worldly concerns, and may be reasonably expected to give more attention to its meetings and its operations.

Without dwelling upon the near approach to completion of the Richmond Railroad, the winter snow track being in general more easily travelled over than the rough and broken roads of summer, will enable the clergy and laity in the rural Districts more conveniently to attend, and to take part in the consultations and discussions of the Society.

In reviewing the operations of the Central Board during the last six months, it will be found that though no new object has been developed, and though it has been found impossible to carry out as fully as could be wished, important measures in which the clergy and laity feel a deep and mutual interest, yet the Society is in a healthy and satisfactory state, proceeding gradually and tranquilly, but it is believed, steadily and securely in public favor, and in its legitimate course of usefulness.

#### MISSIONARY LABOR.

During three months of the last half year, two clergymen have been employed as Missionaries, one at the Quarantine station, the other in the District of St. Francis.

The Rev. Mr. Allen vacated his office of Missionary on being appointed to a fixed charge, and the Rev. Mr. Stewart, who discharged the duties at Grosse Isle, has been nominated to the Curacy of Sherbrooke.

## WIDOWS AND ORPHANS.

The making some provision for the widows and orphans of the clergy who may die in the discharge of their pastoral duties in this Diocese, appears from the amount collected for the purpose in the different Districts, to be one of the most popular of the objects of the Society, and bids fair for years to come, to enable you to help the widow to maintain her fatherless children, and to bring them up in the nurture and admonition of the God of their fathers. The sum invested for the Widows' and Orphans' Fund being at present £1750, beside which, there remains in the hands of the Treasurer, waiting for a favorable opportunity for investment, £131 7s 8d.

## DEPOSITORY.

The sales at the Depository for the last six months have amounted to £23 2s 5½d. A selection of Bibles, Prayer Books, and other valuable publications has been obtained from the Society for Promoting Christian Knowledge, imported and placed upon the shelves of the Depository for sale. It is hoped that additional accommodation may be provided for this portion of the Society's establishment, at a trifling increase of annual expense, and that, in consequence, a larger sum will be realised by sales in future years. Grants have been made to several schools, missions, and lending libraries, of Bibles, Prayer Books, and miscellaneous literature. Altogether, there have been circulated by this means during the last six months:—

Bibles, 127.

Testaments, 42.

Prayer Books, 162.

Other publications of the Society for Promoting Christian Knowledge 151.

Though one of the great objects for which the Church Society was incorporated, was "the encouragement of Education and the support of Day Schools and Sunday Schools, "yet, from the peculiar difficulties which surround the subject, your Board has hitherto found itself unable to engage in any organized system of education; still, however, the subject is being carefully weighed, information has been sought for from every clergyman in the diocese, and no exertion shall be spared by your Board in their endeavors to discover and to avail themselves of such a system as shall combine an ordinary secular education with daily religious instruction in the Holy Scriptures, the Liturgy, and the Catechism. It may reasonably be hoped, that the time is not distant when such assistance shall be obtained for secular education as can be made available consistently with the teaching of the Church, and that the same privileges will be, ere long, conceded to the Church of the Empire, as are now in this colony granted only to the members of the Church of Rome.

From this brief narrative of the operations and accounts of your Board for the last half year, it will be seen that none of the important objects for which it was appointed have been altogether overlooked, that some progress has been made in furthering each of them, and that the income from the

principal source from whence your Society draws its support, has not diminished but increased.

But the increase is far from what it ought to be in a community professing to be followers of the Lord Jesus and Members of His Church.

Every object connected with the glory of the Redeemer and the advancement, prosperity and efficiency of His Church, should meet from Christians a liberal and a cheerful support. We labor not for ourselves alone but for future generations—for future generations of immortal souls, who may be saved for the glories of Eternity by our activity and Charity, or lost for ever by our apathy or penuriousness. And every recent event connected with our country teaches us that we must depend under God upon ourselves alone if we would place the Church upon a firm basis in this country.

We are not justified in calculating upon any extraneous aid. We cannot even hope that all which now belongs to us will be left with us. In such circumstances it is satisfactory to be able to reflect that a combination of the humblest efforts will produce much.

"If all the members of the Church would but act upon the Scriptural principle, of consecrating a tenth of their income to God's glory and the advancement of the Redeemer's Kingdom what a noble fund would the Church then possess! A fund sufficient for every emergency, and adequate to meet every requirement." Nay, were but *one dollar* paid annually by each member of the Church in this Diocese, our present income would be trebled and the Society be enabled to carry out all its most important objects. What we have is not our own. We are but stewards of God's bounties—it is required of stewards that a man be found faithful—and shortly we shall all have to render in an account of our stewardship to that God who cannot be deceived. Your Board would most respectfully ask, ought not this solemn consideration to induce all often and seriously to enquire of their own souls whether in the disposition of their goods they are careful to render unto God His portion?

In conclusion, your Board would exhort all to trust and pray that we may have grace to persevere in the work of the Society—which they are persuaded is the work of God—and not to slack our hands, until the happy day shall come, if not to us at least to some future generation, when every Township of this broad Province shall be supplied with the salutary ministrations of Christ's Holy, Catholic and Apostolic Church, and every baptized Christian within it, has become a member of the Church Society.

## ANNUAL REPORT FOR 1854.

In consequence of the alteration which took place last year, in the period at which the Church Society usually held its Annual Meeting, the Report which was presented by the Central Board on the 11th January 1854, embraced a term of six months only. To-day the Board appears before your Society to account for its Stewardship during the past year, and would commence this pleasing duty by recording its humble but hearty thanks for the encouraging measure of success with which it has pleased Almighty God to bless its labors.

In the spring of the past year, when the prices of provisions and fuel had risen to such a height as to cause distress and alarm amongst those who had to subsist upon small fixed incomes, your Board came to a resolution that all Clergymen in the Diocese, who receive £125 per annum or less, should be paid a gratuity of £12 10s. each for the purpose of assisting them to that extent, in bearing the additional expense to which they had been subjected during the year, in consequence of the advanced prices of the necessaries of life.

This small grant, your Board has reason to know, afforded seasonable relief to many a self-denying sufferer, and it would indeed be matter of much gratification, could your Board entertain the hope that the Revenue of the Society would enable it permanently to augment the incomes of the poorer Clergy, instead of only relieving them by a casual gift.

That some great effort must at once be made by the Laity for the maintenance of the Clergy is evident to every one who considers the altered circumstances in which the Church in this Province is now placed.

The votaries of the voluntary system have been victorious in the Legislature. The Reserves of Land which the piety of a religious King and Parliament, had set aside for the maintenance of a Protestant Clergy, having

through the energetic activity of that portion of the community, which is inimical to State endowments, been alienated to other purposes, the Church is left to her own unaided efforts for support. And surely it is not too much to expect that such of her sons, as have battled faithfully for the integrity of her rights, will feel it to be a pleasure as well as a duty, to sustain her in her misfortunes; and that those of her members who have acted on the conviction that their spiritual mother would be more prosperous from being deprived of her patrimony, will now intimate the mode by which poverty is to advance her usefulness, or prove by the munificence of their free will offerings, that while she has been weakened and impoverished by the action of the Legislature, she is still sustained and supported by the duty and loyalty of her children.

Your Board has reason to believe, notwithstanding the circulation of its reports, and other publications explanatory of the nature and objects of the Church Society that these are not sufficiently understood or appreciated by the members of the Church, and would in all humility and reverence say that its objects are "the same which drew the Saviour from the skies"—the salvation of immortal souls—the sending forth Missionaries to preach the everlasting Gospel, and administer the Sacraments—the diffusing of the word of God—the circulation of books which inculcate the duties of true religion, the education of the young in the nurture and admonition of the Lord, the erection throughout the country of temples wherein the congregation of God's people may "assemble and meet together," and the making of an humble provision for the widows and orphans of such of the Clergy as may be smitten by the hand of death in the discharge of their laborious and ill requited duties. These, and such as these are the objects for which the Church Society was established, and towards the attainment of which the earnest prayers, and the active co-operation of every member of the Church should ungrudgingly be directed.

But, it may be asked : How are the funds of the Society managed, and who are Members of the Society?—The answer is briefly this—Every Member of the Church throughout the length and breadth of the Diocese who pays not less than 10s. a-year, or gives not less than £12 10s. as a donation to the Society's funds, is eligible as a member of the Corporation, and, as such, has as much right to be heard, and possesses as good and valid a vote at this and the other general meetings of the Society as its Patron or President.

Your Board has much satisfaction in stating that His Excellency the Governor General has consented to accept the office of Patron of the Society, and has also become an annual contributor of £12 10s. to its funds.

While alluding to those, who are Members of the Church Society, it is the duty of the Central Board to state that at the lamentable fire which consumed the Parliament House on the 1st of February last, many of the books and records of your Society were destroyed in the flames, and amongst others, those which recorded the election of many of the present members, and that as the question of membership may at any time arise, your Board has appointed a Committee to prepare from the printed reports and the Treasurer's books, which with all the Title Deeds and Securities of the Society are safe—a list of those whose payments will prove them to have been Members, or to have been entitled to be elected Members, which list accompanies this report, and your board would venture respectfully to recommend that at the present meeting the persons named in this Return be elected and constituted Members of the Church Society of the Diocese of Quebec.

#### *Missionary Labor.*

Early in the last spring the Revd. C. H. Stewart, in the capacity of travelling Missionary of the Society, proceeded to Grosse Isle, where he remained during the period of the annual immigration, administering the consolations of reli-

gion to the sick, and preaching to the Immigrants and others who came under his charge, the inestimable riches of the grace of God.

The Reverend Gilbert Percy, A. B., having suffered severely from his onerous duties in St. Roch's in this city, and having been advised by his medical attendant to seek for renovation in change of air and scene, left Quebec on the 29th July, for Rivière du Loup, and finding his health sufficiently restored to undertake some Missionary duty proceeded by direction of the Bishop and under the auspices of this Society, to visit the destitute settlements on the banks of the Saguenay, where he arrived on the 2nd of August, and was kindly and hospitably received by Mr. Radford, Mr. David Price, and others. He occupied himself in visiting the different settlements and families in that neighbourhood, in public worship, in preaching and administering the sacraments, until the 20th of the same month, when he proceeded to Murray Bay, and visited the Protestant families resident there.

Mr. Percy thus concludes his Journal of this very interesting Missionary visit.

"I shall long retain a pleasing recollection of my visit to the several stations on the Saguenay. Every where I was received by the Protestant inhabitants of every class with expressions of extreme kindness and goodwill, expressions certainly not called forth by any feelings personal towards myself, a stranger altogether unknown, but by the character under which I appeared amongst them, that of a Clergyman and Minister of our holy religion."

"Protestants of various denominations all eagerly attended my ministrations—and from the great majority I heard but one wish: that they might have a clergyman resident among them.—They professed themselves ready to do their utmost towards the maintenance of a Minister—and I doubt not that these professions were made in full sincerity and truth.—If a clergyman was stationed either

at Chicoutimi or Grande Baie, he might have Sunday Services alternately at those places, and in the Summer season would be able also to visit occasionally the other stations on the Saguenay."

#### *Widows and Orphans Fund.*

With regard to this branch of the trust confided to your Board, they have abundant cause to bless and praise the mercy of the Most High, that while the Diocese has been severely visited by fearful sickness and death, His ministering Servants have been preserved amidst their labors, so that no new claim has been made upon the fund set aside for the widows and orphans of the clergy, while the contributions gathered for the purpose, together with the balance in hand from last year's accounts, have enabled your Treasurer to invest the additional sum of £250, retaining in his hands £193 2s. 5d. for future investment.

#### *Depository.*

The sales during the last twelve months have amounted to £38 15s. 2d. Through the medium of the Depository not only many copies of the Holy Bible, and the Book of Common Prayer have been distributed throughout the Diocese, but also many publications of a devotional and instructive nature, the use and study of which are calculated, under the divine blessing, to increase the knowledge of "the Faith once delivered to the Saints."

#### *Education.*

Whenever applications for aid towards promoting education have been received, your Board has deemed it a duty to answer them by grants, as liberal as the funds of the Society enabled it to make, and it has only to express its regret that the inadequacy of those means have prevented it from making grants as liberal as the urgent character of the objects, would appear to demand.

Owing to the illness of the Secretary of the Society, it has been found impossible to prepare in time for this meeting, a detailed statement of the amounts raised in the several Districts and Missions, but this will appear with the Report when published, so far as the necessary materials have been received.

It is matter of much thankfulness that the statements of the amounts contributed in the Diocese prove incontestibly the increasing confidence reposed in your Society by the members of the Church, and your Board indulge the hope that the great objects of the Church Society will commend themselves more and more to the



minds of Churchmen and incline them to take an active personal interest in the diffusion of "pure and undefiled religion" through every settlement and township in the Province.

Though much, very much remains to be done, yet something has been effected by your Society. The field is a wide one, the harvest is abundant, the laborers alone are wanting, and the surest, and indeed it would seem the only way in which the present Missionaries can be maintained or additional Clergymen supported is by the establishment of District and Parochial Associations, which, it must be confessed, have not increased in number or in activity in proportion to the expectations originally entertained. Fears, it is known have been raised that if such Associations were formed they might seriously interfere with local engagements, but such has not been found to be the case. On the contrary it has been generally ascertained that where associations have been formed, and exertions made for Diocesan purposes these so far from impeding the accomplishment of objects strictly local, have excited an increased readiness on the part of the people to assist in Parochial matters.

Let us then put our hands to the work in faith and in hope. The Canadian Branch of our Church must now look wholly to the free-will offerings of her children for support. Let us "Remember the words of the Lord Jesus, how He said, it is more blessed to give than to receive." Let there be fostered among us the quickening spirit of charity, and we shall be induced to labor year after year with increased earnestness for the dissemination of pure and undefiled religion, being well assured that by clinging to the faith of the Apostles, Martyrs and Confessors as declared in God's Holy Word, and witnessed to by His Holy Church, we shall preserve our souls in peace, and through the merits of our divine Saviour enter into our rest "and stand in our lot at the end of the days."

Besides a legacy of £10 to the Widows and Orphans' Fund from the late Miss Walker, of Lennoxville. Some changes having taken place within the year in the distribution of the labors of the Missionaries in this District, and

new appointments having been made, it has become obligatory upon the people in the several localities which benefit by these arrangements to contribute more largely than heretofore towards the support of their respective pastors. Some diminution may consequently be not unreasonably expected in the amount contributed directly to the Church Society, as these payments are not made through it; but the whole amount raised for Church purposes is found to be every year increasing, as will appear by the particulars given in the tabular statement. The aggregate sum thus reported for Sherbrooke, Waterville, Hatley, Compton and Coaticook, (the reports from the other Missionaries mentioning only what has been done for the Society,) is £454 5s. 6d.

The Missionary at Sherbrooke reports that "the cause of the Society seems to be prospering, which is evinced not only by the readiness of the people to respond to its calls, but also in the disposition manifested to do more for local Church purposes. In several instances the subscribers have intimated their intention of increasing their subscriptions to the Society."

Of the local contributions at *Hatley* that of £35 towards an endowment fund seems to deserve special notice, the object being identical with those which come more directly within the sphere of the Society's operations. No contribution, however, has been made within this mission to the funds of the Society.

The Missionary at Bury acknowledges with much thankfulness the amount of good which he has been enabled to effect by means of the small grant of £12 10s made by the Central Board for educational purposes. The Board, as has already been mentioned, have voted the sum of £75 towards the establishment of a new mission at Stanstead in this District, but the arrangement has not yet gone into effect, the necessary amount to make up a salary for the Missionary not having been yet raised by the people upon the spot. There are, how-

ever, reasonable grounds for the expectation that it will not be long delayed.

The Rector of Drummondville writes to the Secretary of the Society that beyond the amount of collections after Sermons his parish is unable at present to contribute anything to the Funds of the Society, "as every means of local assistance is pressed into use for carrying on the work of the new stone church which is now fairly started; and the short crops and scarcity of money have had the effect of throwing into arrear some even of the contributions for local objects." One annual subscription of twenty-five shillings has notwithstanding been received from this parish. The Nicolet Endowment Fund has received an increase this year of £40 6s 9d, of which £3 15s are annual subscriptions.

\* Since the Report was read and the accounts for 1854 closed, a Return has been received from Three Rivers, shewing a sum of £8 10s in annual contributions, and a donation of £3 to Widows and Orphans' Fund.

The Revd. E. G. W. Ross reports donations for local purposes at Rivière du Loup en bas, from friends in different quarters, to the amount of £10 16s. 10d., and gratefully acknowledges the kind assistance received in this way.

The Revd. H. Roe writes that at the vestry meetings held at the three Churches in his mission at Easter last, it was unanimously resolved, in every instance, to appropriate the offertory collections upon occasion of the administration of the Lord's Supper, "towards the fund for the support of Travelling Missionaries in the back and destitute parts of this country." The sum of £2. 17s. 5d. has been raised in this way, (which is not included in the amount given above.) The amount of annual subscriptions sent in by Mr. Roe is smaller than that of last year, which is accounted for by the recent division of his extensive mission, and the consequent increase in the amounts contributed upon the spot towards the support of the Missionaries. For this and other local objects £75 have been raised in Ireland, and that portion of Inverness, which remains within the mission of Mr. Roe, besides a "considerable sum," (of which the amount is not given) subscribed towards the purchase of a bell for the Church at the former place, independently of the amount raised in the new mission of Lower Inverness and Nelson. It is worthy of mention that the people of Ireland and upper Inverness have exceeded by more than £15, the stipulated sum of £25 which they are held bound to contribute towards the Clergyman's salary. The excess is to be applied towards a fund for building a new parsonage.

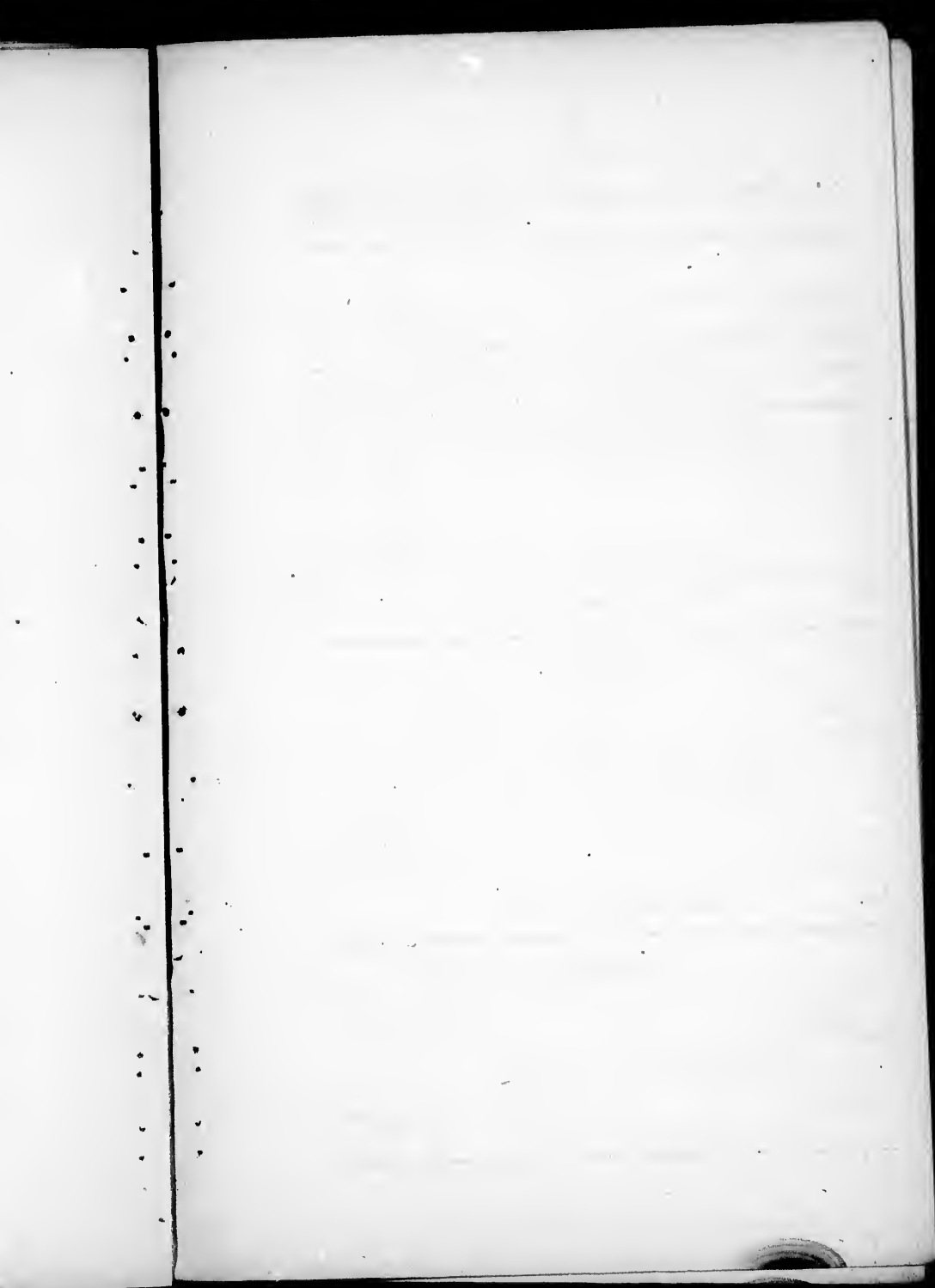

### *I. A Bequest of a sum of Money, or of Shares of Stock, or Public Debentures, for the general purposes of the Society.*

For and towards the encouragement of education, and the support of Day Schools and Sunday Schools in the said Diocese of Quebec, in conformity with the principles of the United Church of England and Ireland.

Or,

For and towards a Fund for assisting persons preparing for the Ministry of the Gospel in the United Church of England and Ireland within the said Diocese of Quebec.

Or,

For and towards a Fund for circulating, in the said Diocese of Quebec, the Holy Scriptures, the Book of Common Prayer of the United Church of England and Ireland, and the Books and Tracts approved by the said Church Society for circulation within the said Diocese of Quebec.

Or,

As an aid towards the erection, endowment and maintenance of Churches according to the Establishment of the United Church of England and Ireland within the Diocese of Quebec,—the erection and maintenance of Parsonage Houses,—the setting apart of Burial Grounds and Church-yards, and the endowment and support of Parsonages and Rectories, according to the said Establishment within the said Diocese.

### *III. A Devise of Real Estate for the general purposes of the Society.*

I give and devise unto the "Church Society of the Diocese of Quebec," incorporated by a Statute of the Province of Canada, passed in the seventh year of the Reign of Her Majesty QUEEN VICTORIA, all and singular, &c.
