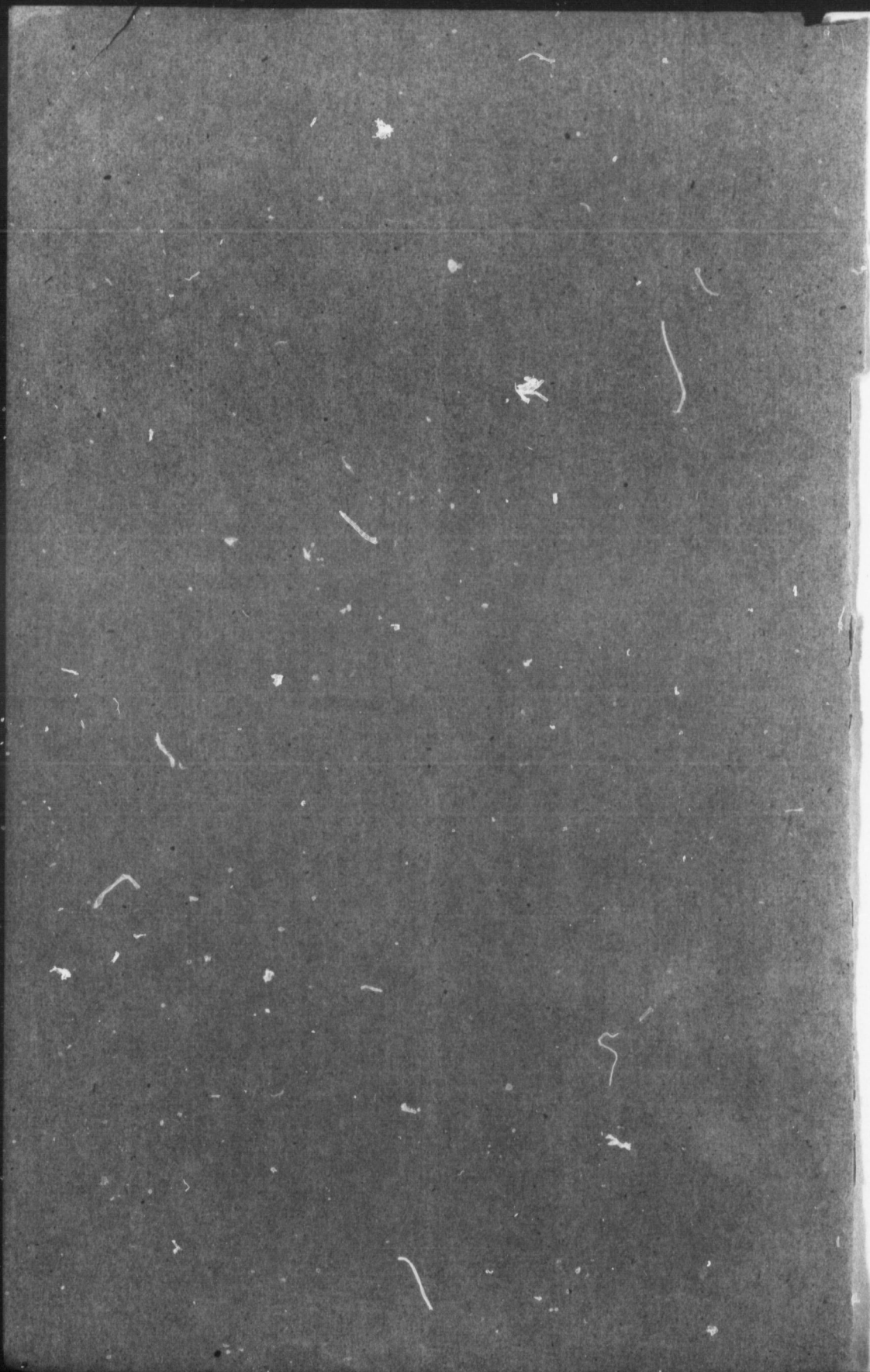

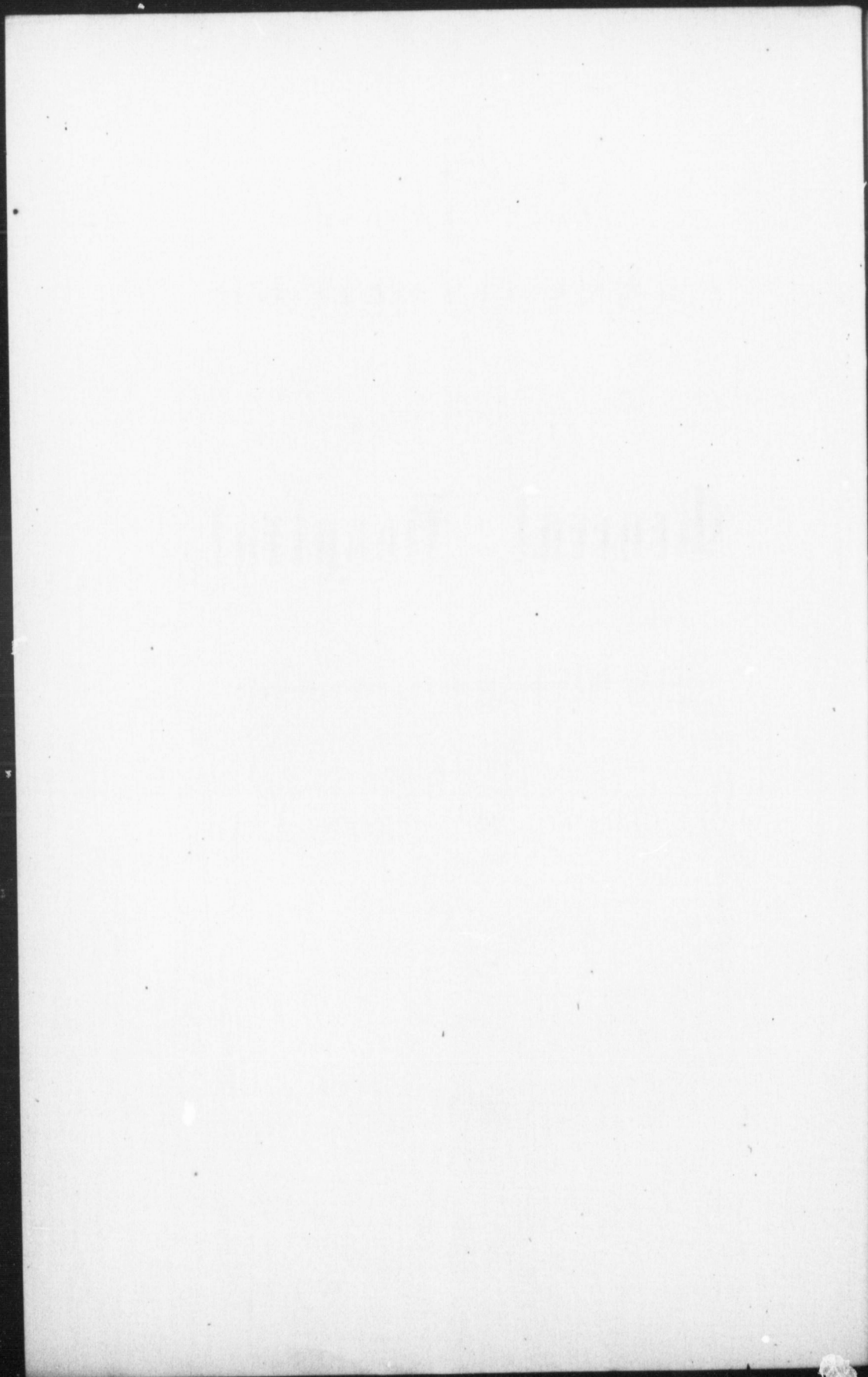

FORTY-FOURTH ANNUAL REPORT
OF THE
MONTREAL GENERAL HOSPITAL.

The Annual Meeting of the Corporation of the Society of the Montreal General Hospital, was held in the Governors' hall of the Institution, on Tuesday the 15th May, 1866, when the Board of Governors presented the following Report, which was read and adopted. The chair was occupied by John Redpath, Esq.

The Board of Governors of the Montreal General Hospital present their Annual Report to the Corporation of the Montreal General Hospital, with a concise statement of the receipts and expenditure of the Society for the year ending the 30th April, 1866.

The moneys received during the year have amounted to \$16,547.07, and may be thus enumerated :—

During the year just lapsed the institution lost one of its most munificent benefactors by the death of the late Mrs. Reid, widow of the late Honble. Chief Justice Reid. It will be in the recollection of some now present, that in the year 1848 the late lamented lady conveyed to the Governors of the hospital the munificent offer of building, at her own expense, another wing to the hospital, to correspond exactly with the wing previously erected by the beneficence of the late Mr. Richardson. In the letter to the governors, conveying the offer, we are informed that this generous proposal had been prompted by Mrs. Reid's own feelings, and was in perfect accordance with the often expressed sentiments of her late venerated and beloved husband; it certainly was a noble and becoming tribute to his memory, and a fitting way of transmitting his name to posterity as a benefactor of the poor.

The list of original contributors to the building fund of the Society has been reduced also during the year, by the decease of the late James Logan, Esq., for many years a "Life Governor" of the Institution. It is a matter for regret to the well wishers of the hospital, that no addition to the ranks of the Life Governors has been made during the year; and that not even the vacancies above alluded to have been filled up.
