## REPORT OF THE SESSION FOR 1886.

The Session have again the privilege of presenting a gratifying report to the Congregation. Our membership, at the close of 1885, numbered 451, and during the past year 120 new members have been added, 57 by certificate and 63 by confession of faith. There have been removed from the roll during the year, in all, 59 members, 3 by death, 25 certified to other churches, and 31 who have left us, but not yet applied for certificates. The net gain is therefore 61 members; so that the membership at the end of 1886 stands at 512. As in our last report, we have again to express our gratification at the large number added to the Church by confession of faith, a result mainly due to the earnest labours of the Bible class teachers and

Mr. Shearer, our missionary; 24 have united with the church from the Bible classes, and 16 from the mission. During the year the Session has been weakened by the resignation of two of the elders, Mr. W. C. Forman and Mr. Robert Fairbairn. Mr. Forman had endeared himself to us all by his earnestness and zeal in the spiritual work of the Church, and we are sure the congregation will unite with us in wishing for him a happy and prosperous career in his •new sphere of usefulness. Mr. Fairbairn felt constrained to tender his resignation on account of the exigencies of his business making it impossible for him to discharge his duties. The Sacrament of the Lord's Supper has been observed eight times during the year, and the attendance has been good on every occasion. The number present at the December communion was the largest since the organization of the congregation. The attendance at the church services on Sabbath has been on the whole satisfactory, although there are a large number of our people who never attend in the evening. A marked improvement has taken place lately in the attendance at the weekly prayer-meeting, and we trust that the whole of our members will avail themselves of this precious privilege in the future, so that we may have the church filled every Wednesday night.

The Session desire to thank the choir very heartily not only for their services on the Lord's Day, but also for taking charge of the service of praise at the prayer-meeting on Wednesday evenings.

As will be seen from the report to be submitted, the work in the Elizabeth Street mission has greatly prospered during the past year under the able leadership of Mr. Shearer; and the Session earnestly hope that his services may be secured for the coming year.

The Pastor began a visitation of the congregation in May last, accompanied by the elder of each district. So far, about half of the congregation have been reached in this way, and it is hoped that the work will be accomplished before May. These visits have all been paid in the evening, and therefore have occupied more time; but the Session is convinced that, except in cases of sickness, little is accomplished by visits through the day. In conclusion, the Session would unite with the congregation in giving thanks to God for all the blessings bestowed upon us, for the relief from the financial burden of the floating debt through the exertions of the ladies of the congregation, for the means so generously provided for the maintenance of the Elizabeth Street mission, for the means of grace enjoyed, and for the evident tokens of God's blessing accompanying the preaching of the Gospel.

That we may enter now on another year of blessing, may we agree together to be loyal to our Master and to the Church and to one another.

## SABBATH SCHOOL REPORT.

The Twelfth Annual Report of the Sabbath School Teachers' Association, presented herewith, witnesses the fact that the School has maintained, and in some respects increased, the degree of prosperity which has been a feature of its management for several years past.

The average attendance for 1886 has been 161, and the number of scholars on the roll, 216, as against 167 and 225, respectively, for the previous year. The total amount realized through collections in the School during the past year has been \$240, and this amount, the Teachers have decided, is to be devoted entirely to missionary purposes. This is an increase of \$12 over the total collections, and of \$49 over the missionary collections for 1885, and represents an average of \$4.61 per Sunday.

The Teachers are thankful for the proceeds of two special collections from the congregation, which realized \$53.80; and they are also under a deep debt of gratitude to Mr. A. R. Creelman for a handsome donation towards the library, voluntarily given by him. They trust his worthy example will be followed by other members of the congregation, as the library has had no additions to it for over a year, the above mentioned contribution having been used to pay for books purchased in December, 1885.

The work of assisting in the endowment of a cot in the Sick Children's Hospital claimed the attention of a number of the scholars during the spring months, and \$54 was collected by them towards this end, of which amount, \$29 stands accredited to the children of the Infant Class.

It was with much sorrow that the Association accepted the resignation, in March last, of Mr. George Anderson, who had acceptably fulfilled the duties of Superintendent for over a year, and who had intended leaving the city to take up his abode in Montreal. Some time afterwards, however, the Teachers were pleased to learn that he had altered his determination, and he still remains a frequent and welcome visitor at the School.

Miss Robertson and Mr. Forman, teachers who have been engaged in working in the School almost since it was established, have also, during the year, resigned their positions, much to the regret of their fellow-workers. They The Teachers also regret the loss of their able organist, Miss Annie McIntosh, but are reconciled by the fact that the new duties she has undertaken still permit of her invaluable assistance being secured on special occasions, when sought for.

Six scholars, having attained the requisite age, were promoted to the Bible Classes during the year.

All of which is respectfully submitted.

## ANNUAL REPORT OF YOUNG MEN'S BIBLE CLASSES, 1886.

In presenting the Annual Report of the Young Men's Bible Classes we are pleased to note the interest and attention which has characterized the members during the past year.

Our year was divided into two parts, the classes having adjourned during the month of August, owing to a large proportion of the members being absent from the city. During the first part the number of names on the roll of the Senior Bible Class, conducted by Mr. Macdonald, was 31, with an average attendance of 14, which, after the vacation, had increased to 37 names on the roll, with an average attendance of 19.

The Junior Bible Class, taught by Mr. Gzowski, has a roll of 21 members, with an average attendance of 14. Of those on the roll of the Senior Bible Class one was compelled, through sickness, to leave the city, while another is now teaching in the Sabbath School.

Recently, through the efforts chiefly of Mr. Macdonald, a Young Men's Association has been formed, which has as its objects the promotion of the social and spiritual life of the young men of our church, and the enlisting of their co-operation in general church work. By this means we hope to see the membership of our classes largely increased, as we are well aware of the number of young men attending our church who do not come to our classes, and whose duty we consider it, as well as their privilege, to be with us on Sabbath afternoons.

In conclusion, we would express to Mr. Macdonald and Mr. Gzowski our deep appreciation of their earnest and zealous services, always so cheerfully given, and pray that, during this year, God may bless their words and works even more than He has done in the past.

## ANNUAL REPORT OF YOUNG LADIES' BIBLE CLASSES, 1886.

It is with feelings of intense thankfulness that we cast our thoughts back over the year which has just closed, and behold how wonderfully God's hand has been with us in all that time. The class has grown steadily, and it is gratifying to find that, although several have discontinued for various reasons, two of the members having, during the year, gone to teach in the mission school, and some, who were wont to attend most regularly, being only able, through failing health, to be with us occasionally, yet the number of names on the roll exceeds that of any previous year, new members joining from week to week.

At present there are 180 names on the book, the average attendance for the year being 92. The average for the first quarter was 89; for the second, 100; the third, 77; and for the fourth, 111. The largest number on any one Sunday was 134; the smallest, 24, the latter being on an occasion of special attraction elsewhere, as well as being a very wet day. For several Sabbaths we have been occupying the church, the lecture-room proving incapable of comfortably seating the large number that came week after week to hear the precious words that fell from our dear teacher's lips. The present quarters are much more suitable, being less trying to the speaker, and affording a better opportunity for the members to become acquainted with each other.

The ladies have in the last year, as heretofore, shown themselves always ready to help in any good work, both by the giving of money and time. There were \$45 collected by them for the endowment of a Canadian children's cot in the Hospital for Sick Children. Besides this, \$6 were collected by the Misses Ada, Maggie, and Lily Jackes, of Eglington, and contributed through a member of the class for the same worthy object. The amount contributed through the mite boxes, issued by the Mission Band, was \$31.88. The sum of \$2.50, which was given by some of the members, was applied to the Girls' Industrial Institute, in connection with which one of our number conducts a week-night Bible Class. Another sum, amount-

A good number of Christmas cards have also been handed in, to be sent to the North-West and Trinidad, besides a great many articles of cast-off clothing. Under the head of clothing may be mentioned a large parcel left at Mrs. Harvie's house, containing many useful articles, all new, and accompanied by a note, asking her to send them somewhere where they would be of use, and signed "Some of the Girls." They were sent to the File Hill Reserve. A special collection was taken up for missions, which amounted to \$3.67 over and above the ordinary contri-There are about 30 tract distributors in the class, bution. the response to an appeal for more during the past month being very encouraging. Another appeal, made for a music teacher for a child who was very anxious to learn but unable to pay, met with an immediate response.

During the year a Saturday evening prayer-meeting has been instituted, which, we feel sure, has been productive of good. We know that God has answered the prayers of those few devoted members who have met week after week to plead His promises, for, since its inauguration, our teacher has gained in strength, and the blessing of God has been upon her work. We would urge the class, then, all who find it possible, to continue in this good work. The moment of silent prayer, a brief uplifting of the heart to God, without which we have not commenced the class for months, has also brought great blessing, in the increasing evidences of the presence of the Holy Spirit among us, touching the hearts and consciences of many. Several have been brought to Christ, and united, some with our own church, some with others. Three of the members have publicly professed their faith by baptism. Special petitions, which have been offered from time to time during these intervals of communion have been signally answered.

We would ask the older members not to forget their duty in looking up the strangers, of whom there are many, and, by a pleasant word and a hearty shake of the hand, making them feel at home among us, and giving them cause to love the class as we love it, for, were it not for our Bible Class and the kind and loving work of our dear teacher, Mrs. Harvie, many who are now rejoicing in the light would still be groping in the darkness of doubt and unbelief. We would again ascribe all our success and happiness to God our Father, and go forward, feeling sure that He who has led us in the past will not forsake us as we launch forth on the untried sea of another year.

# ANNUAL REPORT OF THE LADIES' AID SOCIETY.

With pleasure and gratitude the Ladies' Aid Society begs to present to the congregation its Sixth Annual Report—for the year 1886.

During the year twenty sewing meetings have been held, thirteen quilts made and disposed of, and eightyseven garments cut out and completed for the women and children of our Elizabeth Street Mission. The attendance of ladies at our meetings has been very encouraging; but, as our work and requirements in our new mission district are steadily increasing, we earnestly invite new friends to assist in our labour of love. On January 1st, 1886, a representation was made by members, that money was required for our winter's work in aiding the poor, and as we have no fees connected with our Society, and depend entirely on voluntary contributions, a motion was carried to the effect, that the Pastor be asked to make a statement on our behalf, from the pulpit. Accordingly the appeal was made, and was kindly and liberally responded to by individual members; the ladies, however, feel that the congregation as a whole would be willing to assist in the work, and would respectfully request that a portion of each collection for the poor be given to them. In February last it was agreed that each member of our Society should be asked to provide once in the year for the weekly tea given at the Mothers' Meetings; this proposal has been heartily entered into by twenty-seven kind friends, bread and butter, and cake being supplied, or, when preferred, fifty cents is paid in money. Tea and sugar have so far been donated by others. As the weekly attendance is now much larger at the Mothers' Meetings, our ladies will gladly add the names of any who may be disposed to aid in this means of cheering the many weary mothers who attend.

In the fall, Mr. Shearer invited a special meeting of lady workers to organize Cottage Meetings, to enable those who were sick, infirm, or not able to attend the Mothers' Meetings, to have Bible readings, prayer, and praise conducted at their own homes each week. Seven districts were arranged, and the work undertaken, and very favourable reports have so far been given in.

Towards the close of the year one of our members submitted to our Society the advisability of having a course of lectures for the benefit of the Elizabeth Street Mission, and at the same time to increase medical knowledge amongst the ladies. After consideration and discussion with Dr. Wishart and other medical gentlemen, arrangements were made for the delivery of a course of eight lectures on "Emergencies." The first lecture to be given in the Ladies' Parlour on December 11, 1886. Tickets for the course, \$2.00.

Most heartily we congratulate the committee on their success, as over fifty ladies have attended and appreciated two lectures already given; also, we beg to express our sense of obligation to those medical gentlemen who have so readily and ably given their valuable time and talent for the good of our Society.

As in former years, we again heartily offer our most sincere thanks to our benevolent friend, Mr. Spence, for his many acceptable favours, also to all in the congregation who have kindly assisted us with donations of money, materials, groceries, cast-off clothing, stovepipes, carpets, etc., and also to our Managers for their kind letters of ek. In presenting this, the Fifth Annual Report of our Woman's Foreign Missionary Society, we would do so with hearts full of humbleness and gratitude to God for all the care He has bestowed on us as a people, and for the part He has permitted us to take in His vineyard in assisting in the winning of souls to Christ in the dark and unenlightened countries, by the giving of our prayers, means, talents and interest. The share we take, however, seems meagre when we think of that noble band of men and women who have given up those things which are dear to most of us, home and friends, to go into far distant countries, making new ties, and facing many unseen dangers, to fulfil the injunction of their Master, to "Go and preach the Gospel to all nations, baptizing in the name of the Father, and of the Son, and of the Holy Ghost." Surely, when we think of them, our prayers will rise more earnestly that they may be upheld through many discouragements in their labours.

Every month we are cheered with letters from the different fields, each one telling its story of progress. And especially are we interested in the work being accomplished amongst the Indians of our own North-West; and we realize more and more, when reading accounts which tell of their own anxiety to train for native ministers and teachers, the power and benefits of Christian influence.

In our Society we have the advantage of having as members ladies who take a most active part in the organizing of the different societies through our own towns and villages, and from them we learn a great deal about the formation of societies, and of the work being done in this section of Ontario.

The Auxiliary has held twelve meetings during the year; and to our worthy President we owe a word of thanks for making the meetings interesting and instructive. The average attendance has been 19. The Auxiliary numbers 76 members. Of these, 6 are life-members, 2 having recently been added to the list; 51 have paid the \$1 fee, and constituted themselves members of the general Society. This is an increase of 8 over the previous year.

Friends will please bear in mind this has been entirely a voluntary offering, as no special effort has been made by concerts or lectures. In October, we held a thanksgiving service for the year, which proved very interesting; each gift was accompanied by a well-chosen text. The sums ranged from five cents to \$2.00.

The expenditure of the whole Society last year was \$13,822.45. This year the Board has called on the Auxiliaries to raise the sum to \$15,000, to enable the Society to go on with its work without any financial difficulty arising in its path. Shall we not, then, strive to give more of our means towards the furthering of the great object in view? —that of "Winning the world to Christ."

## REPORT OF THE FLOATING DEBT COMMIT-TEE OF THE C. P. C. BIBLE CLASSES.

In submitting the report of the Floating Debt Committee of the Bible Classes your Committee are sorry to say that they cannot present a very satisfactory report. In 1885, when this Committee was formed, it showed a splendid record for the year, having raised, through their efforts, the sum of \$500. This year, however, it was found very difficult to get the same amount of enthusiasm among either the members of the classes or the people of the church, and the general opinion seems to be that there had been so many entertainments during the previous year that they were, to a certain extent, tired of them. We had, during the year, through the kindness of Messrs. Wilson and Muldrew, two parlour concerts, which, although not realizing quite as much as was expected, were very successful entertainments. A lecture was also delivered in the church by the Rev. Dr. MacVicar, of Montreal, on "What Great Men Know but dare not Speak of." The lecture, which was a very fine one, was delivered to a very small audience, and was a financial failure. Our Bible Class and Sunday School Picnic to Lorne Park brought our entertainments to a close. The amount realized during the season, as will be seen by the Treasurer's report, was \$43.17.

## ANNUAL REPORT OF THE MISSION BAND FOR 1886.

The Mission Band, in reviewing the work of the year just closed, have great reason for thankfulness to our Heavenly Father in blessing us so abundantly in our work for Him.

During the year we have held 11 meetings, one in union with the "Mutual Help" and "Tract Distributors," which was greatly enjoyed by all. We have 36 members on the roll, the average attendance at the meetings being 20; our President having set us a good example in being present at all the meetings, and with her hearty co-operation and zeal in Foreign Missions making them particularly interesting and attractive. Last May our Band, together with the other city Mission Bands, held a book reception in St. Andrew's Church, and in this way gathered a large number of books and papers to send to the North-West Indian reserves.

Several able papers have been prepared and read by the members, India being the subject one month, its history and geography, the inhabitants and their customs, were freely discussed, showing that the interest had increased, and giving us a greater insight into the missionary world.

The funds have been raised by mite boxes, one containing \$6 from a class conducted in the Girls' Industrial School by one of the members of our Bible Class, a special collection from Young Ladies' Bible Class, members' fees, and a strawberry festival held in June. Mr. Howie kindly

consented to aid our Band in giving a lecture on "His Schooldays in Lebanon," for which he receives our hearty thanks. In September Miss Lawrence gave us a most thrilling address on her work in the North-West, at the close of which a collection was, taken up. We find the monthly leaflet increasing our interest, the letters coming, as they do, direct from the field of labour. The amount we paid to the general Society was \$136. With \$25 the Society made their President, Mrs. Harvie, a life member of the Woman's Foreign Missionary Society.

On the whole, our work has been encouraging. Let us work on hopefully and prayerfully, looking for the Psalmist's prophetic vision, "The Lord gave the Word; the women that publish the tidings are a great host."

We have missed from our number, during the past year, Mrs. Jaffray, our Vice-President, also Miss McKay, our former Secretary, whose presence and help we have so greatly valued in past years. We return our best thanks to Rev. W. Burns and the Misses Paton for their kindness in being present with and adding to the pleasure and profit of our meetings.

We would be pleased to see an increased attendance at our meetings; we would also gladly welcome many more of the ladies of the congregation. But we trust that, during the coming year, they will not only count it their duty, but a pleasure and privilege, to be present with us.

We purpose paying the sum of fifty cents per month for piano hired by Young Men's Association for the winter months.

Help to the amount of one dollar was given to a girl out of a situation, and the same amount to a poor sister with a family in distress.

We know that our meeting together has not been in vain. Prayer has been asked, and prayer has been answered; and, on one occasion, nearly all present led in prayer.

For the past we thank God, and for the future we take courage.

## REPORT OF THE ELIZABETH ST. MISSION.

In presenting the Sixth Annual Report of the Mission Work, we desire to give expression to our devout thankfulness to God for His rich blessing on every part of the work during the year. Since the beginning of the year several new departments have been added to the work, and most of the old ones have been extended, and we have good reason to believe that our efforts have been more than ever blessed to the salvation of precious souls.

The Sabbath School opened in the new Mission Hall with an attendance of 44 scholars. There are now about 110 scholars on the roll, with an average attendance of 66 for the year, and 14 teachers and officers. The teachers have laboured diligently to instruct the young in the Word of Life, and encouraging progress has been made. Several from the Bible Class, as well as some from two other classes, have joined the membership of the Church. We regret deeply our inability to retain our hold on many of the larger scholars, and feel that something should be done to attract the larger boys and girls. In February we spent about \$40 in purchasing books, the old ones having been well read, and we felt the need of keeping good reading in the hands of the children.

The Sabbath evening services have been very encouraging, especially during the last three months. The attendance has increased from about 40 to about 90.

The prayer-meeting has held its own, the average attendance being about 18.

The work of the Tract Distributors has grown very much during the year. An account of their work, as well as that of the Mothers' Meeting and the Girls' Sewing Class, lately organized, will be found in separate reports. The Band of Hope has been carried on with encouraging success.

A Penny Savings Bank was organized in February for the purpose of promoting saving habits among the people of the district. The report will show with what success the object has been carried out.

A monthly meeting of workers was begun during the summer months, which has proved a great blessing and a fruitful source of increasing the interest of all in the work. th w ar

the d a ork. From 9 to 9.30, Saturday evening, is observed by all the workers as a season of private prayer, especially for the work of the following day. God has heard our prayers and blessed us.

A system of cottage meetings among women has been carried on since October. Each of five bands of ladies holds a prayer-meeting once a week in its respective district. Much good has resulted from these meetings, both to the workers themselves and to the women of the district.

More than 30 in all have professed conversion in connection with the whole work, and about 20 have united with our Church from the Mission.

Our missionary, Mr. Shearer, has made about 400 visits during the last nine months. We can here merely express our appreciation of his zeal and devotedness in his Master's work while with us. We only hope that nothing may stand in the way of his continuing his connection with us.

The Mission has lost a faithful friend in Mrs. Tyson, who during the year has been obliged to give up her class owing to ill health. The work of the district set apart for our church by the the Presbytery was all overtaken two months ago; accordingly, the Society thought best to go across Elizabeth Street, into the territory of St. James Square Church, the latter having previously removed their work to another part of the city.

The Society takes this opportunity to thank the Ladies' Aid Society for their timely and valuable assistance, both in visiting the sick and helping the poor, in any cases reported to them by the distributors. They also take great pleasure in thanking Mr. Kilgour for his generosity in supplying them with covers for the tracts.

The members of the Society this year number 37, as against 17 last year. Nine meetings were held, with an average attendance of 14. They could wish for some improvement in this matter.

They regret that they feel their hands bound by the scarcity of funds wherewith to provide tracts. They trust that God will put into the hearts of His people to come to their aid in this matter. It is with the greatest thankfulness that they see many coming out to the Sabbath services and the weekly meetings' held in the Hall, and not a few publicly testifying for Christ—won for the Master through the faithful work of the distributors. They feel much encouraged by such visible signs to go forward with more earnestness to their work.

We cannot close without thanking those members of the Ladies' Aid who have so kindly furnished refreshments for the meetings, and also the friends in the congregation who sent us parcels of tea and sugar which have been distributed to those found needy.

## TO THE SUPERINTENDENT AND COMMITTEE OF MANAGEMENT OF THE ELIZABETH STREET MISSION.

The Staff of the Dispensary for Women, in connection with the Elizabeth Street Mission, beg leave to present the following report :—

A dispensary for the treatment of diseases of women was opened on the 8th of February, 1886, with the following Staff:—Drs. Cameron, J. F. W. Ross, McPhedran, and Nevitt, and Messrs. Acheson, McKenzie, Scadding and Thorburn. Dr. Scadding was appointed shortly afterwards on the General Hospital staff, and his place was taken by Dr. Wishart.

The Dispensary was open on Monday, Wednesday, Thursday and Saturday of each week, from 2.30 to 3.30 p.m., two of the staff being in attendance each day. Arrangements were made with Mr. Meldrum, 520 Yonge Street, to supply medicines to the patients, other than those used at the Dispensary, at a reduced rate; and these arrangements, we are fully assured, have been faithfully carried out.

No attempt was made to advertise the movement beyond asking the members of the Tract Society to mention it when making their visits in the districts allotted to them.

The number of patients treated during the past year was 69, many of these coming for treatment on several occasions, so that the number of entries on the day-book for the past year has been 270. In addition to this a number were visited at their own homes. Of these patients two were operated on successfully at the Toronto General Hospital by a member of the Dispensary Staff by abdominal section; and three were operated on at their own homes. A large percentage have been completely cured of their ailments, and all have been more or less benefited. It is hardly possible to estimate the amount of good that has been done in thus mitigating the sufferings of even this small portion of the sick and destitute poor of the city.

The members of the staff have to thank the many kind friends who came to their assistance with donations of various articles necessary for the equipment of the Dispensary; and without making invidious distinctions, they would especially acknowledge the receipt of \$25 from the Committee of Management of the "Emergency Lectures." This money has been applied to the purchase of necessary instruments and medicines, while the ordinary running expenses have been a charge on the general fund of the Mission.

The staff are unanimously of the opinion that while perhaps the Dispensary has not been of marked benefit to the Mission, yet that it supplies a serious want among the charitable schemes of the city, and that with more publicity given to it, by means of an advertisement in one or more of the newspapers, its sphere of usefulness would be largely increased.

They recommend, therefore, that the Dispensary for Women be made a separate scheme distinct from the Mission med cont and feel tutio

## PENNY BANK .- FIRST ANNUAL REPORT.

The Bank has been blessed with a large measure of success in its work; for this we thank God, and hope that He will continue so to bless us, that this department of the work may become a permanency, and so a source of strength to the mission.

At the inauguration of the Bank last February the hope was freely expressed that we should have at least 100 depositors on our books at the close of the year; we have great pleasure in informing you that this calculation was very much astray. During the year 346 accounts have been opened, of these 31 have been closed, leaving a net number of 315 open accounts. That such a large number of people should trust us, at the beginning of our career, with their savings, speaks well for the future of the institution.

We have, as you will notice per Treasurer's report, handled a very large amount of money, viz.: \$912.38; of this amount we have on hand \$374.95, the balance having been withdrawn, a large portion of it prior to the Christmas holidays. In reference to our interest allowances, we regret that a large number of depositors have kept their accounts hovering in the neighbourhood of the interest limit, viz.: \$3, but never quite reaching it, thereby forfeiting a right to interest. We trust that these depositors will govern their accounts accordingly in the future.

The Bank commenced operations on Saturday evening, January 30, being open, therefore, forty-eight nights to the close of the year. The following totals will be interesting, not only as giving some idea of the work involved, but in comparison with next year's report :---

There are numbers of depositors who, but for the Bank, would have been without actual necessaries this winter, and also a great many young people who are learning now to save instead of waste their small money.

In closing this report your Secretary has to record the great interest manifested in the Bank by the President, the Treasurer and the managers. Every one appears to have made it his duty to be on hand when wanted, thereby considerably lessening the labours attached to any position by a proper distribution of them.

The Managers beg to submit to the congregation their Report for the year ending December 31, 1886.

Statements showing the receipts and expenditures during that period are appended.

The average weekly collections by envelope and loose contributions for the years 1885 and 1886 were as follows:

It will be observed that the year closed with a balance in the Treasurer's hands of \$18.08. In order to obtain this result, however, it was necessary towards the close of the year to call upon the congregation for a special contribution, and to apply towards the ordinary expenditure the proceeds of the social, held in the month of March last.

The Managers desire to express the hope that, in view of the large additions made to the membership of the congregation, the ordinary envelope and loose collections will soon be found sufficient to meet the current expenditure.

A very slight increase on the part of each of the present envelope contributors would produce this desired result.

It is to be regretted that the revenue for congregational purposes has not increased in proportion to the increase of membership. In 1883, when the membership was 391, the weekly contributions were \$110.78, or \$4.70 per week more than during the past year, when the membership was increased to 512, and, although the increase during the past year over 1885 was 61 members, yet the revenue during these years was about equal. At the close of 1885 there were 171, and there are now 184 regular contributors by envelope, who are giving weekly the following sums:

The Managers are very much gratified to be able to report that the floating debt has been extinguished during the year. This work was entrusted to the ladies of the Ladies' Aid Society, who have rendered a most valuable service to the congregation in bringing about this important result. Besides removing what was felt to be a heavy burden upon the congregation, there will be a diminished annual outlay for interest, which will contribute very materially towards equalizing the current receipts and expenditure.

An effort is being made by the Managers with a view to re-arranging the mortgage debt and procuring a reduction of interest payable thereon. Strong hopes are entertained that this effort will be successful, and a saving thereby effected sufficient to permit of much-needed repairs and renewals being made to the church property.

It has been deemed advisable at the present time, in view of the re-arrangement of the mortgage debt, to appoint new trustees of the church property from amongst those who are still members of the congregation; the formal notices, which are requisite under the provisions of the deeds of the property, having been published from the pulpit, a resolution will be submitted to the congregation at the Annual Meeting for the purpose indicated.

It is estimated that the ordinary expenditure of the church for the present year, exclusive of repairs, will be about \$5,720, which will require the collection of the sum of \$110 weekly; this is a slight increase over the expenditure of last year, owing chiefly to the larger amount of insurance payable this year.

The Managers are of the opinion that the time has now arrived for the congregation to take into consideration the ques men deal
