## An Act to amend the Charter of the Ontario, Simcoe and Huron Railroad Union Company,

WHEREAS it is expedient and necessary to alter and amend the Act Preamble. passed in the twelfth year of Her Majesty's Reign, intituled, "An Act to incorporate the Toronto, Simcoe and Lake Huron Union Railroad Company," in order to afford a just and proper protection not only to the 5 owners of lands adjoining the line of the Ontario, Simcoe and Huron Railroad Union Company's railway and works connected therewith, but to all persons whatever from damage to their horses, cattle or other animals by the trains or engines on the said railway: And whereas the eighteenth section of said Act does not sufficiently provide therefor, it is 10 desirable and necessary to provide for the fencing and separation of the whole line of such railway from the neighboring lands; Therefore Her Majesty, &c., enacts as follows:

1. From and after the time when this Act shall come into force, the Sec. 18 of 12 said eighteenth section of the said Act shall be repealed.
