The Bait Act.

JUDGE PROWSE ANSWERED.

Editor Evening Telegram.

Dear Sir,-I notice by your issue of the 20th instant that D. W. Prowse is again under the impression that he was the one and only saviour of the fishermen of this country by his enforcement of the Bait Act.

From the article in question any one, not intimately acquainted with the facts, would believe that Mr. Prowse had been for years engaged in enforcing the Bait Act, and that it was due solely to his efforts that the French were deprived of bait.

The report of Judge Bennett on the 'Carrying out of the Bait Act" says that on the 6th March, 1888, an expe-dition was fitted out under the charge of Judge Prowse, assisted by Sub-fa-spector Sullivan, The steamers "Glo-ver," "Hercules" and "Favourite" were employed from here and the former carried the Judge, whilst the latter was under the orders of Sub-Inspector Sullivan.

No violation of the law was tempted before the 23rd April, when the steamer "Greyhound" was added to the protection fleet, and no material violation of the Act occurred an til the 10th May, Judge Prowse, ac. cording to the evidence produced, ap pears to have very little to do from the 6th March until the 23rd April owing to the great scarcity of herring. and rumour said that the Judge enjoy ed the time immensely at Mr. Holman's, the Newman's agent in Harbo Breton.

On the 10th May Judge Prowse lef for St. John's in the "Lady Glover and never more returned, leaving Sub-Inspector Sullivan in charge. Weakened by the absence of the "Lady Glover," and the difficulty of preventluties of protection, the carrying out of the Bait Act in May was a failure

"During the month of April larg-quantities of bait were carried to St Pierre from Fortune Bay," is the de-position of one of the persons who gave evidence before the Commission, so that Judge Prowse's efforts at enorcing the Bait Act proved a complete failure.

On the 26th May Commander Rob nson was appointed to take charge of the Bait Protection Service with the s.s. "Ingraham" as flagship. Why did Judge Prowse resign? Why was he superseded by Commander Robinson? Oh! thereby hangs a tale which the correspondence in the archives of the Colonial Secretary's Office could reveal and which Judge Prowse would not like to have publish ed. Did Judge Prowse get tired of ma! le-mer, or did he fear that he would be annihilated by the bait catchers. or was he removed because of his at tempt to make arrangemens with the French authorities without consulting his Government? 1 do not care o give the real reason; perhaps the Judge may do so. 

An Untoward Incident.

The heavy sentence imposed by a German Military Court on two British Officers convicted of espionage, can-not fail to intensify that bitter ten-sion which has unfortunately prevailed for a long time between two na tions, related by blood, and largely de pendent on each other's trade. Mili-tary spice take their liberty in their own hands, and can only grin and bear the punishment meted out to them, when caught. In the meantime the fire had got under way and volumes of smoke and flam were coming from the building when men of the Western and Cen tral Stations arrived on the scene Two streams of water besides the chemical were turned on the fire as put in through the bacl r, which was burst open to get at the fire, and the other was put in through the front door. There is another theory that a barren containing paper and rubbish stood near the door and that a spark of fire may have got into it. The policemen noticed some hoops on the spot this morning after the fire was over. All the groceries on the west side of the shop and the dry goods on the east side of that department are all ruin-ed by fire and water. The damage is estimated at about \$10,000. It is

said that the total insurance on the whole building and contents is \$40,-000, most of this being held by the Beloise, Mr. Knowling's own company. Having the grocery and dry goods stores closed down at this particular season means a great loss to Mr. Knowling.


BOLTON, Dec. 22. The disaster at the Little Houlton Colliery, which was wrecked by explosion following a fire yesterday in even greater than was first thought It is probable that 360 lives have been

lost. It now appears that the men who were supposed to have been res cued from this mine, came from an adjoining pit, that was also seriously damaged. 
