JOLIETTE, Que., Nov. 2.—The preliminary investigation in the case of John Hooper, charged with the willful murder of his wife by poisoning with prussic acid on a C.P.R. train on Sept. 18, was resumed before Magistrate Leprohon this morning. The Ontario witnesses were examined by the Crown, and the Hooper side of the records of the inquiry by the jury.

Dr. Clark, superintendent of the Rockwood Asylum, testified that Mrs. Hooper had been taken away by her husband, and that he was going to George and was going to leave her with her own people. Her mental trouble took the form of delusional insanity and she never attempted to take her life. Her health was good during the whole time of her confinement in the asylum.

THE TROTTERS' EASY VICTORY.

Directum Defeat in Three Straight Heat-Pascal Makes a New 10-Mile Record.

FLYWOOD PARK, Nov. 2.—The match race between the two crack champions, Directum and Pascal, for a purse of \$500, was trotted to-day and resulted in an easy victory for the black whirlwind, and in a change of hands in the hands of the two horses.

The track was in excellent condition and before the race there was some talk that Directum would be the horse to make a record.

Around the lower end of the track the cheering and excitement rose still higher, and the supporters of the black stallion were still in doubt, but as they rounded the hill the crisis came, as Pascal led away and seemed not to be able to hold the strain, Directum had a lead of half a length.
