(A) INTERNATIONAL NEGOTIATIONS AND AGREEMENTS

Agreements concluded:

- Multilateral: Convention (No.32) concerning the protection against accidents of workers employed in loading or unloading ships (Revised 1932), adopted by the International Labour Conference at its 16th Session, Geneva, April 27, 1932: the instrument of ratification by Canada of this Convention was deposited with the Acting Secretary-General of the League of Nations on April 6, 1946.
- Multilateral: Convention (No.63) concerning statistics of wages and hours of work in the principal mining and manufacturing industries, including building and construction, and in agriculture, adopted by the International Labour Conference at its 24th Session, Geneva, June 20, 1938: the instrument of ratification by Canada of this Convention was deposited with the Acting Secretary-General of the League of Nations on April 6, 1946.
- Canada-United States: Great Lakes Fisheries Convention, signed at Washington, April 2, 1946, subject to ratification.
- Canada-United Kingdom: Agreement supplemental to Agreement dated May 27, 1943, with respect to the acquisition by Canada of the United Kingdom's interest in Canadian munitions plants, signed at Ottawa, April 2, 1946.
- Canada-France: Exchange of Notes concerning the release of private property from government control, dated at Ottawa, February 12, March 22, 23 and 27, and April 3, 1946.

- 4. Mr. Sevki Alhan, Turkish Minister to Canada, has left Ottawa for two months. In his absence, Mr. Rifki Zorlu, First Secretary, will be Charge d'Affaires a. i. of the Turkish Legation.
- 5. Dr. A. Fiderkiewicz, Minister-designate of Poland, is expected to arrive in Canada shortly. The following members of his staff are already in Ottawa; Mr. Z. R. Bielski, First Secretary, Mr. T. Wiewiorowski, Commercial Attache, and Mr. Edmund Semil, Cultural Relations Attache.
- 6. Colonel August Schomberg has been appointed Assistant Military Attache at the United States Embassy and Mr. Meade Foster has arrived to take up his duties as Agricultural Attache at the United States Embassy.

- 7. The following changes occurred at the French Embassy during April: With the closing of the French Naval Mission in Ottawa, Lt. Commander Pierre de Bellaigue, Naval Attache, has been transferred to Montreal where he will be in charge of the French Merchant Marine Mission; the Military and Air Attache, Lt. Col. Henri Mesnet, has recently been promoted to the rank of Colonel and will assume the duties of Naval Attache.

On April 3 a ceremony took place at Whitehorse, Y.T., to mark the taking over by Canada from the United States of the Alaska Highway, the airfields on the Northwest Staging Route, the landline communication system and other defence projects. The ceremony was arranged under the auspices of the Permanent Joint Board on Defence and General McNaughton, Chairman of the Canadian Section, represented the Government.

The United States Government was represented by the United States Ambassador in the absence of Mr. F.H. LaGuardia, Chairman of the United States Section of the Board. Mr. R. M. Macdonnell was present as Secretary of the Canadian Section.
