Etobicoke Township Re-Elects Old Council, All of Whom Opposed Reference.

NIAGARA TOWNSHIP VOTES "DRY"
BY SMALL MAJORITY OF SIXTEEN.

Local option carried yesterday in the town of Toronto Junction (population over 7500). The vote defeated in York Township (population about 11,000). It was carried in the Township of Niagara, Lincoln County. The majority was 16 to 1.

North Toronto town a petition was presented to the Council asking for a vote on local option. The Council refused the petition on a unanimous vote. A temperance ticket was brought out for the Council, three of whom were elected and four rejected.

The election of Reeve Bryan and the three councillors of Etobicoke Township who opposed the reference of the local option by-law to the people, is an indication of the feeling in that township where the reform was made the chief issue.

The members of the Council of the Township of York divided on the question of local option as follows:

To refer the question to the electors, Councillors Henry, Maclean, Wanless. Against the reference, Reeve Sylvester and Councillor Syme.

The whole Council sought re-election yesterday and all were successful except Mr. Maclean, who supported the local option by-law.

Territory Affected by Local Option.
The entire population of York Township, the new federal riding of South Toronto, is affected by the local option.

The local option by-law was carried in the township of York, but was defeated in the township of Niagara, Lincoln County.

Non-Resident Vote.
The non-resident vote in the township of York was 16 to 1 in favor of the local option.

How Junction Will Get Supplies.
Dry Junctionites will have to cross the line into the township of York to get their supplies.

The Political Color of It.
Toronto Junction is a strong Conservative town. It has no vote for the Grigs who owned all the licenses, and most of whom had been active workers for the Ross government in the Queen's Park.

Junction Anti-Optionists Lament Poor Organization

Temperance sentiment made a difference in voting all thru the town.

Toronto Junction, Jan. 4.—Local option carried the day at Toronto Junction by a majority of 190. It was a clean fight on both sides. The electors went about it quietly and there was no bitter discussions outside of any of the polling booths. Both sides were well organized and each had a good supply of rigs, so that there was no difficulty in getting out the vote. It was the largest vote ever polled in Toronto Junction. There was no uncertainty about the result. Not a candidate who were in any way opposed to the measure received smaller votes than last year. Councillor Hain in Ward 2, who voted against the by-law, was successful by a majority of three against an opponent who did not live in the ward, and his victory is more to be attributed to his personal standing in the ward than to the anti-local option sentiment of the district.

The anti-local optionists blame to a very large extent their organization, and the taking for granted reports brought to their committee-room as their favor, which were not correct. They also think a larger vote from the city might have been polled had the weather not been so cold, but it is almost safe to say that more enthusiastic anti-local optionists came from the city than those in favor of the measure, and a bigger vote might have been in their favor.

Fought Out on Principle.
The local option question appears to have been fought out very largely on principle, and with temperance or prohibition. Indeed the vote polled does not adequately express the full temperance sentiment of the town, as many temperance men voted against the by-law, believing it would be ineffective in its operation and were afraid to place the town under it for three years, which is the longest term for which it is in force. Now that the by-law is carried this influence will support the measure, and the authorities in enforcing it. One hundred and ninety is not a very large majority for local option, compared with the vote cast, or compared with the majority of 248, which Mayor Chisholm received. Nevertheless, the non-resident vote was largely against local option, and that these votes were large property owners, having all the character of the vote which leaves the local vote much in sympathy with the by-law.

The working of the by-law did not enter much into the fight. It was purely a matter of principle. The by-law was caught at the tide and rolled forward to its goal by the church pulpit. Never have all the church pulpit in Toronto Junction taken up an issue as they did this one. From the pulpit it extended to the membership of the churches, and society became practically a committee for local option. The anti-local optionists, trusted together to organize and personal canvass. Both were bad, and the influences behind them were such that public sentiment did not favor them. What arguments they had were not properly placed before the electors. A campaign sheet was issued, but it had no weight with those in favor of the measure. Indeed, both campaign sheets had little to do with the result. It was a fight between the churches and the bars, and the churches won. The by-law will be given its third reading by a unanimous Council, and will go into operation on May 1.

OTTAWA POSTOFFICE GONE
\$40,000 LOSS BY FIRE

Roof and Second Flat of Building Burned Away Early Last Night.

Ottawa, Jan. 4.—The city postoffice, one of the most important buildings in Canada, was practically destroyed by fire tonight. Smoke was seen about 9 o'clock issuing from windows in the third or roof story, in which are located the offices of the Railway Mail Service and the Grand River Works. The framework of the roof, as well as the floors, partitions and massive tower structures were all of wood, and in half an hour the entire flat was aflame.

The night was bitterly cold and the fire brigade was handicapped by the outset by difficulty in locating the seat of the conflagration, so that it was not until the flames burst thru the roof that the dozen hoses from the fire engine and hydrant direct could be brought to bear upon the burning woodwork.

In an hour the roof was burned away and the second flat occupied by the Inland Revenue and Customs, was soon after a prey to the flames. Their further progress was also checked, however, and the ground floor, in which was the postoffice proper, was damaged solely by water, as well as the adjoining warehouse and other customs offices in the basement.

The postal staff, as well as the fire broke out, all went to work to save the mails. These and the other movable equipment of the postoffice, however, taken to the House of Commons, and from there the mail will be despatched, pending the completion of other arrangements of temporary quarters.

The building was of the finest architecture in the Romanesque style, and cost when erected thirty years ago \$100,000. Its roof was entirely of woodwork, and the great mass of woodwork which it was composed was a veritable fire-trap, and, like the building, was the flames gained a footing, no water supply could stay the fire. The damage is about \$40,000. The government carries no insurance on its public buildings.

Men Who Met Defeat Express Regret and Receive Praise of Winners.

The final meeting of the Council of 1903 was held yesterday afternoon, all of the members being present excepting ex-Ald. William Burns and S. G. Curry. Ald. Sheppard moved a resolution expressing the regret of the Council at the retirement of the members who failed of re-election, and acknowledging their faithful services. The mover spoke in very kindly terms of the outgoing councillors, and Ald. Woods seconded the resolution in a few sympathetic words. Mayor Uihart spoke consolingly to the defeated candidates, regretting that in a political contest, some must fall by the wayside.

Dr. Lynd's Remarks
He called first upon ex-Ald. Lynd as the senior member, to respond for the defeated candidates. The doctor said that it was a consolation to him to hear the words of the mover and the seconder of the resolution. He was leaving the Council with regret, but was glad that the civic affairs would be in good hands. Controller Oliver said there were no regrets in his case, as he had been defeated squarely and honestly and had no complaint to make. He had endeavored to do his duty, and it was a matter of little import who ruled the city if his interests were preserved by the incoming Council, which he could be trusted to look after its affairs.

J. R. L. Sturt was very grateful to the citizens who had voted and worked for him. His private and business life was so full of promise that he did not regret his retirement.

Stephen Not Dismayed
S. W. Burns said that, although defeated, he was not dismayed, and would be in the contest again. He had learned that a personal canvass should not be neglected when one's opponents were making it.

A letter was read from William Burns, who wished his regrets conveyed to the members, as he had been compelled to leave town on business. Controller Hubbard spoke in a very generous and complimentary way for 10 years from Ward 4, whom he considered as the most honorable, courteous and able man with whom he had sat in Council. He regretted Mr. Burns' defeat very much, and said it could only be ascribed to overconfidence. Mr. Hubbard also referred to Ald. Curry as a member who had been of great service, especially in connection with the work on the island.

Sang G-d Save the King
The Mayor advised the Council that all the reports for the year had been filed and declared the meeting adjourned. The adjournment was in singing the national anthem, and were led by a leading theatrical man in a beautiful rendition of one stanza of "Auld Lang Syne."

Struggle for Committee Honors.

Immediately after the close of the session, little groups were formed lobbying for the membership prizes. The selection of controllers by popular vote was regarded as one of the most important features of the year, and there will be some warm contests for the chairmanship. In the Works Committee there will probably be no opposition to the re-election of Ald. Sheppard, as he is so closely identified with the work of the department that the interests of the city would suffer by his displacement. Dr. Harrison is probably the best candidate for the chairmanship of the Board of Health, although Dr. Noble may seek the honor.

There will be hot fight for the honor of presiding over the Property Committee, which is second in importance only to the Board of Works. Ald. John Dunn will again seek the office, but Ald. Chisholm of Ward One paid much attention to the committee during the past year, and was chairman of several sub-committees. It is particularly well informed on the St. Lawrence Market, and, having headed the poll in his ward, is entitled to some consideration.

What Would Suit Ward?

Ald. Ward is seeking preference and thinks the Parks and Amusement Board would suit him, while Ald. Ramden is willing to take charge of the city's visitors, as the head of the Recreation Committee. W. T. Stewart, however, will not give up the charge of the parks easily. Ald. Eell will probably be re-elected to preside over the Fire and Light Committee, and Controller Hubbard's successor in looking after the island will be Ald. Woods or Ald. Foster.

The committee to strike the Standard Committee for the year is made up of the senior members from each ward and will be composed of Ald. Stewart, W. T. Stewart, Ald. Wood, W. A. Sheppard, Ward 3; Ald. Harrison, Ward 4; Ald. Woods, Ward 5; and Ald. Wood, Ward 6. The meeting of the Council will be held on Monday next.

ABEEL EXTRADITION CASE MAY PROVE SENSATIONAL

Imputation of Deceit Against Millionaire Goeliet Will Cause Vigorous Prosecution for Forgery.

Because he masqueraded as a millionaire and under the affection of a New York girl under the name of Robert Goeliet, young James Abeel is now under detention at Welland and an effort will be made to-day to extradite him. W. R. Riddell, K.C., of Toronto, has been retained by the State of New York to procure Abeel's return. He goes to Welland on an early train this morning. To a witness who suggested that Abeel might be a forger, Riddell said that he would not be surprised if a very sensational situation should develop before the case is concluded.

The technical charge upon which extradition is asked is forgery. Abeel signed a letter of introduction in the name of John B. VanEvery, a high official connected with the Western Union Telegraph Co. Moreover, the girl to whom he made love under the name of Goeliet, the wealthy Toronto man, was an operator in the employ of the company.

Mr. Riddell said he had little information further than that contained in the newspapers, but that a special officer from New York would be permitted to view the evidence. He understood an element of mystery surrounded the case in so much as it was charged vaguely that Abeel was acting as representative of Goeliet. This was the imputation of deceit against Goeliet, that caused the prosecution against the prisoner.

The signing of a false name to a document for the purpose of deceiving or imposing upon anyone, whether a fraud be perpetrated or not, constitutes forgery. Mr. Riddell said he could not understand this young fellow has lately come into a sum of money, and has been spending his money in a very reckless way. Still, I believe he insists that he is not the man wanted, that I am told the girl identified him. In any event he has money and has employed counsel to defend him. Altogether the case presents many curious features.

BIBLE LAW VS. CRIMINAL CODE.

Eastern Couple Observed Former and Are Now in Court.

NEWS OF THE RAILWAYS.

There was a local illustration yesterday morning of the excesses that have been operating the past few weeks on the work of the railway. 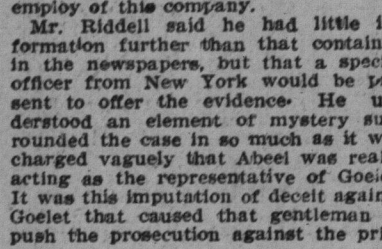

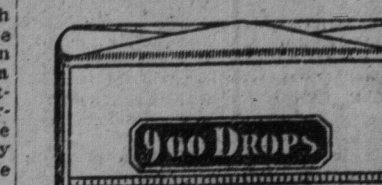
