# GRAND DIVISION, S. OF T.

## SEMI-ANNUAL SESSION.

CARLETON, May 8th, 1888

The Semi-Annual Session of the Grand Division was opened in Granite Rock Division Hall, on Tuesday evening, at 8 o'clock, Grand Worthy Patriarch Campbell in the Chair.

Officers absent—Grand Conductor and Grand Sentinel.

Appointed *pro tem.*—Reps. J. A. S. Mott, Grand Conductor; John Rankin, Grand Sentinel.

After services by the Grand Chaplain, the Grand Conductor declared the Grand Division opened in due form.

The Grand Worthy Patriarch appointed the following Committees:—

Credential Committee—Reps. A. Y. Paterson, S. B. Paterson, E. L. Strange.

Enrollment Committee—Reps. F. B. Ellis, J. C. Thomas, John Kinney.

The Credential Committee reported the credentials correct for the following representatives in waiting for initiation: Miss Laura M. Wales, Miss Lizzie J. Flemming, Geo. S. White-nect, W. H. Bennett—Gurney, No. 5; A. C. A. Salter, H. J. Thorne—Albion, No. 14; John McCabe, J. F. Woodhead, Jas. Stratton, J. W. Fisher—Masons & Mechanics, No. 38; Mrs. J. Larkin, Thos. Larkin, Joseph Rowley, W. W. Clark, Alex. McClelland, Henry Rowley, William McConnell—Granite Rock,

No. 77; Neil Hoyt, E. S. Henniger—Excelsior, No. 347; Wm. Lindsay—Campbell, No. 299; Thos. Millar—Valley, No. 250; G. D. Martin—Gordon, No. 275.

The representatives were introduced and initiated members of the Grand Division.

On motion, Rep. C. A. Everitt was appointed to obligate all representatives presenting themselves for initiation during the session,

On motion—

*Resolved*, That all members of Subordinate Divisions in possession of the quarterly password be admitted as visitors during the session

Reps. J. J. Gillis, No. 14 J. A. Russell, No 5, M. G. B. Henderson, C. H. Ferguson, Jas. N. Wetmore, No 275, were obligated and took their seats in this Grand Division.

The Grand Worthy Patriarch read his Report :

*Dear Fellow-workers :*

I submit my first Official Report with feelings of devout gratitude to the Great Patriarch above, who has crowned our efforts with a measure of success, and with cordial acknowledgment of your sympathy and active co-operation.

The report of our active and painstaking Grand Scribe will show the Order in this jurisdiction in an encouraging condition; substantial growth in the departments, and a spirit of hopefulness and activity among our members, which gives promise of better and more vigorous work in the near future.

Our beloved Order, believing that the liquor traffic is a moral and political evil—requiring moral and political action to subdue it—undertakes not only to rescue the fallen, prevent others from falling, but to instruct and persuade the Canadian elector, to demand, by voice and ballot, the total suppression of the traffic in strong drink. I trust, therefore, that this Semi-Annual Session shall so imbue us with love for the Order, burning zeal in our own holy cause, the great demand for prompt action, that we shall return to our homes so impressed with the responsibilities and important issues of the reform as to cry from our hearts for ever and ever “ everlasting war against rum, eternal death to alcohol.”

#### OFFICIAL VISITS.

I have not been able to do as much for the spread of our principles and order as I would have liked, nevertheless I have made 21 official visits, delivered 25 public addresses and preached two anni-



versary sermons. My plan of visitation has been among Divisions in the Counties of Carleton, Charlotte, Kings, St. John and York; and I hope to look in upon nearly all of our Divisions before my term of office expires.

#### DISPENSATIONS AND DECISIONS.

I have granted dispensations to Intercolonial Division, No. 243, and Gibson Division, No. 306, to instal minors into office; and to Rising Star Division, No. 303, to "allow members 14 years of age and upwards to vote"

Deputies residing in the City of St. John have asked if it would be a violation of the pledge for members of our Order to sign an application for license to sell intoxicating liquors. In reply I stated that according to my reading of the Constitution and Code of Laws, and of decision 224 in the Digest, which says: "Voting directly or indirectly for the sale of any of the beverages named in the Pledge, is a Violation of the Pledge; that members signing applications for license were guilty of 'conduct unbecoming a Son of Temperance.'" Regarding the matter as one of much importance to us, and to prevent as far as possible controversy and trouble in our Division-rooms because of it, I submitted the question and my answer to the Most Worthy Patriarch, E. H. Clapp, Esq., asking for his opinion. He replied as follows: "You ask whether it would be a violation of the pledge for a member of our Order to sign an application for the granting of a license to sell intoxicating liquors under your new law." "My decision would be *yes*. I am entirely in accord with you in this matter, and think you do not need any aid from me except the formal decision which I have given you." This I trust, will be the final settlement of the question, so far as we, at least, are concerned.

#### STATE OF THE ORDER.

The condition of our work in New Brunswick may be set forth by the word *prospering*. While we have not made as much progress as we deserved, nevertheless the record is full of interest and encouragement. Five new Divisions have been organized, two resuscitated, and the older ones have held their own in numbers and influence. I take this occasion to thank and congratulate all who have in any way helped plant the principles of our Order in the hearts and lives of the people.

In looking over the map of our Province we discover plenty of room for new Divisions in most of the Counties—and we should go in and possess the land. Using existing Divisions as rallying places for our forces for work in other directions, making each point gained a radiating center, from which the reform shall be advanced until the Province is belted with the working-bands of the Order.—But we shall make a disastrous mistake if all our energies are expended in purely aggressive lines. It is equally our duty to revive

and nurture weak and declining Divisions, and if possible get those, which are either sleeping or dead, at work again. We have reached a position in our work which devolves a double responsibility on the Propagation Committee—first, to organize in all desirable localities, and also devote attention and care to the delicate members of the family, that they may be nurtured into vigorous life. With this end in view the Committee engaged the services of our Grand Scribe as an Organizing Agent, giving him special instructions to visit the weak and declining Divisions, that in their regular meetings they might have the help of his presence and matured experience in our routine work. He has faithfully followed out his instructions, and reports from the localities visited show that his visits have been most helpful and quickening to our work. This, to my mind, is a step in the right direction, and it is for us to continue the use of means that will bring the twofold benefit of *numbers* and *stability*; but if we cannot have *both*, by all means let us have *stability*.

#### DISTRICT DIVISIONS.

I believe great benefit would be obtained from District Organizations in overlooking this work of reviving and building up declining Divisions. From the thought given the question, I believe that District Divisions, properly conducted, would promote the spirit of fraternity between the Subordinate Divisions, furnish a way of strengthening the weak, increase the zeal and activity of our members, and thus greatly aid us in the advancement of our work. Let us give the matter careful consideration; and at this juncture I am prepared only to recommend that a competent committee be appointed to obtain the results of District Organization in other jurisdictions, and to make such recommendations to the Annual Session as they in their wisdom may think for the best interests of our Order.

#### CADETS OF TEMPERANCE.

As allied with this, I wish to ask your attention to an important field of labor, which has been long overlooked, and does not yet receive the attention it deserves. I refer to the formation of Sections of Cadets of Temperance. The value and importance of training a nation's childhood in the principles of total abstinence is conceded, and I know of no better way of meeting our obligations in this respect than by organizing Sections of Cadets. Three have been instituted, and a number of Divisions have the matter under consideration. This field demands our best thought and attention.

#### MOST WORTHY PATRIARCH'S VISIT.

Since our Annual Session this jurisdiction was favored with a visit from that representative and devoted worker E. H. Clapp, Esq., Most Worthy Patriarch of the National Division, whose words of counsel and encouragement to the Representatives who were present

at the Special Session convened at St. John to receive him, and public address in the Institute, advocating with weighty words of wisdom and tender words of love, the great principles of our Order, will not soon be forgotten by those who were privileged to hear him.

#### JUBILEE ADDRESS.

At the Annual Session you were pleased to appoint the Grand Scribe and myself a Committee to prepare and forward an humble address to Her Most Gracious Majesty, conveying the congratulations of this Grand Division on the completion of the Jubilee year of Her Majesty's most auspicious reign, and an expression of your strong and loyal attachment to person and throne. Your Committee discharged this duty to the best of their ability, and have the honor to report that your address was presented, and that Her Majesty was pleased to express her pleasure in receiving it, and her approval of all efforts looking toward the social and moral welfare of her subjects.

#### PROHIBITION.

The legal aspects of the Temperance movement are well known to you. The success, the unrest, the agitation, the apparent failure and defeat which mark our history, teach us that the only effectual remedy is Constitutional Prohibition. The apparent change in opinion, which the action of certain States in the American Republic, and Counties in the Dominion, would seem to indicate, does not, I take it, show that we are losing ground in the fight. Into a discussion of the causes leading to these results we do not propose now to enter, neither is this the place. Statistics furnished the department at Washington show at least that the objection so often urged that prohibitory laws cannot be enforced, has lost much of its force; and the defeats recently experienced, brought about partly by local and partly by political influences, I take as an emphatic expression of the dissatisfaction of the people with partial measures, and the strengthening of the sentiment that will ultimate in absolute Prohibition. For this we shall continue to pray, and wait. Toward this we shall move as the "Sabbath and port of our labors," and until this be accomplished we are determined not to slacken our efforts, nor "to bate a jot of heart and hope, but still bear up and steer right onward."

" 'Tis weary watching wave on wave,  
And yet the tide heaves onward;  
We build like corals, grave on grave,  
To forge a pathway sunward.

We are beaten back in many a fray,  
Yet ever strength to borrow,  
And where our vanguard rests to-day,  
Our rear shall camp to-morrow."

#### THANKS.

In conclusion, I desire to express my grateful appreciation of the unvarying kindness which has been accorded to me individually and

officially. The most pleasant, harmonious and fraternal relations have existed between me and the members of the Order; and I take this opportunity of thanking especially the Grand Scribe, the other Grand Officers, the members of the Propagation Committee, the Deputies who have reported, and the old and honored members who have so kindly and efficiently rendered assistance to me in the discharge of the responsible duties pertaining to my office. And now hoping that the session will be a most interesting and profitable one, and that great zeal and loyalty shall be its fruits,

### GRAND SCRIBE'S REPORT.

GRAND DIVISION, S. OF T.,  
Carleton, May 8th, 1888. }

*Grand Worthy Patriarch, Officers and Members:*

In pursuance of the duty devolving upon your Grand Scribe, I herewith submit a report of the operations of our Order in this jurisdiction, so far as I am enabled from the Returns received at this office for the term ending March 31st. It is not as complete as I should wish, owing to a large number of Returns not having been received.

Since the Annual Session there have been two Divisions organized, viz. :—

Princess Louise, No. 342, Little River, Albert County;  
Bulmer, No. 343, Moncton, Westmorland County.

The following Divisions failed to forward Returns for the quarter ending December 31st:

And for the quarter ending March 31st:—Portland, No. 7; Johnson, 62; Dover, 70; Oxford, 134; St. Martins 164; Lime Rock, 207; Everitt, 238; Home Circle, 244; Victoria, 245; Beillie, 248; Petiscodiac, 252; Moss Rose, 254; Britannia, 255; Spreading Oak, 256; Laurenceville, 261; Rockland, 267; Red Granite, 270; Hampton, 272; Leading Star, 274; Twilight, 276; Rising Sun, 278; Springfield, 282; Fort Moncton, 286; Essex, 288; Lincluden, 301; Caledonia, 310; Gladstone, 311; Pokiok, 312; Star, 313; Janeville, 314; Kingsclear, 315; Rolling Dam, 316; McKenzie Corner,

With few exceptions all these Divisions are in good working order, advancing the cause in their different localities, and I presume the reason of so many not reporting is the members are absent from their homes during the winter months, and the meetings are not held and attended as punctually as they otherwise would be. Some of the Divisions have not reported for several quarters, and are therefore placed on the suspended list, but I have strong hopes that in the near future they will arise in their might, put on their armor and go forth to battle with the enemy of all mankind, as in the times which have passed.

The Returns so far received indicate the following result:

Initiated, 1237; Joined by Card, 36; Reinstated, 84; Withdrawn, 305; Suspended Divisions, 654; Suspended, 564; Expelled for Violation of Pledge, 81; Expelled for other causes, 41; Deaths, 22; Violations of Pledge, 124

I am pleased to report that the number of suspensions for the last quarter has been smaller than at former periods, and trust that it may so continue.

In accordance with a Resolution at the Annual Session 1,000 copies containing the proceedings of the Semi-Annual and Annual Sessions were published and distributed among the different Divisions. A copy of Resolutions referring to the death of Hon. John B. Finch was forwarded to Mrs. Finch, as requested. A copy of Resolutions in reference to the Board of Education providing the best text books on the subject of Alcoholic Spirits, and making it imperative upon the teachers to include as a specialty the education of their pupils in this branch of physiological study was forwarded to the proper quarter.

At the request of the Propagation Committee I spent a month (part of the months of March and April) visiting Divisions in the Counties of Kings, Northumberland, Gloucester and Restigouche; during that time I visited sixteen Divisions, all of which were found in good working order; the attendance was good and great interest manifested in the cause in the different localities; the work of the Divisions is being felt in a great degree, many persons who for a long time stood aloof are now connecting themselves with them, as they find the time has now arrived when they must take part in driving the tempter from their midst, that they and theirs may be safe from the all-pervading destroyer. I intended visiting other Divisions, but travelling on the ice becoming unsafe, and the roads being almost impassable, prevented me doing so. I organized Caraquet Division, No. 344, at Upper Caraquet; this is the first branch of our Order planted in that locality, and I am in hopes it will yield abundant fruit. I found that visits of this kind were required and appreciated; the opinion everywhere expressed was, that they would be of greater benefit than those of a stated lecturer, and the wish that they would be continued. The majority of the Divisions have very fine halls of their own, and those not having them intend building this year. I am strongly of the opinion that if we wish to

keep the Divisions up to the standard of their work, visits must be paid more frequently than they have been in the past, as I find instruction is at all times in season. When visiting the Divisions I brought the subject of the Cadets of Temperance before them, which was favorably received, and the result so far is that three sections have been organized, and I expect more to follow. The only objection was that in some of the places there were Bands of Hope, and it was thought not prudent to interfere with them at present, as they were doing good work in their own way. When we look back in the history of our noble Order and consider the work that has been accomplished since its organization, who can calculate the good which has been done during these years—how many have been saved from filling drunkards graves, how many desolate homes made happy, how many freed from the snares and temptations of the tempter through its influence? Let us then take courage from the past and push on with renewed vigor in the future! feeling that we are battling in a righteous cause, and that as we sow so shall we reap.

The Most Worthy Patriarch and Most Worthy Conductor being announced in waiting in the ante-room, Past Most Worthy Associate Everett retired and entered with the distinguished visitors. The Most Worthy Patriarch and Most Worthy Conductor were escorted to the position of honor and introduced to the Grand Division. The Grand Worthy Patriarch invited the Most Worthy Patriarch and Most Worthy Conductor to seats at the session and introduced them to the members in a brief address. They were received with the Grand Honors. The Most Worthy Patriarch then responded in a most eloquent address. He referred to the cordial manner in which he had been received in the Province, and his feelings in returning to scenes which were so familiar. In New Brunswick he had first joined the Order of the Sons of Temperance, in its schools he first learned the principles of the Order, and he had graduated in this Grand Division, and the credit for all that he had been able to accomplish, all the honors he had received he now placed at the feet of his *Alma Mater*. He referred to the work the Order had done in the past and the prospects for the future. He briefly outlined some of the difficulties that were to be met with in the work and some of the causes that impeded the rapid growth of the Order in the United States. Prohibition was a subject for discussion in the Division room, but in these discussions it should be remembered that no member had the right to impeach the motives or discuss the party politics of another member. In the Division room, both party politicians could meet and the feelings and sentiments of neither should be attacked. He closed with an eloquent peroration calling on the members for more united efforts in electing Temperance men as representatives, and that more individual effort be put forth for the carrying on of the work along the old lines of moral suasion, for the rum-drinker, and legal suasion for the rum-seller.

*Whereas*, This Grand Division has listened with much pleasure to the earnest, energetic, and thoroughly sound views of the Most Worthy Patriarch on the various questions vital to the interests of the Order, we take this early opportunity of expressing our heart felt thanks to that Officer for his presence at this Annual Session of the Grand Division of New Brunswick, and for the excellent remarks just presented.

The motion was adopted by a standing vote.

The Most Worthy Patriarch replied in a few remarks, asking that a copy of the resolution of thanks be given him that he might refer to it in future and be reminded of his happy association with the Grand Division of New Brunswick, at their annual session.

The Grand Division then returned to the order of business.

The Grand Worthy Patriarch read his Report as follows :

WOODSTOCK, October 17th, 1888.

*Dear Fellow-Workers :*

I bid you a hearty welcome to this the Forty-first Annual Session of the Grand Division of New Brunswick. We have assembled to review the events and proceedings of the year just closed ; to advise with each other ; and to legislate for the continued prosperity of our beloved Order. Enthusiastic in your devotion to our *cause*, you will not be unmindful of the lessons of the past, nor slow to utilize the advantages of the present, and I know, that as heretofore, harmony will pervade and wisdom direct your deliberations.

Most devoutly would we express our gratitude to the Great Patriarch above for the measure of success we have secured, and invoke His blessing upon our deliberations that such plans may be devised as will increase our usefulness and render us more efficient in extending our "circle of sobriety," until it shall embrace the entire race of man.

#### OFFICIAL VISITS AND DECISIONS.

Since the Semi-Annual Session I have visited Divisions in Carleton, Charlotte, King's, St. John and Westmorland Counties ; and on several public occasions—as well as from the pulpit—advocated the principles for which we are associated. The duties and cares, however, of an important vocation prevent me giving that attention to the affairs of our Order their importance demand, and especially this summer, owing to an attack of fever, my plan of work and visitation has been sadly disarranged—consequently I have not done all I had in my heart to do while at the head of the Order.



Dispensations have been granted to two Divisions to instal into the office of Worthy Patriarch persons not twenty-one years of age; and to one Division my authority—satisfactory reasons being given—to enact a By-Law permitting members under eighteen to vote in said Division. I also acceded to the request of the Grand Worthy Associate, and granted a dispensation—having effect until this Annual Session—to organize “York District Division, No. 1.” Reports show the wisdom of the departure, as quite an impetus has been given to our cause in that locality. Several questions have been submitted to me by my Deputies, for decision, and in almost every case I have been able to answer by referring to the Constitution and Rules of the Order.

#### THE WORK.

Since my last report four new Divisions and four Sections of Cadets of Temperance have been instituted. These new organizations are planted in important centers, bringing to us influence as well as numbers, and giving promise not only of power in their respected localities, but of honor to the jurisdiction. From the reports to hand we learn that 1 920 have been initiated during the year; but we regret to state that the combined loss to our membership from death, withdrawal, expulsion and suspension have not been offset by the valuable acquisitions by initiation, and the new Divisions organized—and we are compelled to report a decrease for the year of 576. The reports from the Deputies, however, are most hopeful, and the inference is that the Divisions suffering losses (in the ways just indicated) are taking a new lease of life, and through the coming winter their motto will be—“Excelsior.”

The Grand Scribe, in his report, will give you an exhaustive statement of the condition of the Order, and you will be impressed with the necessity of renewed diligence in the prosecution of our work. Something must be done at this Session to stimulate our work and enthuse the Subordinate Divisions with a sense of their privileges and responsibility.

Let us then take counsel together and go home to work as we have never worked before. Resolve to make the extermination of the traffic the “Sabbath and Port” of our labors. Using every effort to arouse the people, and pressing in and in, with even narrowing parallels, until we breach the citadel of “drinkdom,” spike their every gun, and upon their dismantled breastworks plant the standard of our victory. Here, I would remind you, that this great work cannot be done by the Grand Officers or representatives alone. Its accomplishment each member must help to the full extent of ability. The young must be enlisted, the diffident encouraged, the indifferent aroused, the inebriates reclaimed, and to do this there must be united and continued effort. No Subordinate Division can continue in existence very long after it ceases to initiate new members.—New members are to our Order like new blood to the body—meaning

new life and vigor. As an Order we cannot, in the very nature of things, stand still. We must increase or decrease, and if we would do the work at our hands to do, and make a record worthy of ourselves, we must individually and collectively labor for the spread of our principles—gratefully accepting the opportunities, and measuring up to the obligations of the hour.

#### DISTRICT DIVISIONS.

The question of *District Organization* will come before you through the report of the committee appointed at our last session. Let the report receive your most patient and deliberate consideration. Personally I regard it as a most important feature of our work. Bringing together, as the organization will do, the *workers* of the local Divisions, this new cord of fraternal feeling and sympathy will strengthen the Order in its hold upon the general membership. The interchange of views upon the different phases of our work, will give clearer insight into our needs and duties and strengthen us for their performance. If by the sense of this Grand Body we are committed to District organizations, I have no recommendation other than to request the Representatives and members to assist in making them successful, not only as regards attendance, but in the dissemination of the principles of abstinence and prohibition.

#### CADETS OF TEMPERANCE.

It affords me great pleasure to refer to the gratifying increase—both in membership and Sections instituted—of the Cadets of Temperance, and this may compensate in a measure for any disappointment we may feel at not being as strong in numbers as we expected. One of the many duties of a Son of Temperance is to foster this important auxiliary of our Order. The importance of training, in temperance and virtue, a nation's children cannot be over estimated. Our Order has always had a warm side for the young; and it is our duty to "gather the children," teaching them that which we have learned ourselves, that they trained and benefitted by our work may, with more wisdom and grace than their fathers, stand in their place in the gates of the future and claim empire for our cause.

#### PROHIBITION.

What we need to-day is not so much enlightenment as *action*—and that in the direction of the utter disannulment and extermination of the drink-evil. The making illegal of a traffic that entails upon us every year enormous expense; injures the public health; hinders the moral and intellectual development of the people; retards the progress of education, and causes so much pauperism and crime, is in an eminent degree a moral and religious duty. Christian fervor, conviction, force and self-sacrifice are necessary to its accomplishment. The people of Canada have the right to be delivered from this awful and desolating scourge. Let us *agitate* therefore, and continue the *agitation*,

until the people of this country in the majesty of their might shall arise and demand, in tones that cannot be misunderstood by those who make the laws, the repeal of those statutes which grant for gold the privilege of ruining man in his body, soul, and estate, under the authority of an Act in Parliament. Such a *vox-populi* will be the *vox-dei*, and put an end to the Temperance conflict. The attempt to restrain the liquor traffic in the past by license laws, has been inadequate and unsatisfactory. And public sentiment to-day is rapidly crystallizing in favor of its total suppression. The near future will, I believe, witness its utter annihilation. Let us fling in the face of our foe our defiance of immediate and absolute Prohibition. Upon this truth we set up our banner, which, leading on with varying fortune, will in time lead on to conquering.

" Swing inward, O! gates of the future,  
 Swing outward ye doors of the past,  
 For the soul of the people is moving,  
 And rising from slumber at last ;  
 The black forms of night are retreating,  
 The white peaks have signaled the day,  
 And freedom her long roll is beating,  
 And calling her sons to the fray."

THANKS.

In conclusion, I desire to express my high appreciation of the spirit of confidence and kindness shown toward me by the Officers and Representatives of this Grand Division, and take this opportunity of expressing my sense of obligation to all who have so kindly and efficiently rendered me assistance in the responsible duties pertaining to my office. To-night I return you the emblem of authority with which you invested me one year ago, and retire from the office of Grand Worthy Patriarch. The numerous and important duties of my vocation make this step necessary ; but in the future, as in the past, I shall co-operate with you in " advancing the interests of our Order," fighting for " God and Home and Native-land," until in the Providence of God this hidra-headed beast Intemperance is banished from the face of the earth forever.

REPORT OF GRAND SCRIBE.

The Grand Scribe read his Report as follows :

WOODSTOCK, October 17th, 1888.

*Grand Worthy Patriarch, Officers and Members :*

We are here to-day in the Forty-first Session of this Grand Division to interchange the greetings of an exalted friendship, to take counsel with each other and devise the best means to promote the interest of

this time-honored institution. Through the year just closed, our Order has not advanced with that rapidity which we all should wish, but we should feel grateful for the work which has been accomplished when all things connected therewith are taken into consideration. It is to be regretted that so many Divisions have failed to forward Returns for the last two quarters, which prevents me giving the correct standing of the Order. The condition of most of the Divisions is good: there are some that are particularly weak and need immediate attention, if what little life now remaining is not to be permitted to die out. With proper attention these and many Divisions which have ceased working might be built up, renew their former vigor, and resume the place they once occupied among the noble band of workers to promote the cause for which we are associated. Since the Semi-Annual Session there have been four Divisions organized, namely, Blissfield, No. 347, Bamford Settlement, Northumberland County; Tilley, No. 348, Carleton, St. John; Marysville, No. 349, Marysville, York County; Fair View, No. 350, Sunny Brae, Westmorland County. These Divisions have started with a large membership, and will be a great acquisition to our Order, besides being a great benefit to the localities in which they are situated. These make the number of Divisions organized during the year ten.

I have also to report the instituting of the following Sections of Cadets during the year:

Campbell, No. 5, Richibucto; North Star, No. 6, Bathurst; Buc-touche, No. 7, Buctouche; Tilley, No. 8, Carleton.

I was in hopes of being able to report the instituting of other Sections, having been in communication with Deputies of Divisions in different parts of this jurisdiction on the subject, and have no doubt that in the near future others will be instituted. Those that have been instituted are working well, and have quite a large membership.

I am pleased to report that the following Divisions forwarded Returns for the quarter ending June 30th:

## DISTRICT DIVISION'S REPORT.

*Grand Worthy Patriarch, Officers and Members :*

Committee on the State of the Order submitted their Report :

#### REPORT OF COMMITTEE ON STATE OF THE ORDER.

*To the Officers and Members of the Grand Division of the Province of New Brunswick :*

Your Committee on the State of the Order beg to submit the following Report :

1. Your Committee notes with satisfaction that the funds available for the purposes of this Division are in such a healthy condition that large possibilities of propagation and other work are within the reach of the Order, and fortunately we have reached a position in which the income of the Division is more than sufficient to meet the expenses of work carried on in the line of the efforts of previous years.

2. Your Committee cannot fail to note the fact that this Division, with less than 6,000 members, lies adjacent to the jurisdiction of a similar organization in Nova Scotia enrolling over 16,000 members; and would recommend a careful consideration of the methods of work pursued by our Sister Division of Nova Scotia and imitation of the lines of effort there in vogue, in order that a like effort here put forth may produce a like result in this Province.

3. Your Committee commends the activity of the Grand Worthy Patriarch and Grand Scribe in visiting the Subordinate Divisions throughout the jurisdiction, and would urge upon the Grand Division Officers generally the desirability of frequent visits on their part.

4. Your Committee would approve of the action of the Grand Worthy Patriarch in granting a dispensation for the establishment of York District Division, and would recommend to the Grand Division that a careful consideration of the principles and practice connected with such Divisions throughout the jurisdiction, take place.

5. Your Committee strongly recommend that a more systematic effort be put forth to establish the Order of Cadets of Temperance throughout the Province, and notes with satisfaction that four Sections of Cadets have been organized.

6. Your Committee draws attention to the fact that notwithstanding ten Divisions have been opened during the year, a decrease of 576 members is recorded as the numerical summary for the past twelve months. Also that the number of members belonging to Divisions suspended last year is 758. Had it been possible to continue those Divisions in existence a slight increase in our membership would be shown.

7. Your Committee would therefore earnestly recommend to the Grand Division that some new departure for the coming year be inaugurated, looking towards a more systematic and it is hoped a more fruitful effort in the line of keeping up the Subordinate Divisions at present existing and establishment of new Subdivisions, and in the opinion of your Committee it would be more satisfactory to have a paid Lecturer and Organizer in connection with the Grand Division, to whom a substantial salary could be paid, rather than as at present, the funds be handled by local Committees, with the unsatisfactory results shown during the last few years.

*Resolved*, That the Grand Scribe of this Grand Division send a copy of these Resolutions to each Grand Division and all other prominent Temperance organizations in Canada, requesting their concurrence and assistance in the matters contained in these Resolutions, in order that at the next session of Parliament, or the session of 1890, petitions from the entire Dominion may be presented in favor of the prohibition of the importation, manufacture and sale of intoxicating liquors, except for medicinal, sacramental and mechanical purposes.

*Resolved*, That the Committee do not proceed to obtain the signatures to these petitions until satisfactory assurance be obtained that the movement will be general in the other Provinces, so that all the Provinces will move in the matter concurrently.

*Whereas*, The Dominion Parliament a few years ago by Resolu-



tion declared itself in readiness to enact Prohibitory Legislation as soon as public opinion would sustain it, and

*Whereas*, The votes taken on the adoption of the Canada Temperance Act, and other action of the people have in our opinion fully shown to the Dominion Parliament that the people are ready for Prohibitory Legislation.

Your Committee therefore feels that the Government is now in duty bound to enact the Prohibitory Legislation sought for, and that it is not desirable to proceed with the expensive and laborious scheme laid before the Grand Division.
