LICENTIATE IN SACRED THEOLOGY.

Graduates in Arts of this University, or of other Universities recognized by it, and such other persons as shall have been accepted as candidates for Holy Orders by the Bishops of Quebec and Montreal, may become students in Divinity, and, after a period of two years of residence, may proceed by Examination to the title of Licentiate in Sacred Theology.

Such students are required to pass the Examinations at the end of every term during the two years.

In 1894 the Mathematical Honour subjects were divided into three stages. Each stage requires one year. Honours of the first grade require all three stages. The first and second stages constitute second grade honours. The first stage alone constitutes third grade honours.

To qualify for entrance as a candidate for Classical and Mathematical Honours, a student must pass the general examination at the end of the second year (or an equivalent); he must obtain seventy-five per cent. in the Classical or Mathematical group respectively, and must have obtained fifty per cent. in the aggregate at such examination.

All candidates for Honours and options are required to take as Theological subjects: In the year 1897-8.

NOTE ON CLASSICAL BOOKS-When editions are not specified, those of the Tutorial Series, published by Messrs. Hinds and Noble, New York, are recommended for private study, but plain texts only are allowed in the Lecture Room.

REGULATIONS FOR HONOUR COURSE IN THEOLOGY

(ADOPTED JUNE, 1895.)

The Course of Honour Theology shall consist of three grades, the first or highest extending over three years, the second over two years, the third over one year.

The examination for entrance shall in each case be equivalent to that at the end of the second year in Arts, the candidate being required to attain at least 75 per cent. in the aggregate of the classical subjects. He must also have passed an examination in (1) St. Matthew's or St. Mark's Gospel, (2) Paley's Evidences, Part I., and (3) general knowledge of the contents of the English Bible. Besides this, he must have satisfied the Dean of the Faculty as to his capacity for English composition.

These qualifications attained, he may enter the *first* grade (or three years' course) either (1) immediately on admission into the university, or (2) on the completion of the first or (3) second year of his ordinary Arts course.

He may enter the *second* grade (or two years' course) on completion of the (1) second or (2) third year of his Arts course.

Or he may inter the *third* grade (or one year's course) on the completion of the (1) second or (2) third year of his Arts course.

The course shall consist of five main branches, as follows:—(1) Holy Scriptures, (2) Dogmatic Theology, (3) Church History, (4) Evidences of Christianity, (5) Criticism and Archæology.

Of these, the first three shall be obligatory; the last two alternative, one of the two being selected each year by the Dean of the Faculty with the approval of the Council. By the same authority, if No. 4 be selected, selection shall further be made of one of the three departments of the subject:—(1) Buddhism compared with Christianity, (2) Christianity and modern systems of thought, (3) Natural Religion and Revelation. If No. 5 be selected, selection shall be similarly made of one among the three departments:—(1) Old Testament Criticism, (2) New Testament Criticism, 3) Old and New Testament Archæology.

The second grade (or two years' course) and the third grade (or one year's course) shall consist, generally speaking, of the subjects assigned to the first grade in the years in which they happen to occur, as set forth in the annexed table of those subjects as distributed over the three years of the course; care being taken, however, to secure completeness of treatment in the subjects so far as they are taken up, and all being done to the satisfaction of the College Council.

The selection of text books and books of reference (supplementary to those which are specified in the first four columns of the schedule as permanently obligatory) shall be made from time to time by the Professors of the Faculty of Theology, sanctioned by the Visitors and approved by the Council. Original authorities, as well in Church History as in Dogmatic Theology, shall be mastered in the original languages.

The Examinations are open to Boys and Girls from any Canadian school. The regulations for 1898 will be sent on application to the Principal.

BISHOP'S COLLEGE.

By an Act of the Legislature of the Province of Quebec, passed in the year 1843, Bishop's College was constituted a body corporate, consisting of the Lord Bishop of Quebec (or in case of the division of the Diocese of Quebec, of the Bishops of the Dioceses into which the Diocese of Quebec should be divided), the Trustees of the College and the College Council.

By a subsequent Act of the Legislature of the Province of Quebec, passed in the year 1870, the governing body of the College was materially altered, with the object of bringing the College into more immediate connection with the Synods of the Dioceses of Quebec and Montreal. According to the terms of this Act, three Trustees and three members of the College Council are appointed by each of the Bishops of the two Dioceses now contained within the Province of Quebec, and five Trustees and five members of the College Council are selected from a larger number in each case nominated by the vote of their respective Synods; members of the Corporation hold their seats for three years and are eligible for re-appointment.

Bishop's College, which owes its existence to the earnest and untiring efforts of the late Bishop Mountain, of Quebec, was designed in its foundation to satisfy a two-fold need: first, to provide the Church of England in the Province of Quebec with a suitable place for educating her ministry; and, secondly, to offer to the Province at large the blessing of a sound and liberal education based upon religious principles.

The village of Lennoxville was selected as its site, on the grounds of its central position, in the midst of the English-speaking population of the Province of Quebec, and the prospect it afforded of moderation in the scale of expense to individual students.

Residence within the College is the rule and characteristic of the system of Education in Bishop's College, the common Collegiate Life, after the model of the great Universities of Oxford and Cambridge, being regarded as a training of great importance.

The work of the College began in October, 1845. Among the benefactions made to the College may be mentioned :-

Liberal donations from friends of the Church in Quebec, Montreal and the neighborhood of Sherbrooke and Lennoxville, and \$5,000 from the S. P. G., and the same from the S. P. C. K.

More than \$10,000 raised in England by the Rev. J. 1847. H. Nicolls, D.D., Principal of the College, including \$5,000 from S. P. C. K. About the same time \$30,000 was given to Bishop Mountain by a munificent friend, Thomas Churchman Harrold, Esq., of Little Horkesley Park, Essex; Miss Leeds, of Ipswich, Suffolk, giving \$1,000.

In 1848 the S. P. G. offered an annual grant of \$1,200, shortly

afterwards commuted for a sum of \$16,000.

1849. Professor Hellmuth (afterwards Bishop of Huron) collected \$4,000 in England.

Numerous donations towards new School Building erected on site adjoining College.

Endowment Fund, \$10,000, carrying free tuition, subscribed by various friends in shares of \$500.

Rev. Dr. Nicolls, Principal, collected funds in England 1865. tó supplement endowment.

Large subscriptions obtained by Rev. C. H. Badgley, Rector, and others towards rebuilding school.

In this year and about this period the Harrold Fund for Professorship of Divinity (\$25,000) was raised by the untiring efforts of Professor Roe, D.D., (now Archdeacon of Quebec), and begun by noble gifts from two friends of the College in the Diocese of Quebec; also by the same initiative a fund now reaching \$11,000 was raised towards the endowment of the Principalship.

The sum of \$29,000 was left to the College by two ladies of Quebec, Mrs. Davis and Mrs. Davidson, for a Professorship and Divinity Exhibitions. Part of this has been applied to the Professorship of Mathematics.

1886. Fund of \$6,000, raised by subscription, begun amongst the Alumni and Old Boys at the Alma Mater Dinner, to build the Bishop Williams Wing, on the suggestion of the Principal;

the insurance of this was applied towards the present Bishop Williams Hall, which is used as the Convocation Hall of the University.

1888-92. Fund of \$15,000 raised by subscription to build the Divinity House, collected by the Principal.

1888-90. A sum of \$11,000 raised by efforts of Archdeacon Roe towards the endowment of the Jacob Jehoshaphat Salter Mountain Professorship of Pastoral Theology, and \$4,000 was given to endow the Divinity House by Dr. Mountain, in addition to a large donation to the endowment of the Professorship.

1891. Special grant from Provincial Government, \$10,000, in consequence of disastrous fire of February, 1891. About the same time \$15,000 or more was raised to supplement the insurance money (\$41,000), and to provide for improved and more substantial buildings. Most of this was raised through the efforts of the Principal, Dr. Adams, and the Head Master H. J. H. Petry, Esq.

The school has cost about \$57,000, and no debt remains on the building.

Of the \$15,000 raised in 1891, Mr. R. Hamilton gave \$4,000, and Colonel Charles King, of Sherbrooke, \$1,000, which was devoted to the Chemical Laboratory bearing his name.

The new buildings of the School are remarkably massive, and much has been done towards rendering the building fireproof.

Many friends have aided in the above benefactions, amounting to not less than \$100,000, during the years 1884-94. Amongst those who have rendered aid on a large scale may be mentioned R. Hamilton, Esq., Rev. Dr. J. J. S. Mountain and Hon. E. J. Price.

The College Chapel, originally built (1857) through the exertions of the late Principal, Dr. Nicolls, was enlarged (1875-8) in memory of the late Bishops Mountain and Fulford, the Rev. L. Doolittle, one of the earliest benefactors of the College, and finally of Dr. Nicolls himself. The chapel is well adapted for its sacred uses, and not altogether unworthy to be compared with some of the College Chapels of the great English Universities. It has been opened for worship since January, 1893, but still lacks the stalls, the final floor, and many of the stained glass

At least \$2,000 more is required to complete the Chapel, irrespective of the stained windows.

Memorial windows have been given by Bishop Dunn, one in memory of Rev. Dr. Lobley, the second Principal, and another of Rev. L. Doolittle; by Chancellor Heneker, to the memory of Bishop Williams; by the ladies of Lennoxville, in memory of the first Principal, Dr. Nicolls; by the late Mrs. Nicolls, in memory of Bishop G. J. Mountain; and by Rev. Dr. J. J. S. Mountain, in memory of members of his family.

The College Buildings were restored in 1875, on an improved Besides the Students' rooms and a larger and smaller dining hall, there are three large lecture rooms and a reading

room for the use of Professors and Students.

In 1890 a Divinity House was erected, containing a residence for the Professor of Pastoral Theology, two Lecture Rooms, a Common Room, a room used for devotional offices, and rooms for Students. The building was completed in 1893. It has cost \$15,000, of which Mr. Robert Hamilton has subscribed \$6,500, Hon. E. J. Price \$3,000, S. P. C. K. £300.

In May, 1897, Mr. J. H. R. Molson, who had already subscribed \$5,000 to the Jubilee Fund, bequeathed the sum of \$10,000 for the benefit of Bishop's College School.

Earlier in the same year Mr. A. D. Nicolls bequeathed \$3,000 to establish Scholarships in memory of his father, the Rev. J. H. Nirolls, D.D.

The Library has been to a great extent replenished, and now contains upwards of 8,000 volumes, including many most valuable modern works in Theology, General Literature, Mathematical and Physical Science, Classical and Philological Research, but requiring much liberality to keep it adequately equipped.

A small Museum of Geological and other specimens has been collected, and it is to be hoped will be greatly increased by contributions from Students and other friends of the College.

JUBILEE FUND, 1895-6-7.

JUBILEE OF BISHOP'S COLLEGE AND BISHOP'S COLLEGE SCHOOL,

LENNOXVILLE, PROVINCE OF QUEBEC, CANADA.

The institution began its work in 1845, and celebrated its jubilee in 1895. To mark this event, and to meet the continued demands of an ever-advancing standard of education, it was resolved to raise a Jubilee Fund, the sum aimed at being Fifty thousand dollars, at least.

Of this sum, Forty thousand dollars is intended for endowement of College and School, and Ten thousand is needed for buildings. (Chapel and Gymnasium.)

The two most pressing objects for endowment at the present moment are:

- A. The Headmastership of the School.
- B. The Professorship of Classics in the College. At least \$20,000 is required for each.

The following endowments should also be raised to at least \$20,000 each:

- C. J. J. S. Mountain Professorship of Pastoral Theology. (\$12,000 in hand).
- D. Professorship of Applied Science. (\$1,200 in hand).
- E. Principalship Endowment. (\$11,800 in hand).

Besides these, the following sums are a minimum urgently needed for buildings:

- F. For the completion of the restoration of the Chapel, \$2,500.
- G. For a new Gymnasium, \$7,500.
- H. Extension of College, at least \$15,000 required.

The increase of students in 1896, and the reasonable anticipations arising from promised students for 1897 render an additional building to accommodate students an urgent necessity—at least \$15,000 would be required for this purpose.

Gifts to the Jubilee Fund may be allotted by the donor to any one or more of the above objects, and the needs here detailed would require a total of One hundred thousand dollars.

Bishop's College is governed by a Corporation, the Members of which are appointed by the Bishops and Synods of the two Dioceses of Quebec and Montreal, which are co-extensive with the Province of Quebec. It is under the control of the Church of England, but its advantages are open to, and are used by all, irrespective of creed.

Bishop's College School is managed on Incorporated Association, working in conjunction with the Corporation. It is the only Boarding School in the Province on the model of the great English Public Schools.

An earnest appeal is hereby made to all friends of the higher education in this Province and elsewhere, as well as to all Graduates and Old Boys, for their assistance, both by their own contributions and by the use of their influence with others, in order that the foundations of the Institution may be strengthened, and that it may meet the constantly increasing requirements for improvement and expansion, which are characteristic of the education of the day.

The Calendar of 1896 contained a list of subscribers to the Jubilee Fund from rather more than 200 subscribers.

The required total is not yet complete.

The conditions of the S. P. C. K., in offering £1,000, are as follows, and both the conditions are required to be fulfilled before the £1,000 can be claimed:

- (a). The total of the Jubilee Fund from all other sources must be £9,000.
- (b). There must be raised, with what is funded already, and that which is subscribed in the Jubilee Fund for these purposes, and the £1,000 of the S. P. C. K., enough to raise the Prin-

cipalship Endowment Fund to \$20,000 and to raise the Mountain Professorship of Pastoral Theology to \$25,000. This will require something like \$4,000 more than is already subscribed.

It is urgently hoped that this sum may be speedily forth-coming to add to the two Funds, marked C and E in the "Form of Subscription."

Note.—The Ten Thousand Dollars, required to secure Twenty Thousand offered by Robert Hamilton, Esq., D.C.L., was secured on June 3, 1896; since that date the Hon. E. J. Price has promised \$5000. On June, 1, 1897, the Jubilee fund stood at \$42,600, including \$5,000 from the late J. H. R. Molson, Esq., besides the £1000 promised by the S.P.C.K. and the \$2000 promised by Dr. Mountain. To secure the offer of the S.P.C.K. the sum of \$4,000 is still required.





BISHOP'S COLLEGE.

ADMISSION.

Candidates for admission into the College are required to present testimonials of good conduct, and may be admitted either as matriculants or as candidates for matriculation in the PREPARATORY CLASS the members of which attend Lectures on the Subjects of the Matriculation Examination.

Members of any other recognized University are admitted to the same standing on presentation of the necessary certificates under certain conditions.

Casual students, and such as cannot keep continuous residence, may, with the approval of the Principal, attend particular courses of instruction, without becoming regular students.

COLLEGE FEES.

The Payments required of Students, covering all necessary expenses, are as follows:

Each room is furnished by the College with ordinary furniture, but each Student provides his own bedding and towels. These, however, are provided by the College to such Students as desire them, at a charge of \$2.50 per term. The Students have the use of the College Infirmary under due regulations.

Every Student pays a deposit of \$30 at the beginning of each Term, and the balance of his account at Mid Term.

COLLEGE READING ROOM.

Open to Professors and others on the Staff as well as Students. Subscription: Three Dollars a year.

The vacations are one month at Christmas, and in the summer from the last Thursday in June to the second Saturday in September. Return tickets at reduced rates are issued for the vacations to all points on the Grand Trunk Railway, and on the Quebec Central and Canadian Pacific Railways for Christmas and Easter.

Terms are kept by residence in the College, with regular attendance at Chapel and Lectures, and the punctual performance of all exercises required by the various Professors and Lecturers. No Student is allowed to count any term as a term of residence of which he has not kept at least three-fourths. In the case of Students whose parents or guardians reside at such a distance from the College as to admit of regular attendance at Chapel and Lecturers, actual residence in College may be dispensed with.

All students will be supplied with a copy of Rules, etc., on entrance, and must apply at once on arrival to be registered.

All students are expected to have College Cap and Gown; also a surplice; and if candidates for holy orders, a cassock as well.

Regular attendance at chapel services on Sundays and week days is required of all. Non-members of the Church of England may obtain exemption on written request of Parents or guardians and guarantee of regular attendance on Sundays at other Churches.

Lectures are given in the College to the Students of the several years, on the work appointed for their respective yearly examinations. The progress of all the Students is further tested by an examination in the subjects of Lectures at the end of each term.

All Students are required to write Essays during Term on Subjects appointed by the Principal, and to perform such exercises in Reading and Public Speaking as he may think desirable.

The following books amongst others are used in Lectures, or recommended for private use by the Students, matriculated and preparatory.

EXHIBITIONS.

There are at present established in the College the two S.P.G. Jubilee Scholarships (or their equivalents.)

Two Davies and Davidson Exhibitions (one of which is in abeyance for a time.)

One Mountain Jubilee Scholarship is available from 1894 onward. Besides these by the bounty of the venerable S.P.G., there are eight Exhibitions (four for Quebec and four for Montreal Diocese), of the value of about \$145 each and assigned by the Bishops of Quebec or Montreal respectively to students on passing an Examination in the Bible and in English Dictation. The S.P. C.K. also makes a grant for six Exhibitions; the holders of these must be of a standing to take Holy Orders within three years from the date of receiving the Exhibitions, and these Exhibitions are tenable only by natives of the Dominion of Canada. All these Exhibitions are tenable on certain conditions which are expressed in the following form or its equivalent which has to be duly signed as directed.—

Form of Assignment and Conditions of Exhibitions.

ASSIGNMENT OF EXHIBITIONS IN BISHOP'S COLLEGE TO CANDIDATES FOR HOLY ORDERS.

I hereby assign to Mr.

the Diocese of an Exhibition of the value of per annum, for a period of years; such Exhibition to be held by him subject to the following conditions:

1st. That he shall produce to me at the close of every Michaelmas and every Trinity Term a Certificate in the following form, duly signed:

time he has applied himself diligently and faithfully to his studies, and has made satisfactory progress in the same; and that so far as we are in a position to judge from what we know of his general walk and conversation, we believe him to be a sincerely religious man,* with satisfactory marks of vocation to the Sacred Ministry.

* The signatures of the Professors will apply to this last clause only in the case of Students in the Divinity Course, and in the half year preceding it. Principal.

And that in case he should at any time fail to procure and present to me such Certificate, the title to the aforesaid Exhibition shall thereupon cease and determine, as shall also his standing as a Candidate for Holy Orders.

2nd. That such candidate shall take the subject of Hebrew, and shall pass all the Examinations in the same throughout his College Course.

3rd. That such Candidate engages, as a just return for this benefaction, to serve the first five years of his Ministry in the Diocese of Quebec, (or Montreal if required by the Bishop of Montreal.)

4th. That if through misconduct, or any other cause except some infirmity which may incapacitate him for study, he should cease to be a candidate for Holy Orders in one of these two Dioceses, he hereby binds himself to repay the Bursar of Bishop's College whatever sum he may have received down to that time from his Exhibition.

Every student in the Faculty of Arts holding an Exhibition from the S.P.G. or S.P.C.K. is required, as essential to the continuance of his Exhibition, to pass annually an examination in the contents of a portion of the English Bible; and every student in the Faculty of Divinity is required to pass the same examination; as essential to the maintenance of his status in that Faculty.

These examinations for five years will be as follows:

1897.—Ezra to Isaiah (inclusive.) Psalms. Book IV. (xc.-cvi.) I. Corinthians to Philemon (inclusive.)

1898.—Jeremiah to Malachi (inclusive.) Psalms. Book V. (cvii.-cl.) Hebrews to Revelation (inclusive.)

1899.—Genesis to Leviticus (inclusive.) Psalms. Book I. (i. xli.) St. Matthew and St. Mark.

1900.—Numbers to Ruth (inclusive.) Psalms. Book II. (xlii.-lxxii.) St. Luke and St. John.

1901.—I. Samuel to II. Chronicles (inclusive.) Psalms. Book III. (lxxiii.-lxxxix.) Acts and Romans.

In 1897 the examination will take place on September 21.

N.B.—Candidates for exhibitions must in their first examination pass in a general paper only of an elementary character in the whole Bible.

PROCEEDINGS IN MUSIC.

BACHELOR OF MUSIC.

The Candidate for this Degree must be either (1) a Graduate of this or some other recognized University, or (2) a Clergyman in Priest's Orders, or (3) a Barrister-at-Law, or (4) he must produce a Certificate of having employed five years in the study and and practice of Music.

The degree is open to women qualified under (1) or (4).

The Candidates will be required to pass three Examinations, separated by intervals of not less than one year, to be called the First, Second and Final Examinations in Music, and before admission to the Final Examination he must have composed an exercise in at least four parts, with an accompaniment for the organ, piano, or string band; and this Exercise must have been approved of by the Examiners.

Candidates who present satisfactory evidence of having passed some recognized Examination equivalent to the First Examination in Music may be allowed to take the First and Second Examinations on consecutive days.

The exercise must be sent to the Registrar not later than June 1. and any Candidate intending to present himself for Examination must give notice to the Registrar not later than June 1, on a printed form, which will be supplied on application.

The Examinations will be held beginning on 1st Tuesday in October.



PROCEEDINGS IN MEDICINE.

The Faculty of Medicine has its seat in Montreal (Ontario and Mance Streets). Convocations are held annually for the conferring of Medical Degrees in that City.

The Degrees of this Faculty are those of Master of Surgery (C.M.) and Doctor of Medicine (M.D.), the former being conferred only upon those who at the same time obtain the Degree of Doctor of Medicine.

The College building contains large lecture rooms, several smaller lecture rooms for Practical Chemistry, Practical Physiology, Histology, Bacteriology, etc., and large, airy, well-lighted dissecting rooms at the top of the building, isolated from the rest of the class-rooms. Under the new Anatomy Act of the Province of Quebec, ample material for dissection is provided at moderate rates.

The Histological, Physiological and Bacteriological Laboratories are supplied with a complete outfit of Microscopes, Microtomes and of Bacteriological and other modern apparatus. The Pharmacological Laboratory, besides possessing a very complete cabinet of drugs and their preparations and alkaloids, has all the necessary appliances and means for the working of B.P. preparations and every facility for practical dispensing. Recently the Faculty has expended another large sum for apparatus in several departments, to facilitate practical teaching.

Students who do not desire the license of either the Quebec or Ontario College of Physicians and Surgeons, and not otherwise qualified, will be examined by this University on October 15th and 16th, 1897, and March, 1898, on the following subjects. Fee \$5.

3. Mathematics, comprising (a) Arithmetic, (b) Algebra as far as Simple Equations, inclusive, (c) Geometry, the subject matter of Euclid, Books I, II and III, with easy deductions.

4. Botany, as in Gray's School and Field Book of Botany.

5. One of the following optional subjects:—(a) Greek, (b) French, (c) German, (d) Italian, or any other modern language, (e) Logic.

The course of instruction covers three years and consists of lectures, clinics and practical work in the Dental Infirmary and Laboratory. All candidates for admission except those who are graduates in arts or medicine, of a British or Canadian University, must pass the matriculation examination of the Dental Association of the Province of Quebec, before they can register as students of this college. Students who intend to practise in the Province of Quebec, must sign indentures with a Licentiate of Dental Surgery in active practice in the province at the beginning of their course. The Dental Act requires three full years as an indentured student after the matriculation has been passed.

The student is required to provide himself with necessary instruments and appliances, a list of which may be obtained from the Superintendent, Dr Andres.

The University of Bishop's College will confer the degree of Doctor of Dental Surgery on all students who have fulfilled the following requirements:

1st. Must be 21 years of age.

2nd. Must be of good moral character.

3rd. Must have passed the matriculation and have completed the full term of three years.

4th. Must have passed all examinations and paid all college and University fees.

EXTRAS—Music, \$10 a term; Shorthand, \$20 a year. Subscription to games, \$5 a year—optional. Drawing Materials, Chemicals, etc., \$2.50 a year. Books, Stationery.

Besides this a deposit of \$15 at the beginning of the year (i. e., Sept.), or on entrance, to be made up again to that sum at the beginning of each term, to cover personal expenses, is required by the Committee. An account of sums expended will be rendered. The Committee of Management do not advance money for the pupils beyond the deposits. When the deposit is exhausted parents will be notified.

Boys are not allowed to obtain credit at shops without a school order; these orders are not given for any considerable value, except by written consent of the parents.

No cash advances will be made to those boys for whom deposits are not made, nor will orders be given to these.

Sons of Clergymen working in the Diocese of Quebec and Montreal and in other cases are admitted at a greatly reduced rate, if they reside in the School-house. Boys over 13 years of age will be required to produce satisfactory testimonials of good conduct from the head master of their last school.

Forms with questions relating to previous health of intending pupils are sent to parents, and full answers are requested.

The payments for Board and Tuition must be made strictly in advance. No boy will be permitted to continue in the School, unless a certificate from the Secretary of all dues having been paid be presented to the Headmaster not longer than a fortnight after the commencement of each term.

All other School accounts will be sent in the usual way. A term's notice must be given in writing before the removal of a pupil in all cases.

BOARDING.

The control of the Boarding Department of both College and School is in the hands of a Committee of Management, consisting of the following:—The Rev. Prof. Scarth, M.A., Chairman; the Rev. the Principal; W. Morris, Esq., B.A., LL.B.; the Head Master (ex-off.); W. A. Hale, Esq.; E. B. Cochrane, Esq.; F. W. Frith, Esq., B.A., (Secretary).

The School house is under the personal supervision of the Head Master, assisted by the Lady Matron, who occupies rooms

in the building.

New boys will be charged, on entrance, a fee of \$15, for bedding, etc., which is supplied by the School. This sum will cover the whole period of a boy's residence in the School.

Parents are particularly requested to send their boy's linen, etc., carefully and clearly marked, and with a complete inventory.

Reports are sent home at intervals during every term; at the end of the term, full details of standing in all subjects and term for examination; and in both, records of conduct, diligence and punctuality. Toall these the parents' careful attention is called.

The parents are invited to correspond freely and fully with the Head Master on any matter relating to their sons' progress and well-being.

DUTY.

School hours are from 9 a.m. to 12.45 p.m., with 15 minutes' recess at 11 o'clock. Afternoons, 2.15 p.m. to 4 p.m. in summer, 4.30 to 6 in winter.

Wednesdays and Saturdays are half-holidays. Study for House Boys:

Morning-7.30 to 8 in winter; 7 to 8 in summer.

Evening—7.30 to 8.45 in winter; 8 to 9 in summer.

On half-holidays Roll is called at 4 p.m., at which all boys are obliged to present themselves, unless they obtain special leave.

BOUNDS.

The city of Sherbrooke, the railway station and hotels are out of bounds. Leave to visit them can be obtained from the Head Master alone.

CHAPEL.

All the Boys attend service in the College Chapel every morning and twice on Sunday.

In case of conscientious objection on the part of the Parents it is arranged that boys attend other Churches so far as practicable. Roman Catholic boys for example are expected to attend their own Church in Lennoxville.

SCHOOL WORK AND EXAMINATIONS.

The School is graded into six Forms. To enter the first form a boy must pass a good examination in Reading, Writing, Spelling, the elementary rules of Arithmetic, and elementary Geography. A preparatory form has been established under an experienced teacher to prepare boys for the entrance examination of the first Form.

In the fifth Form, boys will be allowed to discontinue the study of Greek and to take Chemistry, Physics and Physiology instead. Botany will also be studied by the Science boys in the sixth Form.

Examinations will be held at Christmas and Midsummer.

In order to be promoted to a higher form a boy must obtain 50 per cent of the marks attainable during the year. Boys who fail to secure promotion will be allowed to remain one year longer in the same form, but those who are not successful at the close of the second year will not be allowed to return to the school. A certificate of promotion will be appended to the yearly report of each boy; those boys who successfully pass the final examination of the sixth Form will be granted a Diploma. No boy can enter the third Form who cannot pass a very

satisfactory examination in writing and spelling.

The Bishop's College School Recreation Club is managed by a Committee of Masters and Boys elected by the School. The annual subscription is \$5.00 (optional). This club embraces:

No boy is allowed in a boat or canoe who cannot swim across the River Massawippi.

During the Swimming season three of the best swimmers are appointed daily to teach the younger boys and to guard against accidents.

DRESS.

Parents are requested not to send too large a quantity of clothes with their boys. It is expected that all boys in sixth, fifth and fourth Forms will wear on Sundays a black morning coat; and boys in the third, second, first, and preparatory Forms an Eton jacket and waistcoat of black cloth with Eton turndown collar.

It is advisable that each boy be provided with a stout Jersey for football and other games.

SCHOLARSHIPS AND PRIZES.

In addition to the regular prizes given by the School, the following are open to competition:—

The Walker Scholarship, the Eastern Townships Scholarship, and the St. Matthew's Church, Quebec, Scholarship, one of which is given each year, entitling the successful candidate to \$50 per annum for three years on condition of residence as a Student of Arts in Bishop's College.

"Reid School Scholarship," given by the late Rev. C. P. Reid, D.C.L., value \$70, for sons of Clergy in Diocese of Quebec, awarded on the Bishop's nomination.

The "Leray Scholarship" for proficiency in French, open to old pupils in their first year at Bishop's College under certain conditions, and given by the Chancellor.

The Silver Medal which His Excellency the Governor-General offers for competition each year.

The Silver Medal offered by His Honor the Lieutenant-Governor of Quebec, for Mathematics in the Upper School.

Mr. G. R. White, of Quebec, offers a prize of \$6 for the best Essay on certain Historical Subjects.

The Chancellor's Prize, which will be awarded for History.

A Latin Prose prize has been offered for competition by the Very Rev. R. W. Norman, D.C.L., D.D., Dean of Quebec, for several years.

A special Prize for the encouragement of French has been given for some years by the Council of Public Instruction in Quebec.

The "Old Boys" Prize was founded 1874, by former Lennoxville boys, as an evidence of regard and affection for their old school.

The "Irving" Prize was founded in memory of the late Rev. G. C. Irving, Rector of the School 1863-7, for the best boy in Mathematics in the Lower School.

The Robertson Prize for the best collection of Wild Flowers is given by the Rev. A. H. Robertson, of Cookshire, P.Q.

A prize is given yearly to the boy, who, in the opinion of the Head Master and Masters, has been, by his good conduct and loyalty, of the greatest service to the School.

Of those Lennoxville boys who have entered the Royal Military College nearly all have been offered commissions in the Imperial and Dominion Forces.
