Assessment.

In St. John there has been, very lately much discussion over the assessment question, in the Common Council, the press, and, of course, among the people generally.

It is very difficult matter, so to adjust taxation as to make it fall equally on all classes, so as not on the one hand to oppress the man with exiguous income from labor, handicraft, or small precarious business; or on the other, to overburden the man of comparative wealth, or of fair means; to pay respect to the necessities of the poor, and to encourage the investment of capital in houses, etc., and so retard the growth of a city or town, and not to allow the owners of personal property of any description to escape paying their due share of the common burden.

Every one who imagines, has his own notion of curing the defects of the system of assessment in the place where he lives. One is for taxing rich and poor alike in the matter of, and in proportion to, their income. Others are for piling it on the rich, and in an ascending scale according to the amount of their wealth; others are for laying the heaviest burden on the man who has the most land, or the most stock, or the most real estate. Our contemporary, the St. John Globe, says that, "no doubt in time will be discovered that the true principle of taxation will be to make every man pay in proportion to his ability to pay." This certainly, is the equitable principle which ought to underlie all systems of assessment. The poor man would then pay no more or no less than he ought, as a citizen having the benefit of the protection of civil government, to pay, and from the payment of which just share very few poor honest men, we imagine, desire to escape. Having laid down the above dictum, incontestable proposition, the Globe proceeds to say that "when that principle is applied the rich man only, and the man of fair means will pay." We both feel and see how that result will come about, or the pertinence of the inference it draws from that assertion. "For the Globe adds, 'it is clear that a man who owns \$50,000 or \$100,000 of property is better able to pay a large sum, than a man of \$5,000 is able to pay a small sum. Therefore there should be an ascending scale. If, for example, \$10,000 pays \$1,000 tax, \$100,000 ought to be \$10,000, or \$200,000, ought to be \$20,000, or \$300,000, ought to be \$30,000, or \$400,000, ought to be \$40,000, or \$500,000,
