

The G. W. P. read his report as follows :-

OFFICE OF GRAND DIVISION, C. E.

To the Officers and Brethren of G. D. of C. E.

Another period has elapsed and we are again met in Grand Division to receive the reports of our officers and to deliberate on matters calculated to promote the prosperity of our order, and the good of our common humanity. Let us come to the task in a humble, prayerful spirit, and determined with divine aid to use our best energies for the promotion of our glorious cause.--Let us pray to our Heavenly Father and invoke his forgiveness for our past apatby, and ask his blessing on our labours that the fruits thereof may be more abundant for the time to come,

In reporting on the state of the Order in this jurisdiction, I regret that I have it not in my power to by before you so full and accurate a statement as I would wish to have done, owing to the neglect of my Deputies in making their Quarterly Reports with due regularity. The time of the Semi-Annual meeting of G.D. being at han I, and reports from only a very few of my Deputies 'being received, I deemed it my duty to address a circular to those Deputies who had failed to report, calling on them to furnish me forthwith with information respecting the state of the Order in their several localities. To these circulars answers have been returned by some of them to whom they were addressed-to several no answer has been returned/ I have likewise made afficial visits to a few of the Divisions in my own immediate neighbourhood. There has been one old Division revived, and I have just been informed by the G. S. that a new Division has just been organized in the Eastern Town"

Most of the Reports received by me are favorable as to the state of the Divisions reported, and the apperance of the Divisions visited by myself warrant me in saying that the prosperity of the cause in those localities are much more encouraging than they have been for a consilerable in e past. At the same time, it must be confessed, that in other localities our prospects are far from encouraging. Some Divisions have ceased to exist and many more are in a very languid and depressed condition. Still we have much to encourage us in our onward course, with energ, and determination to work one and all of us in our different sph res, seeking opportunity whenever it can be found to advance the interests of the Order with a humble dependence upon Divine aid, we must be successful.— Let us put our shoull let to the wheel and the car of temperance will once more roll on triumphantly in our midst.

Since our last meeting it has been my privilege to attend the Annual Session of the N. D., held at Providence, R. I. The most cheering accounts were given of the renewed life and energy pervading the Order throughout the length and breadth of the land. Many matters of gr-at interest to our Order were brought under the notice of the meeting and after mature deliberation disposed of—all of which you will have an opportunity of considering when the proceedings are published. A few of these matters I will now take the liberty of bringing under your notice :—

A request having been made from various sections of the country for a new Ritual, a committee was appointed at the Session of the N. D., held at Lerington, to prepare a new Ritual and to report at the succeeding meeting .--The Ritual, as presented by the committee, was taken up and discussed, clause Aby clause, and ultimately adopted with amendments. The old Ritual forms the ground work of the new one, adopting from the one at present in use such portions as were deemed improvements, forming a work such as will give satisfaction to all parties, and set this matter of Ritual finally at rest. The M. W. P. deeming it a matter of the utmost importance that measures should be adopted to employ Lecturers, and to disseminate written information on the subject of temperance throughout the/country, and recommended the establishment of a permanent fund for this purpose, leaving it with the N. D. to devise the proper means for raising that fund. The matter was remitted to a committee, and after mature d I beration reported that they considered the object sought to be obtained was one of paramount importance-that they did not under present circumstances deem it advisable to make any alteration in the constitution of subordinates, but that each G. D. should be recommended to take such steps as to them should seem best for carrying out the important recommendation of the M. W. P. I trust, therefore, you wil give this matter your most serious consideration, and that you will adopt such measures as will enable us to carry out the views of the M. W. P. in disseminating a correct

knowledge of the principles of temperance, and of our beloved Order throughout the community. I have likewise to bring under your notice an alteration which has been made in constitution of subordinates, to this effect, that no Per Capita Tax will in future be due or payable for any member over 12 months in arrear.

At the request of a representative from N. B., I have to bring under your consideration a subject which seems to me to be of importance to the interests of temperance throughout the British Provinces—That is, the holding a general temperance convention for the Provinces at such time and places as may be agreed upon, which I now recommend to your favorable consideration.

In conclusion I have great pleasure in rendering my acknowledgments to the G. S. for the zeal and ablity with which he has conducted the affairs and watched over the interests of the Order.

Office of GRAND SCRIBE. Montreal, June 23, 1857.

To the Grand Division of Canada East :--

OFFICERS AND BROTHERS,-In submitting to you my Semi-Annual Report, I am extremely sorry that I cannot congratulate you on any increase to the number of our Divisions, or any great measure of success attained by the Order in Canada East since our last meeting ; and this is the more to be regretted when we look around us among the neighboring Grand Divisions, and observe the expressions of gratitude finding utterance in the reports of Grand Scribes and Worthy Patriarchs, of the great measure of success that has attended the labors of the Sons in the localities during the past half year, in addition to the number of Divisions and the increased life and activity manifested among Subordinate Divisions, in carrying on the great work in which we are engaged. The Committee on Appeals presented the following Report :--

To the Grand Division Sons of Temperance, Canada East, and Grand Worthy Patriarch, Officers and Brothers :

We, your Committee on Appeals, to whom was referred the case of Bro. William Hall, P. W. P. of Gough Division, against a report of a Special Committee of the said Division, and also against the Division for having adopted the said Committee's Report—In this Case Bro. Hall charges Bro. Healey with contempt, in passing complainant as A.C. and going to the P. W. P. for the retiring "pass-word," on two several occasions—to wit, on the nights of the 13th and 20th of October, 1856.

The Committee appointed to examine into and decide upon that charge, after two several considerations of the matter in question, gave as their report that no contempt had been intended, and that consequently the charge fell to the ground. From this report complainant appealed to the Division, and, after much deliberation, the Division sustained the report of the Committee from which report and decision complainant appeals to this Grand Division.

Your Committee are of opinion that the plea of non-intention of contempt was not sufficient grounds for the conclusions they arrived at; and that the word contempt, as used in the charge, was not misapplied. We therefore recommend the adoption of the following :--

That the report of the said Committee, and the decision of the Division, on that report, be reversed.

Your Committee would further recommend that the P. W. P. should carefully guard against such departures from the usages of the Order, as he seems to have done in giving the retiring pass-word to Bro. Healey; and that members of our Order should on entering the Division Room discard from their minds all such private feelings as are calculated to lead them from such departures in future.

Order, to whom has been committed the consideration of the G. W. P. and Grand Scribe's Report, beg leave to state,-That whilst the G. W. P.'s report gives expression to sentiments of gratitude to Divine Providence for sparing us to meet together for the purpose of promoting the object of our organization ; yet, we cannot but regret the absence of so many of our official Brethrenwho, on former occasions, cheered us by their presence, and whose enlightened wisdom guided us on our onward course. May we not fear that this apparent apathy, of which the G. W. P. justly complains, and which we so deeply feel on the present occasion, will be productive of serious evil in rendering our annual and semi-annual gatherings less interest. ing, especially in those localities where our meetings are held, who naturally look forward with deep interest to our assemblnig among them as a means of reviving their drooping energies, and of encouragement in struggling with their surrounding difficulties. This is no time for relaxing our efforts. The work of death is advancing ; our responsibilities as an Order are fearfully increasing. Let us not slumber at our posts, but watch and be sober. We would most earnestly call upon our Subordinate Divisions to attend to their duty and send, whenever it is practicable, suitable men to the Grand Division, to aid us by their experience in this good cause.

We learn with deep regret that many Subordinate Divisions have not reported their proceedings for several quarters, and that some D. W. G. P's have been equally remiss, in responding to the G. W. P.'s circular. The absence of such reports necessarily prevent us from arriving at a satisfactory knowledge of the state of the Order within our jurisdiction. We fear that there is too much cause to apprehend that several Divisions are not only in a declining state, but have already fallen. At the same time, we trust that whilst so many have been faithless found, that others have been found faithful, and maintaining their post with fidelity and success.

Our attention has also been directed by the G. W. P. to the recommendation of the M. W. P. of the National Division, as to the propriety of establishing a fund for the more general dissemination of Temperance principles, and showing the dreadful consequences of intemperance, by the publication of Temperance writinga or the employment of lecturers for that purpose. Whilst we regard these suggestions as well deserving our serious consideration, we feel doubtful how far a general co-operation could be realized, from the fact that it is with difficulty that we can sustain our ordinary and necessary expenses, and an additional expenditure might militate against our welfare. We are of opinion that much may be done by Subordinate Divisions themselves, especially when the co-operation of the ministers of religion can be secured, by holding frequent Temperance meetings in their respective localities.

The subject of the proposed Temperance Convention, to be held in the British Provinces, is one of great importance, and has had our most serious

consideration; but we do not see that the elements necessary for carrying out so extensive a measure are within our reach. The present depressed state of our finances appears to be an inseparable barrier in the way, but we recommend that the subject be taken up for consideration by the Grand Division at its Annual Session.

We hail with pleasure the announcement of the organization of a new Division; and whilst we feel that we have not so fully carried out our mission as we ought, and feel humbled on that account, yet, so far from yielding to despondency, we pledge ourselves to adopt the recommendation of the G. W. P., to put our shoulders to the wheel of the car of Temperance, and to press onward till our cause shall triumph in every part of the world.

GRAND SCRIBE'S REPORT.

In the Grand Scribe's Report we see little to remark upon, beyond what has already been taken notice of in the Report on the G. W. P.'s Report except the fact of his continued zeal and deep interest in the cause in which we are engaged. We sympathise with him in his concern, that such a state of apathy should exist; and when he asks the important question : shall such a state of things be allowed to remain ? we would most emphatically answer no, and would pledge our selves to renewed exertions, and hope at our next meeting to be able to present a more cheering state of things. We beg, in conclusion, to express the satisfaction which we feel at the manner in which the G. W. P. and Grand Scribe have discharged the duties of their respective Offices during the past half-year.

To the Grand Division of Canada East, Officers and Members :

OFFICE OF THE GRAND DIVISION,

MONTREAL, 21st October, 1857.

In submitting my Report to the Grand Division, in Annual Session assembled, I have again to express my regret that I am unable to furnish you with such information regarding the state of the Order in Canada East, as it is desirable you should be in possession of. The District Deputies having failed (with some honourable exceptions,) to make the Quarterly Report required by the constitution. I addressed letters in some cases to District Deputies, in others to the R.S. of the Division, and in some instances to private members of the Order, whom I know to have been active S. of T., but little additional information has been collected thereby. Such information as I have received, I now place before you :

Montreal—Howard Division—Never since its organization has the Division been in a more prosperous condition, or with a better prospect of a useful career before it.

Neal Dow Division-Has held no meeting for a considerable time.

Quebec—The Deputy reports "the cause as proceeding, if not rapidly, at least surfly. The Divisions have been engaged in keeping the cause as usual, as much before the public as possible."

St. Andrews—The Deputy states, "I can only say that during the past Quarter, the Division has been kept in working order. I think we have reason to hope, that our winter's campaign, will be a successful one."

Victoria Division—Lachute – the Division is in good working order. The number is small, but are actuated by a sincere desire to promote the object of the organization, and peace and harmony characterise all their meetings.

St. Michaels Union-The Deputy reports that there are at present twice the number of members in good standing, to what there was last October.

Lacolle Division-Is in a prosperous condition.

St Johns-Cameron Division-Continues in good working order.

Bristol-Deputy states that the Division is not in so flourishing a condition as could be wished.

Manningville-"The cause in this place is encouraging, at the present

time the great obstacle to our progress, is the number of unlicensed grogshops. At present there is a difficulty in getting at them—but hope soon to do so,—when we may expect large additions to our numbers."

New Glasgow-In good working order.

Leeds-Balaklava Division is in a healthy condition, and going on prosperously.

St. Francis' Division—Bro. the Rev. T. W. Constable reports as follows :-The Division under my charge is prospering, and will soon become a very important auxiliary in our great work ; and when we shall have got into full operation, and got our bye-laws into circulation, we will increase more rapidly. There has been no public circulation of information respecting our Order, and no Temperance meeting lately. Having now a little more leisure than I have had for some time past, I intend to hold some public meetings ; and as soon as the new ritual is out, I will organize another Division at Melbourne.

Of the other Divisions in the jurisdiction, I can give no certain information; and I am afraid that the greater number, if they have not actually ceased to exist, are at least in a very languid and decaying condition.

Since last meeting of the Grand Division, one new Division has been organized at Lake Beauport under very favorable circumstances.

Upon the whole, although we have not much reason for gratulation, still we have no cause to despond. Although in some portions of our jurisdiction there is an apparent apathy and want of energy, yet, in other portions, there is displayed an energy and a determination to carry out the great principles of our noble and beneficent Order, which has not been exceeded in any former period of our existence. That this energetic feeling may continue, let me remind the brethren of the essential importance of punctual attendance at stated weekly meetings of the Divisions. It is to the neglect of this duty that the apathy and want of energy above complained of is mainly attributable. Neglect of attendance cannot fail to diminish the interest felt in the cause, whilst regularity tends to keep alive attachment, excite sympathy, and encourage enterprise.

In my last Report, I brought under the notice of the Grand Division a recommendation of the Most Worthy P., for the formation of a fund to defray the expense of diffusing correct information on the subject of Temperance, and the peculiar fitness of the Order of the S. of T. to sustain and promote Temperance principles, as also the report of the Committee of the National Division, to which that recommendation of the Most W. P. was referred, recommending that the matter should be left in the hands of Grand Divisions, to do what seemed best in their serveral localities. This Grand Division reported in favor of the measure, but before taking any steps to carry out the recommendation, wished it to be ascertained what each Sub-Division would place at the disposal if **a**ny Divisi dollar

posal of the Grand Division for the purpose. I am not aware what response, if any, has been made by any of the Divisions with the exception of Howard Division, who have resolved to place at the disposal of the G. D. the sum of fifty dollars for the employment of a lecturer.

Two matters of practical import I beg to bring under your notice for consideration: Are we to have a Prohibitory Law? and what is our duty as a body relative thereto?—and 2nd, Is the Order of the S. of T. as efficient for the purposes of its organization as it might? If not what is to be done to render it more efficient.

My connexion with this office is now about to expire, and sorry am I that I have been unable to devote so much time as it was my earnest wish to do to the advancement of our glorious cause, and have possessed more talent to discharge the duties of my office with honor to myself and profit to the Order; and as, no doubt, that in the discharge of those duties there have been many errors, both of omission and commission, I rely on your goodness to overlook them as errors of the head rather than the heart; and with a full consciousness of the justice of the cause in which we are engaged, and your earnest desire for its accomplishment, I commend it and you to the guidance of Him who, in His own good time, will order all things right.

The Grand Scribe read his report as follows :----

QUEBEC, OCT. 21, 1857.

G. W. P., OFFICERS AND BROTHERS,—I herewith present my report of the transactions of this office, since our last meeting in June, at Lachute. As the time between these two meetings have been but short, there is not much to report.

On the 15th July, a new Division was organized at Lake Beauport under the name of Lake Beauport Division, No. 36.

The returns for the present quarter are only just coming in, but I observe by those already received, considerable improvement in the number admitted this quarter over last. Howard Division, Montreal, has admitted 37 new members; St. Lawrence Division, Quebec, has admitted 10, while last quarter the return showed only two; Manningville admitted 14, and last quarter none. These are but a few, and I trust the others that may come in, will show the same improvement.

There are a number of Divisions that have ceased sending returns, and although parties connected with them have been repeatedly written to, no answer has been returned and no knowledge ascertained of their condition. It is unfortunate that Deputies should have been appointed, who are so unfaithful to the trust imposed in them, as not to report on their state, and thus give us the satisfaction of knowing whether the Divisions in their locality are alive or dead.

Since last meeting, copies of the proceedings of the National Division have come to hand, and been distributed to the Subordinate Divisions under our jurisdiction.

The alterations and amendments to the constitutions have been few. I would, however, direct attention to the following :--

The Committee on Geremonies and Regalia presented the following report, which was agreed to :--

The Committee on Ceremonies and Regalia, to whom were referred the resolution of Bro. Hodges, asking that passwords and withdrawal cards be prepared for lady visitors, beg leave to report, that they have had the matter under consideration, and believe the interests of the Order would be advanced by having a uniform password for females, but that cards for lady visitors, are unimportant and unnecessary and they therefore offer the following resolutions :—

Resolved, 1.—That the M.W.P. be instructed to prepare annual and quarterly P. Words for lady visitors and transmit the same to the G. Scribes under the jurisdiction.

Resolved, 2 .- That it is inexpedient to prepare a card for visitors.

Part 2nd of Constitution of National Division was amended, so as to read as follows:

"It shall be composed of such Grand and past Grand W. P's., and Grand and past Grand W. A.'s and such acting Grand Scribes as have served two consecutive years as Grand Scribes, as shall be elected their Representatives by a majority of the members present at such annual session of the Grand Division."

It was resolved,—"That Divisions are not to pay per capita tax on suspended members, and members more than 12 months in arrears for dues."

A new Ritual is to be given to the Order, composed principally from what is commonly known as the "old Ritual." In the meantime, however, Divisions are at liberty to use such Rituals as they have on hand.

It was resolved to admit lady visitors of the Order to witness proceedings in Grand and National Divisions.

The next meeting of the National Division takes place at Indianopolis, on the second Wednesday of June next, at 2 P. M.

In regard to the employment of a lecturer for Canada, I have received no communications from any Division, except Howerd, which I lay before you, and trust that some further action be had in the matter.

Your Committee trust that in future, Representatives will keep this subject before their Divisions, and urge the Deputies at all times to a full and faithful execution of the duties of their office.

From all quarters whence reports have been received, our cause seems steadily and surely moving onwards to its consummation, total prohibition. This movement though not proceeding with a speed correspondent with our wishes, is still gathering additional momentum ; and your Committee hope that every member of this Division will live to see the day when the tracks of our principles will be laid down like a net of Railways, and the velocity of their motions will exceed that of the sweeping steam engine, and their universal propagation and adoption become a permanent and undoubted fact-a great and glorious public good. In other quarters there seems to exists an apathy which must be shaken off, and to effect this laudable object, every individual member of this Division must strive to do his very best, must put his hand to the plough, and his shoulder to the wheel, until our cause and its ramifications, the tree and its, branches, stand forth boldly and distinctly, well cleaned and cultitivated, and bearing fruit richly and abundantly. One of the first points in this course of conduct, will be personal attendance at the meetings of the Division. This, as truly observed by the P. G. W. P., is a most essential point, and Representatives, if they would be considered as doing their duty, should never miss one opportunity of impressing their Divisions with a full sense of the immense importance of this particular feature of progressive improvement.

Another, and the most important of all, is the employment of a Lecturer. In concluding their review of the G.W.P's. report, your Committee cannot allow that officer to retire from his high and honourable position without marking their sense of his energetic and efficient conduct, and they have no doubt this Division will warmly second them in returning him sincere thanks for the same, and earnest wishes for his future happiness, and welfare, temporal and eternal.

After our meeting in Quebec, the Lecture Committee sent a circular to the different Divisions, to see if we could employ a lecturer during the winter months, but the encouragement we got was not of such a nature as to warrant us in employing one for this season; but still I would recommend the same object to be taken into consideration this fall, as some of the Divisions were very liberal in subscribing towards that purpose, and I have no doubt but the whole Order would benefit if this were carried out.

I had a visit from the G.W.P., of New Brunswick. He gave me an account of the Order there, and stated that lectures from men who had the cause at heart, and working men of the Order, did more to extend the Order than any other means, and they keep such lecturers employed as much as possible.— New Bruuswick has made up its mind to have a full Prohibitory Law. They have had reverses, but still progress sure and steadily.

I have the pleasure of informing you that we have got another Division opened in Quebec, composed of French Canadians, under the title of Montcalm Division.

I think during the next winter that they will do a great deal of good, as they have a large field to work on. I have also had the honor of granting a charter to a new Division at Richmond. I have no doubt that it will prosper under the guidance of the Rev. Mr. Constable, and extend the glorious cause.

Lacolle-Lacolle Division is in good working order, and increasing.

St. John's-Cameron Division is not prospering, having had a great number

REPORT OF DEPUTY GRAND WORTHY PATRIARCH OF MONTREAL DISTRICT.

Montreal, 25th May, 1858.

Grand Worthy Patriarch, Sons of Temperance, Canada East :

Dear Sir and Brother,—I have to apologize for neglecting, in accordance with my instructions as your deputy, to forward you reports before the first days of April and January last, but will endeavor, if alive and well, to attend to this duty more faithfully hereafter.

My jurisdiction, as you known, is unfortunately limited to Howard Division No. 1, of which, however, I am glad to be able to give a very encouraging account. Its growth in numbers, as you are aware, has been very respectable for some eighteen months back, but at no prior time was its progress made satisfactory than during the two quarters terminating on the 1st April, and which success has been even on the increase from that date to the present time, as many as 46 initiations having taken place at the last eight meetings. The number of members in good standing on the 1st April was 160, and is now about 200. The average attendance at present is about 50, and would be much larger with our present membership, at almost any other season of the year.

You will be pleased to learn, that the greatest amount of unanimity and the best possible spirit still prevails amongst the members of this Division, which assists materially in its advancement.

Its meetings are announced every week in two of the leading daily papers, as well as occasionally in the *Witness* and *Temperance Advocate*, which it is thought has a good effect, by keeping the order and its great and noble work before the public.

A short time since the division reduced its rates of initiation fees and dues 50 cents for former, and 50 cents per quarter for latter, and for persons under 18 years of age, to one half these rates. This alteration was deemed to be advisable, as the benefits were done away some time ago, and it would be likely to have lection The a unit series means

The division took an active part during the past winter and early spring, in a united effort with the other temperance bodies in the city, in getting up a series of public meetings, which were nearly all well attended, and were the means of bringing some members into the division.

With a view to making the weekly meetings of the division more attractive and interesting, the plan was adopted about a year ago, of having an original production or reading on some suitable subject, from one of the members ateach meeting, which has been continued without much interruption, as I am sure with good results.

In my next report I expect to be able to inform you of the establishment and promising condition of a new division at Cote St. Paul, about 3 miles up the Lachine Canal, where there are about a dozen members of Howard Division, connected with Mr. Higgins' Axe and Tool Manufactory, amongst whom is Mr. Higgins himself, an old and valiant cold water man, and who was the means of bringing the others into the order. There is no doubt but a good working division will spring up there.

I cannot close this report without alluding to one thing, which in my opinion has been a chief cause of the success, which I am proud again to refer to, that has attended Howard Division, and that is the regularity of attendance at the the meetings, and uniform zeal of some of its old members, and without intending the slightest disparagement to others of the old stock, or newer members (many of whom deserve credit on this score,) I cannot forbear mentioning the names of Brothers Henry Rose, J. S. Hall, J. M. Hall, W. G. Slack, J. Montgomery and Andrew Dawson, whose well known faces are hardly ever missed at a meeting.

The organization of this Division and its progress is looked forward to with considerable interest, as it is hoped, if successful, it will be the introduction of our order among a large class of our population that were thought to be inaccessible to our labors.— If the French Canadian population receive this introduction of our order among them favorably, it will be the uneans of greatly enlarging our usefulness in Lower Canada, and add considerably to the number of Divisions under our jurisdiction.

The other Division was instituted in Melbourne, under the name of Richmond Division, No. 38.

Information has also been received of the revival of Clarenceville and Lancaster Divisions, both of which were considered virtually dead. We trust that they now start under auspices that will put them in a more flourishing condition than they have yet experienced.

Although I thus congratulate you on these additions, I am sorry that the number of returns received during the last two quarters are fewer than on previous occasions. For the quarter ending December 31, only 11 returns have been received, and for the quarter ending 31st March, 10. Although there has been a falling off in the number of returns, yet I am happy to inform you that several of the statements received show considerable additions to the number of members, and a very marked revival of interest in our order in these localities. We hope this interest will spread through our entire jurisdiction, and stir up our Divisions to renewed exertions, so that the beneficial effects of our order may be felt through all our borders. your

Although the picture has a bright it has also a dark side. Notwithstanding all the exceptions, the subordinate divisions in a great number of cases are in good working order, and some of them rapidly increasing in number. I regret to be compelled to confess that intemperance is not correspondingly diminished, but rather on the increase. The existence of our Order, without doubt, prevents the evil from spreading more rapidly than it otherwise would; but it is melancholy to reflect that, after having expended large sums of money, and years of laborious effort, we have been instrumental

mainly in hindering the more rapid development of intemperance, when its utter extirpation might have been expected.

Much positive good doubtless has been done, but in a negative form. Our progress has been up hill with many a slip backwards. Some have grown weary with the incessant and seemingly never-to-be-ended with hoary evil. Others have given up in despair. Such have mis-calculated the nature of human depravity, and of the vice against which we are waging war. This moral demon, this destroyer of men, women and children, has a thousand lives, and will die hard. Do you ask "When is this moral warfare to end ?" If any think, that after fighting a few years, with various turns of fortune, they are going to retire with laurels, and rest upon their trophies, they have mistaken the calibre of their enemy. With such a foe, it is a wearisome battle. Intemperance is a stronghold not easily subdued; we will have to wait many an assault in the trenches, and repel many a sortie, before we are able to storm the well fortified citadel; it may require a generation or two to accomplish its subjugation. Shall we therefore relinquish the contest? never! we fight for posterity as well as for ourselves.

A hundred years ago the Dutch built their ramparts—mud walls—to resist the effects of the ocean upon the soil they had redeemed from its grasp. Does the Hollander trust these walls? No, day by day he steals an hour from toil to fill the breach made by the ocean. The willows are constantly decaying and must be replaced to keep out the wild waters that roar above his head, that he may retain the heritage left him by his father. We also have redeemed some ground.—

"Yet much remains To conquer still ; peace hath her victories Not less renown'd than war.

We have shut out the angry floods of appetite, custom and interest that are around us. It may take a time to convert the remaining water into land, but will we not fight to retain the land we have redeemed at somnch labour and expense? We will, if it should cost us our life-time spent in this effort alone.

In the name of hundreds saved, and millions exposed to the destroyer, I charge you not to peril by indifference what so much toil and self devotion have purchased for us. Our fathers are growing grey in this service, shall we not transmit the works of their hands with unimpaired efficiency to posterity, and put those who come after us in a position to finish that which we have begun.

But have we put forth efforts in keeping with the magnitude of our undertaking ? We have pledged ourselves not to cease working until every brother in the great brotherhood of humanity stands embraced within our circle of safety and honor. How does this comfort with the fact of our ably conducted Tembe: fai rej

We should not rest contented till the *Temperance Advocate* is in the hands of every man, woman and child, who can read, in the Province. If we are to rely upon the instrumentality of the press as a means of conversion of the entire Province to temperance and prohibition, we must circluate the *Temperance Advocate* by thousands.

It is with sincere regret that I inform the Grand Division that the committee appointed last year to procure a Lecturer, for Eastern Canada, have failed to accomplish that object. If times had not been so hard I believe it would have been attained, and I think that an object of such importance should not be lost sight of.

In presenting my official report, I cannot overlook the fact that several new Divisions have been opened during my administration, which argues well in favour of the cause.

A few hours hence I shall be called upon to lay down the emblem of my authority, and retire from the chair. I embrace this opportunity to express to the Grand Division my deep sense of obligation for their courtesy and confidence. I came among you a stranger and you were pleased to confer upon me the highest office in your gift. It has been my endeavour to show you that your confidence was not misplaced, but I retire from my office under the painful conviction that my efforts, though equal to my ability, have not been commensurate with the obligations of the chair.

Permit me again to revert with sincere satisfaction to the fact that, during my administration, the members and interests of the Order have not diminished, but increased. Much of this prosperity is due to the efficiency of your Grand Scribe, with whom my in imacy has been of the most pleasing character, and to whom I am indebted in being able with any degree of ability to meet the duties of my office. To the other officers of the Division I return my most sincere thanks for the manner is which they have discharged their respective duties, and the respect and courtesy with which they have treated the chair, as well as for personal favors.

Leaving the interests of the Order in the hands of the thoughtful and benevolent men around me who are looking and labouring with unwavering faith for the day of social redemption, I respectfully submit this, my last report, in Love, Purity, and Fidelity.

The Grand Scribe read his report as follows :

To the Grand Worthy Patriarch, Officers, and Brothers of the Grand Division of Canada East.

It gives your Grand Scribe great pleasure in greeting you, thus time after time in presenting you with his reports, and he now wishes you all personal health and much happiness, and that the Order in our locality may receive great good from your meetings.

In regard to the progress of the cause in Canada East, I have not much to report for the short time since we last met.

In August last, Worthy Brother Lambly, D. G. W. P. for Leeds, instituted a New Division at Inverness, under the name of Havelock Division, No. 39.

I have also had information from Portage du Fort, of the re-organization of the Division there, and from the communications received, they appear to have started with considerable vigor and much promise of success.

The number of returns received during last year have increased over previous ones, and I have to congratulate you therefore, on an improved and decidedly improving state of things in our Order in Ganada East; and I am glad to have to record this, as accounts from every quarter indicate a like improvement throughout North America. The Most Worthy Scribe in his last report, just come to hand, states, that in his opinion, "based upon an extended correspondence, the Order of Sons of Temperance has not been in so good heart at any time within the last seven years as at this date." He ascribes this to the earnest, living spirit, which showed its existence in many Grand Divisions, and their jurisdictions, during the term closed, and from the increase reported he chiefly justifies his conclusions, that the Order has again assumed the ascendant over the opposition of its enemies, and the still more to be dreaded *neutrality* of its members and friends.

This awakening interest calls us to a more earnest and ardent devotion of all our powers to increase this interest, and give it such a direction as will result in the greatest practical effort for good. The Committee on the state of the Order, in noticing this revival says, it is a truth, whether our philosophy of human society may account for it or not, that

"There is a tide in the affairs of men,

Which, taken at its flood, leads on to fortune ;"

and the amount of effort required to accomplish any desired result is much less when this "tide" is in our favor, than when it is against us. The present is a propitious time for our labor of love. The horizon which but a few months ago was hung with darkness, is now streaked with the dawn of a Temperance revival which, if we are but faithful to our mission, will cheer many a desolate home, will save from disgrace and ruin many a tempted youth, and will

In regard to our Order, the M. W. S. writes,-" The Order of the Sons of Temperance has become a necessity to the Temperance cause, and to the safety and welfare of the community. It is, in fact, a necessary institution in North America, as the all-important, sole and specific counter agent of intemperance and its consequent vice and crime. What desolation would not ensue were its star to disappear from the moral horizon. How many thousands would go back to their cups and to temporal and eternal ruin ; how many hearts and homes be shrouded in darkness and desolation; how rampant would not intemperance and crime leap up on every hand, and blur and bloody the earth around us and our children, if its holy light were quenched ?" If the members of our Order will for a moment consider it thus in preserving the healthforming, the moral character, and controlling the life conduct of so many thousands within its pledge, and sustaining the peace and comfort of their families, as well as in its vast influences on social ideas and customs, no one but will be willing to throw up its standard anew, and make one more brave and overpowering struggle for a god-like victory.

To the unorganized friends of Temperance, the M. W. S. states, "that their duty to themselves and the cause, requires them to be known to the world as its advocates, and would further press upon them, that organization is essential to life and power; and that the Order of Sons of Temperance is cheaper in support, relative to efficiency, than any other; and that Union with the Order may be vital to their wishes, as it is unquestionably, the only general, living, breathing, and working champion of the cause."

To the Subordinate Divisions of the Order and its membership the M. W. Scribe briefly savs, "that even yet more depends upon themselves. They are the veritable life and being of our noble Order, without whom all is naught, and upon whom and whose efforts rest most essentially and really THE TRIMPH OF THE ORDER. I would say to them, remember, Brothers, that union is strength and the sure anchor of our common hopes, and that a true life on your part will most surely beget zeal, prosperity and increase. Let technical disputes pass from you; encourage a magnanimous harmony in the "lesser matters of the law" for the sake of the cause. Let a supreme devotion to the spirit of the Order animate you. Give your entire energies for 1859 to the immediate enlargement of your Membership. The order of Sons of Temperance, of which you are the substantive primary parts, is the sole, active and Meliable army of Temperance, and it is of the first importance to keep it numerous in the field.

"Total abstinence is undeniably the great and only safe rule for all men just as moderate drinking is the most perilous snare of those who adopt it. Persuade the young men to join your ranks-accrete to yourselves men of principle and influence who favor the cause, and thus consolidate the friends of Temperance into the Order. It is an error to hold that this great Order on which so much depends, is to remain merely an asylum for inebriates. Let it be your holy duty to rescue all such whom experience tells you you may save. But I beseech you to firmly assume a more advanced position, and assert your Order to be a great preventive as well as a curative body. Thus will you do most good to "the cause of all mankind" and also assuredly lay the foundations of a lasting future. As members, be punctual in your attendence at the stated meetings of your Divisions; nothing is more important. Neglect of the Division room infalliably destroys the interest, attachment and energies of Members, absent and present, and so far damages the Order and cause; whilst a punctual attendance of all gives life and love, vigor and success. As iron sharpeneth iron, so does the countenance of a friend encourage his co-workers.

"Throw yourselves into a missionary attitude. Let every sound Division present a new Division to its jurisdiction and the National Division, during the year; and let the general aim be to erect a grand organized Brotherhood of Temperance over the whole North American continent for our own and the good of our people. Pay but little attention to the subject of general apathy, it is nothing—it is an abstraction. It is private apathy (and often our own) against which we have really to contend. Let every man speak to hus neighbour, and each man reason with himself, and we shall soon have no cause to complain of it.

Finally, brothers, let us be heartily active. By inaction we put to risk all previous toils and gains, and PREVENT FUTURE PROGRESS. Let our glorious Order once more feel the forward pressure of warm hearts and willing hands and under the blessing of a beneficient Providence all will again go passing well.

The alterations in Constitutions or ritual made at last meeting of the N.D, were very few, and I am glad to observe the strong feeling manifested by that body against such :---

Rule XXIII of the constitutions of G. D's relating to election of officers has been repealed .--

Rule XXI, in regard to the appointing of committees, has also been repealed .--

Rule III has been amended, so that the Grand Division can hold their Annual and Quarterly Sessions at such times as may be fixed at a previous Annual Session.
