The Opposition Policy.
The following resolution, which was moved in the House of Commons by Sir John Macdonald, represents the commercial policy of the Opposition—
"That this House is of opinion that the welfare of Canada requires the adoption of a national policy, which is to judiciously readjustment of the Tariff, will benefit and foster the Agricultural, the Mining, the Manufacturing and other interests of the Dominion; that the object of Policy will retain in Canada thousands of our fellow countrymen, now obliged to expatriate themselves in search of the employment denied them at home; will restore prosperity to our struggling industries, now so sadly depressed; will prevent Canada from being made a sacrifice market; will encourage and develop an active inter-provincial trade and moving (as it ought to do) in the direction of reciprocity; will be in accordance with our neighbors, who have the varied interests of Canada may demand, will procure for this country a reciprocity of trade."

The reception accorded to him by his constituents is a good certificate for those of the people of Canada who do not know him personally. The fact that Senator Brown and Premier Mackenzie are expected to go to Bruce for the purpose of encountering him, and if possible, "draw his fire" is of itself strong evidence that he is recognized as a more than ordinarily able exponent of public affairs.
In his reply to one of the addresses presented to him, "he strongly urged upon the young men to watch with special care the administration of the finances of the Dominion, no matter what Government might be in power." This has been his special forte in the Senate, and perhaps both from the intimate knowledge he has acquired of Dominion finances, and from the independent position he has ever taken in respect to political parties, there is no man in public life in the Dominion whose utterances ought to have more weight with the public than Senator Macpherson. In a speech which he delivered in the Senate just before Parliament was prorogued, he dwelt upon the state of the finances of the Dominion with even more than his usual vigor.
On that occasion he so fully exposed the fallacy of the Government supporters, who pointed to the Estimates as a proof that the Government were economically inclined—that that line of defence has been completely abandoned by the Government organs. He said the Estimates were merely an approximation to the probable expenditure. It ought to be a close approximation if the Government were really qualified to manage the finances of the country. Unfortunately for themselves and their argument, the Government had largely exceeded their estimate. For the financial year ended June 30th, 1877, the expenditure had exceeded the Estimate by no less a sum than \$1,789,600. During the current year the expenditure had been more than double that sum, the Gov't thus largely over-stepping the authority to expend given them by Parliament. One way and another the Government in the session of 1877, underestimated the expenditure by no less a sum than \$2,734,000.
Hon. Mr. Scott interrupted Senator Macpherson, trying to show he was wrong in his statement, but only succeeded in showing that Mr. Macpherson's view of the valueless character of the Estimates was the correct one. And Mr. Macpherson's conclusion was that "there is an absence of that regard for accuracy (on the part of the Government) which ought to characterize public men, and which, in former years, did characterize the public men of the country."
Mr. Macpherson, after demolishing the argument of the Government based upon the Estimates, pointed out the character of the legislation of the last five years. He said:
