An Act further to amend the Act incorporating the Metropolitan Gas and Water Company of Toronto.

WHEREAS it is desirable further to amend the Act passed in the Preamble. sixteenth year of Her Majesty's reign, and intituled, "An Act "to incorporate a Company to be called the *Metropolitan Gas and Water Company, of Toronto,*" by extending the time at which the said works 5 must be in operation : And whereas the said Company having shewn by their petition that they hope shortly to be in a position to proceed vigorously with the works so as to have them in operation by the year of Our Lord, 1861 ; Therefore, Her Majesty, &c., enacts as follows :

I. The fifth section of the Act eighteen Victoria, chapter two hundred and eighteen, amending the Act cited in the Preamble of this Act, is hereby repealed, and instead thereof it is enacted,—That if the said works, or either of them, shall not be in operation before the expiration of three years from the passing of this Act, the said Act cited in the Preamble of this Act shall be void and of no effect.

II. This Act shall be deemed a public Act.
