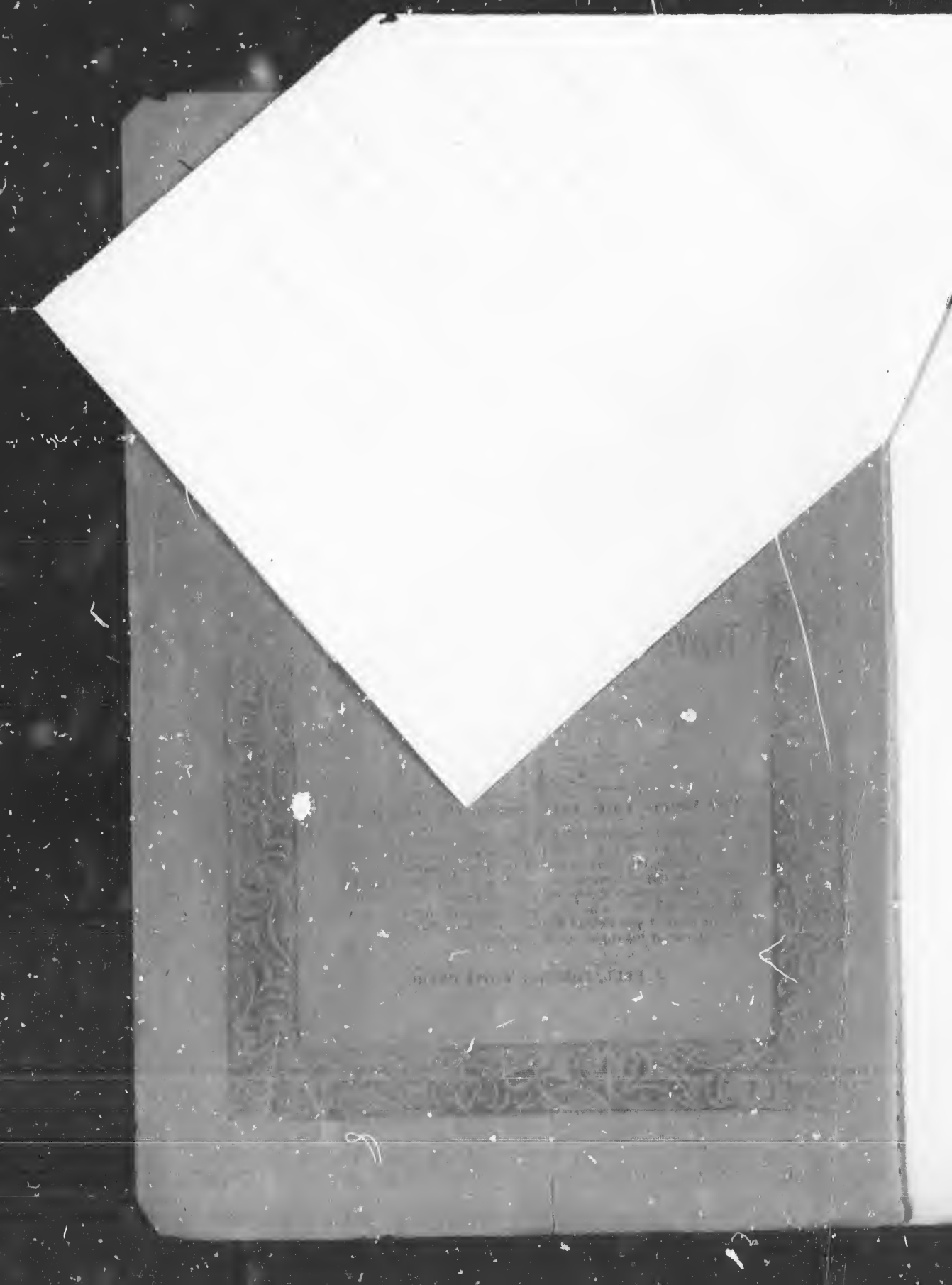
1881. VOTERS' LIST, 1881.
