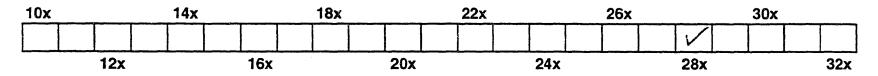

An Act to amend the Lower Canada School Acts.

HEREAS it is expedient to abolish the offices of School Commis-Preamble. sioner and Inspector of Common Schools, in Lower Canada, and aurther to amend the School Laws of that portion of the Province; Therefore Her Majesty, &c., enacts as follows:

I. The Act passed in the sixteenth year of Her Majesty's Reign, and Office of intituled, "An Act to amend the School Laws of Lower Canada," is here- School Comby repealed. with so much of the Act passed in the twelfth year of Her missioner 5 Majesty's Reign, and intituled, "An Act to amend the School Law of the Act 16 V., Lower Canada," and so much of the Act passed in the ninth year of Her c. 208, and Majesty's Reign, and intituled, "An Act to repeal certain enactments Parts of the therein mentioned, and to "make better provision for elementary instruc- 27, 12 V., c. tion in Lower Canada," and of the Act passed in the Sessions held in the 50, and 19, 20 10 19th and 20th years of Her Majesty's Reign, and inuituled, "An Act to V. c. 14, reamend the Common School Laws and further to promote elementary educa- pealed. tion in Lower Canada," as provides for the election or appointment of School Commissioners, or as vests any powers in them or assigns any duties to them, and the office of School Commissioner is abolished.

II. All the powers vested by the said Acts or any of them in School Certain pow-15 Commissioners, for laying out the School Municipality into School Dis- ers of School tricts, and for levying or causing to be levied by assessment and rate, any Commissionsums of money for School purposes, and for receiving and applying the erstrausferred to LocalCounsame and the shares of the Common School Fund coming to any School cils. 20 Municipality, shall be and are hereby transferred to and vested in the Local Council of the Municipality in which such School District is situate, and may be exercised by them, as fully and effectually to all intents and purposes as if such power had been by the said Acts or either of them, vested in such Council in lieu of such School Commissioners, subject 25 always to the penalties and liabilities imposed on School Commissioners for neglect of any duty assigned to them or any contravention of the law.

III. All the powers and duties vested in or assigned to School Commissioners by the said Acts or either of them, except such as are hereinbefore transferred to vested in and assigned to the Local Council of the Municipality, shall be School 30 and are hereby assigned to and vested in the Trustees of the several Com- Trustees. mon Schools respectively, with respect to which they would without this Act have been exercised by School Commissioners, subject always to the penalties and liabilities imposed on School Commissioners for neglect of any duty assigned to them or any contravention of the law.

IV. Notwithstanding any thing in the said Acts or any of them, no School fees not 35 School fees shall be payable for any child which does not attend the School payable for in respect of which such fees are payable, or for any time during which children not attending. such child shall not attend the School.

So much of the sixteenth section of the said Act, passed in the venting ap-pealsrepealed. twelfth year of Her Majesty's Reign, as provides that no judgment rendered upon the suits and prosecutions therein referred to, shall be liable to be appealed from, and that no such suit or prosecution shall be removed by writ of certiorari, shall be and is hereby repealed.

After the psssing of this Act, there shall be held on the first the election of in in each year, a general meeting of all the landholders and house-School holders in each School district, for the election of School Trustees, such Trustees in each School meeting to be called by some Justice of the Peace resident in the same or District. some adjoining School district, or in his default by any other Justice of 10 the County, or in their default, by any three landholders, by giving eight days previous public notice at the door of the Church or place of public worship therein, or if there be none then by a notice posted at two of the most public places in the School District; and at such meeting, the Justice calli g the same, or in his default such persons as those attending the 15 meeting shall appoint, shall preside; and at such meeting the said landholders and householders shall elect three persons, being themselves electors, to be Trustees of such School District.

Term of office. VII. The School Trustees so elected shall hold their offices until others are in like manner elected in their stead : and they and their successors, 20 To be a Corporation. by the name of "The Trustees of the School No. , of the "," shall be a Corporation, with School Municipality of power to acquire and hold such real property as may be required for the Powers. use of their School, and other the usual powers of Corporations, together with those transferred to them hereby from the School Commissioners, and 25 all other powers requisite for the efficient management of the School and School property.

VIII. If the election of Trustees in any School District shall, from any Failure of election pro- cause, fail to be held in any year on the day hereby appointed, it may be vided against held on any day thereafter; being called and notice thereof given in the 30 manner hereinbefore provided.

IX The said Trustees may appoint one of themselves as Clerk.

X. On the first day of May in each year, the Trustees of each School School Trustees to District shall make an estimate of the sum (not exceeding in any year the make a yearly) required for defraying all expenses of or relative 35 sum of estimate of to their School for the then current year, specifying the several items of expenses. XI. The amount received from Government for each School Muni-Principle on which Govern- cipality shall be distributed and paid by the Council receiving the same, ment allowamong the several School Districts therein, in proportion to the number ance shall be of children between the ages of six and fourteen in each, as nearly as they distributed

can ascertain such number; and it shall be the duty of the School Trustees among the to ascertain the number of such children in their School District, before several School they shall make their said estimate of expenses for any year; and the number so ascertained shall be stated in writing at the foot of their esti-5 mate, such statement being sworn or alfirmed by one or more of the Trustees before some Justice of the Peace, to have been ascertained as aforesaid and to be correct to the best of his or their knowledge and belief: and the Trustees shall with their estimate deliver in a statement of the average number of children attending such School during the then last year.

10 XII. The foregoing provisions of this Act shall not apply to any City or Act not to apply to Towns, incorporated Town or Village.

XIII. The third, fourth, fifth, sixth, seventh and eighth sections of the Office of In-Act passed in the Session held in the 14th and 15th years of Her Majesty's spector abol-Reign, and intituled, "An Act to provide for the establishment of a Normal 15" School, and further to promote Education in Lower Canada," are hereby

repealed, and the office of Inspector of Common Schools in Lower Canada is abolished.

XIV. The foregoing provisions of this Act shall come into force on the Commence-, and not before.
