The attention of parties receiving these lists is especially directed to Sec. 6, of the ' Voters' Lists Act,' as follows :

The Sheriff shall immediately upon the receipt of his copies cause one of them to be posted up in a conspicuous place in the Court House ; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posted in a conspicuous place in his office ; every Public or Separate School Head Master or Mistress shall in like manner post up one of his or her copies on the door of the School House ; and every Postmaster shall post up one of his copies in his post office.
