An Act to authorize the Courts of Queen's Bench, Chancery and Common Pleas in Upper Canada to admit Henry Edward Bennett to practise as an Attorney and Solicitor therein respectively.

WHEREAS Henry Edward Bennett, of the City of Toronto, Esquire, has by his petition set forth that he is a member of Saint John's College, Cambridge, of the Degree of Bachelor of Arts, and has been duly called to the Bar by the Honorable Societies of the Inner Temple and of Osgoode Hall respectively, and that he has been resident in the said City of Toronto for and during the three years last past, and during the last of such years has attended at the office of John Cuckmore, Esquire, a Barrister and Attorney-at-Law and Solicitor in Chancery, practising in the said City of Toronto, for the purpose of making himself acquainted with the laws and statutes of Upper Canada, and with the practice of an Attorney and Solicitor in the Courts thereof, and hath prayed that an Act may be passed to authorise the several Courts of Law and Equity in Upper Canada to admit him to practice as an Attorney and Solicitor in the said several Courts respectively: And whereas it is reasonable and expedient to grant the prayer of the said petition: Therefore Her Majesty, &c., enacts as follows:

I. It shall and may be lawful for the Court of Queen's Bench, the Court of Chancery, and the Court of Common Pleas in Upper Canada respectively, in their discretion to admit the said Henry Edward Bennett to practise as an Attorney and Solicitor therein respectively, any law or custom to the contrary notwithstanding.

Courts in U. C. may admit H. E. Bennett as an Attorney and Solicitor.

II. This Act shall be deemed a public Act.
